The meeting of Building & Works Committee of NIT, Kurukshetra started with a welcome note for the incoming Chairperson Dr. S. N Mahendra, Director, NIT, Kurukshetra and a vote of thanks for the out going Chairperson Dr. N P Mehta, Ex-Director, NIT, Kurukshetra.

The minutes of the meeting are as under:-

# Item No. 2.1 To confirm the minutes of the 1<sup>st</sup> meeting of the Building & Works Committee (BWC) held on 8.11.2002.

The Building & Works Committee confirmed the minutes.

### Item No. 2.2 To report the action taken on the minutes of the 1<sup>st</sup> meeting of the Building & Works Committee held on 8.11.2002.

The Building & Works Committee noted the action taken on the minutes of the 1<sup>st\*</sup> meeting of the Building & Works Committee. While reviewing the actions taken on the earlier decisions, the BWC made the following observations/decisions:

- (i) The PWD (B&R) has not yet installed a tube-well in its campus (leased out by NIT, Kurukshetra) situated on the NIT campus. The BWC requested the PWD (B&R) to install the said tube-well at the earliest so that the Institute discontinues the practice of supplying drinking water to PWD campus.
- (ii) The following high power committee as constituted by the Director, performs routine check on quality control on the on-going civil construction works executed by NBCC and PWD (B&R):
  - 1. Dr. V K Arora, Chairman, Deptt. of Civil Engg.
  - 2. Dr. V K Sehgal, Senior most Professor of structural Engg.
  - 3. Dr. R C Bhattacharjee, Prof. I/C (Estate & Constn.)
  - 4. Prof. Sathans, Lecturer of Electrical Engg.
  - 5. Sh. Maya Ram, Estate Officer
  - 6. Sh. D K Kaushik, JE (Electrical)

On the recommendation of the above Committee, the Director approves to the taking over of the respective building.

(iii) Earlier PWD (B&R) was the only executing Agency for the Institute for Civil works. However, the BWC vide item No.21.3 decided to allot some works to NBCC on trial basis. The BWC desired that the above high power committee should also evaluate the performance of NBCC vis à-vis PWD (B&R)

- (iv) The BWC desired that the Institute Master Plan be reviewed keeping in view future growth of the Institute
- (v) The BWC expressed satisfaction over the over-all progress of the ongoing works.

### Item No. 2.21 To consider & approve the RCE for Provision of High Mast Security Lights and Boundary in the Community park

Community parks in NIT, Kurukshetra. Further, The BWC suggested that the above provision for one number park be borne out of plan grant and that for the other out of College Development Funds.

### Item No. 2.22 To consider and approve the RCE for Provision of Chain link fencing etc. around tennis court in Sports ground

The Building & Works Committee approved the rough cost estimate amounting to Rs. 7.23 lacs for provision of Chain link fencing around tennis court etc. in Sports ground in NIT, Kurukshetra.

# Item No. 2.41 To consider and approve the Rough Cost Estimate for the Installation of HT/LT Sub-Station

The Building & Works Committee approved the rough cost estimate amounting to Rs. 302.00 lacs for the Installation of HT/LT Sub station in NIT, Kurukshetra. However, BWC observed that the provisions made in the agenda note cover only the instructional Building, street lights and hostels. The BWC suggested that the sub-station should have the capacity to include the entire campus including residential sector. The revised cost for the sub-station covering the entire campus be worked out and the work be executed in phases.

#### Item No. 2.42 To consider & approve the RCE for the installation of DG Sets

The Building & Works Committee approved the rough cost estimate amounting to Rs. 154.00 lacs for the installation of 2 Nos. DG sets of 1250 KWA capacity each in NIT, Kurukshetra. Further, BWC suggested that additional capacity for covering the entire campus be worked out.

#### Item No. 2.43 To adopt Delhi Schedule of Rates for framing estimates

The Building & Works Committee approved the adoption of *Delhi Schedule of Rates* (DSR) instead of *Haryana Schedule of Rates* (HSR) for framing estimates.
