Guidelines for MBA Admission 2019-21

1. As no PWD candidate applied for the MBA Admission against one Open (PWD) seat, this seat has been offered to a candidate from the Open category on Merit basis.
2. As no PWD candidate applied for the MBA Admission against one OBC (PWD) seat, this seat has been offered to a candidate from the Open category on Merit basis.
3. As the number of eligible applicants for the OBC seats are less than the number of allocated seats, the committee decided to offer the vacant OBC seats to the candidates from the Open Category, on Merit basis. This is in accordance with the guidelines of the Hon'ble Supreme Court.
4. It is decided that those candidates who do not report for the First Counseling (Scheduled on May 22, 2019) will lose their seat in the respective category. This sliding process will be done on May 24, 2019.
5. After sliding, the vacant seats, if any, in all categories will be notified on May 27, 2019 (As given in MBA Admission 2019-21 Prospectus).
6. In the 2nd counseling on May 28th, 2019, the vacant seats will be first offered to the Waitlisted candidates in order of merit. Those who have not reported for the First Counseling, may be considered for the vacant seats, if any, after list of the Waitlisted candidates is exhausted.
7. No candidate will be considered for MBA Admission in any circumstance who have either not participated in Group Discussion and Personal Interview or have not been recommended for admission by the Panel of experts.
8. The candidate must deposit the full fee in all respect at the time of Admission.
9. Physical presence of candidate is mandatory at the time of admission.
