Guidelines for MBA Admission 2020-22

1. As no PWD (OBC) candidate applied for the MBA Admission against one OBC (PWD) seat, this seat has been offered to a candidate from the OBC category on Merit basis.
2. As no PWD (SC) candidate applied for the MBA Admission against one SC (PWD) seat, this seat has been offered to a candidate from the SC category on Merit basis.
3. The online fees (Rs 71400) shall be deposited ONLY through SBI Collect
(<https://www.onlinesbi.com/sbicollect/icollecthome.htm>)
4. The fees will be deposited with the assigned reference number only. No claim will be entertained for any mistakes on the part of the candidate.
5. As the NIT Kurukshetra is 100% residential campus, all the students have to deposit the Full fees (including the hostel rent- Single seater). However, the local residents may get an exemption certificate in this regard from the office of Dean (Academic) and the deposited hostel fees will be adjusted in the subsequent semester fees.
6. After the deposit of fees, the candidate must send the Fees receipt on mba@nitkkr.ac.in on or before June 21, 2020 for further process.
7. The candidates who do not deposit the FULL online fees (during June 18, 2020 9:00 am to June 21, 2020 11:00 pm) will lose their seat in the respective category and further no claim will be entertained in any manner.
