**IMPORTANT NOTICE  
(MAY/JUNE-2021 EXAMINATION)**

The End Semester Examinations in May/June-2020 examination session could not be conducted due to COVID-19 Pandemic. The formula based examination notification of End Semester Examinations during May/June-2020 examination session was issued vide notification No. Acad./2020/274 dated 11.05.2020.

The students who applied as regular or reappear candidate in May/June-2020 for the assessment of the courses on formula based evaluation but the assessment of these courses could not be carried out due to non-availability of SGPA of previous semester were required to apply afresh for reappear examination for such courses in December-2020 examination session. The examination notification in this regard was issued vide No. Acad./2020-21/949 dated 20.11.2020, No. Acad./2020-21/962 dated 24.11.2020 and No. Acad./2020/1012 dated 07.12.2020.

It was also mentioned in the examination notification dated 24.11.2020 that the formula based evaluation provision would be applicable in the December-2020 examination session only.

***It is once again informed to all the concerned that the formula based evaluation will not be applicable for May/June-2021 and further examination sessions.***

The students having reappear in Even and/or Odd Semester courses up to December-2020 examination session were required to submit examination form for online examination during May/June-2021 examination session as per scheduled notified vide No. Acad./Exam/21/284 dated 04.03.2021 and No. Acad./Exam/21/ 542 dated 04.05.2021.

The students who have not submitted reappear examination form for May/June-2021 examination session assuming that they will be covered under formula based evaluation as and when their lower semester SGPA will be calculated are once again informed to submit online examination request in accordance with notification issued vide No. Acad./Exam/21/542 dated 04.05.2021 (Copy enclosed).

The above students must appear for online examination during May/June-2021 examination session for declaration of semester results.

**Subject: - Regarding End Semester Examination for May/June-2021 examination session for reappear examinees.**

The students of UG & PG programs having reappear in external component of Even and/or Odd semester courses are hereby informed that due to prevailing conditions of COVID-19 and late/non-declaration of results of any semesters, if they could not submit reappear examination form for May/June-2021 examination session are allowed to appear in End Semester Examinations subject to following:


1. The students of UG (2017 batch onwards) & PG programs must have minimum 50% attendance in the respective course. The students having attendance between 50% to 64.99% in detained course are required to submit the option form for maximum 'D' grade if the same is not submitted earlier.
2. The students of B.Tech. 2016 and earlier batches having attendance up to 64.99% in detained courses are required to submit the option form for maximum 'D' grade.
3. The students of B.Tech. 2013, M.Tech. 2016, MBA 2017 & MCA 2015 batch or higher batches are only eligible.

The students fulfilling above conditions are required to follow below mentioned process for appearing in reappear examinations in external component of Even and/or Odd semester courses.

- (i) The student is required to send request through email to the respective course coordinator.
- (ii) The student is also required to submit undertaking (duly signed by the student) on plain paper through email to the respective course coordinator mentioning that he fulfills minimum attendance criteria as per Institute rule and is eligible for appearing in end semester exam.
- (iii) The student is required to submit reappear examination form with examination fee receipt (including late fee) and option form for maximum 'D' grade (if applicable, and not submit earlier) in the office of the Dean (Academic) through email on email id (**reappear\_exam@nitkkr.ac.in**) within 03 days of conduct of exam.

The cut list for such students will be sent to examination cell and the concerned teaching department/school on receipt of examination form by Academic Section in phased wise manner and the same will be uploaded on the Institute website for information to all the concerned.
