In compliance of orders passed by Hon'ble High Court of Punjab & Haryana, Chandigarh on 29.05.2018 in the CM-7179-2018 in CWP-11055-2018, CM-8030-2018 in CWP-12384-2018 and CM-7183-2018 in CWP-5516 of 2018, the Summary of Eligibility Criteria including Essential Qualification, Essential Requirement, Cumulative Essential Credit Points etc. is as under:

1. Essential Qualification: Ph.D.

- (i) **Engineering Department:** First class both at UG and PG level (60% or 6.5/10 CGPA) with Ph.D. in relevant branch/discipline. Candidates having Ph.D. degree directly after graduation (B.E./B.Tech. etc.) from reputed Institutes/Universities will also be considered if other norms are fulfilled.
- (ii) **Science/Humanities and Social Sciences Department:** First class both at UG and PG level (60% or 6.5/10 CGPA) with Ph.D. in relevant discipline.
- (iii) **Department of Business Administration:** First class both at UG and PG level (60% or 6.5/10 CGPA) with Ph.D. in relevant discipline.
- (iv) **Department of Computer Applications:** First class both at UG and PG level (60% or 6.5/10 CGPA) and Ph.D. in relevant discipline.

2. Essential Requirements:

- (i) **For External Candidates**
Six years after Ph.D. of which at least three years at the level of Assistant Professor with Academic Grade Pay of Rs.8000/-
OR
09 years total working experience, of which three years should be after Ph.D., with at least three years at the level of Assistant Professor with Academic Grade Pay of Rs. 8000/-
- (ii) **For Existing/Internal Faculty Members (one time relaxation)**
Six years after Ph.D. at the level of Assistant Professor.
OR
Nine years of total working experience with Ph.D. at the level of Assistant Professor."

As per the MHRD, Govt. of India letter F.No.33-9/2011-TS.III dated 04.12.2017:

"The total working experience/length of mandatory service requirements as mentioned in above cited communication could be combination of services in NITs & other Institute of repute."

3. Cumulative Essential Credit Points: 50

The Credit Points are to be counted in terms of Note-2: Credit Point System published in the Gazette of India on 24.07.2017. The Credit Points as mentioned at Note-2, serial No.6 to 20 and 22 will be counted **since the last promotion.**

The MHRD, Govt. of India has forwarded the clarification regarding the recruitment to the post of Associate Professor by the following letters:

4. The MHRD, Govt. of India vide letter F.No.33-9/2011-TS.III dated 23.04.2018 has clarified the following:

The above said letters have been considered by the Institute in terms of General Condition No.2 of the Advt. No.03/2018 which reads as under:

“This being an advertisement governed by the Flexible Faculty Recruitment Rules, relevant instructions from MHRD issued till the date of interviews will be applicable. Incomplete applications/applications without necessary enclosures will summarily be rejected.”

Procedure of Screening and Short-listing:

The Screening of applications has been carried out at three levels as per Recruitment Rules.

At the first level, the Screening Committee at Department Level examined the applications as per the eligibility criteria laid down in Statute and subsequent clarifications and prepared the Summary Sheet. The Department Level Committee comprises of the of the following :

- * Director's nominee - Chairman
- * Head of the concerned Department - Member
- * Senior Faculty of the concerned Department - Member

At the second and subsequent level, the Summary Sheet along with applications screened applications were placed before the Advisory Committee on Faculty Recruitment (ACoFAR) constituted by the competent authority as per Recruitment Rules. The ACoFAR after examining the report of Department Level Committee recommended the list of eligible and in-eligible candidates. It was comprised of the following :

- * Senior most Professor - Chairman
- * One Senior Professor - Member
- * One Senior Professor - Member
- * Dean (Faculty Welfare) - Member Convener

The recommendations of ACoFAR were submitted to the Director. The final list of candidates to meet the Selection Committee were prepared in a combined meeting of the Director, the ACoFAR, the HoD and senior faculty members of the concerned Department.

Short-listing Criteria:

Short-listing criteria was prepared by the Institute for the recruitment of faculty positions based on new Recruitment Rules. Since the total number of eligible candidates in every department were very less as such **short-listing criteria was not necessitated or carried out.**
