Whereas vide order No. DMC-SPO/5215 dated 02.05.2021, the State Executive Committee had declared a lockdown from 03.05.2021 (05:00 am onwards) to 10.05.2021 (till 05:00 am) in the State of Haryana alongwith guidelines to be implemented during the period.

So as to contain the spread of Covid pandemic in the State, in exercise of the powers conferred under Section 22(2)(h) of the Disaster Management Act, 2005, the undersigned in my capacity as Chairperson, State Executive Committee hereby extend the restrictions imposed vide the above referred orders dated 02.05.2021 for another one week, i.e., from 10.05.2021 (05:00 am onwards) to 17.05.2021 (till 05:00 am) in the State of Haryana to be observed as 'Mahamari Alert-Surakshit Haryana' (महामारी अलर्ट-सुरक्षित हरियाणा).

Whereas, the followings additions/substitutions are hereby made in the guidelines dated 02.05.2021 referred to above:-


Addition at Sr. No. 2

d. Tree felling operations of Forest Department and Haryana Forest Development Corporation shall remain operational subject to the condition that they will be allowed only to the extent required for meeting the fuel wood requirements of Municipal Corporations and District Administration.

Substitution of Sr. No. 16 f. and g.

f. No gathering of more than 11 persons to be allowed, including for weddings, cremations/funerals.

g. Marriages will be allowed to be conducted only at home and Courts with a maximum limit of 11 persons (No movement of 'Barat' procession is allowed).
