NOTIFICATION

The Senate in its 39th meeting held online on 23.07.2020 vide agenda item no. S 39.04 approved modality of conduct of the academic activities including teaching and evaluation in online mode for odd semester of Academic Year 2020-2021 due to prevailing conditions of Covid-19 virus. The same was notified by the office of the Dean(Academic) vide letter ref. No. Acad./20/494 dated 10.08.2020. (Copy enclosed).

The Senate has also approved the Academic Calendar for odd semester of Academic Year 2020-2021 for all the UG/PG and Ph.D. programmes except 1st semester of B. Tech, M. Tech and MCA programmes. The same was notified vide letter ref. no. Acad./Cal/2020-21/453 dated 28.07.2020.

The Mid Semester Exam-I is scheduled from 28.09.2020 to 30.09.2020 and Mid Semester Exam-II is scheduled from 05.11.2020 to 07.11.2020 in the Academic Calendar.

As per point no 7 of the letter N.o. Acad./20/494, the Mid Semester Exam are to be conducted in online mode till the institute re-opens and the classes are held in regular mode. The faculty members are required to opt for Subjective/MCQ/Open Book/Quiz etc.

The HoDs of all teaching departments are kindly requested to plan Mid Semester Exam in online mode as per the schedule of Academic Calendar in consultation with all concerned. The faculty may also conduct Mid Semester Exam on other convenient dates in case of unprecedented situations. The concerned faculties are also requested to intimate the respective students (including re-appear students) regarding date and time of the Mid Semester Exam at least one week prior to conduct of the exam by email or any other available mode.

The cut list in respect of the students applied for Sessional Improvement Exam (Internal Re-appear) for odd semester courses will be sent by Academic Section in phased manner before conduct of the Mid Semester Exam-I & Mid Semester Exam-II.

The HoDs may also ensure conduct of Mid Semester Exam during this semester for 1st semester of B.Tech, M.Tech and MCA programmes according to respective Academic Calendars of these programmes notified or to be notified in due course of time. There will be no separate notification for conduct of Mid Semester Exam for all the academic programmes in this semester.

The HoDs of the teaching departments shall notify the sessional test schedule in consultation with the respective course Co-ordinator for the students having re-appear in the sessional of the courses which are currently not offered to the regular batches.
