The Board of Governors decided to nominate Er. Pawan Munjal, Managing Director, Hero Honda Motors Ltd., an alumnus of the Institute on the Board of Governors for a period of five years.

The Board of Governors noted that Ministry of Human Resource Development is yet to nominate (i) an Head of another Technical Institution in the region or an eminent Technologist and (ii) two representatives representing large, medium and small scale Industries.

Before the Board of Governors, National Institute of Technology, Kurukshetra started deliberations, Dr. N P Mehta, Director of the Institute welcomed the Hon'ble Chairman of the Board on behalf of the Institute, the Board and on his own behalf. He also welcomed members of the Board on behalf of the Institute as well as on his own behalf. Dr. N P Mehta also gave a detailed presentation regarding the Institute and its various activities.

The following decisions were taken:-

Item 1.1 To note the declaration made by the Govt. of India to make Regional Engineering College, Kurukshetra as the National Institute of Technology, Kurukshetra with Deemed to be University Status.

The Board noted that the Govt. of India, Ministry of Human Resource Development, Department of Secondary & Higher Education, New Delhi vide letter No. F.9-10/2002.U.3 dated 26.6.2002 on the advice of the

University Grants Commission in exercise of the powers conferred by Section 3 of the University Grants Commission Act 1956 declared the Regional Engineering College, Kurukshetra as National Institute of Technology, Kurukshetra with Deemed to be University Status w.e.f. 26.6.2002.

The Board also noted that the MOA/Rules framed by the Govt. of India for NIT, Kurukshetra have been approved by the BOG, REC, Kurukshetra and State Government of Haryana.

Item 1.2 To consider passing a resolution of vote of thanks to the Govt. of India, the State Government of Haryana and the existing members of Board of Governors, Regional Engineering College, Kurukshetra.

The Board noted constitution of the existing Board of REC, Kurukshetra. The Board also noted that the Institute is by now fully developed with enormous instructional, academic and research activities in various disciplines of Engineering & Technology. The Board further noted that the upgradation of REC, Kurukshetra to that of NIT, Kurukshetra with Deemed to be University Status is mainly due to the initiatives and sincere efforts made by the Hon'ble members of the existing Board from time to time, release of adequate and liberal funds by the Central Government and the State Government of Haryana and able guidance of the Hon'ble Chief Minister, Haryana who is also Chairman of the existing Board, Shri V S Pandey, IAS, Joint Secretary (T), Govt. of India, Ministry of Human Resource Development, Department of Secondary & Higher Education, Shastri Bhawan, New Delhi and Shri Dharam Vir, IAS, Financial Commissioner & Principal Secretary to Govt. of Haryana, Technical Education Department, Chandigarh.

The Board passed the following resolution of vote of thanks:-

The National Institute of Technology, Kurukshetra (formerly known as Regional Engineering College, Kurukshetra) expresses its heartiest gratitude and thankfulness to the Govt. of India, the State Government of Haryana and the distinguished members of Board of Governors, REC



Kurukshetra in running its administrative, financial and academic affairs smoothly. It is by virtue of their versatile ability, farsightedness, able guidance, sincere efforts and initiatives that this reputed Institute marched ahead with pace and has been upgraded to the National Institute of Technology, Kurukshetra with Deemed to be University Status.

The Institute owes a sense of indebtedness to Sh. Om Prakash Chautala, the Hon'ble Chief Minister, Haryana and Chairman of the existing Board of REC, Kurukshetra under whose kind patronage and dynamic leadership, this Institute thrived to its full potentiality.

The Board desired that above resolution of vote of thanks be communicated to the Govt. of India, the State Government of Haryana and all members of the existing Board of REC, Kurukshetra.

Item 1.3 To note constitution of the Board of Governors, National Institute of Technology, Kurukshetra.

The Board noted that as per Memorandum of Association and Rules framed by the Govt. of India, Ministry of Human Resource Development and approved by the Board of Governors of REC, Kurukshetra and the State Government of Haryana, the following is the constitution of the Board of Governors of National Institute of Technology, Kurukshetra:-

- (a) The Chairman: An Eminent Technologist/Engineer/Industrialist/Educationist to be nominated by the Central Government.
- (b) A nominee of the MHRD, Govt. of India.
- (c) A nominee of the Department of Technical Education, Government of Haryana.
- (d) An Head of another Technical Institution in the Region or an eminent technologist nominated by the Central Government.

- (e) The Director of Indian Institute of Technology in the region i.e. IIT, Delhi or his nominee.
- (f) A nominee of the UGC not below the rank of a Deputy Secretary.
- (g) A nominee of the AICTE not below the rank of an Advisor.
- (h) An alumnus of the Institute from amongst alumni in Education/ Industry to be nominated by the Board of Governors
- (i) Two representatives representing large, medium and small scale Industries to be nominated by the Central Government
- (j) One Professor and one Assistant Professor of the Institute by rotation.
- (k) The Director of the Institute ex officio Member Secretary.

The Board noted powers of the Board of Governors as furnished in the agenda item 1.3 and as contained in the MOA/Rules approved for the Institute. The Board also noted its working/functioning as per the MOA/Rules approved for the Institute.

The Board resolved that it will be empowered to approve panel of external experts for various Selection Committees. However, the existing panel of external experts already approved by the Board of Governors of REC, Kurukshetra will be operative till the new panel of experts is approved.

Item 1.4 To note the composition and aims/objects of the Society of National Institute of Technology, Kurukshetra.

The Board noted that as per existing MOA/Rules of REC, Kurukshetra, the members of the Society and the Board are the same. Accordingly, in the new set up of the NIT, Kurukshetra, the members of the Board will also be the members of the Society.

The Board noted the objects and functions of the Society as furnished in the agenda item and as contained in the new MOA/Rules approved for the Institute.

Item 1.5

To consider constitution of the Senate of the National Institute of Technology, Kurukshetra

The Board noted constitution of the Senate of the Institute as per MOA/Rules approved for the Institute. The Board also noted powers and working/functioning of the Senate as mentioned in the agenda item as per the MOA/Rules approved for the Institute.

However, Shri Dharam Vir, IAS, Financial Commissioner and Principal Secretary to Govt. of Haryana, Technical Education Department suggested that out of 9 persons required to be nominated by the Chairman of the Board on the Senate, at least 4/5 persons should be from Industries and remaining from the field of Technical Education. The Board authorized the Chairman of the Board to approve nominees on the Senate viz. three persons, not being employees of the Institute from amongst educationists of repute and six persons for their special knowledge.

The Board authorized the Chairman of the Senate to take decision in emergent cases.

The Board further decided that bye-laws pertaining to the Senate on the pattern of IIT be framed and put up to the Board in its next meeting for approval.

Item 1.6 To consider constitution of the Board of Studies of the Departments in the National Institute of Technology, Kurukshetra

The Board decided that there will be six Board of Studies for the following six Departments common for Undergraduate & Postgraduate Courses in the Institute:-

(i) Civil Engineering Department

(ii) Electrical Engineering Department

(iii) Mechanical Engineering Department

(iv) Electronics & Communication Engineering Department

(v) Computer Engineering Department

(vi) Applied Sciences & Humanities Department

The constitution of the Board of Studies of each Engineering Department in the faculty of Engineering & Technology is proposed as under:-

- (i) The Chairman of the Department will be Chairman of the BOS.
- (ii) All Professors of the Departments.
- (iii) Three Assistant Professors and three Lecturers from the Department to be nominated by the Director, NIT by rotation according to seniority for a period of three years.
- (iv) Two outside experts to be nominated by the Director, NIT from the panel recommended by the Chairman of the Department for a period of three years.

The constitution of the Board of Studies of the Applied Sciences & Humanities Department which comprises four Departments i.e. Physics, Chemistry, Mathematics and Humanities is proposed as under:-

- (i) The seniormost Professor amongst all Professors of the Applied Sciences & Humanities Department will be Chairman of the Board of Studies by rotation according to seniority for a period of three years.
- (ii) All Chairmen of the Applied Sciences & Humanities
 Departments.
- (iii) All Professors of the Applied Sciences & Humanities Department.
- (iv) Three Assistant Professors and three Lecturers from the Applied Sciences & Humanities Department to be nominated by the Director, NIT by rotation according to seniority for a period of three years.
- (v) Two outside experts to be nominated by the Director, NIT from the panel recommended by the Chairman of the Board of Studies for a period of three years.

The constitution of any Board of Studies may be changed/amended by the Director, if the need so arises. The number of outside experts on any BOS may be increased by the Senate.

However, Shri Dharam Vir, IAS, Financial Commissioner & Principal Secretary to Govt. of Haryana, Technical Education Department emphasized that there should be separate Board of Studies for each of the Departments of Physics, Chemistry, Mathematics and Humanities so that these Departments may be equally strengthened. The Board decided that suggestion of Shri Dharam Vir, IAS may be referred to the Senate for taking final decision and in the meantime the constitution of the Board of Studies as furnished in the agenda item will be operative.

The Board further approved following powers and functions of the Board of Studies as furnished in the agenda Item:-

- (i) To recommend the procedure for the conduct of Undergraduate/ Postgraduate examinations, courses of study and syllabi
- (ii) To recommend the panel of examiners of various subjects/various examinations.
- (iii) . To deal with any matter that may be referred to by the Senate.
- (iv) The Director of the Institute may delegate any other power & function to the Board of Studies as he deems fit.

Dr. R S Sirohi advised that matter regarding powers and functions of the Board of Studies may be referred to the Senate. Dr. Sirohi also advised that best academic practices of IITs should be followed in NIT, Kurukshetra too.



Item 1.7 To consider constitution of the Finance Committee, National Institute of Technology, Kurukshetra.

Courses keeping in view possibility to introduce two shifts of classes in the Institute be referred to the MHRD in pursuance of decisions taken in the meeting held on 27.7.2002 in the Ministry under Chairmanship of Shri V S Pandey, Joint Secretary (Tech.), Govt. of India, Ministry of Human Resource Development wherein it was decided that the Institutes may submit

their proposals regarding intake capacity in the existing courses in the month of December, 2002 for consideration for next session.

The Board noted that All India Council for Technical Education vide its letter No. F. No. 441/HAR-10/BOS (PG)/91 dated 29.8.2002 (copy enclosed) has already increased intake of regular Post-graduate Courses as proposed in the agenda item. Regarding introduction of part-time M.Tech. programmes proposed to be run on Saturdays & Sundays the Board decided that this proposal may also be referred to the MHRD in pursuance of decisions taken in the meeting held on 27.7.2002 in the Ministry under Chairmanship of Shri V S Pandey, Joint Secretary (Tech.), Govt. of India, Ministry of Human Resource Development wherein it was decided that the Institutes may submit their proposals regarding intake capacity in the existing courses in the month of December, 2002 for consideration for next session.

The Board also observed as under:-

- (a) Best academic practices of IITs should be adopted.
- (b) The rules regarding Undergraduate and Postgraduate programmes to be effective from 1st semester of the next academic year should be formulated.
- (c) The Institute should process and get the proposals of (b) above formulated and approved by the Senate and the Board on priority basis holding special meetings of Senate/Board.

The Chairman of the Board advised that recommendations of the High Power Committee on RECs for academic excellence should be kept in view.
