Item No.1.3 **To consider and approve the RRCE for Construction of Additional (200 seaters) New Girls Hostel instead of (120 Seaters) Girls Hostel in National Institute of Technology, Kurukshetra.**

Item No. 1.8 **To consider and approve the RRCE for extension Block of Guest House Building (Renovation of Existing Guest House Bldg.), National Institute of Technology, Kurukshetra.**

The Building & Works Committee suggested to rename this building, as "Multi purpose Social Welfare Centre" which will serve social causes including Women Welfare, Staff Club etc. Subject to the changed functional utility, the Building & Works Committee approved the architectural Drawings and estimate of Rs. 64.15 lacs for the construction of the Multi Purpose Social Welfare Centre.

Item No. 1.10 **To consider and approve the RRCE for provision of Special Repair of Hostel, Instructional Buildings and Residences, National Institute of Technology, Kurukshetra.**

The Building & Works Committee approved the revised rough cost estimate amounting to Rs 30.00 lacs for the provision of Special Repair of Hostel, Instructional Buildings and Residences, of NIT, Kurukshetra. Further, the Building & Works Committee keeping in view the deteriorating condition of the old buildings, suggested to prepare a consolidated package for the renovation of old buildings.

To consider and approve the RCE for Replacement of ACC sheets and provision of IRC fabrics in Workshop Block etc., NIT, Kurukshetra




