The Board examined the report of the committee as well as the CBI report in detail. The Board noted that the CBI in its report on page No. 28 had stated, 'no evidence has come forth to prove any quid-quo-pro between the accused public servants and the accused office bears of the Trustee. Thus there is lack of evidence to prove the allegations against the accused public servants i.e. Dr. H.K. Sharma'. Therefore, the Board partially agreed with the CBI advice and recommended initiating the minor penalty proceedings under Rule of 16 of the CCS (CCA) Rules, 1965. Therefore, the Board decided that Dr. H. K. Sharma be issued a charge sheet asking him to reply within 10 days. The Board authorized the Registrar of the Institute to sign the charge sheet. The matter be placed before the Board alongwith reply of Dr. H. K. Sharma.

36.6 To consider the Technical resignation of Dr. Sanjay Sharma.

The Board accepted the resignation of Dr. Sanjay Sharma from the services of NIT, Kurukshetra.

36.7 To re-consider the revision of pay scale of Head Mali as per orders dated 04.02.2015 of Hon'ble Punjab & Haryana High Court in CWP No.3289 of 1995 (O&M) filed by Sh. Morahi Lal , Head Mali (now retired).

In compliance of the orders dated 04.02.2015 of Hon'ble Punjab & Haryana High Court, Chandigarh in CWP No. 3289 of 1995 (O&M), the Board re-considered the case in detail and the earlier decision of the Board of Governors taken in its 81st meeting vide item No. 81.12 held on 17.02.1993 in which the case of Shri Morahi Lal, Head Mali for granting pay scale of Rs. 950-1400 was rejected on the recommendations of the Finance Committee at its 65th meeting held on 28.09.1992.

The Board noted that the Regional Engineering College, Kurukshetra had its own Service Bye Laws, Retirement, Gratuity and CPF Rules, Conduct & Disciplinary Rules and Non-Teaching Service Rules - 1984 and was

functioning under the administrative control of Technical Education Department, Government of Haryana. The Rules of Kurukshetra University, Kurukshetra and Haryana Agriculture University, Hisar based on which Shri Morahi Lal had represented for grant of pay scale of Rs. 950-1400 were not applicable in REC, Kurukshetra as REC, Kurukshetra had its own Rules for its employees. Therefore, his request was not accepted.

The Board also noted that Shri Morahi Lal, Head Mali had been granted the pay scale of Rs.950-1500 w.e.f. 01.05.1990 personal to him without change of his designation and nature of duties as per decision of the Board of Governors in its 77th meeting held on 23.02.1991 and 86th meeting held on 23.01.1996 which was communicated vide Notification No. GA-I/2675 dated 29.02.1996.

After discussion on the case, the Board re-iterated the earlier decisions taken in the 77th & 86th meetings of the Board of Governors of Regional Engineering College, Kurukshetra held on 23.02.1991 and 23.01.1996 respectively.

Further, the Board resolved that a speaking order be issued to Shri Morahi Lal, Head Mali (Retired).

36.8 To consider writing of Annual Confidential Reports of the employees of National Institute of Technology, Kurukshetra.

The Board authorized the Director to decide the Reporting / Review / Accepting Officers for writing the ACR of the employees. The Board observed that normally there should be two stages in writing the ACR, namely Reporting Officer and Reviewing Officer. However, in case there is much difference between the comments of the Reporting Officer and Reviewing Officer, there may be Accepting Officer for the ACR.

36.9 To consider fixation of minimum pay in the Pay Band-3 (Rs.15600-39100) with AGP of Rs. 7000/- in respect of Assistant Professor.

The NIT Kurukshetra recruited candidates having Ph. D. as Assistant Professors in the years 2012 and 2013 in PB-3 and AGP Rs. 7000 in accordance with the Model Recruitment Rules (MRR) received in the year 2012. The Institute also recruited candidates having M. Tech. qualification as Assistant Professors in PB-3 and AGP Rs. 6000 in accordance with the same MRR. The Assistant Professors in the AGP of Rs. 6000 who were M. Tech. were given two increments in the PB-3 in accordance with the MRR. The Assistant Professors in the Grade Pay of Rs. 7000 were not given any increment as nothing was mentioned in the MRR. Consequently, the pay in PB-3 of the Assistant Professors in AGP of Rs.7000 who were Ph.D. became less than the pay in the PB-3 of the Assistant Professors in the AGP of Rs.6000 with only M. Tech. qualification.

Therefore, the Assistant Professors in the AGP of Rs. 7000 requested for grant of 7 non-compounded increments in accordance with clause 2(a) of the MHRD letter F.No.23-1/2008-TS.II dated 18.8.2009. An agenda was placed in the 29th Finance Committee meeting of the Institute held on 04.06.2014. The Finance Committee discussed the matter and recommended to the Board. However the Finance Committee further advised that approval on the issue be obtained from the MHRD. Accordingly, a letter No. Estt.-I / 5391 dated 25.07.2014 was sent to the MHRD (Annexure - I).

The Institute again received representation from the Assistant Professors in AGP of Rs. 7000 requesting to grant 7 non-compounded increments in accordance with clause 2(a) of the MHRD letter. F.No.23-1/2008-TS.II dated 18.8.2009. The issue was again discussed in the 36th meeting of the Board of Governors held on 08.05.2009. The Board discussed the matter and noted that some NITs have fixed higher minimum pay in PB-3 in respect of the Assistant Professors recruited in PB-3 and AGP of Rs.7000 which creates frustration amongst the Assistant Professors with AGP of Rs.7000/recruited in NIT Kurukshetra. The Board requested the Director to write to MHRD to take up the issue for decision in the Council of NITs without waiting for confirmation of the minutes.

In view of the above decision of the BoG, the issue is being forwarded to you with the request to kindly examine the issue of grant of 7 non-compounded increments to the Assistant Professors (PB-3 & AGP Rs. 7000) possessing the degree of Ph. D. in the relevant discipline with clause 2(a) of the MHRD letter F.No.23-1/2008-TS.II dated 18.8.2009 and obtain the decision of the Council of NITs.

I shall be grateful for your early necessary action in the matter.

Sir,

The Institute recruited 85 Assistant Professors during 2012 and 2013 following the MRRs received vide MHRD letter No.F.33-7/2001-TS.III dated 14.03.2012 duly approved by the Board. The minimum qualification and experience requirements for faculty positions of NITs (under the standard 3 tier rigid faculty structure) have been prescribed in the MRRs.

The candidates recommended by the Selection Committee possessing the M.Tech qualification were appointed as Assistant Professor (on contract) in the PB-3 and AGP of Rs. 6000/- + 2 increments and those possessing the Ph.D qualification were appointed as Assistant Professor in the PB-3 and AGP of Rs. 7000/- (without any increment). In the MRRs it is mentioned that two advance increments shall be admissible at the time of recruitment for the post of Assistant Professor (on contract) with AGP of Rs. 6000/- having the essential qualification M.Tech whereas nothing is mentioned for the grant of any advance increment admissible at the time of recruitment in the case of Assistant Professor (on probation on a regular post) in the PB-3 and AGP of Rs. 7000/- having the essential qualification Ph.D.

The initial pay fixation of the Assistant Professors was as follows:

- (1) Assistant Professors (on contract) with Qualification of M.Tech
- PB-3 (Rs. 15600-39100) + AGP 6000/- + 2 increments=Rs. 15600/- + Rs. 1300/- (Two non-compounded increments) + AGP Rs. 6000/- = Rs. 22,900/-
- (2) Assistant Professors (on probation on a regular post) with Qualification of Ph.D
- PB-3 (Rs. 15600-39100) + AGP 7000/- (without any increment)
 Pay fixed at basic pay of Rs. 15600/-+AGP 7000/- = 22,600/-

The admissibility of advance increments at the time of recruitment for the post of Assistant Professor (on probation on a regular post) with AGP of Rs. 7000/-, is not mentioned in the Model Recruitment Rule. Therefore, the initial pay fixation for the post of Assistant Professor (on probation on a regular post) have been made at the minimum of the pay band-3 of Rs. 15600-39100+AGP 7000/- (without any increment) i.e. 15600+AGP 7000/-.

From the above comparison it comes out that the persons appointed as Assistant Professors (on contract) with M.Tech. qualification are getting more pay than the persons appointed as Assistant Professors (on probation on a regular post) with Ph.D. qualification.

The Institute has received representations from the Assistant Professors appointed on probation on a regular post in various Departments in PB-3+AGP 7000/-regarding the above pay anomalies. In these representations, they have mentioned that their initial pay may be fixed after allowing seven non-compounded advance increments as per Clause 2(a) of letter F.No.23-1/2008-TS.II dated 18.08.2009 issued by the MHRD, Government of India, quoted below.

"2(a) Seven non-compounded advance increments shall be admissible at the entry level of recruitment as Assistant Professor to persons possessing the degree of Ph.D awarded in the relevant discipline".

Therefore, to remove this pay anomaly the matter was placed before the Finance Committee in its 29th meeting held on 04.06.2014 for consideration and making suitable recommendations to the Board

The Board of Governors of the Institute in its 33rd meeting held on 04.06.2014 has decided as under:

"The Board decided that approval on the issue be obtained from the MHRD".

The Institute recruited 85 Assistant Professors during 2012 and 2013 following the MRRs received vide MHRD letter No.F.33-7/2001-TS III dated 14.03.2012 duly approved by the Board. The minimum qualification and experience requirements for faculty positions of NITs (under the standard 3 tier rigid faculty structure) have been prescribed in the MRRs.

The candidates recommended by the Selection Committee possessing the M.Tech qualification were appointed as Assistant Professor (on contract) in the PB-3 and AGP of Rs. 6000/- + 2 increments and those possessing the Ph.D qualification were appointed as Assistant Professor in the FB-3 and AGP of Rs. 7000/- (without any increment). In the MRRs it is mentioned that two advance increments shall be admissible at the time of recruitment for the post of Assistant Professor (on contract) with AGP of Rs. 6000/- having the essential qualification M.Tech. whereas nothing is mentioned for the grant of any advance increment admissible at the time of recruitment in the case of Assistant Professor (on probation on a regular post) in the PB-3 and AGP of Rs. 7000/- having the essential qualification Ph.D (copy enclosed as Annexure W on page 53) Subsequently, three persons appointed as Assistant Professor (on contract) in PB-3 and AGP Rs. 6000/with M.Tech. qualification completed their Ph.D degree after joining. Consequent upon their acquiring Ph.D. degree, they were regularized as Assistant Professor in PB-3 and AGP of Rs. 7000/- on probation w.e.f. the date of completion of Ph.D.

The initial pay fixation of the Assistant Professors was as follows:

- (1) Assistant Professors (on contract) with Qualification of M.Tech
- PB-3 (Rs. 15600-39100) + AGP 6000/- + 2 increments Rs. 15600+Rs. 1300 (Two non-compounded increments) +5000= Rs. 22,900/-
- (2) Assistant Professors (on probation on a regular post) with Qualification of Ph.D
- PB-3 (Rs. 15600-39100) + AGP 7000/- (without any increment)

The Institute has received representations from the Assistant Professors appointed on probation on a regular post in various Departments in PB-3+AGP : '000/- regarding the above pay anomalies. In these representations, they have mentioned that their initial pay may be fixed after allowing seven non-compounded advance increments as per Clause 2(a) of letter F.No.23-1/2008-TS.II dated 18.08.2009 issued by the MHRD, Government of India, quoted below (copy enclosed as Annexure X from page 54 to 58).

2(a) Seven non-compounded advance increments shall be admissible at the entry level of recruitment as Assistant Professor to persons possessing the degree of Ph.D awarded in the relevant discipline.

Further, they have also mentioned that other NITs (like NIT Goa and NIT Utterakhand etc.) are offering seven non-compound Ph.D increments to rewly appointed Assistant Professor (Regular) in PB-3 (Rs. 15600 39100 with AGP Rs. 7000/-). In this regard copy of the office order of NIT, Goa and Uttarakhand submitted by them is also enclosed as Annexure Y from page 59 to 61.

The matter is placed before the Finance Committee for consideration and making suitable recommendations to the Board.

Subject: Revision of pay of teaching and other Stalf in Centrally Funded Technical Institutions (CFTIs) following the pay revision of the Central Government employees on the recommendation of 6th Central Pay Commission (6th CPC).

Sir.

I im directed to say that the Government of India have decided, after taking into consideration the recommendations made by the Govardhan Mehta Committee, to revise the Pay of teaching and other staff of Centrally Funded Technical Institutions following the pay revision of the Central Government employees on the recommendation of 6th CPC. The revised pay and other service conditions as approved by the Government of India for the teaching and other staff in CFTIs are as under:

1. For Indian Institutes of Technology (IITs), Indian Institute of Science (IISc.) Bangalore, Indian Institutes of Management (IIMs), National Institute of Industrial Engineering (NITIE), Mumbal and Indian Institutes of Science Education & Research (IISERs).

(l) Lecturers

- (1) Lecturers are not part of the regular faculty cadre in these institutes. Appointment at this level may be made as Lecturer-cum-Post Doctorul Fellow on contract basis to enable bright young Ph.Ds to teach and earn experience in premier institutions.
- (2) At the entry level they may be placed in Pay Band PB-3 of Rs.15600-39100 with Act demic Grade Pay (AGP) of Rs.6000/-p.m. with seven non-compounded advance increments.
- (3) To encourage fresh PhDs to join the teaching system, at least 10% of the total faculty strength should be recruited at this level of Lecturer-cum-Post. Doctoral Fel ow. However, relaxation in respect of educational qualifications could be given up to 25% of total Lecturers recruited. The reasons for such relaxations should be duly recorded and reported to the Board of Covernors of the respective institutions.
- (4) Af er one year of post Ph.D experience, these Lecturers-cum-Post Doctoral Fellows shall be placed in the AGP of Rs.7000/-p.m.

(ii) Assistant Professors

- (1) To be appointed in PBB will AGP of Rs. 8000/p.m. For direct recruits, minimum pay light Pay Band to be fixed at Rs. 30000/.
- (2) For appoir unent as Assistant Professor, and should have a Ph.D. with first class or equivalent in the apprepriate branch with a very good academic record throughout and at least three years' industrializes careful eaching experience, excluding however, the experience gained will be musualing Ph.D.

(iii) Associate Professorx

- (I) To be appointed in IB-4 (Rs. 17410-67000) with AGP of Rs. 95001-p.m. For direct results minimum pay in the IB-4 to be liked at Rs. 428001-.
- (2) For appointment as Associate Prolossor, one slight have a Ph.D with direct class or equivalent in the appropriate bringh wills at very good, academic record throughout and a minimum of also years Teaching/ Industry/Research experience, of which at least three years' should be at the level of Assistant Professors, Senior Scientific Officer Senior Design Engineer.

(iv) Professors

- (1) To be appointed in RB-4 (Rs.47400.67400), will ACP of Rs.10500/- p.m. For direct retruits, minimum, pay inche pay Band to be fixed at Rs. 48000/-
- (2) For appointment as Professor, one should have a PhiD with first class or equivalent with a very good academic record and a minimum of 10 years experience.
- (3) Up to a maximum of ADVs of the posts of Africassors at any given point of time will be allyible for AGP of As. 120001-p.m. after 6 years of regular service in AGP of As. 195001-p.m. subject to performance evaluation based on rescarch publications. Phil supervision, tenching and ounsultancy services are.
- 2. For other Contrally Bundell Technical Institutious.

The pay structure and designations for all other Contrally Funded Technical Institutions will generally be the same as per the selecte of revision of pay of teachers, etc in Universities, etc, as notified by the Ministry of HRI2 vide letter No.1-32/2006-U.II/U:1 (i) dated Itst December, 2008 and darkfirstion ssued thereon from time to time. However, in the case of National Institutes of Technology (NITS), Indian School of Mines University (ISMU), Indian Institutes of Information Technology (IIITS) and Schools of Planning & Architecture (SPAs), the following accelerated promotional benefits will be given while maintaining the UGC Pay Structure and designations;

(a) Seven non-compounded advance increments shall be admissible at the entry I wall of recipitment as Assistant Professor to persons possessing the degree of the D awarded in the relevant discipline.

- (b) (i) An Assistant Professor possessing the degree of Ph.D in the re discipline and with regular service of 3 years' at AGP of Rs. p.m. shall be eligible for moving to AGP of Rs. 1000/-p.m.
 - (ii) An Assistant Professor possessing the degree of Ph.D in the re discipline and with regular service of 3 years' at AGP of Rs. p.m. shall be eligible for moving to AGP of Rs. 8000/- p.m.
 - (iii) An Assistant Profuser possessing the degree of Ph.D in the re discipline and with regular service of 3 years' at ACIP of Rs.; p.m. shall be eligible for moving to ACP of Rs.9000/- p.m., a designated as Associate Professor.
 - (c). Associate Professor completing 4 years' of regular service in the Adas, 9000/- and possessing a Ph.D degree in the relevant discipline sheligible to be appointed and designated as Professor, subject to conditions of academic performance as laid down by the UGC and I university, if any. No teacher other than those with a Ph.D shall be promappointed or designated as Professor. The Pay Band for the post of Professor and be Rs.37400-67000 with AGP of Rs.10000/- p.m.
 - (d) Jp to a maximum of 20% of the sanctioned post of Professors shall be a n PB-4 in the AGP of Rs.12000/- p.m. after regular service of 6 year rofessor in the AGP of Rs 10000 and the minimum pay in the Pay Ban be lixed at Rs.48000/- p.m. Other eligibility conditions will be as laid by the UCC.
 - (e) All promotions will be based on performance evaluation and subjet infillment of other conditions laid down by MIIRD letter No.1-32/ J.II/U.I (i) dated 31st December, 2008.
- 3. Existing faculty of IIITs and ISMU, Dhanbad shall be given the replacementating proposed for IITs, as personal to them. Revised pay, as given in Para 2 above applicable for those recruited on or after the date of issue of these orders.
- 4. Directors: As regards the Directors of the Centrally Funded Tecl Institutions (CFIIs), it was decided to follow a two-tier structure as in the cafaculty positions, as under:-
 - (a) For Directors of HTs, HMs, HSc Bangalore, HSERs, NITTE, Mumbai, a pay of Rs.80,000/- p.m.
 - (b) For Directors of NITs, IITs, ISMU, Dhanbad, NIFFT, Ranchi, SPAs, S. NERIST, CIT, NITTTRs, pay of Rs.75,000 plus Special Allowan R: .5000/- p.m, as applicable to Vice Chancellors of Universities.
- 5. Cac re of Librarians and Directors of Physical Education will be give revised pay and other benefits as notified vide MHRD letter No. 1-32/2006-U.II/1 dated 31st December, 2008. The qualifications and the age of superannuation (60) will remain unchanged.

- 6. The revised pay of Scientific Officers/Design Staff shall be mapped into the normal replacement pay of 6th CPC. However, if the Scientific Officers / Design Saff are doing teaching work, their revised pay as approved for the teaching staff shall be applicable.
- 7. Faculty Structure: The flexible faculty structure will continue in those institutions where it is already in operation. However, institutions like ISMU/III is which were earlier under the IIT pay structure will have the same faculty structure as in UGC scheme except for the accelerated promotions as provided under Para 2 above. The Ministry of H man Resource Development (MHRD) will devise suitable academic criteria for those institutions which may like to change over to a four-tier flexible faculty structure.

8. Other service conditions:

- (i) Annual increment will be at the tate of 3% of the pay as per the CCS (RP) Rules, 2008 (pay in the pay band plus applicable AGP).
- (ii) Pay in the pay hand and Academic Grade Pay shall not exceed the limits set in the CCS (RP) Rules, 2008 i.e. Rs.80000/-.
- (iii) A currulative Professional Development Allowance for Rs.3 lakhs for every block period of 3 years (Rs. One lakh per year) may be made available to every member of the faculty on reimbursable basis to meet the expenses for participating in both national and international conferences, paying the membership fee of various professional bodies and contingent expenses.
- (iv) Revisec pay scales will be effective from 1.1.2006 and other allowances from 1.9.2001 and pay of existing incumbents will be fixed as per the formula given in the CCS (RP) Rules 2008 and the Fixation Table given in Annex-I of Ministry of Finance OM No.1/1/2008-IC dated 30th August 2008. This is further subject to the proviso that the revised pay of existing incumbents as on 1.1.2006 will not be less than the minimum pay at the entry level for direct recruits an each category in the case of HTs, HMs, HSc, HSFRs and NITTE. This would effectively mean that:
 - a) Assistant Professors in the pre-revised scale of Rs. 12.000 Rs. 18.300 with basic pay ranging from Rs. 12.000/- to Rs. 15.780/- p.m. will be placed at the minit rum of Rs. 30,000/- p.m. For those incumbents with pre-revised basic pay of more than Rs. 15780/-, their revised pay will be determined by multiplying the existing pay as on 1.1.2006 by a factor of 1.86 and rounding off the multiple figure to the next multiple of 10 as given in Rule 7 (1)(a)(i) of the CCS (RP) Rules. 2008.
 - b) In the case of Associate Professors in the pre-revised scale of Rs.16.400 Rs.20.000 with basic pay ranging from Rs.16.400/- to Rs.18.200/- p.m., the minimum will be fixed at Rs.42.800. For those incumbents with pre-revised pay of more than Rs.18200/-, the revised pay will be as per Fixation Table corresponding to pre-revised pay scale of S-26 as given in Annexure-I of Minist y of Finance's O.M.No.1/12008-IC dated 30th August. 2008.

- c) In the case of frofessors in the pre-revised scale of Rs.18400-22400 with basic pay ranging from Rs.18400 to Rs.20400 p.m. will be placed at the minimum of Rs.48000/-. For those incumbents with pre-revised pay of more than Rs.20400/-, the revised pay will be us per Fixation Table corresponding to pre-revised pay scale of S-29 as given in Annexure-1 of Ministry of Finance's O.M.No.1/1/2008-IC dated 30th August, 2008.
- (v) In respect of other categories of institutions, pay fixation will be made as per CCS (RP) Rules, 2008 and the Fitment table issued by MHRD for UGC funded institutions vide letter No.3-1/2009-UH dated 4th June, 2009, which is available on he web-site-of MHRD.
- 9. For Registrars, Dy. Registrar, Assit. Registrar. UGC pay scales will apply to Registrar, Dy Registrars, Assistant Registrars of IFE. USERs, NITs, USe and Deemed to be Universities subject to they possessing the qualifications and experience as prescribed by UGC from time to time. For others, normal replacement scale as per CCS (RP) Rules, 2008 will apply. Age of superannuation will, however, continue to be 60 years.
- 10. Anomalies, if any, in the implementation of this order may be brought to the notice of the Department of Higher Education, Ministry of Human Resource Developmen...

This workshop was participated by students and faculty members of the Institute. In addition, the faculty members from other NITs in the region also attended the workshop.

As an outcome of the workshop, the expert panel recommended establishment of a 'Centre for Skill Development' in the Institute for periodically conducting the skill development activities for the students of the Institute as well as for the students of nearby institutions and also reach out to the youth in the society. The summary of the recommendations of the workshop is enclosed (Annexure - 37.4.i from pages 42 to 45).

After considering the recommendations of the skill development workshop, the Director constituted a committee vide letter No.R/108/1939 dated 28.05.2015 to identify a suitable faculty member who

can be entrusted the task of establishing a 'Centre for Skill Development' in the Institute. Copy of the letter is enclosed (Annexure - 37.4.ii on page 46).

The committee has recommended as below:

- a) The Coordinator will report to the Director and will carry out all the required functions to establish and run the Centre.
- b) The Coordinator will be entitled for Professor's grade accommodation in the NIT campus.
- c) The Coordinator will be responsible to carry out following activities:
 - Identification of the skill training needs of the students / faculty / staff and conducting relevant programs in consultation with National / State level agencies.
 - ii. Coordinating with National Skill Development Agency.
 - iii. Any other activity assigned by the Director
- 5. The BoG may consider allocating a grant of Rs.5.00 lacs / annum initially to meet the working expenses of the Centre.

REPORT ON THE WORKSHOP ON SKILL DEVELOPMENT HELD ON JANUARY 9, 2015

Introduction

India is among the youngest nations on the globe as 54 per cent of the country's population is under 25 years of age. This 'Demographic Dividend' can transform the nation if we succeed in tapping the implicit potential. Otherwise, the writing is on the wall: it is a 'Demographic Dynamite' waiting to explode! The one crucial factor that would determine whether we seize this moment in history as our own or fritter it away is how we deal with the education of the youth and convert them from mere population to human resource. Initiatives on education will have to address both access and quality. The complexity of issues in the face of a large population cannot be underestimated. However, this is a challenge that has to be taken up if India is to derive benefit from the opportunity its unique demography offers.

The 'Make in India' and 'Skill India' initiatives of the Government of India are directed at taking up the above challenge. These two initiatives are complementary to each other and, to a considerable extent, would determine the future of this country. 'Skill India' is aimed at equipping the youth with the necessary skills that would make them productive and hence earn them a living and be able to contribute to the overall development of the country.

- Recognizing this need, the Government of India has adopted "Skill Development" as a national priority over the next 10 years.
- A detailed road-map has been chalked out and initiatives to provide an institutional base for "Skill Development" are under way.
- Four categories of "Skill Development" have been identified:
 - 1. Skills for fresh entrants to the job market
 - 2. Re-skilling or skill up-gradation of those already engaged in a job
 - 3. Recognition & certification of skills acquired through informal means.
 - 4. Skill acquired through formal education courses (Diploma/Degree and above)
- As an engineering institution of higher learning, NIT Kurukshetra and other NITs represented here come under the fourth category.

- In view of the government's initiatives on skill development, we need to frame a skill development-centered engineering education, the outcome of which will be an engineer who has the necessary knowledge, the skills and the competencies to successfully handle a job.
- The engineering curriculum should equip a student with soft skills in addition to technical skills.

Recommendation

As a contribution to the national skill development initiative, a Centre for Skill Development be established in the Institute which could cater to the requirements of the Institute as well as other institutions and also reach out to the youth in the society who are unable to be part of the formal education system.

Dr. A. Sivathanu Pillai, former Distinguished Scientist & Chief Controller (R&D), DRDO & former CEO & MD, BrahMos Aerospace, New Delhi, was appointed as Chairperson, Board of Governors, NIT Kurukshetra, by the Hon'ble President of India, in her capacity as the Visitor of the National Institute of Technology (NITs), for a period of three years w.e.f. 08.06.2012 i.e. the date of nomination by the Hon'ble Visitor.

Under the esteemed guidance and leadership of Dr. Pillai, the Institute made remarkable progress in academic development, additional recruitment / promotion of faculty members, and infrastructure. With his visionary thoughts, four interdisciplinary schools of PG and Research *viz*, School of Renewable Energy and Efficiency, School of VLSI Design and Embedded Systems, School of Nanotechnology and School of Bio-Medical Engineering were established. In addition, the institute has recently planned to start Two new M. Tech. programs – M. Tech. in Molecular Engineering and M. Tech. in Cyber Security. The Comprehensive Audit of the Institute by the Departmental Visiting Committee has been completed. The External Review Committee for the external review of the Institute has been approved by the BoG and proposed for approval by the Standing Committee of the Council of NITs. The facilities of the Health Center of the institute have been upgraded, security system of the institute has been reviewed and upgraded for effective

surveillance and monitoring. Construction of 600 capacity new girls' hostel is at advanced stage and foundation stone of 300 capacity multipurpose hostel has been laid. Six storied building for the four Schools along with additional class rooms and faculty chamber has been approved the BoG for which the construction will start shortly. Two new Gates of the Institute have been constructed which have given more visibility and identity to the Institute.

The Board may record appreciation for Hon'ble Dr. A. Sivathanu Pillai for his valued guidance, leadership and mentorship to the Institute as well as for his outstanding contributions as Chairperson, Board of Governors, NIT Kurukshetra.

Item 37.6 To consider amendment to House Allotment Rules

The House Allotment Committee met on 04.06.2015 and recommended following amendment to the House Allotment Rules (Annexure-37.6.i on page 52).

In the amended House Allotment Rules, faculty (or officers) drawing different grade pay have been considered eligible for a given category of houses. For example for DBU, DBL, DA and AD (B) houses, the faculty (or officers) of Grade Pay of Rs. 6000/- (or 5400/- PB-III) & 7000/- (or 6600/-) both are eligible. Similarly for C & AD(A) type houses, the faculty (or officers) having grade pay of Rs. 8000/- (or 7600/-) and Rs. 9000/- (or 8700/-) both are eligible and also for DBU type houses, pool officers, Research Associates/Research Fellows and faculty (or officers) having Grade Pay of Rs. 6000/- (or 5400/- in PB-III) are eligible. This has led to a situation where a faculty (or officer) with a lower grade pay is allotted the requested house while a faculty (or officer) drawing higher grade pay is deprived of the same.

In view of above, it is proposed that for a given category of houses, faculty (or officers) having higher grade pay be considered senior to the faculty (or officers) having lower grade pay. For this the faculty (or officers) in grade pay of Rs. 6000/-will be at par in grade pay Rs. 5400/- (PB-III), 7000/- at par in grade pay Rs. 6600/-, 8000/- at par in grade pay Rs. 7600/- and 9000/- at par in grade pay Rs. 8700/-. The seniority of faculty (or officers) drawing same grade pay may be determined on the basis of length of service in that grade pay.

The matter is placed before the Board of Governors for consideration and approval.

The proposed amendment to the House Allotment Rules is placed before the Board for consideration and approval.

Item To consider amendment to House Allotment Rules

In the amended House Allotment Rules, faculty (or officers) drawing different grade pay have been considered eligible for a given category of houses. For example for DBU, DBL, DA and AD (B) houses, the faculty (or officers) of Grade Pay of Rs. 6000/- (or 5400/- PB-III) & 7000/- (or 6600/-) both are eligible. Similarly for C & AD(A) type houses, the faculty (or officers) having grade pay of Rs. 8000/- (or 7600/-) and Rs. 9000/- (or 8700/-) both are eligible and also for DBU type houses, pool officers, Research Associates/Research Fellows and faculty (or officers) having Grade Pay of Rs. 6000/- (or 5400/- in PB-III) are eligible. This has led to a situation where a faculty (or officer) with a lower grade pay is allotted the requested house while a faculty (or officer) drawing higher grade pay is deprived of the same.

In view of above, it is proposed that for a given category of houses, faculty (or officers) having higher grade pay be considered senior to the faculty (or officers) having lower grade pay. For this the faculty (or officers) in grade pay of Rs. 6000/- will be at par in grade pay Rs. 5400/- (PB-III), 7000/- at par in grade pay Rs. 6600/-, 8000/- at par in grade pay Rs. 7600/- and 9000/- at par in grade pay Rs. 8700/-. The seniority of faculty (or officers) drawing same grade pay may be determined on the basis of length of service in that grade pay.

The matter is placed before the Board of Governors for consideration and approval.
