

The issue need not to be placed in the next BOG meeting.

Instead, clarifications may be required to be sought from AICTE/MHRD on the following points before CAS is implemented.

- (i) Whether the existing ratio of Professor: Asstt. Professor: Lecturer :: 1:2:4 is to be retained after CAS is implemented.
- (ii) Whether the CAS promotees will continue to share the teaching load for the post from which they are promoted or that they will share the load of a promoted post. In the latter case who will share the left out teaching load.
- (iii) How the salary of CAS promotee is to be fixed (current/ retrospectively). At any stage a person junior in rank/status and drawing less salary at present can not draw more salary than the person who is already senior to the CAS promotee and already holding that rank.
- (iv) Most of the candidates applying under CAS might have applied earlier for these posts within the Institute and outside the Institute a number of times and might not have been found suitable for the posts and therefore whether this is to be left to the candidates to decide the date upto which their achievements are to be evaluated by screening committee. If this time found suitable whether their date of promotion will be the date decided by MHRD or the date of approval of BOG, NIT. Kurukshetra.

has to be made from the post of Assistant Professor after 8 years of service as Assistant Professor.

However, as per clarification furnished by the AICTE in the same letter of 10.9.2003, the experience of Selection Grade Lecturer is to be considered equivalent to that of Assistant Professor after acquiring the Ph.D. A clarification should be sought whether period of service as Selection Grade Lecturer prior to acquiring Ph.D. is to be considered equivalent to that of Assistant Professor.

- (iii) As per clarifications issued by the Govt. of India, MHRD vide their letter F.No. 37-104/95-TS-II dated 14.6.1999, the benefits of the CAS be allowed w.e.f. 9.10.1998 or from the date of eligibility for promotion under the CAS whichever is later.
- (iv) The Board decided to adhere to the clarifications in all other matters as per clarifications furnished by the AICTE vide its letter No. FD/PSSC/Clarif./2003/1 dated 10.9.2003.
- (v) The clarifications issued by the AICTE vide its letter No. FD/PSSC/Clarif/2003/1 dated 19.9.2003 under sub paras (ii), (iii) and (iv) may also be adhered to.
- (vi) As per instructions contained in the Govt. of India, MHRD, New Delhi letter No. F.20-18/2003-TS.III dated 15.9.2003, the promotion under CAS shall be effective after approval of recommendations of the Selection Committee by the BOG of the Institute.

Shri V S Pandey, IAS, Joint Secretary (T), Govt. of India, Ministry of Human Resource Development, Department of Secondary & Higher Education, New Delhi, Dr. R.S. Sirohi, Director, IIT, New Delhi, Dr. N K Jain, Joint Secretary, University Grants Commission, New Delhi Dr. K. Subramanian, Adviser-I, AICTE, New Delhi and Er. Pawan Munjal, Managing Director, Hero Honda Motors Ltd., New Delhi could not attend the meeting.

The Board of Governors welcomed Dr. S N Mahendra, new Director of the Institute before deliberations took place. The Board expressed its thanks

to Dr. N P Mehta for his services rendered as Principal/Director of the Institute for more than 5½ years. The Board desired that its feelings be communicated to Dr. N P Mehta by the Director and Member-Secretary.

On behalf of the Institute, on behalf of the Board and on his own behalf, Dr. S N Mahendra extended warm welcome to Prof. B L Dhoopar, Hon'ble Chairman of the Board. Then the Director apprised the Board about some of the initiatives taken by him after assuming the charge as the Director i.e. early completion/handing over of the construction works, automation of the process starting from the admissions of the students till declaration of their results, updating the Institute Website and preparation for the Convocation likely to be held in January, 2003.

Prof. B L Dhoopar, Chairman of the Board observed as under:-

- (i) The decisions already taken by the Board on academic issues should be taken up for implementation on priority basis.
- (ii) A booklet of the new service conditions for the employees mentioning all rules, bye-laws and academic calendar etc. be prepared and placed before the Board in its next meeting.
- (iii) Although a year and half have passed but the Board of the Institute has not been fully constituted. Three members i.e.
 (a) a Head of another Technical Institution in the region or an eminent technologist and (b) two representatives representing large, medium and small scale industries have not so far been nominated for which the matter may be taken up with the MHRD on priority basis.

Shri Dharam Vir, IAS, Financial Commissioner & Principal Secretary to Govt. of Haryana, Technical Education Department observed as under:-

6. My

(i) Although sufficient time has elapsed after the Institute became NIT but there are no substantial changes in the academic qualities.

- (ii) The existing system is not changing on IIT pattern. For example, the Senate of the Institute has not reviewed Syllabi and flexibility in the B.Tech. programmes on IIT pattern.
- (iii) The Institute should work hard to achieve parity with an IIT.
- (iv) For deficient students, some courses should be run during summer vacations so as to help them to graduate at the earliest (beyond minimum prescribed duration).
- (v) The Institute should be allowed to appoint a retired Professor from some IIT or a Technical Institute of repute, having expertise in framing academic rules for the Institute comparable to an IIT and the Professor so engaged should be allowed liberal remuneration for the job.

The Board took the following decisions:-

Item 4.1 To note assumption of charge as Director, National Institute of Technology (Deemed University), Kurukshetra by Dr. S N Mahendra, Professor, Electrical Engineering Department, Banaras <u>Hindu University, Varansi in place of Dr.N P Mehta</u>.

The Board of Governors noted that Dr. S N Mahendra, Professor, Electrical Engineering Department, Banaras Hindu University, Varansi has assumed the charge as Director of NIT, Kurukshetra w.e.f. 11.11.2003 (FN).

Item 4.2 To confirm the minutes of the 3rd meeting of the Board of Governors held on 6.10.2003.

While considering confirmation of the minutes of the 3rd meeting held on 6.10.2003 the Board noted that Dr. Vinay Kumar, Ex-Professor of the Mechanical Engineering Department was allowed EOL (without pay) w.e.f. 31.3.1999 to 31.3.2003 by the Board in its 2nd meeting held on 19.4.2003 but inadvertently the above period was indicated as 31.3.1999 to 26.3.2002 while recording decision on the BOG agenda item 3.18 considered by the Board in its

3rd meeting held on 6.10.2003. The Board desired that the required correction may accordingly be made.

The Board considered comments sent by Dr. R S Sirohi, Director, IIT, Delhi vide his letter dated 2.11.2003 and desired that a proposal on the issue raised by Dr. R S Sirohi should be placed before the Board by the Institute in its next meeting for formulating a rule on the issue.

While considering the agenda item 3.6 the Director and Member-Secretary intimated the Board that the Senate of the Institute in its 2nd meeting held on 29.11.2003 constituted a Committee under Chairmanship of Dr. C V Ramakrishnan, Professor of Applied Mechanics, IIT, New Delhi to consider the issues contained in the BOG agenda item 3.6 from Sr. No. (a) to (e) and the Senate has requested the Committee to finalize its report at the earliest possible. The Director and Member-Secretary also intimated that matter regarding review of specialization of various M.Tech. programmes as decided by the BOG on the agenda item 3.19 will be considered by the Senate in its next meeting after it is thoroughly discussed in the Departments. The Board desired that a system should be evolved in the Institute which may ensure that decisions on the academic matters are taken without delay.

Item 4.3 To note the action taken on the minutes of the 3rd meeting of the Board of Governors of National Institute <u>of Technology, Kurukshetra held on 6.10.2003.</u>

The Board noted action taken/being taken by the Institute on the minutes of the 3rd meeting of the Board held on 6.10.2003 as mentioned in the agenda item 4.3.

Item 4.4 To consider terms & conditions of deputation of Dr. S N Mahendra who joined as Director, NIT, <u>Kurukshetra</u>.

The Board decided to approve terms & conditions of deputation/ foreign service of Dr. S N Mahendra who has joined as Director of the Institute as contained in BHU, Varansi letter No. AB/15-P-92(L)/23027 dated 9.10.2003

Item 4.5 To consider & ratify minutes of 2nd meeting of the Finance Committee, National Institute of Technology, <u>Kurukshetra held on 10.9.2003.</u>

The Board ratified minutes of 2nd meeting of the Finance Committee held on 10.9.2003 as per details furnished in the agenda item 4.5. However, the Board observed as under on the Finance Committee items 2.7 and 2.8:-

- (i) The registration of the students should be introduced and the fee from the students should be realized for the whole semester at the beginning before the registration. The issue should also be discussed in the Senate.
- (ii) The Institute may try to find out some alternative for having its own Guest House in Delhi/New Delhi.

The Board desired that while discussing financial matters the Finance Committee should specifically mention as to which items are required to be got ratified from the Board.

Item 4.6To note grant of Non-Productivity Linked Bonus(Adhoc Bonus) to non-teaching employees of the
Institute for the year 2002-2003 on the pattern
of Central Government.

The Board noted action taken by the Institute in granting Non-Productivity Linked Bonus to the non-teaching employees of the Institute for the year 2002-03 on the Central Government pattern as mentioned in the agenda item 4.6.

The Board desired that in view of adoption of the service conditions of the employees on the Central Government pattern, delegation of powers to

Item 4.8To note action taken by the Director in granting
interest-free Festival Advance during the financial year
2003-04 to Class-III & IV employees of the Institute.

The Board noted action taken by the Director in granting interest free Festival Advance during the financial year 2003-04 to all Class-III & IV employees of the Institute as per past practice as mentioned in the agenda item 4.8.

The Board, however, desired that in future instructions of the Central Government in this regard have to be followed.

Item 4.9 To note action taken by the Director in nominating one Professor and one Assistant Professor of the National Institute of Technology, Kurukshetra to serve on its Board of Governors.

The Board noted action taken by the Director in nominating Dr. R K Arora and Dr. V K Aggarwal for a period of one year w.e.f. 1.9.2003 to 31.8.2004 as mentioned in the agenda item 4.9.

Item 4.10To note the enhancement of uniform/washing

The Board desired that instructions of the Central Government in this regard be followed w.e.f. 1.1.2004.

Item 4.11 To approve Annual Report and Audit Report of the Institute for the year 2002-2003.

The Board felt satisfaction over timely preparation of Annual Report, Audit Report and Annual Accounts of the Institute for the year 2002-03 and congratulated the Institute for the same.

The Board, however, made the following observations:-

- There are certain jobs which should be phased out to contain man power.
- (ii) The Annual Report displays dismal picture regarding publications carried out and conferences attended by the faculty members of the Institute
- (iii) The number of students who were awarded Ph.D degrees during 2002-03 and those presently registered for Ph.D. programmes is not at all satisfactory.
- (iv) There are several B.Tech. students who did not pass out in time and they took years together to do so.
- (v) The Institute should take timely steps to make admissions so that best students are admitted to the M.Tech. programmes.
- (vi) The efforts should be made to register maximum number of students for various Ph.D programmes.
- (vii) All Ph.D. students of the Institute, presently registered with Kurukshetra University, Kurukshetra should be registered in the Institute by getting the registration transferred.
- (viii) The Self-appraisal Reports of the faculty members should highlight their publications in referred journals and those presented in conferences.

(ix) The issues mentioned at Sr. No. (ii) to (vii) above should be considered by the Senate at length.

After detailed discussion the Board approved Annual Report and Audit Report of the Institute for the year 2002-03 for onward submission to Govt. of India, MHRD/Parliament and the revised format of the Annual Report for future preparation of the Annual Reports as enclosed with the agenda item 4.11. As requested by the Director and Member-Secretary the Board agreed to furnish additional information under para 11.1 (page 51) of the Annual Report as placed on the table.

Item 4.12 To consider and adopt the service conditions of the employees of Regional Engineering College, Kurukshetra upon their conversion as National Institute of <u>Technology, Kurukshetra with Deemed University Status.</u>

The Board noted that the Govt. of India, MHRD, Department of Secondary & Higher Education, New Delhi vide their office memo No. F.20-46/2003-TS.III dated 9.11.2003 and office memo No. F.20-11/2003-TS.III dated 12.11.2003 issued certain instructions concerning service conditions for the employees of all NITs so as to ensure uniformity in rules & regulations governing service conditions of the employees in NITs as indicated below:-

The Board further noted that above service conditions will be effective after their necessary adoption by BOG of the respective NITs.

The Board decided to adopt the service conditions mentioned at sr. no. 1 to 11 above in terms of the Govt. of India instructions contained in their letter dated 9.11.2003 under reference w.e.f. 1.1.2004.

The Board further decided to authorize the Director, on advice of the Institute Sr. Medical Officer, to refer employees of the Institute and their family members for special treatment in the Govt. as well as private hospitals as approved by the Central Government from time to time and to allow them reimbursement on the Central Government pattern.

As regards decision taken by the Govt. of India vide their office memo No. F.20-11/2003-TS.III dated 12.11.2003 to allow the non-teaching staff of all NITs to serve up to the age of 60 years subject to their going through screening at the age of 58 years, the Board deferred the issue and desired that it may be put up in the next BOG meeting.

As regards Career Advancement Scheme (CAS), the Board referred to the agenda item 4.19.

Item 4.13 To consider retention of accommodation of the Institute by Dr. Vinay Kumar, Ex - Professor of the Mechanical Engineering Department after retirement and withholding his final settlement of accounts by the Institute.

The Board authorized the Director to take suitable steps to take possession of the house unauthorizedly occupied by Dr. Vinay Kumar, Ex-Professor of the Mechanical Engineering Department at the earliest by constituting a Committee at the Institute level taking into account all legal aspects.

Item 4.14 To note constitution of one member Committee to find out the facts regarding final settlement of <u>Miss Indu Nalwa, Ex- Lecturer, Humanities Department.</u>

The Board noted that one member Committee of Dr. M P Kapoor, Director, Thapar Centre for Industrial Research & Development, Patiala has been constituted to find out the facts regarding final settlement of accounts of Miss Indu Nalwa, Ex-Lecturer, Humanities Department as per decision of the Board taken in its 3rd meeting held on 6.10.2003.

Item 4.15 To consider the panel of External Experts in <u>various subjects.</u>

The Board authorized the Chairman of the Board to take decision in finalizing the panel of external experts in various subjects. The Board, however, desired that the following guidelines may be taken into consideration while finalizing the panel of external experts:-

- (i) The experts should be from top class Institute.
- (ii) Experts from private Institutions and retired persons may not be included except outstanding persons.
- (iii) The guides of the existing staff doing Ph.D should be avoided.
- (iv) Adopt the same format for preparing panel of experts by different departments.

Item 4.16 To consider furnishing the Director's residence and two Nos. residences for visiting faculty members at National <u>Institute of Technology, Kurukshetra.</u>

The Board approved semi-furnishing of two residences for visiting faculty and the Director's residence as per details furnished in the agenda item 4.16. The residence of the Director be semi-furnished taking into consideration dignity and status of the post of the Institute's Director.

Item 4.17 To consider payment of honorarium to the external experts of various Staff Selection Committees and to <u>deliver expert lectures etc.</u>

The Board decided that in addition to TA/DA admissible under the rules, an honorarium of Rs. 1,000/- (Rupees One Thousand only) per day be paid to the external experts for attending meetings of the Staff Selection Committees for teaching and administrative posts, for delivering invited lectures by men of eminence and for attending meetings of Screening Committees.

Item 4.18 To consider compassionate appointments of dependents of deceased employees of the Institute.

The Board noted that so far the compassionate appointments to the dependents of the deceased employees of the Institute were being given on the State Government pattern.

The Board decided that henceforth the appointments on compassionate ground to the dependents of the deceased employees be allowed strictly on the Central Government pattern.

Item 4.19 To consider the implementation of Career Advancement Scheme (CAS) as per latest instructions of Govt. of India <u>and AICTE.</u>

After detailed discussion the Board decided as under:-

- The matter regarding seniority of persons recruited through CAS vis-a-vis those recruited directly be deferred and put up in the next BOG meeting.
- (ii) As per revised Career Advancement Scheme issued by the AICTE vide its letter No. FD/PSSC/Clarif./2003/1 dated 10.9.2003, promotion as Professor has to be made from the post of Assistant Professor after 8 years of service as Assistant Professor.

However, as per clarification furnished by the AICTE in the same letter of 10.9.2003, the experience of Selection Grade Lecturer is to be considered equivalent to that of Assistant Professor after



acquiring the Ph.D. A clarification should be sought whether period of service as Selection Grade Lecturer prior to acquiring Ph.D. is to be considered equivalent to that of Assistant Professor.

- (iii) As per clarifications issued by the Govt. of India, MHRD vide their letter F.No. 37-104/95-TS-II dated 14.6.1999, the benefits of the CAS be allowed w.e.f. 9.10.1998 or from the date of eligibility for promotion under the CAS whichever is later.
- (iv) The Board decided to adhere to the clarifications in all other matters as per clarifications furnished by the AICTE vide its letter No. FD/PSSC/Clarif./2003/1 dated 10.9.2003.
- (v) The clarifications issued by the AICTE vide its letter No.
 FD/PSSC/Clarif/2003/1 dated 19.9.2003 under sub paras (ii), (iii) and (iv) may also be adhered to.
- (vi) As per instructions contained in the Govt. of India, MHRD, New Delhi letter No. F.20-18/2003-TS.III dated 15.9.2003, the promotion under CAS shall be effective after approval of recommendations of the Selection Committee by the BOG of the Institute.
- (vii) The Board noted and ratified composition of the Selection Committee for promotion to the level of Professors, Assistant Professors and Lecturers under CAS as well as for direct recruitment as contained in the Govt. of India letter dated 15.9.2003 under reference.

The Board referred to the constitution of the Selection Committee for teaching posts as per rule no. 12(3) of the Rules/MOA of the Institution and decided that in addition to above Committee, Head of the Department concerned in the Institute (in place of one of the nominees of the Board, if the post for which selection is being made is lower in status than the one occupied by the Head of the Department) will also act as member on the Selection Committee for CAS as well as for direct recruitment.



The Board authorized the Chairman of the Board to nominate two external experts out of the panel of experts on behalf of the Board on the above Selection Committees required from time to time.

(viii) The eligibility criteria and other terms & conditions for promotion under CAS shall be the same as circulated by the Govt. of India and AICTE from time to time.

Item 4.20 To consider implementation of Assured Career Progression (ACP) to the non-teaching employees <u>of NIT, Kurukshetra.</u>

In implementation of ACP of the Central Government, a number of Institute employees loose privilege of ACP of the State Government of Haryana. The proposal given in the agenda needs further discussion and decision.

The Board, however, desired that there is strong need to extend monetary incentives to reward good staff members for which the matter may be first examined at the Institute level and then it may be put up to the Board for consideration and decision. The Board further desired that proformae for reporting Annual Confidential Reports of both teaching and non-teaching employees be reviewed.

Item 4.21 To consider service conditions of the faculty members (teaching staff) as per latest instructions of the Govt. of India – Retirement on superannuation.

The Board noted its decision taken by way of circulation in the last week of Nov., 2003 in adopting service conditions of the faculty members (teaching staff) of NIT, Kurukshetra under which their retirement age on superannuation will be 62 years in terms of the Govt. of India, Ministry of Human Resource Development letter No. F.20-11/2003-TS.III dated 12.11.2003.

Item 4.22 To consider filling up the post of Deputy Registrar (Academic) in the Institute.

The Board desired that the qualifications/experience required for the post of Deputy Registrar (Academic) be re-cast on the pattern of IIT, Kanpur/IIT, Delhi. The pay scales for the post of Deputy Registrars are also yet to be decided after upgradation of the RECs.

Till the post of Deputy Registrar (Academic) is filled up, the Board authorized the Chairman of the Board to engage a retired/retiring officer from Technical Institutes of repute to deal with affairs relating to academic, examination, secrecy and results etc. on contract basis. The Board further authorized the Chairman to decide salary and other terms and conditions of contractual engagement of the aforesaid officer.

Department of the Institute in GGSIP Univ., Delhi.

The Board authorized the Director to decide the matter appropriately assuring that it does not lead to legal and financial implications for the Institute in the long run.

Item 4.24 To consider Enquiry Report regarding death case/promotion of Shri Moti Lal, Ex-Lecturer, <u>NIT, Kurukshetra.</u>

The Board deferred the consideration of the Inquiry Report received from the State Government in November, 2003.

Item 4.25 To consider and approve minutes of 2nd meeting of the Senate, National Institute of Technology, Kurukshetra held on 29.11.2003.

The Board considered and approved minutes of the 2^{nd} meeting of the Senate of the Institute held on 29.11.2003 as per details furnished in the

agenda item 4.25 with the following observations:-

- (i) The meetings of the Senate should be held frequently so that delay in taking decisions on the academic matters and implementation thereof is avoided.
- (ii) A complete and detailed home work is required to be done by the Senate for taking decisions on academic matters, implementation of the academic decisions taken by the Senate as well as by the Board.
- (iii) While evaluating result of the Undergraduate students and making assessment, their participation in training held during summer and winter vacations may be taken into account.

- (viii) A scholarship of the value of Rs. 500/- P.M. may be introduced as advised by Shri Dharam Vir, IAS, Financial Commissioner & Principal Secretary to Govt. of Haryana, Technical Education Department, Chandigarh. Accordingly, the matter may be taken up with Shri Dharam Vir, IAS.

Therefore, it may be advisable to frame appropriate rules, which would indicate that no member would be nominated unless he/she has sufficient period of service left to serve the Board for the full term. You may kindly take necessary action accordingly".

- 7. The Board of Governors in its 4th meeting held on 8.12.2003 considered the aforesaid comments sent by Dr. R.S.Sirohi and desired that a proposal on the issue raised by Dr. R.S.Sirohi should be placed before the Board in its next meeting for formulating a rule on the issue.
- 8. In this regard it may be stated that Dr. R.K.Arora and Dr. V.K.Aggarwal will complete their one year term as the age of retirement of the faculty members of NIT, Kurukshetra has since been increased to 62 years as per instructions of the Ministry of Human Resource Development.

1.0 The Institute

The National Institute of Technology (Deemed University), Kurukshetra is one of the 17 NITs/RECs of the country. It was established in the year 1963 as a joint and cooperative enterprise of the Govt. of India and the State Government of Haryana, to serve the State of Haryana and the rest of the country for imparting technical training to youth and for fostering national integration. Its objective is to provide instructions and research facilities in various disciplines of Engineering and Technology on the advancement of learning and dissemination of knowledge in each such discipline.

The first admissions to a five-year B.Sc. (Engg.) degree course were made by the College in July, 1963 at Punjab Engineering College, Chandigarh and Thapar Institute of Engineering and Technology, Patiala with 60 students at each place. This was repeated in July, 1964.

The Institute started functioning on its present campus at Kurukshetra in 1965-66 with 120 students admitted in the first year of the five-year courses of study for the B.Sc. (Engg.) degree in Civil, Electrical and Mechanical Engineering. The annual intake was increased to take 250 students in 1966-67. A B.Sc. (Engg.) degree course in Electronics and Communication Engineering was added in 1971-72. In 1967-68 M.Sc. (Engg.) degree courses in Civil, Electrical and Mechanical Engineering and in 1971-72. a Post-graduate Diploma in Scientific Instrumentation were also started. By July, 1976 part-time M.Sc. (Engg.) degree courses in Electronics and Communication Engineering and Instrumentation had been instituted. The first registration for the degree of Doctor of Philosophy in the faculty of Engineering and Technology, was made in July, 1967.

The Institute changed over to the four-year engineering degree course with effect from the academic year 1985-86. The new course was designated as B.Tech. The annual intake at present is 463.

Special three-year degree courses in Civil, Electrical and Mechanical Engineering, designated as Bachelor of Engineering for in-service engineering diploma holders were introduced from the session 1982-83.

Two years M.Sc. (Engg.) degree courses in various disciplines were redesignated as M.Tech. degree courses w.c.f. the session 1983-84. In accordance with the Govt. of India's policy, the duration of these courses was reduced to one and a half years.

From the session 1987-88, the Institute introduced a four-year B.Tech. degree programme in Computer Engineering with an intake of 30 students. The Institute also introduced a full time M.Tech. degree course in Electronics and Communication Engineering with an intake of 13. The intake of B.Tech. Electronics and Communication Engineering degree course was increased from 30 to 60 from the session 1987-88. A full time M.Tech. degree course in Water Resources (Civil Engineering Deptt.) was introduced in 1989-90.

In addition to providing instructions in various disciplines of Engineering and Technology at the undergraduate level and post-graduate level, the Institute offers excellent facilities for advanced research in the emerging areas of science and technology. The syllabus and the curricula of the Institute have been revised and they are comparable to IITs.

The Institute has been declared as National Institute of Technology, Kurukshetra with Deemed University status by the Govt. of India w.e.f. 26.6.2002. Earlier the Institute was affiliated to Kurukshetra University, Kurukshetra.

The Campus extends over an area of 300 acres imaginatively laid down on a picturesque landscape. The Institute is fully residential one. It has about 370 houses for the employees. It has 6 hostels for the boys and one hostel for the girls.

This Institute has received financial approval to the tune of Rs. 1042.86 Lacs and additional 8% of the grant for operation and maintenance from NPIU, Government of India under TEQIP Project for procurement of Goods (Equipments, Furniture, Books, Learning Resources and Educational material, Vehicle and small items and services related to goods) for modernization of existing Laboratories & Workshops in the Departments and creating central facilities for the use of this Institute as well as its network institute in Haryana, Carrying out the Civil works & Services. The Matter regarding participation of NIT Kurukshtra in TEQIP Project was placed before the Board of Governors in its 3rd meeting held on 6.10.2003 (Item No.3.14) which was noted by the Board.

The efforts for procurements under this project are in process. The NPIU has provided a set of specific World Bank purchase Rules for this purpose. This Institute has also its own purchase rules. The Purchase Rules of World Bank provided by NPIU are mandatory to be implemented for the procurements under TEQIP Project funded by the World Bank.

On adoption of World Bank Purchase Rules for the procurements under TEQIP Project, the Institute Purchase Rules and World Bank Purchase Rules both are proposed to be implemented for effecting the procurements under the Institute funds and World Bank funds separately. The major differences in Institute and World Bank Purchase Rules are indicated in <u>Appendix</u> - \forall , pages 59 - 62.

The Board may consider and approve the implementation of World Bank Purchase Rules separately for procurements under TEQIP project. Further the Board may also consider and approve to implement the purchase rules of funding agency for procurements under concerned project.

While considering amended qualifications/experience for teaching posts in Humanities and Sciences in the Degree Level Technical Institutions as laid down by the AICTE vide letter No. FD/Pay/01/2001-02 dated 28.2.2002 (copy enclosed as Appendix <u>VI</u> at pages<u>66</u> to <u>67</u>), the Board of Governors of the Institute in its 2nd meeting held on 19.4.2003 noted as under:-

"The Board noted the amended minimum qualification and experience in respect of the Director/Principal/Head of the Institute and Lecturer (Humanities and Sciences) in the Degree Level Technical Institutions as per Notification No. FD/Pay/01/2001-2002 dated 28.2.2002 by AICTE. The Board approved the amended qualifications for the post of Lecturer (Humanities and Sciences) with additional condition that he/she must be Ph.D."

In the same meeting held on 19.4.2003 the Board of Governors while considering the revised minimum qualifications/ experience prescribed for teaching posts in Degree Level Technical Institutions as laid down by the AICTE vide letter No. FD/PSSC/ Notification/2002/1, dated 19.2.2003 (copy enclosed as Appendix ______ at pages ______ 68 ____ to _____ 73 _), decided as under:-

"The Board approved the revised minimum qualifications and experience prescribed for Teaching posts in Degree Level Institutions as per recommendations of AICTE, New Delhi vide letter No. FD/PSSC/Notification/2002/1 dated 19.2.2003. However, the Board decided that the minimum qualification for Lecturer in Engineering subjects be First Class Master's Degree in the appropriate Branch of Engineering/Technology".

As per decision of the Board, referred to above, the minimum qualification for the post of Lecturers in Engineering subjects is 1st Class Master's Degree in the appropriate branch of Engineering/Technology and in case of Lecturers in Humanities and Sciences it is Ph.D.

The Institute is facing difficulty due to poor response to have candidates with 1st Class M.Tech. in Engineering Branches particularly in the Computer Engineering and similarly in the Humanities & Sciences as sufficient candidates with Ph.D. are not available as and when required for the recruitment. It has, therefore, been felt to follow the following qualifications/experience for Lecturers in Engineering & Technology disciplines as well as Humanities & Sciences as prescribed by the AICTE.

1.1 General

- 1.1.0 Minimum length of service for eligibility to move into the grade of Lecturer (Senior Scale) would be four years for those with Ph.D., five years for those with M. Phil., M.Tech., and six years for others at the level of Lecturer, and for eligibility to move into the grade of Lecturer (Selection Grade)/ Assistant Professor, the minimum length of service as Lecturer (Senior Scale) shall be uniformly five years.
- 1.1.1 For movement into grades of Professor, the minimum eligibility criterion would be Ph.D. Those without Ph.D. can go up to the level of Lecturer (Selection Grade)/Assistant Professor.
- **1.1.2** An Assistant Professor with a minimum of eight years of service in that grade will be eligible to be considered for appointment as a Professor.
- **1.1.3** The Selection Committees for Career Advancement shall be the same as those for Direct Recruitment for each category.

1.2 Lecturer (Senior Scale):

(i)

A Lecturer will be eligible for placement in a senior scale through a procedure of selection if she/ he has:

Completed 6 years of service after regular appointment with relaxation of one year and two years respectively, for those with M.Phil, M.E.,/ M. Tech. and Ph.D.

(ii) Participated in summer / winter schools of total duration of 4 weeks, or engaged in other appropriate continuing education programme of comparable quality as may be specified or approved by the All India Council for Technical Education (AICTE). • 78 -- 4/cS-

(iii) Consistently satisfactory performance appraisal reports.

1.3 Lecturer (Selection Grade):

Lecturers in the Senior Scale who do not have Master's degree or equivalent published work, and who do not meet the scholarship and research standards, but fulfils the other criteria given below for the post of Assistant Professor, and have a good record in teaching and, preferably, have contributed in various ways such as to the corporate life of the institution, examination work, or through Research & extension activities, will be placed in the Selection Grade, subject to the recommendations of the Selection Committee which is the same as for promotion to the post of Assistant Professor. They will be designated as Lecturers in the Selection Grade. They could offer themselves for fresh assessment after obtaining Master's degree and/or fulfilling other requirements for promotion as Assistant Professor and if found suitable, could be given the designation of Assistant Professor.

1.4 Assistant Professor:

1.4.1 A Lecturer in the senior scale will be eligible for promotion to the post of Assistant Professor if he/ she has:

(i)

Master's Degree and completed five years of service at the level of Lecturer(senior scale). Those who do not have Ph.D degree, they are required to obtain Ph.D degree within a period of seven years from the date of his/her promotion to the post of Assistant Prfcssor.

(ii) Made some mark in the areas of Scholarship and Research; as evidenced e.g. self assessment, report of referees, quality of publication, contribution to education /innovation, development of new courses and curricula and extension activities.

(iii) After placement in the senior scale participated in winter/ summer schools (short-term courses) of total duration of 4 weeks, or engaged in other appropriate continuing education programmes of comparable quality as may be specified / approved by the AICTE.

- (iv) Possesses consistently good performance appraisal reports.
- **1.4.2** Promotion to the post of Assistant Professor will be through a process of selection by a selection committee to be set up under the statutes / ordinances of the concerned institute / university or other similar committees set up by the appointing authorities.

1.5 Professor:

- **1.5.1** In addition to the sanctioned position of Professors which must be filled up through direct recruitment through all India advertisement promotion may be made from the post of Assistant Professor after 8 years of service as Assistant Professor.
- **1.5.2** The selection committee for promotion to the post of Professors should be the same as that for direct recruitment for the promotion from Assistant Professor to Professor the following methods of promotion may be followed:

The candidate should present her/himself before the selection committee with some of the following:

(a) Self-appraisal report (required).

- (b) Research Contribution books, articles, etc published (at least 4 papers in Journals required). The best three written contribution of the teacher (as defined by her/ him) may be sent in advance to the experts for reviewed before coming for the selection committee interview. The candidate should submit in three sets with the applications.
- (c) Seminars / conferences / workshops attended which should be at least 4 seminars/ conferences/ workshops at the national/ international level or must have attended summer / winter schools (short term course) of total duration of 4 weeks.
- (d) Significant contribution towards teaching / academic environment / institutional corporate life.
- (c) Adequate extension and field research activity.

1.6 The requirement of consistent satisfactory performance appraisal report shall be the mandatory requirement for Career Advancement from Lecturer to Lecturer (Senior Scale) and from Lecturer (Senior Scale) to Lecturer (Selection Grade) /Assistant Professor.

For requirement of completing the courses would be as follows:

- (i) For Lecturer to Lecturer (Senior Scale), summer / winter school courses of total duration of 4 weeks would be compulsory.
- (ii) For Lecturer (Senior Scale) to Lecturer (Selection Grade)/ Assistant Professor, summer / winter school courses of total duration of 4 weeks would be compulsory.

Item 5.11 To consider the extension case of deputation of Smt. Sunita Chauhan, Lecturer in Electrical Engg. Department of NIT Kurukshetra from 20.12.2003 to 19.12.2004.

As desired by the State Govt. Smt. Sunita Chauhan was allowed to proceed on deputation vide No. GA-I/PF/10658-65 dated 19.12.2000 for a period of one year commencing from 20.12.2000(Ab) to enable her to join as Project Director in the Department of Directorate of Technical Education, Haryana, Chandigarh in anticipation of the approval of Board of Governors of the Institute on the usual terms and conditions mentioned in the letter. She was allowed extension for a period of one year which may be extendable to three years on the orders of His Excellency Governor of Haryana as conveyed by Technical Education Chandigarh vide endst. No. CTE-Department, 2K/1078/Tech.Arch dated 6.12.2000. The Board of Governors ratified the action of the State Govt. in posting Smt. Sunita Chauhan on deputation in the Directorate of Technical Education, Haryana initially for a period of one year (extendable to 3 years) commencing from 20.12.2000 vide item No. 94.43. Further His Excellency Governor of Haryana was pleased to extend the deputation period of Mrs. Sunita Chauhan from 20.12.2001 to 19.12.2002 and 20.12.2002 to 19.12.2003. For ratifying the action of His Excellency, the Governor of Haryana in allowing extension in deputation of Smt. Sunita Chauhan with the State Govt. from 20.12.2001 to 19.12.2002 and from 20.12.2002 to 19.12.2003 the matter was placed in the 2nd meeting of the BOG held on 19.4.2003 and the Board decided as under:-

"Smt. Sunita Chauhan, Lecturer in Elect. Engg. Deptt., NIT Kurukshetra was allowed extension in deputation from 20.12.2001 to 19.12.2002 and further extension from 20.12.2002 to 19.12.2003. The Board directed that Smt. Sunita Chauhan should request NIT Kurukshetra for one year's extension in deputation in writing from 20.12.2002 to 19.12.2003 with the undertaking that no further extension will be given to her under the Rules and she will have to resume her duty in the Institute after the expiry of deputation period on 19.12.2003."

Vide Institute letter dated 29.1.2004 as referred to above she was also given the final and the last opportunity to resume her duty at the Institute within 15 days from the date of issue of the said letter.

Now the Institute has been informed vide endst. No. 51/24/2001-1TE dated 5.2.2004 that His Excellency, Governor of Haryana is pleased to further extend the deputation period of Smt.

3. Shri S.C.Gupta is hereby further informed that if for the purpose of preparing his written statement, he wishes to have access to the relevant official record, he should inspect the same in the office of Deputy Registrar(GA) of the Institution on any working day after taking prior appointment from him. It is, however, pointed out that only such documents shall be shown to him as are in possession of the concerned officer and are strictly relevant to the case. It is made clear to Shri S.C.Gupta that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received within the specified period, it shall be presumed that he has nothing to submit.

4. The written statement should be submitted directly to the Director, N.I.T.Kurukshetto.

STATEMENT OF ALLEGATIONS

1. Shri S.C. Gupta, Lecturer in Mechanical Engineering Department, NIT Kurukshetra made a forced entry into room no. 1 of Guest House of the Institute on 7.12.2003 at about 8.45 A.M. where the Hon'ble Chairman, Board of Governors was staying for attending the BOG meeting scheduled for 8.12.2003. Though Shri Ram Kishan, Cookcum-Chowkidar tried to give a slip to Sh. Gupta to write the details for meeting the Chairman, BOG, but Sh. Gupta straightway entered into the room no. 1 and spoke loudly and undesirably to the Chairman violating all norms of decency which is against the Conduct & Disciplinary Rules of the Institute. It is gross indiscipline and omission on the part of Sh. Gupta and causes aspersions on him as a faculty member.

2. On 7.12.2003 in the morning itself Shri Gupta went to the residence of Registrar speaking loudly against the Chairman, BOG. Shri Gupta uttered in an abnormal voice to the Registrar that he was going to lodge an FIR against the Chairman in the Police Station. During conversation Shri Gupta misbehaved with the Institute's Registrar.

3. On the same day Sh. Gupta came in the Guest House 5-6 times to meet the Chairman, BOG ignoring the advice of the Security Officer. In the evening Sh. Gupta came in front of the Director's residence in a drunken condition and insisted to meet the Director. In the intoxication condition, Sh. Gupta started making rounds of the residence of the Director. Sh. Gupta made an entry in the residence of the Director when the Registrar was already present there. Sh. Gupta started abusing the Registrar in presence of the Director. The Security Officer took Sh. Gupta to his residence (Sh. Gupta's residence) with the help of Chowkidar but Shri Gupta again came at the residence of the Director and put off his (Sh. Gupta's) clothes except Pajama and started to lit his body with match box. Under these circumstances the match box and the "Biri" were snatched away from Sh. Gupta by the Chowkidar. As reported, Sh. Gupta remained there in front of the Director's residence till late night. In the late night officers of the Institute went to the Police Station but in the meantime he was picked away by some persons known to him. Such actions cannot be expected from a teacher of Educational Institution like ours and are highly objectionable.

STATEMENT OF CHARGES

1. Nuisance created by Sh. S.C. Gupta, Lecturer in Mechanical Engineering Department at NITK, Guest House on 7.12.2003.

Shri S.C. Gupta, Lecturer in Mechanical Engineering Department, NIT Kurukshetra made forced entry into the room of Guest House of the Institute on 7.12.2003 at 8.45 A.M. where the Hon'ble Chairman, Board of Governors was staying for attending the BOG meeting scheduled for 8.12.2003. Though Sh. Ram Kishan, Cook-Cum-Chowkidar tried to gave a slip to Sh. Gupta to write the details for meeting Chairman BOG but Sh. Gupta straight away entered into room No. 1 of the Guest House where Sh. S.C Gupta spoke loudly and undesirably to the Chairman violating all norms of decency. Sh. Ram Kishan who went running towards the room where Chairman was staying also heard loud voices. That act of Sh. Gupta led to misbehaviour towards the Chairman BOG which is against the Conduct & Disciplinary rules of the Institute which read as under :-.

- An employee shall at all times be courteous in his dealings with other members of the staff, students and members of the public.
- 10 (a)

Whenever an employee wishes to put forth any claim or seeks redress of any grievances or of any wrong done to him, he must forward his case through proper channel.

From the above it is evident that Sh. Gupta did not follow the above rules which is a gross indiscipline and omission on his part. Being a teacher it cause aspertions on the part of his teaching profession.

2. Nuisance created by Shri S.C. Gupta at the residence of the Registrar, NITK on 7.12.2003.

On that very day in the morning itself Sh. Gupta went to the residence of the Registrar speaking loudly against the Chairman BOG. When the Registrar asked him as to why he went to meet the Chairman BOG without "Through Proper Channel" he replied back in loud voice that he himself (Sh. SC Gupta) was a proper channel. Sh. Gupta further uttered in an abnormal voice to the Registrar that he was going to lodge a FIR against the Chairman BOG in the Police Station. It is evident that Sh. Gupta also had altercation during his conversation while entering the Chairman's room at Guest House on 7.12.2003 at about 8.45 AM and also misbehaved with the Institute's Registrar.

3. Nuisance created by Shri S.C. Gupta in the Guest House and at the residence of the Director, NITK on 7.12.2003.

- (i) After receiving a message from the Registrar on the same day, the Security Officer of the Institute reached the Guest House. A Chowkidar was put on duty in the Guest House to stop entry of undesirable elements. In the mean time Sh. Gupta again made a entry but the security officer asked him to come in the evening. The above arrangement was done on the verbal report of Sh. Ram Kishan that Sh. Gupta has come to Guest House 5 or 6 times to meet the Chairman, BOG.
- (ii) In the evening Sh Kamla Parsad, Chowkidar deputed at the resident of Director, NIT, Kurukshetra reported that Sh. Gupta came in front of the Director's residence at about 6.00 PM in a drunken condition. The Chowkidar asked him to go away as he was in drunken state but Sh. Gupta

insisted that he would meet the Director. With this state of intoxication Sh. Gupta started making rounds of the residence of the Director. In the meantime, the Registrar also reached the Director's residence. Thereafter Sh. Gupta made an entry in the residence of Director and started abusing the Registrar in the presence of the Director. The Security Officer, who also reached the Director's residence, arranged to leave Sh. Gupta at his residence in the Campus with the help of Chowkidar in the Director's Car. Sh. Prithvi Raj, Driver of the Car also observed that Sh. Gupta was in drunken condition. These actions of Sh. Gupta clearly indicates his misconduct.

(iii) The Chowkidar Sh. Kamla Parshad also reported that Sh. Gupta again came at about 7.30 PM at the residence of the Director and put off his (Sh. Gupta) clothes except Pajama and started to lit his body with match box. Under these circumstances, the match box and the "Biri" were snatched away from Sh. Gupta by the Chowkidar so that he may not cause any harm to self. Sh. Kamla Parshad also reported that Sh. Gupta was sitting in the same condition in front of the Director's residence till late night. Similar versions were also given by the officers and the faculty members present there. In the late night officers of the Institute went to the Police Station to report the matter but in the meantime Sh. Gupta had been picked away by some persons known to him.

The above action particularly of a teacher in an educational Institution does not hold good for the community and the students. vide No. GA-1/PF/780 dated 22.1.04.

Dear Sir.

Kindly refer to abovementioned Memorandum, Statement of allegations, statement of charges, I submit the following written statements in reply to the same.

1. It is a fact that I went to Room No. 1 of Institute Guest House where Hon'ble Chairman BOG was sitting in the morning of 7.12.03 as he was to preside over the meeting of the BOG scheduled for 8.12.03.

I being a teacher of Mech.Engg. Deptt went to the Guest House to meet Dr. BL Dhoopar, Chairman, BOG who also happens to be a reputed academician of IIT Kanpur and with specialization in the Mechanical Engineering. Being a student of Ph.D. infact I wanted to have some guidelines and the sole purpose for my going to the Guest House was to seek consultation/guidance to complete my Ph.D. as the duration left with me is very short for submission of my Ph.D. thesis.

Incidentally my going to meet the chairman of BOG in the Institute Guest House became a point of controversy but factually I wanted to meet him as an academician and not as the chairman of the BOG.

He openly invited the entire teaching staff of the institute in August 2002 in room no. E-106 while holding a meeting of the teaching staff of the institute. In the said meeting he publically exhorted the teachers of the institute, in the presence of the then Director Dr. N.P. Mehta who was also sitting on the dias, with the

remarks Leave aside administration, talk of administration to your director "I shall not even comment upon that". If you have any problem of academic in nature you are always welcome to me directly.

So trusting his own words upon their face value, I went to meet Sh. Dhooper so that he may throw some light upon my Ph.D. topic Essentially my job is that of a teacher. However, besides teaching I always strive for creation of new knowledge like by pursuing my Ph.D. topic which is a topic of great academic importance.


It is exactly for this scholistic pursuit that I sought the guidance of erstwhile retired Professor Dr. B.L. Dhooper while he was staying in Institute Guest House in the morning of 7-12-03. But my bad luck, Sh. Dhooper feit offended even before I could utter my Ph.D. topic to him.

Obviously, I was ruffled & agitated, as my Ph.D. thesis submission time was fast nearing its end i.e. 4 year tenure, I was enrolled in Sept. 2000 with K.U.K. as a Ph.D. Scholar under proper permission of the Institute.

So if it is a crime to be a student and seek the guidance of those who matter in academia, I have committed a crime for which I submit myself before the authorities that be, to meet out any punishment which they desire.

However, it is further pointed out that I had the courtesy to seek the permission of the attendent of the chairman i.e. some boyish person living in the Institute Guest House and masquerading in the campus as if he is the only person who matters there. But since this boyish person was busy in some kitchen work, he ALLOWED me to meet the chairman directly even without a slip. I also had the sense of courtesy to further tell him "whether I could meet him directly. Even without a slip", Upon this he shot back "when we have told you to go and meet the





chairman directly, who else can stop you from meeting him now. What the slip would do".

So I decided to meet erstwhile retired professor of Mechanical Engg. from a world class premier Institute like IIT, Kanpur. As to my mind, a written slip is nothing but an authorization to go ahead, which I had been granted by that boyish person there.

So dear sir, no norms of decency were violated. After all I am teacher here and a teacher can never be indecent to anybody, least of all his elders and respectable in the Institute and society at large.

So the quoted Conduct and Disciplinary rules of the Institute may not be operated keeping in view the sanctity of the purpose behind my desire to meet Dr. B.L. Dhooper

It is patently untrue that I spoke loudly and undesirably. When I met Hon'ble Chairman BOG of the Institute. My dear sir I had gone to the Guest House in the morning of 7.12.03 not for purpose of putting forth any claim or do seek redress of any grievances of any wrong done to me. I had simply gone for the pious purpose of seeking his guidance as an academician.

2. With reference to point at Sr. No. 2 it is admitted that on 7.12.03 I went to the residence of the Registrar but I only enquired about the period of stay of the Chairman, BOG so that I may consult him regarding my academic problem with Dr. B.L. Dhoopar who incidently is a reputed academician of IIT Kanpur holding a fame in the discipline of mechanical engineering. However this enquiry might have not been to the taste of the Registrar, hence an unpleasant conversation. But to my mind there was nothing behind it to dis-honour the Registrar in any manner whatsoever.

Rather the Registrar threatened me with lodging of an FIR in the police station presuming that I had gone to meet the Hon'ble chairman BOG without proper channel.

Upon this I told the Registrar that Sir, being a law graduate I know that what was all about lodging of an FIR in the circle thana of the town. It shall not be out of place here to mention that I have done LLB (Profession) from K.U.K. in the year 2000, under proper permission of the Institute. But to my mind such a straight forward talk was not liked by the Registrar then.

Obviously the Registrar of the Institute was very over burdened with work at that point of time as a BOG meeting had been scheduled for the next day i.e. 8.12.03. He told me absentmindedly that you go away otherwise he would have to lodge a complaint against me in the police station of the circle since I had committed the 'sin' of meeting the Hon'ble chairman of BOG "Without Proper Channel".

He further told me in the same vain it is not expected of him (the Registrar) to known from his superiors particularly chairman BOG as to for how long he would like to stay here this time.

But since I was under great pressure of getting my doubts regarding my Ph.D. topic dispelled by Dr. B.L. Dhoopar, I requested the registrar to at least tell me the day after as to for how long Prof. Dhoopar would stay in the town this time round.

This further pressing of matter by me might not have been to the liking of the Registrar & that is why he became annoyed and furious with me. But to my mind there was nothing behind it to show any disrespect the Registrar in any manner.

If at all he had felt that my talks or the way of talking with him in any manner was less than pleasant, I request him, that, that be ignored considering our long stay together on the college campus. I have always held him in high esteem and have been throughout been courteous towards him till date.

(i) In reply to para no. 3 it is clearly submitted that I came to the Guest House only twice instead of 5-6 times but I have not met the Chairman more than once when he advised me to see him only after prior appointment even if academic discussion was required, being busy as he was in the BOG items for the next day meeting.

(ii) Honestly speaking the undersigned was neither under the drunken state nor intoxication state in evening of 7.12.03 as the same has been prohibited by the Doctor under whom I am taking the treatment of liver disorder. Had there been a doubt of drunken state I could have been easily medically examined on the direction of the authority by the DR(GA)/Security Officer from the LNJP Hospital, Kurukshetra at that time and could have been suitably punished for the same. My confused state of mind has been concluded as drunken state that was due to the impression of some complications in my family. Still I am sure that I have not acted in an indecent manner in talk or have not acted in any inviolate manner which is a general expectation about a drunken man.

Rather, I went to the Director's residence in the evening of 7.12.03 after obtaining his prior approval on telephone, to discuss a matter of great importance of personal-cum-public in nature.

When I went there, incidently Registrar was also present in the Director's residence office alongwith the worthy Director himself. About the presence of the Registrar I was not aware before. To my mind the Registrar was also under the impression that I had gone there without taking prior proper permission of the Director before being there. It shall not be out of place here to mention that beside taking prior permission of Director I exhibited further courtesy to seek the permission of Chowkidar who had been posted outside Director's residence at that time, before

entering the residence of the Director. Understandably the Registrar was highly burdened with official work as an important BOG meeting had been scheduled for the next morning i.e. 8.12.03.

As soon as I started discussing the said matter of great importance which was personal-cum-public in nature, the Registrar, obviously, got irritated and said abruptly Mr. Gupta, say whatever you wish to say only Later on. It was not the proper time to raise such issues. Moreover you should meet the higher officers of the institute only after obtaining prior permission. As the Registrar had intervened in a very unpleasant and dashing manner I retorted back, my dear Sir, I had not come here uninvited or I was not an undesirable element at all. I had come here only after obtaining prior permission of the Director. It was unbecoming of the Registrar of our prestigious institute to intervene in such, an unpleasant manner when two persons of higher status discuss something very important matter of personal-cum-public in nature.

This might have been taken otherwise by the Registrar and might have been considered in bad taste by him. Infact there was no idea of conversation or discussion with the Director creating any indecency with the Registrar. As I mentioned before I have always been courteous & respectful toward the Registrar of the Institute holding him in high esteem & personal prestige. After all he is a very important link in the official channel of the Institute.

Subsequent to the event referred above, the Registrar called the Security Officer and gave him direction to drop me at my residence DA-10 on the Institute Campus. Sh. Ram Lat Security Officer took me in the Institute vehicle but while dropping me at my residence, he started talking in a very indecent manner and rather he caught me from my neck which resulted into the tearing of my upper body garments including

under-upper clothes. This inhuman act was committed by Sh Ram Lal Security Officer right in front my house on the Institute Campus in broad evening.

At the end I am clarifying that the reason behind my sitting outside the residence of Director in the evening was to show resentment against such a despicable behaviour of Sh Ram Lal Security Officer with a teaching faculty member, by catching me from the neck and tearing apart my upper body garments right in front of my residence when my family was away to Rohtak to attend a marriage in our family. To show resentment against this inhuman behaviour of the Security Officer, I came again to the residence of the Director riding on my own scooter and sat there for quite sometime so that I maybe heard for the grievances cited above. As nobody came outside to listen to me, I had no alternative except to come back being cold whether. My request to seek justice from the authority of Institute against this inhuman behaviour of Sh. Ram Lal security officer may also be looked into. And to my mind further allegation of liting my body with the match box is not correct.

Instead of me this security officer Sh. Ram Lal should have been placed under suspension. After all what right he had to behave in that inhuman way with me. After all he is a person holding a lower status than me in the Institute.

As my colleagues and senior in the faculty, who always praise and appreciate my exemplary conduct & teaching performance in the Institute, tell me that a teacher is like a role model of high moral conduct before the society in general and students in particular. As they tell and I follow if a teacher starts having such bad habits like drinking and smoking, where the students would go for guidance in the matter of moral, ethical, and good desirable conduct ! My job is essentially that of a teacher so ever since the day of my entering into this noble

profession of teaching I have been exhibiting high moral conduct and exemplary behaviour with all my students, collogues & seniors in the faculty.

So my being in the habit of either drinking or smoking biris or cigarettes is patently untrue. So likewise on that day also i.e. 7.12.03 I had neither drunk any liquor or smoked any Biri or cigarette. I am not in such habits my dear sir.

As your goodself have permitted me to have a glance at all the complaints that have been lodged in reference to me, While thanking you for your broad heartedness of providing me a chance to see all the relevant official record. Now since I trust all the people in the institute, I forgo this opportunity of seeing the record. As my colleagues have been telling me, eversince the day of my suspension from Job, based upon such hearsay. I have prepared this reply, for I know that a record is nothing but reducing the hearsay into writing. Once again thank you for your affection towards me on this count. However, I take this opportunity to point out the following pinching phrases in this charge sheet.

In point 3 (i) p. 2 it is mentioned that "Security Officer asked Sh. Gupta (myself) to come in the evening". It is indiscipline on the part of the security officer. After all he is a person (employee) of lower status when compared with that of mine. If all the employees in the Institute of lower status in hierarchy be allowed to "ask" there superiors where the administration of the institute would go in case such a scenario is permitted here?

As your gooself may remember that vide a letter No GA-1/PF/7849 dated 19.11.03, issued to me, under your authorization to DR(GA) of the Institute, I had been granted 4 months Sabbatical Leave for pursuing research on the topic "Process

Planning in Manufacturing system in Industry". Which were to commence on 5.1.2004 and to end on 4.5.2004.

And I had made all the necessary preparations of proceeding on these. Sabbatical leave like as to how data was to be collected from industry, as to how relevant literature was to be procured from the sources that be, as to how knowledgeable persons in the field were to be approached for guidance, as to how & when seminars were to be delivered before the faculty including renowned experts on the topic as to how & which format entire research work was to be consolidated and aligned in the form of a quality research work which might have become a sort of reference upon the abovementioned topic. I was already under active guidance of both of my Ph.D. supervisors on this topic. I was doing all these activities under their noble guidance & affectionate encouragement. One of my supervisors is Dr. S.K. Sharma, who is currently Professor and Chairman Mechanical Engineering Department of NIT Kurukshetra, besides being an academician of repute.

But like a bolt from the blue, in the (AN) of 8.12.03 your goodself signed another letter/order vide No. GA-1/PF/8262 dated 8.12.03, thereby placing me under suspension with immediate effect. Besides my liberty to leave headquarters was effectively banned. I was not even allowed to conduct a practical examination at NCEC Israna under KUK, as my request to do the same was turned down vide another letter No. GA-1/PF/8536 dated 15.12.03, without furnishing any reason whatsoever, what to talk of vising any industry at outstations for the purpose of collection of relevant data for my research work for which these sabbatical leaves were sanctioned earlier.

Sir, to say the least I have been subjected to gross injustice as all principles of natural justice have been denied to me.

I have been condemned unheard, that two behind my back. No reasonable opportunity was afforded to me by your administration before condemning me in the aforementioned manner.

No preliminary enquiry was conducted on record.

Nothing prime facie was found against me.

Not even an explanation was sought from me.

After all I am a very senior employee of the Institute here, serving your Institute for the last about 18 years. The minimum which an employee of my standing can expect from the Institute administration is that he/she is always heard "in person" before condemning him/her in the aforementioned manner.

Furthermore your goodself had not stopped even here, I had been handed down another latter on Instant 10.12.03 vide No. GA-I/PF/8396 informing that the Sabbatical leave already sanctioned & conveyed to me vide No. GA-1/PF/7849 dated 19.11.03 was thereby cancelled.

I have been subjected to one blow after another by running an above quoted series of letters issued to me, ostensibly for no fault of mine.

The order of 8.12.03 signed by your goodself vide No. GA-1/PF/8262 was fixed upon a door of my house in the evening of 8.12.03, behind my back as I have been told by my neighbourers in the campus.

Besides the services which I have been rendering to the Institute for such a long span of time, I have been an Under Graduate & Graduate student of this very Institute. Still I am a Ph.D. student enrolled with K.U.K. under your proper permission alongside serving in the faculty. Also I have done ULB (Professional) for K.U.K. in the year 2000 under proper permission of the Institute.



Throughout my working experience here I have maintained a good, unblemished record of work & conduct in the institute.

Sir, in nutshell what I gather from your order of 8.12.03 I have been placed under suspension solely out of some misplaced anger of Authorities that be here. Be it chairman BOG, your goodself or other officers and officials of the Institute.

At the end I feel that in the light of the facts mentioned above, I deserve to be reinstated with all the consequential intents & benefits w.e.f. 8.12.03 the day of my suspension, so that I may work with added encouragement and sense of purpose in the Institute hence forth. Though the administration has the sword of justice in its hands but this sword ought to be used in a very judicious way, As I have been taught by my teachers of law college in K.U.K.

At the end again, I submit that if any of my word(s) or act(s) has/have caused any displeasure to any one in the institute, be him the Hon'ble Chairman of BOG, your Goodself, our worthy Registrar or all other officers and officials of Institute, I request that such word(s) or act(s) of mine be ignored in the interest of good Institute relations here.

Item **5,14**

To note the engagements of Dr.S.K.Gupta, Retired Professor of IIT, Kanpur for framing academic rules and Sh.S.P.Sharma, Deputy Registrar(Academic) on contract basis.

The Board of Governors in its 4th meeting held on 8.12.2003 decided as under :

"The Institute should be allowed to appoint a retired Professor from some IIT or a Technical Institute of repute, having expertise in framing academic rules for the Institute comparable to an IIT and the Professor so engaged should be allowed liberal remuneration for the job."

On item No.4.22, the Board further decided as under:

"Till the post of Deputy Registrar (Academic) is filled up, the Board authorized the Chairman of the Board to engage a retired/retiring Officer from Technical Institute of repute to deal with affairs relating to academic, examination, secrecy and results etc. on contract basis. The Board further authorized the Chairman to decide salary and other terms and conditions of contractual engagement of the aforesaid officer."

In view of the above decisions of the Board, the Institute has engaged Shri S.K Gupta, a Retired Professor of IIT Kanpur for framing Academic Rules for the Institute. He will be paid remuneration of Rs. 1000/- per day plus TA. He will visit the Institute for one or two weeks during one month. It is expected that he will finish the work in four or five visits. Further, Shri S.P.Sharma, a Retired Deputy Registrar (Academic), North Eastern Regional Institute of Science and Technology, Itanagar, Arunachal Pradesh has been engaged as Deputy Registrar (Academic) of the Institute for a period of one year on a consolidated salary of Rs. 14000/- per month.

The Board may note.

By including these eight (8) Doctors in the above panel of Doctors, there will be 3 specialist Doctors in each field of specialization. There will no financial implications involved if the above Doctors are also taken on the panel of the Institute, as the SMO of the Health Centre will refer the patient for only one Specialist for which the patient is in need of consultation. Same pattern is being adopted by the Kurukshetra University, Kurukshetra for their employees.

The above proposal of the Senior Medical Officer for engaging additional eight doctors, has been approved by the Chairman BOG in anticipation of the Board's approval.

Item <u>5.16</u> To consider implementation of Assured Career Progression(ACP) to the non-teaching employees of NIT, Kurukshetra on State Govt. pattern prior to 1.1.2004.

The Institute had been following the State Govt. of Haryana rules on ACP for the Non-teaching employees circulated vide their notification No.GSR-4/Const./Art./309/98 dated 7.11.1998. The Committee at the Institute level last met in January, 2003 to release ACP scales to the Non-teaching employees on the State Govt. pattern. However, the ACP scales were stopped in May, 2003 as per instructions of the Central Govt. received in May, 2003.

The matter regarding grant of ACP scales on the State Govt. pattern to the Non-teaching employees who were eligible during the transit period i.e. before adoption of the ACP scheme on the Central Govt. pattern was placed before the Board in its 4th meeting held on 8.12.2003 (agenda item 4.20). The Board decided as under:-

"In implementation of ACP of the Central Government, a number of Institute employees loose privilege of ACP of the State Government of Haryana. The proposal given in the agenda needs further discussion and decision.

The Board, however, desired that there is strong need to extend monetary incentives to reward good staff members for which the matter may be first examined at the Institute level and then it may be put up to the Board for consideration and decision. The Board further desired that proformae for reporting Annual Confidential Reports of both teaching and non-teaching employees be reviewed".

The Board in its 4th meeting held on 8.12.2003 (agenda item 4.12) decided to adopt service conditions such as (i) Period of probation on recruitment (ii) Leave rules (iii) Conduct & Disciplinary rules (iv) Medical rules (v) Travelling Allowance & Daily Allowance (vi) Leave Travel Concession (vii) Performance Assessment System (viii) Career Advancement Scheme (CAS) (ix) Assured Career Progression(ACP) (x) Working Days (xi) Holidays w.e.f. 1.1.2004 on the Central Govt. pattern in terms of the MHRD letter No. F.20-46/2003-TS-III dated 9.11.2003.

The Non-teaching employees are pressing hard that they should be allowed ACP scales on the State Govt. pattern for the intervening period prior to 1.1.2004. It may be stated that as per State Govt. rules, the ACP scales are required to be released on completion of 10/20 years service whereas in the Central Govt. the ACP scales are granted after completion of 12/24 years of service. There are approximately 40 ACP cases which are pending for disposal during the intervening period i.e. prior to 1.1.2004 and the financial implication on account of releasing the said ACP scales on the State Govt. pattern amounts to Rs. 50,000/- (app.) per annum only.

Item 2.9 To note action taken by the Institute in entering into MOA with M/s CISCO Systems, a company incorporated under the laws of California, USA for conducting software courses jointly with NIT, Kurukshetra.

The Board noted the action taken by the Institute in entering into MOA with M/s CISCO Systems, California, USA.

Item 2.10 To consider constitution of the Equipment & Stores Committee of National Institute of Technology, Kurukshetra.

The Board approved the following constitution of the Equipment & Stores Committee of NIT Kurukshetra:

Item 2.12 To consider the case of Dr. KK Singh, Lecturer in Civil Engineering Department for allowing him Extraordinary Leave (without pay).

The Board allowed Extra-ordinary Leave (Without pay) to Dr. KK Singh, Lecturer in Civil Engineering, NIT Kurukshetra, with effect from 12.1.1999 to 30.12.2002. - 128 -

The Board expressed that in future disciplinary proceedings should be enforced against all those who stay away from duty without authorized/sanctioned leave.

Item 2.13 To consider the case of Dr. Vinay Kumar, Professor in Mechanical Engg. Department regarding regularization of his absence beyond 26.3.2002 to 31.3.2003.

The Board noted the retirement of Dr. Vinay Kumar, Professor in Mechanical Engg. Department on superannuation after attaining the age of 60 years on 31.3.2003. The Board allowed Extra-ordinary Leave (Without Pay) with effect from 31.3.1999 to 31.3.2003.

Item 2.14 To accord approval to the amended minimum qualifications and experience in respect of Director/ Principal/Head of the Institute and Lecturer (Humanities and Sciences) in the Degree Level Technical Institutions.

The Board noted the amended minimum qualification and experience in respect of the Director/Principal/Head of the Institute and Lecturer (Humanities and Sciences) in the Degree level Technical Institutions as per Notification No. FD/Pay/01/2001-2002 dated 28.2.2002 by AICTE. The Board approved the amended qualifications for the post of Lecturer (Humanities and Sciences) with additional condition that he/she must be Ph.D.

Item 2.15 To consider and approve the construction of additional storm water drains and Garbage Bins in the Institute Campus.

The Board approved the proposal of the Institute for the grant of Rs. 10.05 lac out of the College Development Fund (College Share of Consultancy) for the construction of additional storm water drains and Garbage Bins on the campus.

Item 2.16 To consider and approve the leasing out of Oxidation Ponds for fish culture.

The Board approved the proposal to lease out the Oxidation Ponds for fish culture after obtaining legal opinion on this item.

Item 2.17 To consider the letter of the Financial Commissioner and Principal Secretary to Govt. of Haryana, Electronics & Information Technology Departrment, Chandigarh regarding procurement of Computer Systems, peripherals, allied items, Software and Networking directly from HARTRON.

The Board felt that the Govt. of India has taken over the National Institute of Technology, Kurukshetra, completely under its control, so the letter from the Financial Commissioner and Principal Secretary to Govt. of Haryana, Electronics & Information Technology Department, Chandigarh, has become redundant. However, the Board desired that a copy of the advertisement may be sent to HARTRON while purchasing Computer Systems, peripherals, allied items, Software, Networking equipment etc. so that HARTRON can also quote for such purchases.

Item 2.18 To settle the Court case No. MS 136/1998 at Barasat (Kolkata) and 23/1997 at Haryana State Consumer Commission, Chandigarh on mutual agreement.

The Board approved the request of Indian Institute of Psychometry, Kolkata that both parties will not proceed further in the Court through mutual agreement as per the Agenda Item. NIT, Kurukshetra may take further necessary action in this matter.

Item 2.19 To approve engagement of private Doctors in the field of specialization.

The Board approved the engagement of private Doctors in the different fields of specialization as per agenda item with the condition that the number of Doctors on the Panel be around 10-12.

Item 2.20 To consider grant of pay scale of Rs. 16400-450-20900-500-22400 to some of the faculty members promoted as Professors under the Merit Promotion Scheme.

The Board allowed the grant of pay scale of Rs. 16400-450-20900 500-22400 to the following four Faculty Members promoted as Professors in the Merit Promotion Scheme from 1.1.1996 or from the date of joining as Professor whichever is later as given below:

Item 2.21 To consider payment of traveling allowance for travels abroad on official business/training or for attending conferences etc.

The Board allowed traveling allowance for travels abroad on official business/training or for attending conferences etc. as per Agenda Item

Item 2.22 To consider implementation of Career Advancement Scheme (CAS).

The Board approved the implementation of Career Advancement Scheme (CAS) as per Agenda Item and as per AICTE/GOI letters referred therein. The Board very strongly stressed that while implementing the scheme, the main criteria must be the 'performance of the individual in the Institute' not the mere fact that he/she fulfils the eligibility as per CAS. As a special case Hon'ble Chairman, Board of Governors very kindly agreed to Chair the Selection Committee Meeting involving the promotion of Assistant Professor to Professor under CAS.

Item 2.23 To consider the request of Dr. KK Nagpal, Senior Medical Officer to restrict the recovery of excess amount paid on account of Selection Grade of Rs. 4100-5300.

The case of Dr. KK Nagpal, Senior Medical Officer, was discussed in detail. It was felt that recovery is to be made for the period from 1.5.1989 to 8.4.1992 along with interest @ 12% considering the Notification of Health Department, Govt. of Haryana dated 29.10.1996.

In the discussion there was a reference to the last para of its agenda item; however the Board authorized the Chairman to decide about his request for SMO scale.

Item 2.24 To consider medical facilities to the employees of NIT, Kurukshetra.

This item was discussed in detail and after long deliberations, the following decisions were taken:

- A. The Chief Medical Officer of Kurukshetra on advice of Senior Medical Officer of the Institute's Health Centre will refer cases for special treatment in the Hospitals in Haryana as well as outside Haryana as approved by the State Government from time to time as per existing practice.
- B. An advance to the extent of 75% of the proposed expenditure may be allowed to the employees of NIT' Kurukshetra by the Director subject to the availability of funds.
- C. The Director of the Institute is authorized to make reimbursement of valid admitted expenditure up to Rs. 50,000/- which at present is up to Rs. 5,000/only. The medical reimbursement beyond Rs. 50,000/- may be put up to the Finance Committee for approval as per past practice.

Item 2.25 To consider filling up of vacant teaching posts.

The Board lifted the ban imposed on the fresh recruitment for the teaching posts which are duly sanctioned. It was felt that any reduction in teaching posts is not possible for proper teaching. However, the Board felt that a faculty member may be given additional 10% teaching load if there is shortage of faculty in any Department. The teaching load approved by the Board is as follows:

Professor	.=	12	hours/week
Assistant Professor	=	14	hours/week
Lecturer	=	16	hours/week

If any teacher goes on leave, he/she must make the load arrangement so that the classes are not let off.

However, Board was very specific that we should maintain ratio between teaching and non-teaching posts in the range of 1:1.5. The Board felt that to keep this ratio the Institute can do the rationalization of the non-teaching posts by appointing a Committee at the Institute level. The recommendations of such Committee may be got approved from the Board.

Item 2.26 To consider the payment of honorarium to the teachers @ Rs. 200/- per lecture for additional teaching load in addition to the prescribed work load of teaching.

The Board approved the payment of honorarium to the guest faculty @ Rs. 200/- per lecture. The Board further authorized that a lump sum amount of up to Rs. 1000/- may be given to eminent speakers from outside the Institute in addition to TA & DA.

Item 2.27 To consider vacant non-teaching posts.

The Board noted the vacant non-teaching posts in the Institute. The Board is of the opinion that ratio between teaching and non-teaching staff be maintained as 1:1.5. However, in some cases where there is acute shortage of teaching supporting staff separate request may be put

1

up to the Board for allowing a few non-teaching posts. The Institute will do the rationalization as noted in Item 2.25.

Item 2.28 To consider thefts of various items.

The Board allowed the Institute to write off the various theft items as noted in the Agenda Item 2.28. It was felt that the Institute may go in for insurance in case of costly equipment and computers. The Board desired that most of the items which have got obsolete and outdated should be written off and for this comprehensive proposal may be prepared.

Item 2.29 To note the position of legal cases pending in Hon'ble Courts of Law.

The Board noted the position of legal cases pending in Hon'ble Courts of Law.

It was pointed out that there is a need to scrutinize the Court cases excluding those involving disciplinary proceedings. Those which can be settled should be short listed. The Board authorized the Chairman to examine those and take appropriate decision.

Item 2.30 To consider payment of TA to members of BOG/various Committees / Sub-Committees/ Senate / Members and Experts of Selection Committees, High Dignitaries and eminent Speakers.

The Board approved that traveling allowance for performing journey in AC Car/Taxi to the members oſ **BOG**/Various Committees/Sub-Committees/ Senate/Members and Experts of Selection Committees, High Dignitaries and eminent Speakers who visit the Institution may be paid up to Rs. 8/- per Km. However, the present mileage allowance admissible to the Officers of the Institute who are entitled to travel by Taxi/own car will continue to be Rs. 4/- per Km.

Item 2.31 To accord approval to the revised minimum qualifications and experience prescribed for Teaching Posts in Degree Level Technical Institutions.

The Board approved the revised minimum qualifications and experience prescribed for teaching posts in degree level Institutions as per recommendation of AICTE, New Delhi vide letter No. FD/PSSC/Notification/2002/1 dated 19.2.2003. However, the Board decided that the minimum qualification for Lecturer in Engineering subjects be First Class Master's Degree in the appropriate branch of Engineering/Technology.

The Chairman of the Board thanked all members of the Board for their active participation during course of the meeting.

The meeting ended with a vote of thanks to the Chair.

Item No. 5.21 To consider vacant non-teaching posts for lifting of ban.

Due to the ban imposed by the State Government on the recruitment since 1996 and frequent retirement of the non-teaching staff, vacancies are increasing day by day and it has become very difficult to run the classes, labs, various departments and various administrative office smoothly. The Chairmen of the respective departments and Heads of Sections are pressing very hard to fill up the vacant teaching supporting and non-teaching posts as the work is enormously increasing due to manifold activities of the Institute, particularly on its becoming NIT with Deemed University Status. The Government of India, Ministry of Human Resource Development vide letter No.F.32-1/1999-TS.III, dated 28th May, 2003 also issued instructions that no recruitment/promotions should be effected until the new service rules are notified by this Ministry.

A proposal was placed before the Board of Governors in its 2^{nd} meeting held on 19.4.2003 for consideration of non-teaching posts. The Board of Governors decided as under:

"The Board noted the vacant non-teaching posts in the Institute. The Board is of the opinion that ratio between teaching and non-teaching staff be maintained as 1:1.5. However, in some cases where there is acute shortage of teaching supporting staff separate request may be put up to the Board for allowing a few non-teaching posts. The Institute will do the rationalization as noted in item 2.25.

Engineering Department to join the post of Director-Principal in Ch. Devi Lal Memorial Engineering College Panniwala Mota (Sirsa) on deputation basis.

Dr. DVS Verma, Professor in the Department of Civil Engg. of this Institute informed vide his letter dated 12.3.2004 (copy enclosed as Appendix $\frac{X}{X}$ on page 148 that he has been offered the post of Director-Principal of Ch.Devi Memorial Engg. College, Panniwala Mota (Sirsa) by the State Govt. of Haryana vide letter No. 40/31/2003-4TE/Engg. (copy enclosed) as Appendix XUM on page 149 He has requested to relieve him to proceed on deputation basis for a period of two years so that he could join the said post of the Director-Principal by 17.3.2004

The Board of Governors of the Institute in their 91^{et} meeting held on 11.5.99 decided as under :-

- "An employee will be allowed one year's Extra-(a) ordinary Leave for every completed 5 years service subject to a maximum of three years Extra-ordinary Leave during the entire service with the College. However, in case, an employee is appointed to a prestigious position like Vice Chancellor, his EOL may be extended to a maximum of five years."
- (b) An employee will be allowed deputation to a maximum period of three years during his entire service with the College. The deputation only be allowed if it is in the interest of the College, the State Govt. or Govt. of India.
- (c) The total absence of an employee from the College due to EOL or EOL plus deputation will not be allowed to exceed five years under any circumstances during the entire service of the employees.

The deputation rules as per BOG decision dated 24.4.1984 prevalent in the Institute are re-produced below:-

" Resolved that the employees of the College be allowed to go on deputation by the Competent Authority provided they or the organisation, where they proceed on deputation, pay leave salary contribution and also contribution towards gratuity as per rates prescribed by the Haryana Govt. as amended from time to time and also pay towards Contributory Fund as per rates prescribed by the College."

However, the deputation rules on Central Government pattern are as under:

"The deputation will be for a maximum of three years. Deputation to other Ministries/Departments for the fourth year may be granted with the approval of the Secretary of the borrowing Ministry. Extension for one year beyond the fourth year requires the approval of the Minister of the borrowing Ministry, but no deputation allowance is admissible for that period. Extension beyond fifth year can be only with prior approval of the Department of Personnel and Training."

Dr. D.V.S Verma may be allowed to proceed on deputation to join as Director-Principal of Ch. Devi Lal Memorial Engg. College Panniwala Mota (Sirsa)(Govt. of Haryana Institution) for a period of two years from 17.3.2004 to 16.3.2006 on the terms and conditions as referred to above. He has not proceeded on any long leave or any deputation for any assignment during his service in the Institute.

The matter is placed before the Board for consideration and decision.
