The Board of Governors in its 12th meeting held on 25.4.2007 ratified the following decision of the Finance Committee taken in its 10th meeting held on 21.3.2007 with regard to grant of Fixed Medical Allowance to the exemployees of the Institute:

"The Finance Committee considered the proposal as mentioned in the agenda and recommended that fixed medical allowance of Rs.100/- per month may be allowed to an employee of the Institute w.e.f. 1.4.2007 who has since been retired after 1.1.2004 the date from which the Institute adopted service conditions on the Central Government Pattern."

Subject: Economy measures.

Sir.

I have been directed to invite your attention to the subject mentioned above and to state that the matter regarding effecting economy in expenditure in the State has been engaging the attention of the Government for quite sometime. After careful consideration, the Government have decided to take following measures:-

(A) Posts

(i) All the vacant posts including those under the 10% cut in Government Departments/Boards/Corporations which have been lying vacant for a period of more than 3 years in the past and for which no requisition has been sent to HPSC/HSSS Board, stand abolished forthwith. Detailed information regarding the number of such posts abolished and the action taken by all concerned in this connection should be communicated to the Finance Department (in B & C Br.) by 31.5.1992.

(ii) The number of staff employed on daily wages shall be frozen as on 31.12.91. The services of all those daily wages employees who have been engaged after 31.12.91 shall be dispensed forthwith except where there are court orders to the contrary. Any further employment on daily wages basis in future shall be made only after approval from the Finance Department. Detailed information regarding the number of employees engaged in each organisation on daily wage basis as on 31.12.1991 and the number of employees whose services are dispensed with in accordance with those instructions should be furnished to the respective haministrative Secretaries by the concerned departments and also to the Finance Department(in B & C Br.) latest by 31.5.1992.

This decision, however, will not apply to the Engineering Departments in whose case the matter is under consideration of the Government separately. However, the total number of daily wages in these departments as on 31.12.91 shall not exceed till the decision is taken by the Government in this matter.

(h) Vehicles & Touring

(i) The Heads of the departments have been authorised by the Finance Department vide its letter No. 11/6/91-FD III/ 226 dated 13.2.91 to dispose of the condemned vehicles at their own level without referring the cases to the Finance Department. However, these powers were delegated upto 31.12.1991. It has now been decided to further extended this delegation upto 31.3.1993.

(ii) The life of a vehicle, before 1t is considered fit for condemnation, is 5 years coverage of 1,20,000 kms, whichever is enried as per the existing instructions. If has now been iccided to increase this limit from 1,20,000 kms, to 1,60,000 before a vehicle is considered eligible for condemnation.

(iii) It has been noted that the departments send proposals for condemnation and disposal of vehicles once it has completed the prescribed time span or covered the prescribed kilometerage without actually going into the question of suitability of the vehicle for running beyond these prescribed limits. This aspect must be kept in mind while preparing proposals in future. It has also been decided that wherever the body of the vehicle is in good condition, the departments should consider replacing only the engine instead of replacing the vehicles itself. Seats and other upholstery of the vehicle could also be redone/replaced, if so necessitated.

(iv) It has also been decided that all the departments/ organisations should review the availability of the vehicles with them and replacement of a vehicle shall not be allowed except in cases of vehicles earmarked for the Head of the Departments. For others, which are provided as staff vehicles no replacement shall be provided once such staff vehicles complete their life span normally except in cases where F.D. is fully convinced of the new for such replacement. The departments/Organisations should constitute a pool of vehicles of other than the earmarked vehicle and should use such pool of vehicles to meet the requirements of other officers. It has also been decided to encourage the use of personal vehicles for performing of official duties, Accordingly, wherever a Govt. vehicle can not be provided to the officer from within the pool and he is otherwise cligible to perform journeys by his personal car, the same should be allowed by the Controlling Officer. For this purpose, the rates of mileage would also stand revised from %. 2.00 per km. to %. 2.50 per km.

(v) Increase in expenditure on account of POL consumption has been a matter of concern for the State. While increase in the prices of POL is beyond the control of the State, it has been rated that the Controlling Officers of vehicles do not pay adequate attention to the maintenance of vehicles and the levels of consumption of fuel for these vehicles. Poor maintenance of vehicles by drivers not only results in increase in consumption on POL but also have an adverse bearing on maintenance and repair expenditure of vehicles. It has therefore been decided to limit the expenditure on POL at the level of actual expenditure during the year 1991-92. Finance Department shall not be in a position to accept proposals for additional provisions for FOL at the time of revised estimates. The Controlling Officers of vehicles should also pay adequate attention to the maintenance of vehicles and should ensure proper up-keep by the drivers. It

has also been decided to constitute a Committee consisting of the Finance Secretary, the Home Secretary and the Commissioner & Scretary, Transport to go into the question of laying flown the minimum consumption norms for vehicles and framing guidelines which would be followed in this regard.

(vi) While ceiling of 10 day's touring in a month would continue, it has also been decided that the actual touring days would be limited not only for the purpose of claiming TA/DA but else for the purpose of use of vehicles except for local journeys at the place of posting. In other words the vehicle alse shall not be taken-out on journeys beyond 10 days in a month. Officers should make attempt to curtail the touring to barest minimum.

C) Telephones

It has been noted that the expenditure of Telephone bills has been increasing substantially over the period. While the increase in expenditure is admittedly attributable partly to the hike in telephone charges, part of the increase is also on account of lack of control on the misuse of Telephones by the concerned offices. It is a fact that misuse of telephone facilities is continuing even now. This practice of misuse of telephone facilities are controlled. Accordingly, the departments should make an attempt to restrict the expenditure on use of telephones. It has been decided that wherever the telephone bills exceed the prescribed limits, such bills shall be got approved from the concerned Administrative Secretaries. However, in case where the telephone bills exceed the prescribed limits by 100% the cases should be shown to the Finance Department for its approval. Instructions regarding installation of STD barring devices in all the Govt. offices had been issued earlier. It is requested that the keys of these devices must be kept by the Critical controlled and increase in expenditure is restricted on this account.

D) Office Expenses

- i) It has been seen that the departments keep on incurring expenditure under this object without proper advance planning in view of the budget provisions. Resultantly, there are demands for higher provisions at the time of Revised Estimates. This issue was been considered in detail and it has now been decided that no additionality would be provided under this object at the time of Revised Estimates. Accordingly, the Departments are advised to plan their expenditure properly so as to restrict the same at the budgeted level in Budget Estimates 1992-93.
- ii) The propriety of expenditure from the State funds must be kept in mind. Accordingly the departments/board/corporations should desist from incurring expenditure on large scale printing of Greeting Cards on various occasions and diaries etc. The should be at a very limited scale and Greeting Cards/diaries etc. would be issued only by the Heads of departments/M.Ds of boards and corporations. Cases have come to notice where expenditure on postage of Greeting Cards have also been incurred from the Govt. office. This is not admissible, similarly, no Greeting Cards would be supplied free of charge to officers/employees at the expense of the Govt.
- iii) It has also been noted that huge expenditure is insurred on large display advertisements for public functions presided over by the Ministers. There is need to estrict expenditure on this account; and the expenditure on such display advertisements should be restricted to the minimum. It has also been seen that officers in the field offices send special messengers for distribution of invitation cards to Senior functionaries in Chandigarh for the functional in the field. It has been decided that this practice should be stopped.

(E) Execution of capital works-time overruns and the resultant cost overruns.

It has been noted that there is considerable lack of planning in execution of capital works. Consequently, almost all the capital works suffer from time overruns and the resultant cost overruns. The departments, especially the executive departments, should monitor the progress of Capital Works regularly so as to avoid any time overruns and the consequent revisions in estimates. It has now been decided that all Administrative sanctions of new works as have not yet been started. Except, the works as committed in 25-point Programme, woull stand cancelled forthwith. Fresh administrative sanctions would not be issued till it is clear that funds are available for new works after meeting the requirements for on-going works and works included in 25-point Programme. Priorities should be fixed as per above guidelines but within the over all budgetary allocations.

(F) The Burcan of Public Enterprises would review the working of all Beards and Corporations from time to time and recommend action for improvement in their working. All the Boards and Corporations are advised to supply necessary information required by the Burcau for carrying out its mandate. The Burcau shall also examine the issue of multiplicity of functions with various organisations and would review activities where more than one organisation is involved in implementing similar programmes. The Burcau, in such cases would recommend merger of such organisations or taking such activities out-side the purview of such organisations.

These instructions will come into force with immediate effect. The approval of the Chief Minister has been obtained.

I have been directed to invite your attention to the applied mentioned above and to state that on the recommendations of Resources & Economy Committee, the State Covt., after careful consideration, have decided to take the following measures:-

- 1. Reduction in Staff Expenditure:
 - No new posts shall be created either on plan or Non-Plan side.
 - ii) Posts ram ining vacant as on 1.7.96 shall not be filled up. Details of all posts filled and vacant as on 1.7.96 should be sent to Finance Deptt. by 22.7.96.
- iii) The posts rendered vsc nt on addcunt of retirement ofter 1.7.96 shall be filled up only to the extent of 90% and remaining 10% posts shall remain un-filled. It is clarified that posts which have become vecant because of retirement prior to 1.7.96 shall not be filled up as decided in para (ii) above. Indentification of these 10% posts which shall not be filled up for the remaining period of 1996-97 shall be done by the concerned Heads of Departments and conveyed to Finance. Department by 22.7.96.
- iv) Where-ever the Heads of Department feels that any post is require to be filled up, the same may be filled up by merging/re-org mising/re-deployment of steff already evailable within the department. In case these incumbants needs training, they can be retrained as per the requirements of the job by the Heads of Departments

It is felt that present norms for entitlement of staff are quite liberal and therefore, the Administrative Reforms Department has been asked to examine, explore and recommend the new norms for entitlement of staff. However, the suggestions from the departments in this regard and any sucmoto reduction norms shall be Appreciated which may kindly be conveyed to the Secretary Administrative Reforms Department.

It his been decided to impose a % economy cut on overall revenue expenditure provided in the Budget for 1996-97. however, the discretion to indentity the items of expenditure where reduction had to be effected has been left to the concerned deportments and they are requested to review eich scheme Plan and Non-Plan to week out the redundant activities to eliminate duplication and over-lapping of functions as well as the agencies. For this purpose every departments will act as BUDGET CENTRE and the Heads of Departments are requested to carry out the detailed examination, and suggest modifications in their approved budget of 1996-97 so as to achieve the objective of atleast 5% saving.

- 5. Economy on Govt. Vahicles:
- i) Condemnation of Vehicle
- a) It has been decided to revise the condemnation norms for Govt. vehicles from the present mileage limits of 1,60,000 to 1,80,000 kms and the limit from 5 years to 6 years.
- b) Condemnation should be ordered keeping in view the condition of the engine and other vital parts. The vehicles may be retained in use even after expiry of the revised forms provided the vehicle is in good running condition and till the time the vehicle in replacement is made available.

- (c) It has been noticed that some departments are using the condemned vehicles despite the fact that their replacement have been allowed and surchased by them. Therefore, the lieds of Departments should confirm to the Finance Deptt. should confirm to the finance Department by 22.7.96 that such vehicles whose replacements were purchased are not longer in use and have been auctioned as per proper procedure.
- replacement of vehicles shall be allowed only in case of replacement of vehicles which have been condemned. The condemnd vehicles should be suctioned after observing the prescribed procedure at the corliest after replacements are purchased.
- Lepair at Government perhaps :- It has been decided that repair of vehicles at trivate Torkshops be get done only upto an expenditure limits of Ms. 1500/- at a time. However the efforts should not be made to split the large bills into various bills of less than %. 1500/- each. All repair above 4. 1500/- should be done at Govt./bepartment workshops.
- 4. The instructions of the finance bepartment issued from time to time on all matters relating to the economy in expenditure will, however, continue to be effective as before.
- in this requested that fit iled exercise may be done in this regard by all the Heads of Deptts, and the desired information on above points be sent to the undersigned by name by 2..7.96 positively so that the nacessary action may be taken by Pinance Department.

These instructions will come into force with immediate offect.
