In this connection, it is submitted that the membership of Senate nominee on Board of Governors in the category of Professor is lying vacant as the present term of two years of Dr. S. K. Madan, Professor, Civil Engineering Department has expired on 23rd October, 2020.

It is further submitted that the vacancy so created is to be filled from the category of Professor of the Institute by Senate. Previously, Dr. S. K. Madan, Professor, Civil Engineering Department was nominated as Senate nominee member on the Board of Governors in the category of Professor.

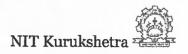

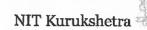

- 9. The students are also required to write their Roll No and signatures on each page of the answer sheet.
- 10. The samples of first and subsequent pages of answer sheets are attached as Annexures A & B respectively.
- 11. The maximum page limit for answering question paper is 30 pages including graphs.
- 12. It is mandatory to specify page number on each answer sheet. As an illustration for a student using 18 pages as answer sheets, page numbering will be as 1/18, 2/18, .... 18/18.
- 13. The students must use blue/black pen only for writing their answers.
- 14. The students shall not mention their mobile number and name on the answer sheet.
- 15. At the end of schedule time, the students will make a PDF file of answer sheet naming it as Roll No.pdf (As an illustration 1181xxxx.pdf) and submit it on the e-mail id of the coordinator/examiner mentioned on question paper.
- 16. The evaluation record of the answer sheets of the course will be saved in excel format and the same will be shared with the students by e-mail after evaluation of answer sheets, before the final submission of awards to the examination branch as per the procedure.

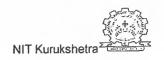

# BoG 54.8 To note the instructions of Ministry of Education letter dated 28.10.2020 regarding Special cash package equivalent in lieu of Leave Travel Concession Fare for Employees of the Institute during the block year 2018-2021.

The Ministry of Education, Govt. of India vide letter F.No.33-3/2020-TS.III dated 28.10.2020 had sent the Ministry of Finance, Department of Expenditure O.M. F.No.12(2)/2020-EII(A) dated 12.10.2020 regarding Special cash package equivalent in lieu of Leave Travel Concession Fare for Central Government Employees during the block year 2018-2021.

The Ministry of Education in its letter dated 28.10.2020 has instructed to the NITs for taking further appropriate action at the Institute level. In the Ministry of Finance letter dated 12.10.2020, it has been mentioned that due to Covid-19 pandemic and resultant nationwide lockdown as well as disruption of transport and hospitality sector, as also the need for observing social distancing, a number of Central Government employees are not in a position to avail themselves of LTC for travel to any place in India or their Hometowns in the current Block of 2018-21.

Therefore, to compensate and incentivise consumption by Central Government employees thereby giving a boost to consumption expenditure, it has been decided that cash equivalent of LTC, comprising Leave Encashment and LTC fare of the entitled LTC may be paid by way of reimbursement, if an employee opts for this in lieu of one LTC in the Block of 2018-21 subject to the following conditions:-

- a) The employee spends the money of a larger sum than the entitlement on account of LTC on actual expenditure.
- b) Cash equivalent of full leave encashment will be allowed, provided the employee spends an equal sum. This will be counted towards the number of leave encashment on LTC available to an employee.

c) The deemed LTC fare for this purpose is given below:-

Category of employees	Deemed LTC fare per person (Round Trip)
Employees who are entitled to business class of airfare	Rs. 36,000
Employees who are entitled to economy class of airfare	Rs. 20,000
Employees who are entitled to Rail fare of any class	Rs. 6,000



- d) The cash equivalent may be allowed if the employee spends a sum 3 times of the value of the fare given above.
- e) The amount both on account of leave encashment and fare shall be admissible if the employee spends (i) an amount equal to the value of leave encashment and; (ii) an amount 3 times of the cash equivalent of deemed fare, as given above on purchase of such items / availing of such service which carry a GST rate of not less than 12% from GST registered vendors / service providers through digital mode and obtains a voucher indicating the GST number and the amount of GST paid.
- f) The admissible payment shall be restricted to the full value of the package [leave encashment as admissible for LTC and deemed fare] or depending upon the spending.
- g) While TDS is applicable in the case of leave encashment, since the cash reimbursement of LTC fare is in lieu of deemed actual travel, the same shall be allowed exemption on the lines of existing incometax exemption available to LTC fare. The legislative amendment to the provisions of the income-Tax Act, 1961 for this purpose shall be proposed in the due course. Hence, TDS shall not be required to be deducted on the reimbursement of deemed LTC fare.

A copy of the Ministry of Education letter dated 28.10.2020 along with Ministry of Finance, Department of Expenditure O.M. F.No.12(2)/2020-EII(A) dated 12.10.2020 regarding Special cash package equivalent in lieu of Leave Travel Concession Fare is enclosed as <u>Annexure – 54.8 (i) from pages 58 to 61</u>.

Head of the Departments/DDOs may make reimbursement under this package as per the details given above on receipt of invoices of purchases made/services availed during the period post the issuance of this order from the employees who are desirous to avail this package. It may be noted that in order to avail this package an employee should opt for both leave encashment and LTC fare.

An amount upto 100% of leave encashment an 50% of the value of deemed fare may be paid as advance into the bank account of the employee which shall be settled based on production of receipts towards purchase and availing of goods and services as given in Para 2(e). The claims under this package (with or



without advance) are to be made and settled within the current financial year. Non-utilization/under-utilization of advance is to be accounted for by the DDOs in accordance with the extant provisions relating to LTC advance i.e. immediate recovery of full advance in the case of non-utilisations and recovery of unutilized portion of the advance with penal interest.

These orders will take effect from the date of issuance of this Office Memorandum and will be in force during the current financial year till 31st March, 2021.

The Ministry of Education, Department of Higher Education, Technical Section-III vide letter F.No.33-3/2020-TS.III (Pt.) dated 19.11.2020 had forwarded the CDN Section, Department of Higher Education letter No.C.29011/02/2019-CDN dated 17.11.2020 alongwith letter of Bharat Sanchar Nigam Limited dated 26.10.2020, letter of Ministry of Communication, Department of Telecommunications dated 12.10.2020 and letter of Ministry of Finance, Department of Expenditure dated 04.09.2020 for mandatory utilization of network of Bharat Sanchar Nigam Limited (BSNL) and Mahanagar Telephone Nigam Limited (MTNL) for internet/broadband-landline/leased line by all Ministries/Departments of Government of India/Central Public Sector Undertakings (CPSEs)/Autonomous Bodies etc. under Central Government.

# BoG 54.10 To adopt the instructions of the Vigilance Section, Ministry of Education O.M. dated 06.01.2021 regarding submission of immovable property return by the employees of Autonomous and subordinate Institutes/Organizations of the Ministry.

The Ministry of Education, Department of Higher Education, Vigilance Section had issued Office Memorandum vide No.C-19011/7/2017-Vig. dated 06.01.2021 along with OMs dated 09.01.2020, 11.01.2019, 21.12.2017, 20.06.2017, 05.04.2016 and 13.08.2015 regarding submission of Immovable Property Return by the employees of autonomous and subordinate institute/organizations of the Ministry.

The Ministry of Education in its letter dated 06.01.2021 has instructed to the autonomous and subordinate institutes/organizations under this Ministry that Rule 18 (1) (ii) of the CCS (Conduct) Rules requires submission of Annual Property Returns by all Gorup "A" and "B" Officers in respect of immovable property by 31st January of each year. Normally such a provision exists in all organizations even where organizations have their own conduct rules. As per guidelines issued by DoPT vide its Office Memorandum No.11012/11/2007-Estt.A dated 27th September, 2011, vigilance clearance shall be denied to an officer if he fails to submit his annual immovable property return of the previous year by 31st January of the following year, as required under Gol decisions under Rule 18 of the Central Civil Services (Conduct) Rules, 1964.

All Institutes/organization are required to circulate guidelines regarding submission of IPR by 31st January. However, it has also come to notice that these guidelines are not circulated by the Institutes. Due to non-circulation of the guidelines by the Institutes, officers working in various Institutions/organizations under the administrative control of this Ministry do not submit their Annual Immovable Property Return within the prescribed time limit and the concerned organizations are not making any serious effort to issue instructions to their employees in this regard. Often request for vigilance clearance are received from the concerned Bureau without certification of submission of IPR within the prescribed time limit and this results in denial of vigilance clearance.
