NOTIFICATION


The Senate decided to give mercy chance to the students of B.Tech. 2009 batch onwards to appear for Odd as well as Even Semester re-appears after a gap of one-year from the completion of maximum duration of B.Tech. degree i.e. eight years, subjects to the following conditions:

1. They will be given only one mercy chance for odd semester reappear and one chance for even semester reappear during regular examination sessions for odd & even semester respectively.
2. The students should not have more than 10 reappears in total. Further, the student should not have more than five reappears in odd semester and five reappears in even semester.
3. Internal and External reappear will be counted as separate reappear wherever applicable.

Further, the Senate in its 36th meeting vide item no. S 36.05 decided to conduct even and odd end semester reappear examinations simultaneously in Nov./Dec.-2019 and May/June-2020 exam session.

Therefore, the students of 2011 batch who fulfil above conditions have to exercise appropriate option given in the mercy application form for mercy chance in May-June 2020 and/or Nov-Dec, 2020 examinations and submit the same in the office of Dean (Academic) on or before February 07, 2020 positively.


