can be further extended by another two years on the recommendations of a valid Selection Committee. However, his/her services would be automatically regularised on the same post in the same Pay-Band and the same AGP from the date of his/her acquiring Ph.D. degree within the stipulated period.

The regularisation of such Assistant Professors may be carried out as per the terms and conditions of the appointment letter and Recruitment rule prevailing at that point of time."

 The meeting of the Committee constituted to devise norms for implementation of the four-tier flexible cadre (faculty) structure for both the new and the existing faculty in NITs, IIITs and ISM-Dhanbad was held under the Chairmanship of Additional Secretary (TE) on 16th December, 2013 (Monday) at Ministry of Human Resource Development, Shastri Bhawan, New Delhi.

The Committee in its aforesaid meeting resolved the following:-

- That there would be no automatic migration to the salaries and AGP's of the four-tier flexible faculty structure;
- Any change of the Grade Pay under Four-Tier will be purely through open advertisements and on the recommendation of duly constituted Selection Committees;
- (iii) Those who*do not fulfill the essential qualifications, relevant experiences and other essential requirements as in <u>Annexure</u> – I [pages 3 to 4], however, will continue in the present grade;
- (iv) As an eligibility criteria for the post of Professor, the requirement of minimum four year's experience at the level of Associate Professor shall mean that of Associate professor under the Four-Tier System i.e. at the AGP of ₹9,500/-Associate Professors of three tier system with Academic Grade Pay of ₹9,000/- shall also be eligible but with seven year's experience, if they meet the relevant academic requirements for the post.

- (v) Professors with ₹10,500/- AGP will only be considered for HAG Scale in accordance with Ministry's letter dated 22nd March, 2013 and the concerned Professor has to have 6 (six) years of service in AGP of ₹10,000/- or higher, and
- (vi) The academic criteria as approved by the Council of NITs [<u>Annexure – I]</u> has to be used in conjunction with the Ministry's letter F.No.33–9/2011–TS.III dated 23rd August, 2013 [<u>Annexure – II (pages 5 to 7)</u>] for selection under four-tier flexible pay structure.

 The Recruitment Rules and other guidelines to be adopted by the Board of Governors (BOGs) are attached at <u>Annexure – III [pages 8 to 22]</u>.

Sir,

This Ministry had received a reference from MNNIT, Allahabad seeking clarifications regarding applicability of the provisions of NIT Faculty Recruitment Rules, 2011 on Assistant Professors who were appointed in the Institute on contract as per provisions contained in above said Rules prior to the Implementation of 4-Tier Flexible Faculty Structure. These Asst. Professors were not having Ph.D. degree at the time of their contractual recruitment following the provisions of 3 Tier System for Faculty recruitment in NITs.

2. One of the conditions of the contract signed between the appointees and the Institute was that "as the appointee do not possess a Ph.D. degree which is an essential requirement, the post is offered initially for a period of three years which can be further extended by another two years on the recommendations of a valid Selection Committee. In the mean time the appointee will have to acquire Ph.D. degree, failing which the contract may not be extended beyond the period of five years. However, his/her services would be automatically regularised on the same post in the same Pay-Band and the same AGP from the date of his/her acquiring the Ph.D. degree within the stipulated period."

 Therefore, a clarification was sought by MNNIT, Allahabad whether such faculty can be regularised as per the rules and conditions of the appointment letter / contract or not in view of the fact that 4-Tier Flexible Faculty Structure is in vogue.

4. This matter was examined in this Ministry in consultation with D/o Legal Affairs, M/o Law & Justice. The regularisation of such Assistant professors (mentioned in Institute's letter dated 7th February, 2017) may be carried out as per the terms and conditions of the appointment letter and Recruitment rule prevailing at that point of time.

BoG 43.27 To consider the fixation of minimum pay in the Pay Band-3 of Rs.15600-39100 plus AGP of Rs.7000/- in respect of Assistant Professors recruited in the year 2012 and 2013.

The Institute had recruited 25 Assistant Professors during the year 2012 and 2013 against the Advertisement No.14/2012 and No.05/2013 for various disciplines (under the standard 3-tier rigid faculty structure) following the Model Recruitment Rules (MRRs) received from the MHRD, Government of India vide OM No.F.33-7/2001-TS.III dated 14.03.2012 which were approved by the Board of Governors of the NIT, Kurukshetra.All the above said 25 Assistant Professors were appointed on the basis of Ph.D. qualification and placed in the Pay Band-3 of Rs.15600-39100 plus AGP of Rs.7000/- without any advance increment.

The admissibility of advance increments at the time of recruitment for the post of Assistant Professor (on probation against the regular position) in PB-3 with AGP of Rs.7000/- was not mentioned in the Model Recruitment Rules. Therefore, the initial pay fixation for the post of Assistant Professor on a regular post was made at the minimum of the Pay Band-3 of Rs.15600-39100 with AGP of Rs.7000/- without any advance increment.

Now all the above said Assistant Professors have represented that their pay should be fixed at Rs.18600/- + Rs.7000/- = Rs.25600/- in terms of Fitment Table notified by the MHRD alongwith OM No.F.3-1/2009.U.I dated 04.06.2009 <u>Annexure – 43.27.(i) from pages 275 to 276</u>. Further they have also represented that the benefit of seven non-compounded increments should also be granted to them on acquiring the Ph.D. degree in terms of Clause-2 (a) of OM dated 18.08.2009.

To minimize the court cases and to look into the pending issues of faculty and non-faculty staff members of the NIT, Kurukshetra, a High Level Committee of the following experts has been constituted vide letter No.Gen-1/3962/7635 dated 23.11.2016:

> 1. Shri S.C. Narang Chairman Former Chief Controller Resources and Management, DRDO Head Quarters & Former Chairman, Centre for Personnel Talent Management, DRDO, New Delhi

2. Shri Suresh Chand Former Chief Administrative Officer, TBRL, DRDO, Chandigarh.

The said matter was placed before the High Level Committee and the said Committee after going through the relevant documents, submitted its report on 12.07.2017 <u>Annexure – 43.27.(ii) from pages 277 to 279.</u> with the following recommendations:

"The Assistant Professors who had joined the services of the Institute with Ph.D. degree and granted the AGP of Rs.7000/- should be considered to refix their pay in the Pay Band to Rs.18600/- instead of Rs.15600/- as per the fitment table circulated by the MHRD vide their letter No.F.3-1/2009-U.I dated 04.06.2009."

The method of pay fixation as represented by the Assistant Professors has been provided in the new pay revision in terms of 7th Central Pay Commission and notified by the MHRD, Government of India vide OMF.No.15-4/2017-TC dated 27.10.2017 <u>Annexure – 43.27.(iii) on page 280.</u>

In view of the position as explained above, the matter is placed before the Board of Governors to consider *the fixation of minimum pay in the Pay Band-3 of Rs*.15600-39100 plus AGP of Rs.7000/- in respect of Assistant Professors recruited in the year 2012 and 2013 as per the recommendations of High Level Committee dated 12.07.2017 and the MHRD, Govt. of India OM dated 27.10.2017.

Committee was informed that Department of Law & Legal Affair, Ministry of Law & Justice had mentioned in Para of NS EO No.272733/Adv.-B/2017 that "on successful completion of Ph.D. within the specified period (i.e. Maximum 05 years), the services of the employees would be automatically regularized on the same post, in the same Pay Band with same AGP from the date of his/her acquiring the Ph.D. degree" while according the opinion on the application of Recruitment Rules at -appropriate time.

The Committee has gone through the representations submitted to the Institute by the said members alongwith the supporting documents, the Model Recruitment Rules (MRR) of 3-tier system, condition of their appointment letter and the proforma of pay fixation in respect of each member to identify the stage of anomaly has taken place.

The committee on having gone through all the said documents and personally hearing the affected Assistant Professors as well asyofficers and

staff members of administration who have carried out the pay fixation to understand the methodology followed by them by fixing the pay have observed that:

- (I) The terms of appointment of all the faculty members are as per the MRR under 3-tier system. The initial pay of the said faculty members was fixed in the Pay Band-3 AGP Rs.6000/- at Band Pay of Rs.15600/- i.e. initial stage of PB-III with two advance increment for M.Tech.
 - (II) All the said Assistant Professors were granted the AGP of Rs.7000/- on acquiring the Ph.D. as per their terms and appointment or who were appointed initially with the qualification of Ph.D.
 - (III) The claim of the said Assistant Professors for granting initial increments on regular appointments to the said post is contrary to the rules & instructions provided under the 3-tier system. Since there is no such provision for granting initial increments at Rs.7000/- AGP.
 - (IV) The anomaly has taken place while fixing the pay is that while granting the AGP of Rs.7000/-, the initial pay in the pay band for AGP Rs.6000/- was considered instead of the pay in the initial pay band for AGP Rs.7000/-.
 - (V) The Assistant Professors who were granted the AGP of Rs.7000/on completion of Ph.D. degree needs to be reviewed as per the said contents referred by Department of Legal Affairs, Ministry of Law in their Notification No.272733/Adv.-B/2017 dated 24.05.2017 to regularize the service of such Assistant Professors in the same post, same Pay Band and same AGP.

 The AGP of Assistant Professors who are granted AGP of Rs.7000/- on completion of Ph.D. degree & may be reviewed and regularized their services from the date of completion of their Ph.D. in the AGP of Rs.6000/- as per their terms of appointment.

BoG 43.28 To consider the extension of contractual appointment of the Assistant Professors appointed on long contract in Pay Band-3 with AGP of Rs.6000/-.

The Institute had recruited Assistant Professors during 2012 and 2013 on contract basis initially for a period of three years in the Pay Band-3 of Rs.15600-39100 with AGP of Rs.6000/- following the Model Recruitment Rules (MRRs) received vide MHRD letter No.F.33-7/2001-TS.III dated 14.03.2012 duly approved by the Board. As per Model Recruitment Rules, a Clause was inserted in the appointment letters of the said Assistant Professors that their services will be regularized only on acquiring the Ph.D. Degree within the specified period of three years or extended period of two years, as the case may be, and after satisfactory completion of their initial or extended probation period. However, they will earn their annual increment as per rules.

Thereafter, to consider the extension of contractual period by two years for the said faculty members was placed before the Board of Governors in its 39th meeting held on 05.04.2016 vide agenda No.39.11 and the Board decided as under:

"The Board considered the matter and after detailed discussion the Board approved the extension of contractual appointment by two years for the faculty members appointed on three years contract under the standard 3 tier rigid faculty structure."

In compliance of the above said decision of the Board of Governors, on completion of initial period of three years, the contractual appointment was extended upto a period of two years in respect of the above said Assistant Professors and the said period of two years is also going to expire shortly but 28 Nos. of Assistant Professors could not complete their Ph.D. degree till now <u>Annexure – 43.28.(i)at page</u> <u>283</u>. The said Assistant Professors were asked to inform the office about the status of their Ph.D. degree on or before 27.11.2017, but they have informed that their Ph.D. work is still under process, so they have requested to extend their contractual appointment till the completion of their Ph.D. in their discipline.

In this connection, it is submitted that the Institute received representations from some Assistant Professors appointed on contract basis in various departments in AGP of Rs.6000/- mentioning therein that NIT Calicut, NIT Mizoram and VNIT Nagpur have extended the contractual appointment of Assistant Professors for a further period upto 2½ years beyond the completion of stipulated period of their contractual appointment. Copy of the one sample representation is enclosed as <u>Annexure 43.28.(ii) from pages 284 to 293.</u>

In view of the position as explained above, the matter is placed before the Board of Governors to consider *the extension of contractual appointment of the Assistant Professors appointed on long contract in Pay Band-3 with AGP of Rs.6000/for a further period beyond the completion of their stipulated period of five years.*

With due respect, in response to the letter (No. Estt.-I/PF/379/5884, Dated: 21-11-2017) received on 22-11-2017 at 04:10 PM, I, Satnam Singh, joined Mechanical Engineering Department as Assistant Professor (No. Gen-1/SRD/12/566, dated 04-02-2013) on 8th February 2013 (Forenoon). As per the condition of regularization of service after completion of Ph.D. within the stipulated period of 3+2 years from the date of joining at the present post, I had to complete the Ph.D. on or before 8th February 2018. But as I joined the institute in the month of February, 2013 and the new academic session started in August, 2013. So I got my Ph.D. registered on 9th August, 2013 late by six months. Thus I did not get the stipulated time to complete my Ph.D. work. My Ph.D. work is complete and I am waiting for the acceptance of publications of my communicated papers which is a prerequisite for pre-synopsis. My all Ph.D. progress reports are also satisfactory. I will submit my Ph.D. thesis report, as soon as I will receive the acceptance notification for the publications. It is worth to mention here that, there is uncertainty in time taken for the review process and for the defence of Ph.D. work. Some NIT's have given extension to their faculty members up to two and half years, recruited under the same terms and conditions (MRR, Tier-3). Therefore, I humbly request to extend my service for two more years on the basis of summary attached herewith as Annexure-I (Ph.D. work status summary) and Annexure-II (Service summary).

The extension of two years should be given due to the following important reasons.

- 1. I am working in the field of fibre reinforced composite (FRP) fabrication and testing. I developed a new type of material for ship building applications using FRP along with stainless steel sheets. As the experimental facilities to perform the mechanical testing of composites are not available in NIT Kurukshetra. The machines required to perform the experimentation in strength of materials laboratory are not working for many years. Therefore I had no option other than to go outside NIT Kurukshetra for experimentation. The machines and equipments used during research work at other institutes / laboratories are mentioned below.
 - a) Universal testing machine (UTM) with tensile, compression and bending fixtures at IIT Jodhpur, Rajasthan.
 - b) Izod impact testing machine and UTM at CITCO Chandigarh.
 - c) High speed shear homogenizer, Vacuum degasser setup, Ultra-sonicator setup at Thapar University, Patiala, Punjab.
 - Field emission scanning electron microscope at IIT Roorkee, Uttarakhand and Aligarh Muslim University, Aligarh, Uttar Pradesh.
 - e) Shear machine at IIT Jodhpur, Rajasthan.

The maximum time was exhausted during fabrication and testing of specimens. Because these facilities are not available in NIT Kurukshetra, so I went to above mentioned institutes during weekends and in vacations to complete the experimentation work. Lot of time was wasted due to travelling to above mentioned **idstu**tes. The other reason for the delay in the experimentation work is that the time slot was not readily available at other institutes due to high rush of their own students. Due to the unavailability of lab facilities at NIT Kurukshetra, I was unable to complete work on time, which results in the delay of submission.

2. As per the terms and conditions of MRR, NIT Kurukshetra has to provide each and every facility to pursue the research work in time. I was in need of four chamber water bath to perform the hygrothermal study during my research work. I applied for the permission to buy the same in tribology lab from plan grant. It could be helpful for M-tech students also. Head of Department (Mechanical Engineering) moved my file on urgent basis, but there were further delays due to poor administration and the setup was not purchased till date. Ultimately, I had to buy it from my hard earned money after a delay of one year.

3. As per the terms and conditions of Ph.D. prospectus, the maximum time given to complete Ph.D. in NIT Kurukshetra is 7 years for both full time research scholars and part time research scholars. Now, there is a provision to further extend it up to two more years (i.e. total-09 years). I am a part time research scholar cum a faculty member. I have to perform several other duties like NBA work, M-tech guidance, B-tech project guidance, regular teaching load etc. along with Ph.D. research work.

4. There is uncertainty in time taken by the journals to publish a research paper. This process involves various sub-steps like review of article, revision, acceptance, publication and the time taken for each step is not fixed which results in the delay of submission.

 Other NIT's like NIT Calicut, NIT Mizoram, and VNIT Nagpur etc have given extension in service to their employees up to 2.5 years to complete their Ph.D. (Supporting documents attached). Those faculty members are also working under the similar terms and conditions of MRR (Tier-3).

Some of the faculty staff members of the Institute have represented that they have been promoted under CAS from the date of decision of the Board of Governors while they should have been promoted from the actual date of eligibility in terms of Clause-4(q) of OMNo.F33-7/2011-TS-III dated 14.03.2012 notified by the MHRD, Government of India. The Clause-4(q) of OM dated 14.03.2012 is reproduced below:

"All Institutes shall strive to conduct annual selection processes regularly. In case of Institutes that have not conducted CAS interviews for 3 years or more, Selection Committee may, as a onetime measure, examine scholastic contribution of internal candidates made after the last interview and recommend a salary and AGP they would have earned now, had the Selection Committee met at the appropriate time."

To minimize the court cases and to look into the pending issues of faculty and non-faculty staff members of the NIT, Kurukshetra, a High Level Committee of the following experts has been constituted vide letter No.Gen-1/3962/7635 dated 23.11.2016:

Effective date of pay fixation of Assistant Professors

The Committee assembled on 20.12.2016 at 9:30 am in the Board Room of the Institute. The committee was apprised about the facts of the case by Prof. I/C (Admin & PR) Prof. V. K. Bajpai.

Committees Assembled at 09:30 am on 19.12.2016 in the Administrative Block of the Institute.

Committee was apprised in regard to the pay anomaly cases of Assistant Professors who were promoted / placed in the PB 3 AGP-7000/- and AGP of Rs. 8000/- with the effective date of promotions from the date of approval of BoG consequent to the promotion/placement of Assistant Professors against the one time opportunity provided by MHRD vide their letter no. F.33-7/2011-TSIII Dated 14.03.2012 (Annexure I).

Committee interacted with some of the affected Assistant Professors to have their version of their claimed anomaly.

Most of the Assistant Professors have raised the issue of effective date of the promotion i.e. the date of eligibility for promotion rather than from the date of approval by the BoG

as per the instructions /provisions under MHRD Letter No. F.33-7/2011-TSIII Dated 14.03.2012 (Annexure I)

Committee on having gone through the representations of affected Assistant Professors, instructions issued by the MHRD, approval of BoG and relevant correspondence of administrative office observed that:

- i. The Institute is governed by the rules as were applicable to UGC/AICTE in regard to the promotion of Faculty Members under CAS under 3tier system before 14th march 2012.
- Although the Institute invited the applications for promotion under CAS to all Faculty ii. Posts vide Notification No. Estt.-I/CAS/6992 Dated 25.11.2010 (annexure II). In response the applications were received from eligible Faculty Members. The Interviews were held only for the promotion to the post of Professors. The process for selection to the other Faculty Posts were held in abeyance without assigning any reason thereof.
- iii. Institute took up the special Recruitment drive for filling up the backlog vacancies reserved for SC/ST vide Notification Advertisement No. 14/2012 (Annexure III) at AGP of Rs 7000/. The incumbent Assistant Professors at AGP of Rs 6000/-, who had Ph.D. were also called for interview for upgradation to AGP of Rs 7000/-. Except one, all the incumbent Assistant Professors could not get through. Although these Assistant Professors were made eligible for same upgradation next year by the Institute as per guidelines of MHRD/UGC.

At the instance of MHRD instructions to the Institute for taking up the promotion process as one time measure to fill the backlog vacancies as per UGC / MHRD guidelines Institute had called for the applications from the eligible Faculty Members vide Notification No. Estt-I/1684 dated 13.03.2013 (Annexure IV) and the process of promotions of Faculty Members was taken up. The Faculty Members so promoted were given the effective date of promotion from the date of approval of BoG. Whereas the effective date of Notional Promotion should be from the date of their eligibility as provided under Para '4q' of MHRD Letter No. F.33-7/2011-TSIII Dated 14.03.2012 (Annexure I).
- vi. Committee was also apprised that Hon'ble High Court Agartala vide their Judgment Dated 31.03.2016 has extended the benefit of CAS to all eligible Faculty members. The appeal of the institute in the case was dismissed vide Hon'ble High Court order dated 05.05.2016 (Annuxure V). MHRD vide Para '4q' of their Letter No. F.33-7/2011-TS.III Dated 14.3.2012 has also provided that "All Institutes shall strive to conduct annual selection processes regularly. In case of Institutes that have not conducted CAS interviews for three years or more, Selection Committees may, as a onetime measure, examine scholastic contribution of internal candidates made after the last interview and recommend a salary and AGP they would have earned now, had the Selection Committee met at the appropriate time". Taking into account the said para '4q' NIT Calicut granted the promotional benefit from the date of eligibility (Annexure VI).
- vii. Mr. Karan Sharma, Mr Sandeep Santosh, Anil Dahiya and Arvind Sharma claimed that they were eligible for the AGP of Rs.8000/- & Rs.9000/-, but were considered for granting only to the AGP of Rs.8000/- with effective date of promotions from the Date of approval of BoG^a i.e. 22.08.2013 whereas the committee should have considered the effective date from the date of eligibility.

Recommendations

Committee in view of the said observation is of the considered opinion:-

 Revised Selection Committee should consider the applications received from the different faculty members vide Institute's Letter No. Estt.-I/CAS/6992 dated 25.11.2010 where the promotion processes were withheld during the year 2010.

Sir / Madam,

I am directed to refer to the various communications leaved by this Ministry on the rules and regulations for promotion under Career Advancement Scheme (CAS) for faculty members of the National Institutes of Technology (NITs). The Ministry has received a number of representations from the faculty members of the NITs on the implementation of OAS. The issue had also been discussed in meetings of the Board of Governors (BoGs) of NITs, wherein concerns have been expressed.

2. In order to resolve the issue, a Committee (under the Chalimanship of Prof. Sunil Kr. Salangt, Director, NIT-Rourkela) was constituted for removal of pay anomalies. The report submitted by this Committee was examined in the Ministry. If was felt that the instant issue was intricately linked with the Recruitment Rules for faculty posts.

In order to approach the instant issue from a holistic perspective and in the backdrop of a need for Recruitment Rules, it was considered necessary to examine these two issues afresh. Accordingly, a Special Committee was set up under the Chairmanship of Issues arresh. Accordingly, a opecial committee was set up under the unalimitation of Prof. Sarangi, Director, NIT -- Rourkela vide this Ministry's order R.No.24-1/2010-TS.ill dated 27.07.2011 and 23.08.2011. The Sarangi Committee articidatafled examination of the aforesaid issues submitted its report to Standing Committee of the Council of NITs in its meeting held on 15.11.2011 under the Chairmanship of Dr. R'A. Mashelkar, The Council of NITs in its 3rd meeting held on 18.11.2011 resolved to, accept the recommendations of the Sarangi Committee for Implementation of CAS & Recruitment Rules of faculty in NITs, as modified by the Standing Committee: 4.

Subsequent to the resolution of the NIT Council, representations have been received in the Ministry from several NITs regarding the decisions taken for removal of anomalies, faculty promotions, condition of service, etc. These representations have since been examined in the Ministry in consultation with certain Charpersons of the BoGs and Directors of NITs. After due deliberations, the following general and specific

Career Advancement Scheme (CAS) is an integral part of a rigid staff structure where this number of posts at any given level is limited. Such a scheme provides an avenue through which a dual fied employee climbs to the higher rung of the career ladder, even if there is no vacancy. It, however, will not be theated as mere formality as the putpose of the scheme was for development of merit and not eligibility based promotions.

For a faculty member to gain advancement under CAS, he or she must satisfy the approved criteria under three broad heads. (i) a critical number of years in the lower level or designation and/or AGP. (ii) sumulative academic performance during the service period at the current level in terms of teaching and research output as well as sharing institutional responsibility, and (iii) proficiency and knowledge in one's chosen field of research and teaching. Superior report in all these three fronts gualifies a faculty member for advancement to a trigher level.

CAS has been in operation in Institutions under guidelines provided by AICTE and UGC, It is clatified that those norms and procedures are not applicable to NITs, CAS in NITs will be governed by guidelines and regulations defined by the Ministry of HRD and the Council of NITs.

The Directors will be assisted by an in-house Advisory Committee on Faculty Redruitment (ACcFAR). Necessary details of this Committee are provided in the Redruitment Aules for faculty positions.

Any distinction between faculty recruited against vecant positions and those promoted under CAS will be abolished completely. It is distributed emphatically that funlike the UGC system, there is no distinction in qualification or achievement between internal and external candidates while assessing their suitability for higher post as in the practice prevalent in the IIT system.

All recommendations of the Selection Committee shall take effect only from the date of approval of the recommendations by the Board or any later date as decided by the Board. There shall be no retrospective implementation of recommendations in any case (either financial or notional).

The constitution of the Selection Committee, the procedure and criteria of selection shall be same for internal and external candidates. There shall not be a separate or special interview for CAS selection; interviews should be conducted elong with candidates for direct recruitment against vacancies. If any,

All Professors Prespective of the mode of selection should start at the basic pay of Rs 43,000/- and AGP of Rs 10,000/- dn of after 01,01,2006.

When a vacancy occurs in the higher posts and there are serving faculty members with corresponding designation under CA3 sthey must be adjusted as per the respective seniority list before freah advertisements are published. For a faculty member, there should be no distinction draws between a CAS past or an direct selection post. Reservation principles for categories specified (viz, SC / ST / QBC) should be honoured.

Under special circumstances, if an institute is looking for new faculty at Professor or Associate Professor level with expertise not available within the Institute; the Board of Dovernors (on recommendations of the AOdFAR) can earmark a vacant position exclusively for external recruitment.

Any promotion or enhancement of Pay Band of Grade Pay, already implemented by the institute should be got reviewed / examined by the Board by a duty constituted Selection Committee (Immediately) Any increment paid over the beginning of the scale of Associate Professor to those Assistant Professors who did not complete 3 years, is to be recovered from future pay.

The orders issued by the Ministry following the 6° Central Pay Commission provides minimum number of years of service to go to a higher AGP or a higher designation, e.g. 3 years from AGP Rs 6 0004 to Rs 1 6004 of from AGP Rs 7,0007 to AGP Rs 5,0007 etc. These are to be implemented only through the formal selection process. Addinal Selection Committee tas per the NIT Act. 2007 and the Statutes of 5 TS must examine the candidature and ensure that an enhancement is recommended on the strength of academic contribution expected of a faculty member of an institution of National Importance.

The minimum duration prescribed by the Pay Commission for eligibility to move to higher AGPs are applicable only to performing feaulty delivering quality academic output. A faculty memory apart from satisfying the minimum duration requirement must meet academic and related standards set out in Recultinent Rules before being considered by the Selection vertice, Actual selection will depend on academic (research teaching, writing and academic administration) performance.

The eligibility onlettal (number of years in lower AGP) should be seen as necessary but not sufficient condition for upgradation of AGP, or phange of designation. Any upgradation can be done only on recommendation of a duly upgradation about the as serious, and digbilited as that for change of designation. A cancidate must convince the Selection Committee that he of she engaged in scholaste pursuits (teaching, research and minagement) to deserve an upgradation after his / her last advancement.

Existing faculty members without Ph.D. degree must direct (al least 50% of their time during semester days) and during vacations and fiolidays towards completing their Ph.D. A faculty member without Ph.D. will not earn any ensure that such faculty members are reasonably freetfrom non academic duties to ensure that their Ph.D. gets completed before they are considered for enhanced AGP. A concerted effort must be made to make all faculty members of all NITs obtain Ph.D. degrees.

In case of upgradation of AGP of Professors to HAG scale, personal interview shall be dispensed with. The Selection Committees constituted as per the Statutes for the selection of Faculty, shall make their recommendations on

the strength of published work, petents, spansored projects, consultancy, continuing and distance education, PHD, guidance and contribution to the administration of the institute, including service in other comparable institutions if on sanctioned leave, atc. as submitted by the candidates.

All NITs will be required to adopt the 4-tier flexible facility structure (presently operating in IITs, IIMs, IISERs and NITIE) within a time frame to be determined by Council of NITs.

In view of the above, it is requested that the above guidelines may be adopted by the respective BoOs so as to undertake promotion under CAS while adhering to the basic principles of Government rules & regulations and relevant instructions. In case, any further difficulties are noticed within one year of the issue of these guidelines, the same may be placed before the Special Committee constituted by MHRD (vide order F.Nc.33 – 7/ 2011 – TS.III dated 14th March, 2012) for a decision thereupon.

Decision	Director informed the meeting that the Institute had conducted interviews for promotion of faculty under the one time CAS approved by the MHRD. From the applicants, all faculty members satisfying the eligibility norms as on 30.04.2013 were called for the interview. Besides the above, four other faculty members, whose applications were rejected by the scrutiny committee, were also called for the interview on the basis of an order of the Hon. High Court of Kerala dated 27 th June 2013. At the outset, Dr. Santosh. G. Thampi, Registrar, and Dr. Sameer, S. M., Member, BoG, requested that they may be permitted to stay away during the discussion on this item as they had attended the interview. The BoG allowed them to stay out and Dr. R. Vijayakumar, Dean (Faculty Welfare) was called inside to assist the Director in presenting the minutes of the Selection Committees. The Director along with the Dear (Faculty Welfare) presented department wise the minutes of the selection committees constituted for promotion of faculty under CAS. The selection committees had proposed that the following faculty may be promoted to the posts noted against their names w.e.f. their respective date of eligibility worked out by the scrutiny committee. The details pertaining to dates of eligibility were also presented before the BoG. The recommendations of the FC in this regard were also presented before the BoG. The following important features regarding the dates of eligibility were noted by the BoG.

- 1. All promotions are based on the norms followed for the last CAS interviews in the Institute. Dean (FW) explained to the BoG that as per the above mentioned norms, the eligibility period for moving from Lecturer to Lecturer (SS) is 6 years for those with BTech, 5 years for those with MTech and 4 years for those with Ph.D. To move from Lecturer (SS) to Lecturer (SG), the eligibility period is uniformly 5 years as on the cut-off date. For movement to the post of Professor, the eligibility period is 8 years as Assistant Professor. (Service as Lecturer (SG) will be counted towards the 8 years, from the date on which the candidate acquires Ph.D).
- 2. All the dates of eligibility are on or before the cutoff date (30-04-2013).
- Correction of CAS anomalies on the date of eligibility had been accommodated, as directed by the BoG (BG17.06).

Dean (FW) also requested the BoG to consider case of faculty members who have put in teaching service in Government Colleges and/or Government aided Colleges. Mr. Satpal Sharma representing the MHRD said that a uniform decision across all NITs is required in the matter and until such time a decision is taken, the request cannot be considered. Taking note of this view of the MHRD and the recommendation of the FC, the BoG decided not to consider the case of faculty members who have put in teaching service in Govt. Colleges and Govt. aided Colleges for the time being. The BoG also decided that this can be taken up after a uniform policy in this regard is evolved at the NIT Council.

Sub. : Revision of Pay Scales of Teachers in Engineering colleges and other degree level technical institutions including Architecture, Town Planning, Pharmacy and Applied Arts and Crafts institutions following the revision of Pay Scales of Central Government employee on the recommendations of fifth Central Pay Commission.

Sir,

I am directed to say that in fulfilment of the Constitutional responsibility for coordination, determination and maintenance of standards in Higher and Technical Education, the Central Government and All India Council For Technical Education (AICTE) have taken, from time to time, several measures. Following the revision of pay scales of Central Government employees on the recommendations of the Fifth Central Pay Commission, The Central Government has revised the pay scales of teachers in Central/Universities and colleges thereunder and has offered to provide financial assistance to those State Governments who wish to adopt and implement the same in their respective States.

- It has now been decided by the Central Government, after taking into consideration the recommendations made by the AICTE and revised pay scales of teachers in Central Universities and colleges thereunder, to revise the pay scales of teachers in the Centrally-funded degree level technical institutions. A copy of the scheme giving details of the revised scales of pay and other related provisions is enclosed (Annexure).
- The Central Government has decided to provide financial assistance to the State Governments who wish to adopt and implement the scheme of revision of pay scales subject to the following terms and conditions:
 - a. The Central Government will provide financial assistance to the state Governments which have opted for these revised pay scales to the extent of 80% of the additional expenditure involved in the implementation of the revision.
 - b. The State Government will meet the remaining 20% of the expenditure from their own sources.
 - c. The financial assistance, indicated above, would be provided for the period 1-1-1996 to 31-3-2000.
 - d. The entire liability on account of revision of pay scales etc. of teachers of degree-level technical institutions would be taken over by the State Governments w.e.f.1-4-2000.
 - e. The Central assistance would be restricted to revision of pay scales in respect of only those posts which were in existence and filled up as on 1-1-1996.

AICTE : Nonfication on Revised Pay Scales & Secures Conditions

- The State Governments, after taking local conditions into consideration, may also decide in their discretion, to introduce scales of pay different from those mentioned in the Scheme, and may give effect to the revised scales of pay different from those mentioned in the Scheme, and may give effect to the revised scales of pay from January 1, 1996, and 27-07-1998, as the case may be, or a later date. In such cases, the details of modifications proposed either to the scales of pay or the date from which the Scheme is to be implemented, should be furnished to the Government of India for its approval and subject to the approval being accorded to the modifications, Central assistance on the same terms and conditions as indicated above will be available to the State Governments for implementation of the Scheme with such modifications, provided that the modified scales of pay are not higher than those approved under the Scheme.
- 4. The Payment of Central assistance for implementation of the Scheme is also subject to the condition that the entire Scheme of revision of pay scales, together with all the conditions to be laid down in this regard by the AICTE is implemented by the State Governments as a composite scheme without any modification except to the date of implementation and scales of pay as indicated above.
- It shall be necessary for the technical institutions to make necessary changes in their Statues, Memorandum of Association, Rules/Scheme, Regulations, Bye-laws etc., as the case may be, to incorporate the provisions of this scheme.
- 6. The detailed proposal for implementation of the Scheme on the lines indicated above may kindly be formulated immediately and sent to the Department of Education in the Ministry of Human Resource Development for examination so that Central assistance to the extent indicated above can be sanctioned for the implementation of revised scales of pay.
- Anomalies, if any, in the implementation of the scheme may be brought to the notice of the Department of Education in the Ministry of Human Resource Development for Clarification.
- This Scheme applies to teachers in all degree level technical institutions and colleges, universities faculties/departments/institutions which are covered under the AICTE Act.
- Regional Engineering Colleges are joint ventures of the Government of India and the State Governments. This Scheme of revised pay scales may be implemented by them with the approval of their respective Board of Governors.

Scheme of Revision of Pay Scales of teachers in Centrally Funded degree level technical Institutions following the revision of pay scales of Central Government employees on the recommendations of the Fifth Central Pay Commission.

(i) Pay Scales

Statement showing the existing and revised scales of pay of teachers from 1-1-1996 to 26-7-1998 is at Annexure I For the period 27-07-98 onwards the scales contained in Annexure II would be applicable.

The revised scale of Associate Professor is for the existing incumbents only on personal basis. These posts will get abolished as and when the present incumbents vacate the posts. No fresh recruitment shall be made to the cadre.

The scheme of revision of pay scales of Librarians and Physical Education personnel was included in Ministry of Human Resource Development Letter No. F. 6-1/88-T.5 dated 28-02-1989. The revised pay scales for these categories as given in Annexure III will be applicable to such technical institutions where the scheme as contained in the Ministry's letter referred to above are in operation before 1-1-1996.

Incentives for Ph.D / M. Phil / ME / M.Tech. ii)

- At the time of recruitment as Lecturers, four and two advance increments will be admissible to those of the Science / Humanities faculty who hold Ph.D and M.Phil degrees respectively; in . and to those of the technical faculty who hold Ph.D. and M. E. / M. Tech. degrees respectively.
- One increment will be admissible to those Science / Humanities teachers with M. Phil and to those technical faculty with ME/M.Tech. who acquire Ph.D within two years of recruitment. h.
- A Lecturer with Ph.D will be eligible for two advance increments when he moves into Selection 4. Grade as Assistant Professor.
- A teacher will be eligible for two advance increments as and when he acquires a Ph.D. degree d., in his service career.

iii) Career Advancement

- Minimum length of service for eligibility to move into the grade of Lecturer (Senior Scale) would be four years for those with Ph.D., five years for others with M.Phil / ME / M. Tech. a. and six years for others as a Lecturer, and for eligibility to move into the Grade of Lecturer (Selection Grade) / Assistant Professor, the minimum length of service as Lecturer (Senior Scale) shall be uniformly five years.
- For movement into grades of Assistant Professor and above, the minimum eligibility criteriou b.

M 3,20 would be Ph.D. Those teachers without Ph.D. Can go up to the level of Lecturer (Selection Grade).

- c. An Assistant Professor with a minimum of eight years of service will be eligible for consideration for appointment as professor.
- d. For every upward movement, a selection process would be evolved, for which appropriate guidelines would be laid down by the All India Council for Technical Education (AICTE) in consultation with the Government of India.

iv) Rewarding the Merit

- a. The matter of laying down a super time scale of Rs. 22,000 500-24, 500 to Professors of Eminence in technical education will be considered in due course.
- AICTE would prepare a specific scheme in consultation with Government to reward and recognize meritorious teachers in technical education who may not have M. Phil/M.E. / M. Tech. or Ph.D. but who have made outstanding contributions in teaching and research.

(v) Allowances, effective date and fitment formula

- a. The revised scales of pay as contained in Annexure I will be given effect from 1.1.1996 to 26.7.1998.
- b. The revised scales of pay as contained in Annexure II will be given effect from 27.7.1998.
- c. Pay with effect from 1.1.96 in the revised scales of pay will be fixed after giving the benefit of one increment for every three increments earned in the pre-revised scales as stipulated in Rule 7 of Central Civil Services (Revised Pay) Rules, 1997, and governed by other relevant provisions of Central civil Services (Revised Pay) Rules, 1997 as applicable.
- d. Pay in the revised scales of pay as at Annexure II shall be fixed at the same stage with reference to the stage admissible vide para (c) above. In case where the same stage is not available, the pay may be fixed at the stage next above the pay admissible vide para (c) above.
- e. The payment of arrears will be made in one instalment.
- f. Teachers in Centrally funded degree level technical institutions will be entitled to Dearness Allowance, House Rent Allowance, Transport Allowance, city Compensatory Allowance and other allowances at the same rates and dates as applicable to the Central Govt. Employees.

vi. Age of Supperannuation

The age of supperannuation of teachers in degree level technical institutions will be 62 years and thereafter no extension in service will be given. However, the Institute may re-employ a supperannuated teacher up to 65 years in accordance with the existing provision(s) in the Statutes/Memorandum of Association and Rules / Schemes, Regulations and By-laws of the institute, as the case may be.

(vii) Other terms and conditions of service of teachers.

 Other terms and conditions of service of teachers shall be notified by the AICTE incorporating the approved pay scales and other related conditions on the line of existing Scheme(s) with the approval of Government of India.

- Pending the notification of terms and conditions of service by the AICTE, the revised scales of pay including arrears of salary may be given to the teachers in Centrally funded degree level technical institutions.

- The implementation of the revised scales will be subject to the acceptance of all the conditions mentioned in the scheme as well as of the other terms and conditions to be issued by the AICTE in this behalf.
- The institutions are required to amend their Statutes, Memorandum of Association, Rules / Schemes, Regulations, By-laws of the Institutions, as the case may be, in line with the Scheme within three months.
- Anomalies, if any, in the implementation of the scheme may be brought to the notice of the Department of Education, Ministry of Human Resource Development for clarification.

SUBJECT: - Introduction of Career Advancement Scheme (CAS) for members of faculty in National Institutes of Technology (NITs) -Clarification regarding crucial date, qualifying service & seniority etc.

The undersigned is directed to refer to this Ministry's Office Memorandum (OM) of even number dated 15th September 2003 and subsequent clarifications issued on 4th March and 6th April 2004 respectively on the subject mentioned above and to say that the initial date of introduction of CAS in a REC/NIT shall be the actual date of notification regarding implementation of the revised scale of pay in the Institute but not the retrospective date of implementation of the revised scales of pay i.e. 01-01-1996. Further, the crucial date for determining the fulfilment of eligibility criteria for promotion under CAS shall be 1st July of every calendar year. This is to say that all those persons who have fulfilled the prescribed criteria for promotion prior to Ist July shall be considered en bloc as a batch and the Inter-se seniority of those actually promoted, as a batch shall be maintained with reference to their original seniority in the initial entry grade. However, where promotion of more than one batch has taken place together, all persons of the first batch shall rank senior en bloc to the next batch and like wise.

It is also clarified that the period between the crucial date and the date of the 2. meeting of the BOG in which promotions recommended under CAS are approved shall count as qualifying service for future promotion without entailing any financial liability -notional or actual. on part of the Institute. However, this would not be applicable in respect of those who have not been found suitable for promotion in the first instance where the benefits would be given from the date of the meeting of the BOG only.

All cases of promotions made/to be made under CAS in NITs may accordingly 3. A Depring Hops (For inouted) be regulated as per this clarifications excepting those where a member of the faculty has already retired.



Sir,

I am directed to refer to your letter no. GA-I/CAS 2735 dated 3.4.2007 on the subject mentioned above and to clarify the position as follows:-

The Ministry has already clarified that irrespective of the date on which a faculty completes prescribed length of service under CAS regulations there would be a uniform date i.e. 1st July. For example, the faculty who completed prescribed length of service from 1.7.1999 to 30.6.2000 shall be considered as a batch and their date of eligibility would be 1.7.2000.

As far as Dr. Mahesh Pal's case is concerned, his service between 1.7.2000 to 30.9.2004 can be notionally considered as qualifying service for consideration under CAS for the post of Lecturer (Selection Grade).

It is further clarified the notional service rendered in the grade of Lecturer (Selection Grande) and Assistant Professor cannot be clubbed together for the purpose of qualifying service for the post of Professor. The service rendered as Assistant Professor alone would only count as qualifying service for the post of professor.

It is also clarified that whether it is placement or promotion the financial benefit should be given from the date of the meeting of the BoG only.

BoG 43.32 To consider the report of the Enquiry Officer appointed by the Board to enquire into the Charges framed against Dr. Baldev Setia, Professor, Department of Civil Engineering of the Institute.

The AICTE, New Delhi had sent a letter No. CVO/AICTE/FIR/2009 (PITS)/60 dated September 30, 2011 with reference to FIR registered by CBI, Hyderabad vide no. RC 13 (A)/2009-Hyd in the case of Panineeya Institute of Technology, Hyderabad. CBI had made investigation in the case and submitted its report vide letter No. DPDHY 2011/RCHYD/2009 A 0013/2779 dated 13.08.2011 accusing among others Dr. Baldev Setia, Professor, Department of Civil Engineering, NIT, Kurukshetra. CBI, Hyderabad had recommended for Departmental action against Dr. Setia for lapses in not meticulously checking the actual built up area. The matter was placed before the BOG in its 27th meeting held on 13.03.2012. The Board decided as under:-

"The Board Considered the CBI Reports and decided that the regular departmental action be initiated as per CCS Conduct Rules".

In view of above, decision of the Board a memorandum was issued to Dr. Baldev Setia vide No. Estt-I/PF/2630, dated 17.04.2013 and subsequently reminder dated 10.09.2013 to submit the reply by 19.09.2013 positively.

Dr. Baldev Setia submitted his reply on 01.12.2015 to the above memorandum dated 17.04.2013. The matter was placed before the Board of Governors in its 39th meeting held on 05.04.2016 for consideration and decision. The Board has decided as under:-

"The Board considered the reply of Dr. Baldev Setia and decided that an enquiry be conducted as per CCS Rules. The Board further decided that Dr. P. Bapaiah, Registrar, Indian Institute of Science Education & Research (IISER), Mohali be appointed as Enquiry Officer". -328-

As per the above decision of the Board Dr. P. Bapaiah, Registrar, Indian Institute of Science Education & Research (IISER), Mohali was appointed as Enquiry Officer and he was intimated vide letter No.Estt.-1/210/4626 dated 23.05.2016 to conduct the enquiry into the above case. The Enquiry Officer has submitted its report on 05.08.2017. A copy of the report of the Enquiry Officer is enclosed as <u>Annexure –</u> 43.32.(*i*) from pages 329 to 337.

The Enquiry Officer in its report has made the following observations:

"Prof. Baldev Setia is reasonably right as some (Visitor) stranger visits, he tends to believe that the space shown is correct. Generally demanding for proving the ownership documents of the space, will be difficult for the stranger visiting. This part of activity should have been attended to by the AICTE as AICTE organized the visit also should have to own the major responsibility in this failure. Prof. Baldev Setia is in his rights to state that AICTE also got a complaint within the reasonable time and they have not acted right in time, had it been so, the entire issue would not have arised. Thus, certainly it is established that documents/drawings of the buildings/space have been verified by the team, it is clear that the team visited the space shown to them and certified and recommended for granting permission. For this also major part of responsibility remains with the AICTE officials as they are in possession of all details, documents along with the application. Generally, visiting committee will have a limited time.

Thus though Dr. Baldev Setia as a member of the visiting team failed in devotion to duty, he is only one of the member in the visiting team. The committee as a group committed lapses in Unison and not Prof. Baldev Setia alone, his lapses be considered with a lenient view, more particularly his experience/participation in many such committee's visits and this visit alone only resulted in lapses and also he regretted for his unintentional mistake, if any."

The matter is placed before the Board for consideration.

In the beginning of the meeting, discussions that took place on 13.2.2017 (meeting at NIT Kurukshetra) have been recapitulated as indicated below:

- Professor Baldev Setia was asked whether he needed any assistance to defend him. Professor Baldev Setia had informed that he was not in need of it and stated that he could defend himself. However, Professor Setia stated that he had requested for the C.D. filmed during the visit on 25.06.2009 and CBI report, earlier may be provided.
- When enquired about the measurements of the space at the Institution visited before recommending, Professor Setia categorically stated that no measurements had been taken and it is not needed as per the procedure prescribed by the AICTE.
- Professor Setia also stated that the Regional Office of the AICTE should have completed all the preliminary requirements as they are having the files, papers, documents etc.

The Enquiry Officer asked Professor Baldev Setia about the statement of imputation of mis-conduct at point no. 2. In reply to the allegations on point no. 2, Professor Setia told that there was no shortfall in the plinth area. Professor Setia explained that the space shown to the committee was adequate and the same was recorded in the C.D. as well. Professor Setia also mentioned that the visiting experts committee members are not provided the Documents, Files concerning the Society/Trust Registration, Land , Building Plan, Financial Status Documents at the time of deputing them by the Approval Bureau/ Regional Office. Therefore, the expert committee can not verify and certify these issues at the time of visit of the expert committee. This is as per the Clause 15 of the procedure laid down in the AICTE guidelines for granting the approval by the expert committee for recommendation. According to Professor Setia, Scrutiny Committee at Regional Office and the Hearing Committee at AICTE headquarters have already examined the documents in original concerning the Society/Trust Registration, Land, Building Plan, Financial Status and

the same are accepted by the Chairman ACTE, being the Final Authority and Letter of Intent (LOI) was issued on the basis of the documents prior to visit of the Expert Committee.

As per Professor Setia's stated that in the procedure laid down for granting permission for approval; expert committee is to find about the adequacy and suitability of the space shown in the proposed Institute and the same was followed by the expert committee. Therefore, the Expert Committee role is only recommendatory.

Further Professor Setia stated that AICTE, Regional Office in its letter dated 11.08.2009 had itself indicated that the Institute had shown one CBSE School and B.Ed. College to the Visiting Committee for obtaining the approval from the AICTE. Thus, AICTE itself has accepted that the building shown to the visiting committee is different to the proposed engineering college. Thus on receipt of the complaint AICTE should have rejected or further stopped the processing of the request instead Since the visiting committee of further processing it for according approval. recommendations are advisory in nature, the Competent Authorities at different stages in AICTE should have looked into the veracity of the complaint and accordingly, the request should have been rejected and thus Panineeya Institute of Technology (PIT Hyderabad) should not have been given permission. Professor Setia further stated that the committee was satisfied with the area shown for the operations of the proposed Engineering College. Accordingly, the recommendations had been made. The committee was not aware of the complaint and any further processes at AICTE, New Delhi.

For a question as to that why expert committee had not measured the area carefully; as stated earlier, Professor Setia reiterated that the Expert Committee had not measured the space as that was neither the mandate nor the practice. The expert committee comprising of Senior Level professionals and expecting them to take measurement is beyond comprehension. Thus, it is clear that the actual area is not measured but It is stated that the actual area is found to be adequate for the proposed operations of the proposed Institute.

Professor Setia stated that the report was jointly prepared but it was handwritten by the Convenor AICTE. The minor totalling error in it was a clerical mistake and could not be attributed to the intentions of the members.

He remained on deputation to the post of Deputy Director with the All India Council for Technical Education (AICTE), New Delhi w.e.f.30.9.2003 to 05.03.2010. During the period of deputation, some allegations were leveled against Dr. Sandeep Singhal by the Central Bureau of Investigation (CBI), Chennai and the CBI vide their letter dated 08.12.2010 informed to this Institute to take the disciplinary action against him under the Major Penalties as the irregularities were found at the part of Dr.Singhal during the period of deputation. Thereafter, in another case, the Chief Vigilance Officer, AICTE, New Delhi had informed vide their letter dated 29.08.2013 that some irregularities were found occurred at the part of Dr. Singhal during the period of deputation, so under the head of Minor Penalties disciplinary action be taken against Dr. Sandeep Singhal.

In both the cases, Dr. Sandeep Singhal was charge-sheeted vide Memorandum No.Estt.-I/PF/2176 dated 23.05.2011 and No.Estt.-I/PF/1043 dated 29.02.2012 as per CCS (CCA) Rules, 1965 respectively. He submitted his reply in response to both the Memos.

The said matter was placed before the Board of Governors in its 24th meeting held on 07.02.2011 vide agenda item No.24.28 and the Board decided as under:

"The Board considered the CBI report dated 08.12.2010 and decided that the Institute may follow proper procedure/take appropriate action as per CCS Conduct Rules for awarding major penalty as per CBI Report against Shri Sandeep Singhal, Associate Professor, Department of Mechanical Engineering. After following the proper procedure the matter be placed before the Board for taking final decision in the matter." Thereafter, the said matter was placed before the Board of Governors in its 32nd meeting held on 03.01.2014 vide agenda item No.32.10 and the Board decided as under:

"The Board decided that a Departmental Enquiry Committee be constituted to enquire in the matter and submit its report along with his other cases referred by CBI for consideration of BOG."

Accordingly, in both cases Shri Nagendra Rai, Former Acting Chief Justice, Patna High Court and presently Senior Advocate, Supreme Court of India was appointed the Inquiry Officer and all the necessary relevant documents were supplied to Shri Nagendra Rai to inquire the said matter but the Inquiry Officer could not submit the inquiry report. As per CCS (CCA) Rules-1965, the Inquiry Officer should not more than 70 years of age as on 1st July of the year and during the above period Shri Nagendra Rai had crossed the age of 70 years.

Thereafter, the matter was again placed before the Board of Governors in its 42nd meeting held on 27.06.2017 vide agenda item No.42.14 to change the Inquiry Officer in the said case and the Board decided as under:

"The Board authorized the Director to identify a suitable person to act as Inquiry Officer in the case of Dr. Sandeep Singhal who can complete the inquiry and submit the report in a time bound manner as this case has already been delayed so much. The appointment of such identified person be got approved from the Board by circulation. Further, the report be placed before the Board for final decision in the matter."

In compliance of the decision of the Board, the Director has contacted with Dr. P. Bapaiah, Registrar, Indian Institute of Science Education & Research (IISER), Mohali to conduct the inquire in the above said cases as Inquiry Officer. He is agreed to be the Inquiry Officer.

The Board may kindly note.

BoG 43.34 To consider the confirmation of Shri Pankaj Kumar Bayati to the post of Deputy Registrar.

Shri Pankaj Kumar Bayati was appointed to the post of Deputy Registrar on probation for a period of two years in the Pay Band-3 of Rs.15600-39100 plus Grade Pay of Rs.7600/- vide appointment letter No.Gen-1/3915/515 dated 29.01.2014 against the Advertisement No.27/2012 by adopting the Model Recruitment Rules (MRRs). He had joined his duties on 03.03.2014 (FN). As such his confirmation was due w.e.f.03.03.2016 as his probation period of two years was completed on 02.03.2016(AN).

The matter of confirmation of Shri Pankaj Kumar Bayati, Deputy Registrar was placed before the Board of Governors in its 39th meeting held on 05.04.2016 vide agenda item No.39.15 <u>Annexure – 43.34.(i) on page 343</u> but the Board deferred the confirmation of Shri Pankaj Kumar Bayati due to un-satisfactory report towards his work and conduct. The decision of the Board of Governors is stated below:

> "The Board considered the issue of confirmation of Ms. Pallavi Rai and Shri Shahabuddin on the post of Students Activity & Sports (SAS) Officer and Shri Pankaj Kumar Bayati on the post of Deputy Registrar. The Board observed the status as under:

The Board confirmed Ms. Pallavi Rai on the post of Students Activity & Sports Officer w.e.f. 10.2.2016 and decided that Shri Shahabuddin be confirmed on the post of Students Activity & Sports Officer w.e.f. due date after the receipt of verification of OBC certificate from the concerned State authority. The Board deferred the confirmation of Shri Pankaj Kumar Bayati, Deputy Registrar."

Accordingly, the matter of confirmation of Shri Pankaj Kumar Bayati is being put to the Board of Governors. He has already submitted the requisite information/documents as detailed below as the said documents are necessary for confirmation and all the said documents are available in his personal file and nothing has been found adverse against him:

- 1. Medical Fitness Certificate.
- 2. Oath.
- 3. Declaration regarding marital status.
- 4. Character Certificate.
- 5. Proof of Age.
- 6. Verification of Character & Antecedents.

Vide Memo No.Estt.-I/6620 dated 28.12.2015, Shri Pankaj Kumar Bayati, Deputy Registrar (Academic) was asked to explain his position for making the correspondence directly to the competent authority without adopting the proper channel. A copy of letter is annexed as <u>Annexure – 43.34.(ii) on page 344</u>. In response to the Memo dated 28.12.2015, Sh. Pankaj Kumar Bayati had submitted his reply on 30.12.2015 which was found unsatisfactory.

In this connection, a legal opinion was sought on 16.01.2016 from the Institute Standing Counsel Shri Amarjit Singh Virk, Advocate, High Court of Punjab & Haryana, Chandigarh and the conclusion of legal opinion is stated below:

> "As such in my considered opinion, the Institute may simplicitor dispense with the services of Sh. Pankaj Kumar Bayati, as he is still under probation period, without resorting to any disciplinary proceedings as no reason for such termination is required to be assigned. He can either be served with one month's notice for such termination/dispensing of services or in alternative he can be paid one month's salary in lieu of notice period. However, if the Institute considers to initiate disciplinary proceedings against him for his alleged misconduct, since his conduct in communicating directly to higher authorities is in contravention to the Code of Conduct Rules, which amounts to misconduct and further even the tenor and language of his reply to Memo asking for his explanation also amounts to misconduct, then he can be placed under Suspension, too under Statute 26(1)(i) of the First Statutes, pending departmental proceedings."

A copy of the legal opinion is annexed as <u>Annexure – 43.34.(iii) from</u> pages 345 to 346. Further he had submitted his another reply on 04.02.2016 by showing the apology for the language used by him in his earlier communications. Further he has also assured that such type of mistake will not be repeated in future at his part and he will maintain the office protocol and decorum with more rigorously while in communication with the Institute functionaries.

Thereafter, in another case vide Memo No.Estt-I/3898 dated 09.08.2017 <u>Annexure – 43.34.(iv) on page 347</u>, Shri Pankaj Kumar Bayati was asked to explain his position and he had submitted his reply on 11.08.2017.

Now a special report towards the work and conduct of Shri Pankaj Kumar Bayati has been received on 12.01.2018 from the Dean (Academic) and the overall grading is found Average. However, his knowledge of sphere of work is found Very Good.

The consolidated instructions on probation/confirmation for the Central Government Employees have been notified by the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, Govt. of India vide OM No.28020/1/2010-Estt(C) dated 21.07.2014 and the relevant instructions for Extension of Probation Period is reproduced below :

- "15. If during the period of probation, a probationer has not undergone the requisite training course or passed the requisite departmental examinations prescribed (proficiency in Hindi, etc.), if any, the period of probation may be extended by such period or periods as may be necessary, subject to the condition that the total period of probation does not exceed double the prescribed period of probation.
- 16. The Appointing Authority may, if it so thinks fit, extend the period of probation of a Government servant by a specified period but the total period of probation does not exceed double the normal period. In such cases, periodic reviews should be done and extension should not be done for a long period at one time.
- 17. Where a probationer who has completed the period of probation to the satisfaction of the Central Government is required to be confirmed, he shall be confirmed in the Service/Post at the end of his period of probation, having been completed satisfactorily."

In view of the position explained above, the matter is placed before the Board of Governors to consider *the confirmation of Shri Pankaj Kumar Bayati to the post of Deputy Registrar.*

LEGAL OPINION

345

Sh. Pankaj Kumar Bayati, DR(Academics), Memo No. Estt-I/6620 dt. 28.12.2015 issued to Sh. Pankaj Kumar Bayati & Reply of Sh. Pankaj Kumar Bayati to above said Memo vide DR(Acad)/35/15 dt. 30.12.2015. I have also perused the Conduct Rules of the Institute. Clause 17 of the Code of Conduct Rules clearly provides that the Employees of the Institute must forward their representations putting forth any claim or for redressal of any grievance through proper channel and shall not forward his/her case or even copy of the same directly to the higher authority. It further provides that contravention of this provision may invite disciplinary action against the concerned employee.

Sh. Pankaj Kumar Bayati was appointed as D.R. (Academic) vide appointment letter dated 29.10.2014 & put on probation for the period of two years vide condition no. 4 of his appointment letter, which is yet not over.

Sh. Pankaj Kuamr Bayati sent letter No. Acad/15/5095 dt. 2.12.2015 directly to the Director, instead of raising his grievances through proper channel in clear violation of the Clause 17 of the Code of Conduct Rules referred to above, which entails disciplinary action against him. However, instead of initiating disciplinary proceedings, when his explanation was called for vide Memo dt. 28.12.2015, he (Sh. Pankaj Kumar Bayati) submitted his reply dt. 30.12.2015, even though he admitted to have written directly to the Director instead of moving through proper channel and expressed his regret on one hand to not to repeat the same in future yet on the other hand he is not only justifying his action to writing directly to the Director and also justifying his language but also using inappropriate and uncalled for language in his reply too, which is not only threatening/offensive in nature but defamatory too, which is not warranted from any employee and is also in violation to Clause 3 (General) of the Code of Conduct Rules which provides that No employee shall use abusive/offensive language in letters/communications. This clearly suppicts the bent of mind of the employee that he had no regret for his past action too.

Since Sh. Pankaj Kumar Bayati is still under probation as such during probation his services can be dispensed with by the Competent authority without assigning any reason by giving him either one month notice in writing or one month salary in lieu of the notice period.

The services of an employee can be dispensed with during probation period. However, the same should be dispensed with simplicitor, without leveling any misconduct and without any disciplinary proceedings being initiated, as the termination of services during probation should not carry any stigma over the employee. The termination during probation period can be assailed in the court of law only on the ground that the termination is not simplicitor but casts a stigma and even the courts while scrutinizing such termination order, try to look into the same whether it is simplicitor termination during probation period or it casts any stigma, by going into the background leading to termination of services during probation period.

However, the Institute may also initiate disciplinary proceedings for the alleged misconduct of the employee and after conducting the departmental enquiry, if the charges/allegations are proved then may impose any of the penalties as provided under Statute 26(5) of the First Statute and the employee may be put under Suspension by the Director under Statute 26(1)(i) of the First Statute, if the Institute is contemplating disciplinary proceedings against the employee.

As such in my considered opinion, the Institute may simplicitor dispense with the services of Sh. Pankaj Kumar Bayati, as he is still under probation period, without resorting to any disciplinary proceedings as no reason for such termination is required to be assigned. He can either be served with one month's written notice for such termination/dispensing of services or in alternative he can be paid one month's salary in lieu of notice period. However, if the Institute considers to initiate disciplinary proceedings against him for his alleged misconduct, since his conduct in communicating directly to higher authorities is in contravention to the Code of Conduct Rules, which amounts to misconduct and further even the tenor and language of his' reply to Memo asking for his explanation also amounts to misconduct, then he can be placed under Suspension, too under Statute 26(1)(i) of the First Stautes, pending departmental proceedings.

BoG 43.35 To consider and approve the enhancement of research scholarships in Ph.D. programme of the Institute

The Board of Governors in its 41st meeting held on 31.1.2017 decided as

follows:

- (i) "The scholarship to Research Scholars and Graduate (M.Tech./M.E. etc.) students should be paid strictly in accordance with MHRD's letter F.No. 17-2/2014-TS.I dated 2nd March, 2015 and F.No. 17-2/2014-TS.I dated 18th February, 2015. Research Scholars and Graduate Students with GATE/NET qualifications as specified in these letters only should be provided scholarship.
- (ii) As far as the enhancement of Research Scholars is concerned, the number of Research Scholars should be examined in terms of the desired outcome and the same be placed before the Board in its next meeting."

With regard to point (i) it is submitted that the scholarship to Research Scholars are being paid strictly in accordance with the MHRD instructions issued vide the aforesaid letters. However, with regard to point (ii), it is submitted that10 Ph.D. Fellowship were allowed by the Board of Governors in its 90th meeting held on 25.11.1998 in the following departments:

Further, the Board of Governors in its 5th meeting held on 15.03.2004 decided to increase these fellowships from 10 to 25 (16 for Engineering Departments and 09 for Sciences Department. Thereby, the Ph.D. fellowships made available are 5 per year (0.6 per Engineering department and 0.5 per Sciences and Humanities Departments).In 2004, there were 5 Engineering departments (Civil, Electrical, Mechanical, Computer and Electronics & Communication Engineering) and 04 Sciences &Humanities Departments. The sanctioned faculty strength was 160 (based upon the then faculty students' ratio). Further, in 2007, 2 new Engineering

departments (Information Technology and Production & Industrial Engineering) were started in 2006. Apart from that MBA, MCA & 4 PG schools were also started later on. The Institute faculty sanctioned strength has also been increased to 298 (based on faculty students' ratio of 2010) because of these additional programmes. In 2017, the faculty strength has been revised to about 350.

In view of the above, the research activities have been increased in all programmes. Accordingly, the number of full time Ph.D research scholars has also increased to 207 in 2017. Further, the faculty and scholars are publishing quality research work in the reputed journals as is expected from an Institute of National Importance aspiring for top slot in NIRF rankings to become a world class Institute. However, the number of research scholars getting institute scholarship from budgetary provisions is limited to 25 (5 research scholarship per year for 5 years) only. Resultantly, the bright PG students do not feel motivated for PhD in our Institute because of lack of scholarships for PhD. About 115 research scholars are without any scholarship. Keeping in view this fact, the admissions in Ph.D. programmes for the current academic year 2018-19 are being made only against scholarship scholars.

Under the above circumstances, to enhancing the research activities in the Institute is the need of hour; and for this purpose, the number of research fellowship are required to be increased to invite bright PG students to come forward for research. Further, it is also submitted that many of the labs of the Institute have now been developed to cater to the needs of research scholars and any shortage in the research candidates may lead to underutilization of the important resources. Moreover, these scholars will be helpful to enhance the academic ambiance of the Institute. Therefore, the number of research fellowship may be increased in accordance with the sanctioned faculty strength and on the basis of no. of research specializations available in the concerned departments so that in a span of 05 years, each faculty may have at least 01 full time research scholar. The department / specialization wise details of proposed increase has been worked out which is available on the enclosed <u>Annexure 43.35.(i) on page 351.</u>

The year wise financial implications for five years have also be worked out on account of the proposed increase of number of research scholarships from 05 per year to 64 per year is as under:

At present, the total liability of 25 research scholarship is Rs.91,50,000/-

(Rs.28000/- per student per month + Rs.30000/- contingencies per student per year).

In view of all above, "it is proposed that the number of research scholarships may be allowed to increase from 05 to 64 per year for five years keeping in view the sanctioned faculty strength and specializations available in the concerned departments." Further, Director may also be authorized to transfer any vacant seat to any other department as per requirements. The admissions against the proposed increased scholarships may be effected from the next financial year 2018-19.

Further, it is also proposed to consider scholarship as one time measure, for those research scholars who are currently not availing scholarship from any funding agency. "

BoG 43.36 To consider the obsolescence of Laptop provided to Faculty/Non-Faculty Staff of the Institute.

The Institute has been providing the Laptops to the Faculty under Cumulative Professional Development Allowance (CPDA). The faculty uses the laptops for their teaching and research activities. Most of these laptops either have become obsolete or non-serviceable on account of up gradation of technology. Further, the book value of these Laptops becomes negligible after applying the depreciation as recommended by the Ministry of HRD under Straight Line Method. The recommended depreciation rate is 20% under the Straight Line Method and the same has been adopted while preparing the financial statement of the Institute. The details of Laptops year wise alongwith the purchase value, depreciation and Book Value are as under: -

The depreciated value/book value of all the laptops purchased 05 years and before is nil as on date.

In view of the above, it is proposed that "the above laptops may be obsolete and written off. However, if any faculty/Non faculty staff interested to retain the existing Laptops, he/she may be allowed to retain at the residuary value of Rs.2000/-.(Rs. two thousand only)."

BoG 43.37 To consider the separation of accounting related to Research & Consultancy.

The Institute is providing consultancy services in the field of testing of materials, consulting in the area of designs, proof checking/vetting, preparation of detailed project report, quality control services etc. for Government, Semi Government, Autonomous Bodies and Private Organizations and charging fee thereof. The testing and consulting are being provided as per the rules framed for the purpose as approved by the Board of Governors in its 69th meeting held on 20.2.1987 and these rules come into force with effect from 1.4.1987. Since 1.4.1987, the consultancy jobs are being carried out on the basis of above rules. However, as per requirement some clauses of these rules were amended from time to time as per the decision of FC/BOG of the Institute.

The receipts against consultancy fees collected through cash or online mode are being received in the Main Current Account of the Institute and creating problems to segregate the entries of consultancy fees out of the all other entries of the Main Current Account as this is the account where fees, grants etc. are being received through online transactions related to the Institute. Further, the Institute is unable to trace the online transactions most of the time, related to the amount received from the service receiver. This creates problem for the service receiver as well as the respective Principal Investigator. Consequently, the assigned job gets delayed.

All the relevant expenditure related to the concerned consulting job is being adjusted out of the fees received from service receiver, as per Consultancy Rules, approved by the Board from time to time. Further, the remaining fees was being deposited in the Development Fund of the Institute as an Institute share of consultancy. However, the C & AG during the audit objected in this regard and suggested to convert it as income of the Institute of the concerned financial year. Consequently, the financial statement of the Institute is being prepared by merging the transactions of consultancy income. It has direct impact on the corpus of the Institute. Further, the Institute is also running the various scientific research projects funded by the Government and Non-Government agencies such as DST, SERB, CSIR, ICSSR, DRDO and Industries. The accounting for these research projects are being maintained by the Institute through the separate bank account, specifically allocated for various research projects. The funding agency requires the utilization certificate of the fund disbursed to the Institute, which requires the maintenance of specific accounts for each research project.

In view of the above, it is proposed that "separate accounting for the consultancy and research projects may be maintained to strengthen the corpus of the Institute and the Institute consultancy share generated out of consultancy and research projects may be shifted to corpus. The proposed separation of accounting may be effected from next financial year 2018-19.

Further, it is also proposed that a Research & Consultancy Cell may be established in the Institute and the consultancy rules and regulations may be redrafted accordingly and placed before the next Board meeting for approval."

BoG 43.38 To consider proposal to set up Centre of Excellence (COE) at National Institute of Technology (NIT), Kurukshetra by M/s Siemens Industry Software (India) Pvt. Ltd., Bangalore.

In view of the above, the Institute has come forward to seek the cooperation of the industries for improving the infrastructure and facilities for the students of the Institute. The Institute consulted with M/s Siemens Industry Software (India) Private Limited, Bangalore for the purpose. In this regard, M/s Siemens Industry Software (India) Private Limited, Bangalore has submitted a proposal for setting up Centre of Excellence at NIT Kurukshetra aiming to facilitate a multi-disciplinary learning environment across technology, engineering, science and management faculties. The centre will leverage Siemens' integrated platform to drawn upon the expertise from various industries and provide its partners with knowledge and tools. This will also bridge the skill gap of students vis-à-vis industry needs and impart state-of-the art industry oriented training to help foster significant innovation and learning in technical It envisages setting up of ultra-modern facilities which include state-of-art education. machines, robots, control systems, software; hardware etc. to foster and promote cutting edge research. The proposal will support the students, faculty and Institute in the following fields:

1. The project will build a world class integrated skill development infrastructure at this Institute by modernizing the existing laboratories to reflect industries' ever changing processes;

- 2. The Centre of Excellence will train the students and working professionals with latest and futuristic industry relevant skills. The updated technical education curriculum will also align with the industry needs;
- 3. The project will improve assist better placement of students. Students can compete in national/international employment market for better growth and remuneration;
- 4. This will create industry friendly environment and strengthen the industry-academia partnership;
- 5. This project will improve quality of education and faculty competency.
- 6. This will create an opportunity for revenue generation as it will attract more industries, government departments, organizations etc. for consultancy works.

The proposal has been examined by the officials of the Institute in the meeting held on 5.12.2017 along with three represented from Siemens for its deliverables, sustainability and value addition to the academic programmes as well as skill enhancement of the students. The details of proposals were shared with the Heads and faculty of the Departments of Mechanical Engineering and Electrical Engineering in particular for examination in terms of the short and long term requirements of the laboratories vis-à-vis the laboratories to be developed under the proposal. These Departments identified and spelled out the futuristic requirements of their laboratories. Following the broad understanding of the proposal, a meeting chaired by the Dean (Research and Consultancy) and attended by the Heads/faculty of Electrical Engineering, Mechanical Engineering, and Civil Engineering and two representatives invited from Siemens was held in the Institute on 10-11 January 2018. Laboratory wise detailed deliberations were conducted with focus on laboratory requirements identified by the Departments and the laboratories along with technical specifications/ features of equipments/machines therein as proposed to be developed by the Siemens. Our laboratory requirements and those offered under the proposal were aligned to the extent possible. It was concluded that state-of-the-art equipments/machines offered by Siemens under the proposal shall make significant contribution to meet the long term requirements of the laboratory infrastructure. As an outcome of the proceedings of the meeting, ten laboratories were finalized to be developed in the Siemens Centre of Excellence. These include Design and Validation, Advance Manufacturing, Automation, Mechatronics, Process Instrumentation, Electrical and Energy Studies, Test and Optimization, Machine Metrology, and Internet of Things Laboratories.

M/s Siemens has been supporting various education initiatives under its Global Fund for Technical Education to create a robust technical education eco-system through its experience in industrial products and services. The proposal will be supported with an approximate funding of Rs.200 crores out of which the Siemens will provide approximately 90% cost of the proposal (including absorption of costs) and remaining 10% will have to bear by the Institute.

The Siemens will allocate the grant based on consent from the Institute. It is pertinent to mention here that the Institute has to provide space of about 20,000 square feet area, flooring, furniture & fixtures, workstation class computers, air conditioning, projectors and power supply for the above said Centre of Excellence. In this context, aMoU is required to be signed between the two partners namely the Siemens and the NIT Kurukshetra. After signing the agreement, the Siemens will approve the grant on the Siemens P2O ordering system and will be kept valid for 15 days. The amount will be automatically applied once Siemens logs in the products in the Siemens P2O system.

As informed by the Siemens, this type of proposal supports more than 11100 partners globally that collectively trains over 1,135,000 students every year. In India, the Siemens has established such Centre of Excellence at Ahmdabad, Vijawara and Jhardkhand in collaboration with respective State Governments and at National Institute of Technology, Tiruchirapally (Tamilnadu).

The Siemens team has been requested to make a presentation before the Board on the proposed Centre of Excellence at NIT Kurukshetra.

In view of the above, "the Board may consider the proposal of M/s Siemens and decide/approve for the setting up of the Siemens Centre of Excellence with Industry relevant Skill development at NIT Kurukshetra."
