Note: *The awardees of merit scholarship shall have to submit an undertaking to the effect that he/she is not receiving any other scholarship from any other agency. The bank accounts details and copy of ID Card is also required to be submitted along with undertaking on or before 5:00 PM, 07.08.2020 by email on academic@nitkkr.ac.in so as to send their claim to accounts section for disbursement of merit scholarship amount in their respective bank accounts through DBT.*

The students receiving a merit scholarship will not be permitted to receive any other similar kind of scholarship or stipend from another government fund.

In case, if a student has received some other similar scholarship/stipend, the received scholarship/stipend amount must be surrendered to the government before this merit scholarship is claimed. The education loan or a single cash prize however will not debar the student from being eligible for merit scholarship.

The student receiving merit scholarship must abide by the rules and regulations of the institute. Any misconduct on the part of the scholar may result cancellation of the merit scholarship in part or in whole, temporarily or permanently. The merit scholarship recipients are required to have regular attendance in the respective semester/year.
