Subject: Release of Grant-in-Aid to National Institute of Technology, Kurukshetra during the year 2021-22 under Central Sector Scholarship Scheme of Top Class Education for SC students[renewal for the year 2020-21(3rd year)].

Sir,

I am directed to convey the approval of the President of India for Sanction of **Rs.4,51,575/-** (Rupees four lakh fifty one Thousand five hundred seventy five only) and release of **Rs.1,23,375/-** (Rupees one lakh twenty three Thousand three hundred seventy five only), as institute part for renewal year 2020-21(3rd year), towards Grant-in-Aid to **National Institute of Technology, Kurukshetra here-in-after called NIT, Kurukshetra** during the year **2021-22**(Plan-Non- Recurring) under Central Sector Scholarship Scheme of Top Class Education for SC students as per details given in Annexure enclosed herewith. The balance amount of **Rs.3,28,200/-** (Rupees three lakh twenty eight thousand two Hundred only) will be released to the students through Direct Benefit Transfer (DBT).

2. The Grant-in-Aid will be regulated in accordance with the provisions contained in the guidelines issued by the Ministry of Social Justice and Empowerment Shastri Bhawan, New Delhi. The Grant-in-Aid is also subject to the provisions of Chapter 9 of the General Financial Rules, 2017, as amended from time to time, read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard and in particular to the following conditions:-

- I. All relevant information and documents/ certificates as required under GFR 230 (1) has been received.
- II. The pattern of assistance of rules governing such Grant-in-Aid has received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) below Rule 20 of DFPR, 1978.
- III. The **NIT, Kurukshetra** has agreed to make reservations for Scheduled Castes and Schedules Tribes or OBC in the posts or services under its control on the lines indicated by Govt. of India.
- IV. The accounts of **NIT, Kurukshetra** shall be audited by C&AG or shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC) Act, 1971 and internal audit party by the Principal Accounts Office of the Ministry or Department whenever it is



- called upon to do so.
- V. The **NIT, Kurukshetra** will not obtain grant for the same purpose or activity from any other Ministry or Department of Government of India or State Government. The Collegewill not divert Grant-in-Aid for which it is sanctioned and also not transfer the scholarship of one student to another student without prior approval of the sanctioning authority.
- VI. Performance-cum-achievement report of the SC candidates covered under the scheme shall be monitored regularly by the Head of the respective institution and the same shall be reported through a proper report card, to the Union Ministry of Social Justice and Empowerment at the end of each academic year.
- VII. The **NIT, Kurukshetra** will spend Grant-in-Aid exclusively in pursuance of the objectives for the purpose it is being sanctioned.
- VIII. Grant-in-Aid to the **NIT, Kurukshetra** is subject to the Economy Instructions issued from time to time by the Ministry of Finance or by the Competent Authority.
- IX. The **NIT, Kurukshetra** will present their annual accounts in the standard format as required under GFR 230 (5).
- X. The Utilization Certificate for Rs.1,23,375/- against release of Grant-in-aid of Rs.1,23,375/- released to **NIT, Kurukshetra** during 2019-20 has been received.
- XI. Noted at serial No.in the Register of Grants.
- XII. If the Government is not satisfied with the progress of the project or considers that the conditions of sanction are being violated, it reserve the right to terminate the Grant-in-Aid or to black list the Institute from future grant or any other financial assistance from the Government.

2. The expenditure involved will be met from the Sanctioned Budget Grant under Demand No.92- Ministry of Social Justice and Empowerment, Major Head "2225" Welfare of Scheduled Casts, Scheduled Tribes and Other Backward Classes, 01 – Welfare of Scheduled Casts (Sub-Major Head), 789 – Special Component Plan for Scheduled Casts (Minor Head), 28 – Scholarship for Higher Education for Young Achiever Scheme(SHREYAS) for SCs-28.03 – Top Class Education for SCs-34-Scholarships/Stipends during the year 2021-22(Plan).


3. The above amount of **Rs.1,23,375/-** will be drawn by the Drawing & Disbursing Officer, Ministry of Social Justice and Empowerment and disbursed through RTGS as per following details:

5. **It is also certified that NO earlier UC is pending against NIT Kurukshetra.**
6. The Grants-in-Aid is sanctioned under the additional powers delegated to this Ministry vide Ministry of Finance Office Memorandum No. F.10 (a) E (coord) 62 dated 1st June, 1962.
7. The Direct Cash Transfers (DCT) mechanism has been introduced in 2 number of districts in the State of Haryana. It may be ensured that disbursement of scholarships to the beneficiaries of the Institution in the identified districts is done by way of direct cash transfers to the beneficiaries in their Aadhar enabled bank accounts under intimation to the Department of Social Justice & Empowerment.
8. Further, immediate necessary action may be taken by the Institutions for integration of database of the beneficiaries in their Institution with Unique Identification Authority of India (UIDAI) AADHAR numbers for the purpose of (i) embedding the AADHAR numbers in the database of the beneficiaries for identification and (ii) using the UIDAI AADHAR enabled bank accounts for crediting the scholarships, in those districts where the DCT is yet to be introduced.
9. Enhance rate of stipend or additional slots or additional coverage of institutes or provision of fee to IIT, IIIT or NIT as the case may be, is applicable to 2020-21 only. Its further extension to years beyond 2020-21 shall depend upon approval to continuance of these provisions and availability of funds under the scheme.
