Note 1:

- (1) Any change in the grade pay will be through open advertisement and on recommendation of duly constituted selection committee, except where specifically exempted in these rules.
- (2) All new entrants shall have Ph.D. in the relevant or equivalent discipline and shall have first class in the preceding degrees.
- (3) For existing faculty members who completed their Ph.D. along with their normal teaching load of Institute or quality improvement programme, the enrolment period of Ph.D. will be counted as teaching experience.
- (4) Contribution to Institute Administration shall be recommended by concerned Head or Chairman and approved by the Director. Contribution to departmental Administration shall be recommended by concerned Head and approved by the Director.
- (5) For the departments which are not having any vacancy, movement in higher Academic Grade Pay or cadre shall be carried out as per specified selection process but it will be restricted to only for serving faculty members of the respective departments.
- (6) The permanent faculty members who have put in more than ten years experience, but have not acquired Ph.D. qualification as on the date of these notification shall be mapped into four-tier flexible system as one time measure as per following norms:
 - (a) Permanent faculty with age fifty or above:
 - (i) The Assistant Professors with Academic Grade Pay of Rs.7000 shall be mapped at the level of Assistant Professor with Academic Grade Pay of Rs.8000, provided they have at least 10 credit points in their lifetime.
 - (ii) The Assistant Professors with Academic Grade Pay of Rs.8000 shall be mapped at the level of Associate Professor with Academic Grade Pay of Rs.9500, provided they have at least 25 credit points in their lifetime.
 - (iii) The Associate Professors with Academic Grade Pay of Rs.9000 shall be mapped at the level of Associate Professor with Academic Grade Pay of Rs.9500, provided they have at least 25 credit points in their lifetime:

Provided, they have been found suitable through a Selection Committee duly constituted under the Statutes.
 - (b) Permanent faculty members less than fifty years of age shall be sponsored for Ph.D. in any of the Indian Institutes of Technology or National Institutes of Technology duly provided a facility to take study leave of three-years from their respective National Institute of Technology and on completion of the Ph.D., they shall compete to get into the four tier system as per the new recruitment rules.
- (7) For faculty in the Department of Architecture, following shall be essential qualification without insisting on credit point requirements at Assistant Professor level:
 - (i) M.Arch. or M.Plan. with one year professional experience: Assistant Professor at Academic Grade Pay of Rs. 6000;
 - (ii) M.Arch. or M.Plan. with two years of professional experience: Assistant Professor at Academic Grade Pay of Rs. 7000;
 - (iii) For higher cadres the educational qualifications and credit point requirement shall remain same as given in the table for Engineering and Sciences.

Minutes of the 11th meeting of the Council of National Institutes of Technology, Science Education and Research (NITSER) held on 18th July, 2018 at India Habitat Centre, Lodhi Road, New Delhi

Act, 2007. After detailed deliberations, the Council approved following eligibility criteria for appointment of Deputy Director:-

- (i) The appointment of the Deputy Director shall be made from amongst the senior faculty members of the Institute on the recommendations of the Selection Committee as per provisions under Statute 23 (5) (a) of the respective Statutes.
- (ii) Minimum 5 years of experience as Professor.
- (iii) The candidate applying for the post should not be exceeding 60 years of age at the time of applying.
- (iv) should have done at least 2 years as HoD / Dean.
- (vi) Sufficient contribution in academics, administration and outreach activities.
- (vii) In addition, the candidate shall be an eminent person in his / her field of specialization with an outstanding academic record throughout.

Item No.11.5: To consider and approve guidelines for Higher Administrative Grade (HAG) scale to the Professors of NITs and IEST, Shibpur.
The Council deliberated and approved the guidelines proposed for HAG scales to Professors of NITs and IEST, Shibpur.

Item No.11.6: To consider and approve guidelines for utilization of Research & Consultancy funds and Sponsored Research Projects in the NITs and IEST, Shibpur.
After detailed discussion, the Council decided to refer the proposal to the Standing Committee of NITs & IEST for deliberation and making suitable recommendations to the Council.

Item No.11.7: To consider amendments in the guidelines for utilization of Cumulative Professional Development Allowance (CPDA).
The Council deliberated upon the proposed changes and accepted the same. It was also decided that the NITs & IEST shall send their suggestions on the existing CPDA guidelines for placing the same before the Standing Committee of NITs and IEST for further deliberation and improvements.

Item No.11.5

To consider and approve guidelines for Higher Administrative Grade (HAG) scale to the Professors of NITs and IEST, Shibpur.

As per 6th Central Pay Commission recommendations, the provisions for Higher Administrative Grade (HAG) in scale of Rs.67000-79000/- with no grade pay was extended to the Centrally Funded Technical Institutions (CFTIs) vide MHRD's letter dated 18th August, 2009 [**Annexure – III (pages 80 to 84)**].

2. To implement the HAG scales among the Professors of NITs, the issue relating to upgradation of Professors to HAG was discussed and guidelines / criteria were approved by the Council of NITSER in its 3rd meeting held on 18th November, 2011. Following the provisions under 6th CPC as implemented in CFTIs, the provisions for HAG in NITs were communicated vide our letter dated 14th March, 2012 [**Annexure – IV (pages 85 to 88)**] as reproduced hereunder:-

"In case of upgradation of AGP of Professors to HAG scale, personal interview shall be dispensed with. The Selection Committees constituted as per the Statutes for the selection of faculty, shall make their recommendations on the strength of published work, patents, sponsored projects, consultancy, continuing and distance education, Ph.D. guidance and contribution to the administration of the Institute, including service in other comparable Institutions if on sanctioned leave, etc. as submitted by the candidates".

4. Vide our letter dated 18th March, 2013 [**Annexure – V (pages 89 to 90)**], it was communicated that "when Selection Committees are called upon to consider HAG scale for senior Professors, only eminent people already in HAG or comparable scale of pay, or fellows of national academics, be appointed to Selection Committee". Subsequently, the guidelines for hassle free

implementation of HAG scales in NITs were issued on 22nd March, 2013 [Annexure – VI (pages 91 to 93)] according to which, 20% Professors including those on deputation as Directors in other CFTIs and fulfilling the eligibility conditions given in the guidelines were to be considered for HAG upgradations.

5. Later on the Ministry vide letter 23rd August, 2013 [Annexure – VII (pages 94 to 96)] conveyed the approval for switching over to a Four-Tier Flexible Faculty structure for adoption by the respect Board of Governors of NITs. Under the approved Four-Tier norms, upto a maximum 40% of the sanctioned posts of Professors after regular service of 6 years as Professor can be awarded HAG scale of Rs.67000-79000/- without any Grade Pay in all NITs after fulfilling the eligibility conditions given in the guidelines for implementation of HAG scales in this Ministry's letter dated 22nd March, 2013 [Annexure – VI (pages 91 to 93)]. The same norms were reiterated in our letter dated 15th January, 2014 [Annexure – VIII (pages 97 to 100)] wherein the final norms for implementation of Four-Tier Flexible Faculty structure were issued.

6. The Council of National Institutes of Technology, Science Education Research (NITSER) in its 10th meeting held on 26th May, 2017 under the Chairmanship of Hon'ble HRM approved the new Recruitment Rules (RRs) for faculty staff of NITs and IEST, Shibpur. As approved by the Council, the new RR's have been incorporated in the Statutes by way of suitable amendments, which have been notified on 24th July, 2017 [Annexure – IX (pages 101 to 107)].

7. Though the eligibility criteria for granting HAG scale to the Professors of NITs and IEST has been prescribed in the new RR's, however, the guidelines and the procedure for selection (as clarified on 14th March 2012, 18th March 2013, 22nd March 2013, 23rd August 2013 & 15th January, 2014) needs to be reiterated by the Ministry under the new RR's so as to avoid ambiguity and ensure hassle free implementation of HAG scale under the new RR's. It is,

therefore, proposed to reiterate the earlier norms with certain consequential amendments as per following details:-

- (i) A maximum of 40% of the sanctioned post of Professors who fulfill the eligibility criteria as prescribed in Schedule E of the Statutes notified on 24th July, 2017 can be awarded HAG scales on the basis of the recommendations of Selection Committee as prescribed in Statute 23 (5) (a) of the Statutes of NITs and IEST, Shibpur, respectively.
- (ii) Chairman Advisory Committee for Faculty Recruitment (ACoFaR) should invite, from all eligible and interested Professors, the Bio-data incorporating their scholastic and administrative contributions since their appointment as regular Professor. It should prepare the list of candidates fulfilling all the minimum requisite conditions as prescribed by the Board.
- (iii) In case of upgradation of AGP of Professors to HAG scale, personal interview shall be dispensed with.
- (iv) The exercise will be carried out by the Institute once in an academic year with a cut off as 30th June."

8. As per the new RRs, the essential requirement prescribed for Professor (HAG scale) is 'six years as Professor with Academic Grade Pay of Rs.10000 or Rs.10500 or a combination of Rs.10000 and Rs.10500 in an Institute of national importance'. Besides this, 150 Cumulative Essential Credit Points have also been prescribed in the new RRs for faculty. The norms proposed above are based on the instructions issued by the Ministry in 2012, 2013 and 2014 as mentioned above. However, slight modifications have been made based on the new RRs issued on 24th July, 2017 to simplify the process.

9. The Council may kindly deliberate and make suitable recommendations in respect of NITs and IEST, Shibpur.

The Under Secretary to Government of India, Ministry of Human Resource Development, Department of Higher Education, Technical Section-III, New Delhi vide letter No. 33-1/2019-TS.III (Pt.II) dated 7th March, 2019 requested to adhere the following instructions and take appropriate action regarding tuition fee reimbursement for ST students who are studying in IITs/NITs and are the beneficiaries of the following schemes of Ministry of Tribal Affairs (MoTA):-

- Top Class Scholarship (TCS): Tuition fee needs to be claimed from MoTA.
- Post Matric Scholarship (PMS): Tuition fee may be claimed from Tribal Department of the domicile State of the ST students.
- The ST students who are not covered under the above scheme could be provided fee waiver.

Further, the Under Secretary to Government of India, Ministry of Human Resource Development, Department of Higher Education, Technical Section-III, New Delhi vide letter No. F.33-1/2019-TS.III (Pt.II) dated 27th March, 2019 issued Corrigendum on the said issue conveying a partial modification of the above said communication. The following modification has been made in the last bullet point:-

“those cases which are not covered under first two conditions, may be examined in light of various instructions issued by NITs Division from time to time.”

In place of

“ST students who are not covered under the above scheme could be provided fee waiver.”

A copy of both the letters is enclosed as Annexure - 50.24(i) from pages 230 to 231 .

It is pertinent to mention here that the SC/ST/PH students are getting complete fee waiver on account of instructions issued by the Director (NITs), Government of India, Ministry of Human Resource Development, Department of Higher Education, New Delhi vide letter No. 33-4/2014-TS.III dated 24th June, 2016 through which the tuition fee being charged by NITs was enhanced from existing Rs.70,000/- to Rs.1,25,000/- per student per annum from the academic year 2016-2017. A copy of the letter is enclosed as Annexure - 50.24(ii) From pages 232 to 233 .

Further, the Government of India, Ministry of Tribal Affairs (MoTA), Scholarship Division, New Delhi is releasing scholarship amount containing admission fee, annual tuition fee, other nonrefundable charges, living expenses and cost of books stationary etc. to the ST students on fresh online and renewal online basis under Central Sector Scholarship Scheme of National Fellowship and Scholarship for Higher Education for ST students, studying in UG courses at this Institute. The said scholarship amount is being released to these ST students on claiming by the students and the receipts of claim are forwarded to the MoTA for their record. A copy of sample letters is enclosed as Annexure - 50.24(iii) from pages 234 to 239.

Through these letters, it is clear that these ST students are getting tuition fee waiver and simultaneously availing the benefit of tuition fee and other charges in the shape of scholarship amount from MoTA.

In view of the above, the matter is placed before the Board for *consideration of MHRD instructions on the above issue.*



With a view to further strengthen the National Institutes of Technology (NITs), the Council of NITs in its 9th meeting held on 1st October, 2015 deliberated on the proposal of adopting a funding mechanism for creation of Capital Assets, Research Grants and covering of recurring expenditure through enhancement of fees of students. The Council after detailed deliberation unanimously decided to enhance the tuition fee being charged by the NITs from existing ₹70,000/- to ₹1,25,000/- per student per annum from the ensuing academic year.

2. The Chairperson of the Council of NITs has approved revision of tuition fee in the NITs to ₹1,25,000/- per student per annum from the academic year 2016 - 2017, subject to the following for protecting the interests of the socially and economically backward students:-

- (d) The revised fee would be applicable for students taking admission starting from academic year 2016 - 2017 onwards. The students currently studying / got admitted prior to academic session 2016 - 2017 would continue to pay the existing rates.



The Assistant Professors were recruited on regular basis with Ph.D qualification in the Institute during the year 2012 & 2013 against the Advertisement No.14/2012 & 05/2013 in the Pay Band-3 of Rs.15600-39100 + AGP of Rs.7000/- in terms of the Model Recruitment Rules notified by the MHRD, Govt. of India. The initial pay fixation of the Assistant Professors was as follows:

In this context, it is submitted that the Pay Band-3 of Rs.15600-39100 + AGP of Rs.7000/- was revised to level-11 i.e. Rs.68900-117200 as per Pay Matrix in terms of 7th CPC Report w.e.f.01.01.2016. The said Assistant Professors have represented time and again that their pay should be fixed at Rs.18600/- + AGP of Rs.7000/- = Rs.25600/- (now Rs.25790/- as per Level-11 of Pay Matrix) in terms of Fitment Table notified by the MHRD, Govt. of India along with OM No.F.3-1/2009.U.I dated 04.06.2009. Further, they have also represented that the benefit of 07 non-compounded increments should also be granted to them on acquiring the Ph.D. degree in terms of Clause-2(a) of OM dated 18.08.2009.

Vide letter No.Gen.-1/3962/7635 dated 23.11.2016 a High Level Committee was constituted by the Institute to look into the issues related to the grievances of the faculty & non-faculty members of the Institute. The scheme of Revision of Pay of Teachers and equivalent cadres of the Universities and Colleges following the Revision of Pay Scales in respect of Central Government Employees on recommendations of 6th Central Pay Commission was notified by the MHRD, Government of India vide OM No.1-32/2006-U.II/U.I(i) dated 31.12.2008. Further vide OM No.F.3-1/2009-U.I dated 04.06.2009 the MHRD had issued a fitment table for fixation of pay for Teachers. staff members of administration who have carried out the pay fixation to understand the methodology followed by them by fixing the pay have observed that:


- (I) The terms of appointment of all the faculty members are as per the MRR under 3-tier system. The initial pay of the said faculty members was fixed in the Pay Band-3 AGP Rs.6000/- at Band Pay of Rs.15600/- i.e. initial stage of PB-III with two advance increment for M.Tech.
- (II) All the said Assistant Professors were granted the AGP of Rs.7000/- on acquiring the Ph.D. as per their terms and appointment or who were appointed initially with the qualification of Ph.D.
- (III) The claim of the said Assistant Professors for granting initial increments on regular appointments to the said post is contrary to the rules & instructions provided under the 3-tier system. Since there is no such provision for granting initial increments at Rs.7000/- AGP.
- (IV) The anomaly has taken place while fixing the pay is that while granting the AGP of Rs.7000/-, the initial pay in the pay band for AGP Rs.6000/- was considered instead of the pay in the initial pay band for AGP Rs.7000/-.
- (V) The Assistant Professors who were granted the AGP of Rs.7000/- on completion of Ph.D. degree needs to be reviewed as per the said contents referred by Department of Legal Affairs, Ministry of Law in their Notification No.272733/Adv.-B/2017 dated 24.05.2017 to regularize the service of such Assistant Professors in the same post, same Pay Band and same AGP.

RECOMMENDATION:

The committee having gone through the said documents and observations is of the considered view that:

1. The AGP of Assistant Professors who are granted AGP of Rs.7000/- on completion of Ph.D. degree & may be reviewed and regularized their services from the date of completion of their Ph.D. in the AGP of Rs.6000/- as per their terms of appointment.

The Assistant Professors who had joined the services of the Institute with Ph.D. degree and granted the AGP of Rs.7000/- should be considered to refix their pay in the Pay Band to Rs.18600/- instead of Rs.15600/- as per the fitment table circulated by the MHRD vide their letter No.F.3-1/2009-U.I dated 04.06.2009.



All the above said 25 Assistant Professors were appointed on the basis of Ph.D. qualification and placed in the Pay Band-3 of Rs.15600-39100 plus AGP of Rs.7000/- without any advance increment.

BoG 50.26 Review of the agenda item no. 46.15 to fix the pay of Assistant Professors recruited in PB-3 with AGP of Rs.6000/- against the Advt. No.14/2012 and Advt. No.05/2013 reg.

The matter of pay fixation in respect of the Assistant Professors recruited in Pay Band-3 of Rs.15600-39100 + AGP of Rs.6000/- against the Advertisement No.14/2012 & No.05/2013 was placed before the Board of Governors in its 43rd meeting held on 23.01.2018 vide agenda item no. 43.26 and the action taken report was placed before the Board of Governors in its 45th meeting held on 04.06.2018 vide agenda item no. 45.18. Further the matter was placed before the Board of Governors in its 46th meeting held on 23.10.2018 vide agenda item No. 46.15 and in terms of decision taken by the Board in its 46th meeting, the matter was referred to the MHRD, Govt. of India vide letter No.Estt.-I/5909 dated 06.12.2018 for advice. A copy of the 46th BoG meeting minutes dated 23.10.2018 notified vide letter No.NITK/46th BOG/5615 dated 14.11.2018 is *enclosed as Annexure – 50.26(i) on page 255* & a copy of letter No.Estt.-I/5909 dated 06.12.2018 is enclosed as *Annexure – 50.26(ii) from pages 256 to 293*.

The MHRD, Govt. of India vide letter F.No.10-3/2019-TS.III dated 28.03.2019 has informed to the Institute to consider the matter as per rules & regulations issued by the MHRD and extant relevant instructions of Govt. of India and place the same before its Board of Governors for taking a decision. A copy of letter dated 28.03.2019 is enclosed as *Annexure – 50.26(iii) on page 294*.

In this context, it is submitted that in response to this Institute Advt. No.14 of 2012 & Advt. No.05 of 2013 and subsequent offer of appointment, 54 persons were appointed on contract basis for a period of three years to the post of Assistant Professor in the Pay Band-3 of Rs.15600-39100 + AGP of Rs.6000/- + 02 Increments (for M.Tech.). As per appointment letter their services were to be regularized only on acquiring the Ph.D. Degree within the specified period of three years or extended period for up to additional two years, as the case may be and their pay was to be fixed accordingly. At the time of initial fixation of their pay, they were granted 02 increments for M.Tech. degree in compounded nature inadvertently; whereas, as per Clause-24(vi) of Annexure-I of NIT Faculty Recruitment Rules-2011 notified by the Ministry of

Human Resource Development, Government of India, the increments for M.Tech. degree should have been granted to them in the non-compounded nature. The said Clause 24(vi) is reproduced below:

"During the contract period, the appointee will be put in pay band PB-3 with at least 2 non-compounded increments (for M.Tech. degree). He will also be entitled to the usual increments and allowances, and to all other benefits such as P.F., Pension, future gratuity etc. at par with the facilities extended to regular faculty."

Thereafter, on completion of Ph.D. degree the contractual services of some Assistant Professors were regularized from the date of acquiring of Ph.D. degree in Pay Band-3 of Rs.15600-39100 + AGP of Rs.7000/- + 02 compounded Increments vide OM dated 29.01.2015.

The matter was placed before the Board in its 39th meeting held on 05.04.2016 and 40th meeting of BoG held on 19.08.2016 and the Board decided to get the clarification from the MHRD, Govt. of India.

To look into the issues related to the grievances of the faculty & non-faculty members of the Institute, a High Level Committee was constituted by the Institute. 

The Assistant Professors as mentioned at Sr.No.6 & 7 have submitted their objections and the same have been considered by the Committee at the time of hearing.

After detailed deliberation, the committee had made following observations:

1. The Institute had recruited 85 Assistant Professors during the year 2012-2013 following the MRRs received vide from the MHRD, Govt. of India vide OM dated 14.03.2012 duly approved by the Board. The minimum qualification and experience requirements for faculty positions of NITs (under the standard 3 tier rigid faculty





structure) have been prescribed in the MRRA. It is categorically mentioned in the appointment letters of the Assistant Professors who have recruited against the Advt. No.14 of 2012 & Advt. No.05 of 2013 that they shall be governed under the NIT Act, 2007/Statutes/Rules of NIT Kurukshetra, framed and amended from time to time relating to service conditions and any other matters/conditions not specified in the appoint letter.

2. The candidates recommended by the Selection Committee possessing the M.Tech. qualification were appointed as Assistant Professor (on contract) in the PB-3 and AQP of Rs.6000/- + 02 increments (for M.Tech.); whereas, those possessing the Ph.D. qualification were appointed as Assistant Professor in the PB-3 and AQP of Rs.7000/- (without any increment), in the MRRA. It is mentioned that two advance increments shall be admissible at the time of recruitment for the post of Assistant Professor (on contract) with AQP of Rs.6000/- having the essential qualification M.Tech. whereas nothing is mentioned for the grant of any advance increment admissible at the time of recruitment in the case of Assistant Professor (on probation on a regular post) in the PB-3 and AQP of Rs.7000/- having Ph.D. as essential qualification.

3. Para 24(v) of NIT Faculty Recruitment Rules-2011 notified by the MHRD vide OM dated 14.03.2012 and approved by Board of Governors in its 28th meeting held on 20.07.2012 states that during the contract period, the appointee will be put in pay band PB-3 with at least 2 non-compounded increments (for M.Tech. degree). He will also be entitled to the usual increments and allowances, and to all other benefits such as P.F., Pension, Gratuity etc. at par with the facilities extended to regular faculty.

4. On completion of Ph.D. degrees, the services of said Assistant Professors appointed (on contract) with AQP. Rs.6000/- were regularized retroactively due to lack of clarity to the post of Assistant Professor from the date of acquiring of Ph.D. degree in pay banding of Rs.16000/9100 + AQP of Rs.7000/- + 02 compounded increments vide OM dated 02.01.2015. This created Pay Anomaly with the Assistant Professors (on regular basis) appointed in AQP of Rs.7000/- with Ph.D. qualification through the same advertisement and Selection Procedure. This has caused filing of Court Cases (CMP 4701 of 2016 filed Avnish Kumar Tripathi and Others Vs Union of India and Others).

5. The matter was placed before the Board in the 39th meeting held on 05.04.2016 and 40th meeting of B&G held on 19.08.2016 and the Board decided to get the clarification from the MHRD, Govt. of India.



6. A High Level Committee was constituted by the Institute to look into the issues related to the grievances of the faculty & non-faculty members of the Institute. In one of the grievances of the faculty, the Committee had recommended that the increments so granted have been merged with the basic pay; whereas, it should have been shown separately since their increments were of non-compounded in nature.
7. Subsequently, the MHRD, Govt. of India vide its letter F.No.2-5/2017-TS.III dated 17.07.2017 issued the clarification in consultation with the Department of Legal Affairs, Ministry of Law & Justice, Govt. of India to all the NITs that the regularization of such Assistant Professors may be carried out as per the terms and conditions of the appointment letter and Recruitment Rule prevailing at that point of time i.e. NIT Faculty Recruitment Rules-2011 notified by the MHRD vide OM dated 14.03.2012 in the same band and same AGP. Further, the financial upgradation/promotion is admissible through selection procedure as the recommendations of statutory Selection Committee as per Recruitment Rules prevailing at that point of time.
8. The matter was placed before the Board of Governors in its 43rd meeting held on 28.01.2018 for consideration and the Board decided as under:

Further, the Board decided that the AGP of 04 Assistant professors at Sr. no.4-7, namely Dr. Gurbabu Dyanamina, Dr. Jayaram Nalwa, Dr. Jay Prakash Misra and Dr. Ramesh be re-fixed to AGP of Rs.6,000/- plus 02 non-compounding increments in place of AGP of Rs.7,000/- plus 02 increments in consonance with the terms and conditions of their appointment letters and Recruitment Rules prevailing at that point of time (MRR 2011) i.e. in the same Pay Band and the same AGP of Rs.6,000/- plus 02 non-compounding increments as per the clarification issued by the Ministry vide MHRD letter F.No.2-5/2017-TS.III dated 17.07.2017 and their date of regularization be modified and their service be confirmed accordingly.

9. Accordingly, vide office order dated 09.02.2018, the pay of such Assistant Professors was re-fixed in the Pay Band 3 of Rs.15600-39100 + AGP of Rs.6000/- plus 02 non-compounded increments. However, in terms of orders dated 01.03.2018 passed by Hon'ble High Court of Punjab & Haryana, Chandigarh in the OWP No.5092 of 2018 - titled Dr. Jayaram Nalwa and others Vs Union of India and others the office order dated 09.02.2018 was put in abeyance till further orders vide order dated 02.04.2018.

10. The action taken report was placed before the Board of Governors in its 45th meeting held on 04.06.2018 vide agenda item no. 45.18 and the Board decided as under:

The Board noted the action taken by the Institute as per the decision of the BOG taken in its 43rd meeting held on 23.01.2018 and subsequent compliance of the orders of Hon'ble High Court.

After detailed deliberations, the Board decided that the ACP in said cases may be re-fixed after following the due procedure by issuing notice and providing them an opportunity of hearing. The Board authorized the Director to consider the replies and personal hearing. The report thereon be put up to the Board in its next meeting.

In terms of the said BOG decision dated 04.06.2018, the office order dated 09.02.2018 was withdrawn vide fresh office order dated 06.07.2018. The Hon'ble High Court was informed through Affidavit on 20.07.2018. The Hon'ble High Court passed the order on 31.07.2018 in the GWP No.5092 of 2018- titled Jayaram Nalka & Others Vs Union of India & Others that the present petition is disposed of having been rendered infructuous.

11. Accordingly, as per decision of the Board of Governors with reference to BOG 45.18 and in the light of decision of Hon'ble High Court, such Assistant Professors were informed vide letter dated 30.09.2018 to appear before the Director of the Institute during the period from 03.10.2018 to 05.10.2018 in person to present their case and objections, if any, at least 03 days before the said date in support of their defence.

12. The committee considered the objections submitted, the relevant documents including the terms and conditions of appointment, MPR-2017, enunciated vide MHRD, Govt. of India OM dated 14.03.2012 duly approved by the Board of Governors and clarification issued by the MHRD, Govt. of India vide OM No.2-5/2017-TS III dated 17.07.2017. Further, the 02 non-compounded advance increments are to be considered in pay fixation as per Deptt OM No.171/2010-Bstt (Pay-II) dated 08.12.2012, FR-21(a)(i) and Rule FR 22, GOI. It was observed that there was inadvertent error while fixing the pay and regularization of said Assistant Professors regarding the following:

- (i) Nature of 02 advance increments (for M.Tech.) by considering the increments as compounded instead non-compounded in nature; and
- (ii) Up-gradation to AQP of Rs.7000/- from AQP of Rs.6000/- while regularizing after completion of Ph.D. degree.

The illustration of "existing pay fixation" of said Assistant Professors vis-à-vis of Assistant Professors (regular basis) appointed in AQP of Rs.7000/- with Ph.D. qualification, and anomaly arose thereon, has

been shown in Appendix-A. Further, the pay fixation of said Assistant Professors by considering the advance increments as non-compounded one and AGP of Rs.6000/- as per the above mentioned relevant documents has also been shown in Appendix-A

Recommendations:

The committee having gone through all the relevant documents, objections of the concerned Assistant Professors and above stated observations is of the considered view that the Pay of all the above said Assistant Professors may be fixed on regularization of their services on acquiring the Ph.D. degree in the Pay Band-3 of Rs.15600-39100 + AGP of Rs.6000/- + 02 non-compounded increments (as per the formula/calculations proposed in Appendix-A) from the initial date of joining in terms of their appointment letters and Recruitment Rule prevailing at that point of time as well as MHRD, Govt. of India letter F.No.2-5/2017-TS.III dated 17.07.2017 and DoPT OM No.1/1/2010-Estt.(Pay-I) dated 06.12.2012, FR-9(21)(a)(i) and Rule FR 27, Q10(9).



The Assistant Professors as mentioned at Sr. No.3 & Sr.No.13 were absent from the Personal Hearing. The Asstt. Prof. as mentioned at Sr. No.03 has been relieved from the services of this Institute on resignation.



The committee considered their objection and heard the above candidates in person. After detailed deliberation, the committee had made following observations:

1. The Institute had recruited 85 Assistant Professors during the year 2012-2013 following the MRRs received vide from the MHRD, Govt. of India vide OM dated 14.03.2012 duly approved by the Board. The minimum qualification and experience requirements for faculty positions of NITs (under the standard 3 tier rigid faculty structure) have been prescribed in the MRRs. It is categorically mentioned in the appointment letters of the Assistant Professors who have recruited against the Advt. No.14 of 2012 & Advt. No.05 of 2013 that they shall be governed under the NIT Act, 2007/Statutes/Rules of NIT Kurukshetra, framed and amended from time to time relating to service conditions and any other matters/conditions not specified in the appoint letter.
2. The candidates recommended by the Selection Committee possessing the M.Tech. qualification were appointed as Assistant Professor (on contract) in the PB-3 and ACP of Rs.6000/- + 02 increments (for M.Tech); whereas those possessing the Ph.D. qualification were appointed as Assistant Professor in the PB-3 and ACP of Rs.7000/- (without any increment). In the MRRs it is mentioned that two advance increments shall be admissible at the time of recruitment for the post of Assistant Professor (on contract) with ACP of Rs.6000/- having the essential qualification M.Tech. whereas nothing is mentioned for the grant of any advance increment admissible at the time of recruitment in the case of Assistant Professor (on probation on a regular post) in the PB-3 and ACP of Rs.7000/- having Ph.D. as essential qualification.

In the MRRs it is mentioned that two non-compounded advance increments shall be admissible at the time of recruitment for the post of Assistant Professor (on contract) with ACP of Rs.6000/- having the essential qualification M.Tech. whereas nothing is mentioned for the grant of any advance increment admissible at the time of recruitment in the case of Assistant Professor (on probation on a regular post) in the PB-3 and ACP of Rs.7000/- having Ph.D. as essential qualification.
3. Para 24(v) of NIT Faculty Recruitment Rules 2011 notified by the MHRD vide OM dated 14.03.2012 and approved by Board of Governors in its 28th meeting held on 20.07.2012 states that during the contract period, the appointee will be put in pay band PB-3 with at least 2 non-compounded increments (for M.Tech. degree). He will also be entitled to the usual increments and allowances, and to all other benefits such as P.F., Pension, future gratuity etc. at par with the facilities extended to regular faculty.
4. However, the fixation of said Assistant Professors (on contract) was made/calculated by considering 02 Advance Increments (for M.Tech.) as compounded advance increments instead of non-compounded advance increments inadvertently due to lack of clarity.



5. A High Level Committee was constituted by the Institute to look into the issues related to the grievances of the faculty & non-faculty members of the Institute. In one of the grievances of the faculty, the Committee had recommended that the increments so granted have been merged with the basic pay whereas, it should have been shown separately since their increments were of non-compounded in nature.

6. Subsequently, the MHRD, Govt. of India vide its letter P.No.2-5/2017-TS.HI dated 17.07.2017 issued the clarification in consultation with the Department of Legal Affairs, Ministry of Law & Justice, Govt. of India to all the NITs that the regularization of such Assistant Professors may be carried out as per the terms and conditions of the appointment letter and Recruitment Rule prevailing at that point of time i.e. NIT Faculty Recruitment Rules-2011 notified by the MHRD vide OM dated 14.03.2012.

7. The matter was placed before the Board of Governors in its 49th meeting held on 23.01.2018 for consideration and the Board decided as under:

"Further, the Board decided that the ACP of 04 Assistant professors at Sr. No. 4-7, namely Dr. Giridhar Dhanamraju, Dr. Jayaram Naidu, Dr. Jay Prakash Misra and Dr. Rajnesh be revised to ACP Rs.6,000/- plus 02 non-compounded increments in place of ACP of Rs.7,000/- plus 03 increments in consonance with the terms and conditions of the appointment letters and Recruitment Rules prevailing at the point of time. MHRD letter P.No.2-5/2017-TS.HI dated 17.07.2017 and their state of regularization be modified and their service be confirmed accordingly."

8. Accordingly, vide office order dated 09.02.2018 the pay of such Assistant Professors was revised in the pay Band 2 of RS.45000-39100 + ACP of RS.6000/- plus 02 non-compounded increments. However, in terms of order dated 02/04/2018 issued by the High Court of Punjab & Haryana, Chandigarh in the OMP No. 7303 of 2018 - filed Dr. Rajesh Kumar and Others vs. Union of India and others, the office order dated 23.02.2018 was withdrawn vide office order dated 25.04.2018.

9. Accordingly, as per decision of the Board of Governors with reference to B.O. 4518 and in the light of decision of Hon'ble High Court, such Assistant Professors were informed vide letter dated 20.09.2018 to appear before the Director of the Institute during the period from 03.10.2018 to 05.10.2018 in person to present their case and objections, if any, at least 03 days before the said date in support of their defence.

10. The Committee considered the objections submitted by the Assistant Professors (on contract), the relevant documents including terms and conditions of appointment letters, MRRs-2011 circulated vide MHRD, Govt. of India vide OM dated 14.03.2012 duly approved by the Board of Governors and clarification issued by the MHRD, Govt. of India vide OM F.No.2-5/2017-TS.III dated 17.07.2017. Further, the 02 non-compounded advance increments are to be considered in pay fixation as per DoPT OM No.1/1/2010-Estt. (Pay-I) dated 06.12.2012, FR-9(21)(a)(i) and Rule FR 27, ClO(9). It was observed that there was inadvertent error while fixing the pay of said Assistant Professors (on contract) by considering the 02 advance increments (for M.Tech.) as compounded increments instead of non-compounded one. The illustration of "existing pay fixation by considering advance increments as compounded one" and "Pay fixation by considering advance increments as non-compounded one" is shown in Appendix-C.

Recommendations:

The committee having gone through all the relevant documents, objections of the concerned Assistant Professors (on contract) and above stated observations is of the considered view that the Pay of all the above said Assistant Professors (on contract) may be fixed in the Pay Band-3 of Rs.15600-39100 + AGP of Rs.6000/- + 02 non-compounded advance increments (as per formula/calculations proposed in Appendix-C) from the initial date of joining in terms of their appointment letters and Recruitment Rule prevailing at that point of time as well as MHRD, Govt. of India letter F.No.2-5/2017-TS.III dated 17.07.2017 and DoPT OM No.1/1/2010-Estt. (Pay-I) dated 06.12.2012, FR-9(21)(a)(i) and Rule FR 27, ClO(9).

The meeting ended with vote of thanks to the chair.



Sir,

This Ministry had received a reference from MNNIT, Allahabad seeking clarifications regarding applicability of the provisions of NIT Faculty Recruitment Rules, 2011 on Assistant Professors who were appointed in the Institute on contract as per provisions contained in above said Rules prior to the implementation of 4-Tier Flexible Faculty Structure. These Asst. Professors were not having Ph.D. degree at the time of their contractual recruitment following the provisions of 3 Tier System for Faculty recruitment in NITs.


2. One of the conditions of the contract signed between the appointees and the Institute was that *"as the appointee do not possess a Ph.D. degree which is an essential requirement, the post is offered initially for a period of three years which can be further extended by another two years on the recommendations of a valid Selection Committee. In the mean time the appointee will have to acquire Ph.D. degree, failing which the contract may not be extended beyond the period of five years. However, his/her services would be automatically regularised on the same post in the same Pay-Band and the same AGP from the date of his/her acquiring the Ph.D. degree within the stipulated period."*

3. Therefore, a clarification was sought by MNNIT, Allahabad whether such faculty can be regularised as per the rules and conditions of the appointment letter / contract or not in view of the fact that 4-Tier Flexible Faculty Structure is in vogue.

4. This matter was examined in this Ministry in consultation with D/o Legal Affairs, M/o Law & Justice. The regularisation of such Assistant professors (mentioned in Institute's letter dated 7th February, 2017) may be carried out as per the terms and conditions of the appointment letter and Recruitment rule prevailing at that point of time.

6. The Board of Governors of the Institute may take further necessary action in this matter.







BoG 50.27 To consider and decide on the advise of the Central Vigilance Commission about the CVC complaints of NIT Kurukshetra.

The following complaints concerned with this Institute were under consideration with the Central Vigilance Commission which have now been decided by the CVC and conveyed by the MHRD, Govt. of India as summarized under:

In view of the above, the Board may consider the advise of CVC in the above mentioned cases and decide.

BoG 50.28 To consider for the engagement of the Dental Surgeon on full time on contract basis for the Health Centre of the Institute.

The Institute has engaged a Dental Surgeon in the Health Centre on part-time basis for 04 hours i.e. 8:30 a.m. to 12:30 p.m. for day to day dental checkup of the employees, their families and students. At present the Dental Surgeon is being paid a consolidated salary of Rs. 15,000/- per month as per the decision taken by the Finance Committee in its 29th meeting held on 04.06.2014 and subsequently approved by Board of Governors in its 33rd meeting held on 04.06.2014.

In view of the increase of number of dental patients, it was felt that a full-time Dental Surgeon may be engaged on contract basis. The same observation was also considered by a Committee constituted for providing the better facilities in the Health Centre. The recommendations of the committee were placed before the Board of Governors in its 26th meeting held on 21.10.2011. The Board approved the recommendations of the Institute level committee for Health Centre. The recommendations of the committee are as under:

"The members observed that the services of Dental Surgeon at the Health Centre are inadequate as a large number of patients are visiting the Health Centre and the Dental Surgeon is available only for four hours. In view of this the Committee recommended that the Dental Surgeon may be appointed for full time on contract basis at consolidated salary of Rs. 25,000/- per month as per State Government norms. This may be placed before the Finance Committee and the BOG for consideration."

However, in view of the earlier decisions of the Finance Committee and Board of Governors, mentioned in para 1 of this agenda, the Dental Surgeon has been engaged on a consolidated remuneration of Rs. 15,000/- per month for limited period of 04 hours.

The Senior Medical Officer of the Health Centre has requested vide letter No.HC/2019/162 dated 02.05.2019 for the extension of the duty hours of the Dental Surgeon. In this letter she has mentioned that the Dental Treatment is a lengthy process, large number of patients remain unattended

due to limited time. Therefore, the duty hours of the Dental Surgeon may be extended to full-time so that more number of patients with better attention can be served. The remuneration of Dental Surgeon may accordingly be modified. A copy of the letter dated 02.05.2019 is enclosed as Annexure - 50.28(i) on page 302.

In view of the above, a Dental Surgeon on full-time is required in the Institute Health Centre. It is pertinent to mention here that there is a provision for the appointment of a Dental Surgeon in most of the Technical Institutes of repute like IIT, Delhi, IIT, Madras and IIT, Roorkee etc. The appointment of the Dental Surgeon can be made Under Clause 28 (2) of the First Statutes of the NITs.

Therefore, a Dental Surgeon on full-time may be engaged on contract basis against the approved post of Medical Officer initially for a period of one year on a consolidated salary of Rs.62832/- per month (Level 10 of Pay Matrix as per 7th CPC + Dearness Allowance admissible at the level of Medical Officer). For the appointment of Dental Surgeon, the qualification as prescribed by Ministry of Health and Family Welfare may be considered.

In view of the above facts, it is proposed that *the Institute may engage a full-time Dental Surgeon on contract basis as per the prescribed qualification of Dental Surgeon of Ministry of Health and Family Welfare, under clause 28 (2) of the Statute initially for a period of one year or till further orders.*

BoG 50.29 To note the Office Memorandum dated 19.01.2019 and 31.01.2019 issued by Department of Personnel & Training, Govt. of India regarding reservation for Economically Weaker Sections (EWSs) in direct recruitment in civil posts and services in the Govt. of India.

The Department of Personnel & Training, Govt. of India had issued Office Memorandum F.No.36039/1/2019-Estt.(Res.) dated 19.01.2019 regarding reservation for Economically Weaker Sections (EWSs) in civil posts and services in the Government of India. In this Office Memorandum, it has been notified that 10% reservation will be provided for Economically Weaker Sections (EWSs) in Central Government posts and services and would be effective in respect of all Direct Recruitment vacancies to be notified on or after 01.02.2019.

Subsequently, the Department of Personnel & Training had issued another Office Memorandum vide F.No.36039/1/2019-Estt.(Res.) dated 31.01.2019, in continuation of earlier Office Memorandum regarding reservation for EWSs not covered under the reservation scheme for SCs/STs/OBCs in respect of direct recruitment in civil posts and services in the Government of India.

The relevant points as mentioned in the above Office Memorandum dated 31.01.2019 are as under:

1. *The persons belonging to EWSs who are not covered under the scheme of reservation for SCs, STs and OBCs shall get 10% reservation in the direct recruitment in civil posts and services in Government of India.*
2. *Scientific and Technical posts which satisfy all the prescribed condition can be exempted from the purview of the reservation orders by the Ministries/Departments.*
3. *Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.0 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.*
4. *The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority.*
5. *Department of Personnel & Training had circulated Office Memorandum No.36012/2/96-Estt(Res) dated 02.05.1997 regarding implementation of post based reservation roster. The*

general principles for making and operating post based reservation roster would be as per the principles laid down in the said Office Memorandum.

6. *A person belonging to EWS cannot be denied the right to compete for appointment against an unreserved vacancy. Persons belonging to EWS who are selected on the basis of merit and not on account of reservation are not to be counted towards the quota meant for reservation.*
7. *Every Government establishment shall appoint a senior officer of the Department as the Grievance Redressal Officer.*
8. *Ministries/Department /Attached and Subordinate Offices shall appoint Liaison Officer to monitor the implementation of reservation for EWSs.*

OFFICE MEMORANDUM

Subject: Reservation for Economically Weaker Sections (EWSs) in civil posts and services in the Government of India

Reference is invited to Ministry of Social Justice and Empowerment O.M. No. F.No.20013/01/2018-BC-II dated 17.1.2019 on the above mentioned subject, which, inter-alia, reads as under:-

"1. In pursuance of insertion of clauses 15(6) and 16(6) in the Constitution vide the Constitution (One Hundred and Third Amendment) Act, 2019 and in order to enable the Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes, to receive the benefits of reservation on a preferential basis in civil posts and services in the Government of India and admission in Educational Institutions, it has been decided by the Government to provide 10% reservation to EWSs in civil posts and services in Government of India and admission in Educational Institutions.

2. Persons who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes and whose family has gross annual income below Rs. 8.00 lakh are to be identified as EWSs for the benefit of reservation. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWSs, irrespective of the family income:

- i. 5 acres of Agricultural Land and above;
- ii. Residential flat of 1000 sq. ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

3. The income and assets of the families as mentioned in para 2 would be required to be certified by an officer not below the rank of Tehsildar in the States/UTs. The officer who issues the certificate would do the same after

2. In pursuance of the above Office Memorandum, it is hereby notified that 10% reservation would be provided for Economically Weaker Sections (EWSs) in central government posts and services and would be effective in respect of all Direct Recruitment vacancies to be notified on or after 01.02.2019.

3. Detailed Instructions regarding operation of roster and procedure for implementation of EWS reservation will be issued separately.

OFFICE MEMORANDUM

Subject: Reservation for Economically Weaker Sections (EWSs) in direct recruitment in civil posts and services in the Government of India.

In continuation of this Department's Office Memorandum of even number dated 19.01.2019, the following instructions are issued in consultation with Ministry of Social Justice and Empowerment and Department of Legal Affairs regarding reservation for EWSs not covered under the reservation scheme for SCs/STs/OBCs in respect of direct recruitment in civil posts and services in the Government of India.

✓ 2. **QUANTUM OF RESERVATION**

The persons belonging to EWSs who are not covered under the scheme of reservation for SCs, STs and OBCs shall get 10% reservation in direct recruitment in civil posts and services in the Government of India.

✓ 3. **EXEMPTION FROM RESERVATION:**

3.1 "Scientific and Technical" posts which satisfy all the following conditions can be exempted from the purview of the reservation orders by the Ministries/ Departments: ✓

(i) The posts should be in grades above the lowest grade in Group A of the service concerned.

(ii) They should be classified as "scientific or technical" in terms of Cabinet Secretariat [OM No. 85/11/CF-61(1) dated 28.12.1961], according to which scientific and technical posts for which qualifications in the natural sciences or exact sciences or applied sciences or in technology are prescribed and the incumbents of which have to use that knowledge in the discharge of their duties.

(iii) The posts should be 'for conducting research' or 'for organizing, guiding and directing research'.

3.2 Orders of the Minister concerned should be obtained before exempting any posts satisfying the above condition from the purview of the scheme of reservation.

✓4. **CRITERIA OF INCOME & ASSETS:**

✓4.1 Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below **Rs. 8.00 lakh (Rupees eight lakh only)** are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application..

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq. ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

4.2. The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

4.3 The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

5. **INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:**

5.1 The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-I shall only be accepted as proof of candidate's claim as belonging to EWS: -

- (i) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/1st Class Stipendary

- Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
- (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
 - (iii) Revenue Officer not below the rank of Tehsildar and
 - (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

5.2 The Officer who issues the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the respective State/UT.

5.3 The crucial date for submitting income and asset certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise.

5.4 The appointing authorities should, in the offer of appointment to the candidates claiming to be belonging to EWS, include the following clause :-

"The appointment is provisional and is subject to the Income and asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate."

The appointing authority should verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority.

5.5 Instructions referred to above should be strictly followed so that it may not be possible for an unscrupulous person to secure employment on the basis of a false claim and if any person gets an appointment on the basis of such false claim, her/his services shall be terminated invoking the conditions contained in the offer of appointment.

6. EFFECTING RESERVATION - MAINTENANCE OF ROSTERS:

6.1 Department of Personnel and Training had circulated Office Memorandum No.36012/2/96-Estt(Res) dated July 2, 1997 regarding implementation of post based reservation roster. The general principles for making and operating post

based reservation roster would be as per the principles laid down in the said Office Memorandum.

6.2 Every Government establishment shall now recast group-wise post-based reservation roster register for direct recruitment in accordance with format given in Annexure II, III, IV and V, as the case may be, for effecting 10% reservation for EWSs interpolating them with the SCs, STs and OBCs. While fixing roster point, if the EWS roster point coincides with the roster points of SCs/STs/OBCs the next available UR roster point has been allotted to the EWSs and also the principle of "squeezing" has been kept in view. While drawing up the rosters, the cadre controlling authorities may similarly "squeeze" the last points of the roster so as to meet prescribed 10% reservation.

6.3 Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog.

6.4 Persons belonging to EWS selected against the quota for persons with benchmark disabilities/ex-servicemen shall be placed against the roster points earmarked for EWS.

7. **ADJUSTMENT AGAINST UNRESERVED VACANCIES:**

A person belonging to EWS cannot be denied the right to compete for appointment against an unreserved vacancy. Persons belonging to EWS who are selected on the basis of merit and not on account of reservation are not to be counted towards the quota meant for reservation.

8. **FORTNIGHTLY/ANNUAL REPORTS REGARDING REPRESENTATION OF EWS:**

The Ministries/Departments shall send single consolidated fortnightly report including their attached/subordinate offices beginning from 15.2.2019 as per format at Annexure-VI.

From 01.01.2020, the Ministries/Departments shall upload data on representation of EWSs in respect of posts/services under the Central Government on the URL i.e. www.rrcps.nic.in as on 1st January of every year. All Ministries/Departments have already been provided respective usercode and password with guidelines for operating the URL.

9. MAINTENANCE OF REGISTER OF COMPLAINTS BY THE GOVERNMENT ESTABLISHMENT:

9.1 Every Government establishment shall appoint a senior officer of the Department as the Grievance Redressal Officer.

9.2 Any person aggrieved with any matter relating to discrimination in employment against any EWS may file a complaint with the Grievance Redressal Officer of the respective Government establishment. The name, designation and contact details of the Grievance Redressal Officer may be displayed prominently on the website and in the office of the concerned establishment.


10. LIAISON OFFICER:

Ministries/Departments/Attached and Subordinate Offices shall appoint Liaison Officer to monitor the implementation of reservation for EWSs.

11. The above scheme of reservation will be effective in respect of all direct recruitment vacancies to be notified on or after 01.02.2019.

12. All the Ministries/Departments are requested to bring the above instructions to the notice of all appointing authorities under their control. In case of any difficulty with regard to implementation of the provisions of this OM, the concerned authorities may consult DOP&T through their administrative Ministry/Department.
