
**NOTIFICATION**

**Reporting Schedule for newly admitted B. Tech. students under DASA/MEA/ICCR/SII categories for the Academic Year 2021-22**

The candidates who have been provisionally allotted a seat in the B. Tech. programmes of National Institute of Technology, Kurukshetra under DASA/MEA/ICCR/SII counselling process for current Academic Year 2021-22 are required to report **ONLINE** during **18-22 November 2021** by following the process as explained hereunder:

- (1) The candidates who are required to pay Balance Institute Fee, if applicable as per **Annexure-B**, must pay the same through SBI Collect link to be uploaded on the Institute website before Nov. 18, 2021 along with the help document. **The link will be active from 10.00 am on 18.11.2021 until 05.00 pm on 22.11.2021.**
- (2) Thereafter, the candidates are required to fill the **Google Form** (link will be available on the Institute website before 18.11.2021) for online reporting wherein the payment receipt of Balance Institute Fee, if applicable, and also the relevant documents as per **Annexure-A** are to be submitted. The link for Google Form will also be activated from **10.00 am on 18.11.2021 and remain active until 7.00 pm on 22.11.2021.**
- (3) The candidates are mandatorily required to include the duly filled in and signed undertaking (Annexure-D) regarding genuineness and validity of the documents as part of **Annexure-A**.
- (4) The provisional Roll No. will be issued to those candidates only who have completed all the above three steps and the Roll Sheet for such candidates will be uploaded on the Institute website by 5:00 pm on 14.12.2021.
- (5) The admission will be provisional till the documents are physically verified at the Institute on the dates to be notified on Institute website in due course of time.
- (6) The candidates who do not report after payment of Balance Institute Fee, if applicable as per **Annexures-B**, during online reporting as per above schedule **will lose their allotted seats for which only they will be responsible.** It is responsibility of the candidate to complete all the admission formalities in the finally allotted institute.
- (7) **The orientation programme & classes** for 1<sup>st</sup> semester of B. Tech. programmes will **commence from Dec. 15, 2021 in online mode.** The schedule & time table for orientation programme & classes will be available on the Institute website in due course of time.

- (8) The Institute fee refund rules, as mentioned in **Annexure-B**, shall be applicable if any candidate withdraws his/her admission.
- (9) The hostel fee (Mess and Misc. related), as per **Annexure-C**, will be required to be paid for hostel accommodation at the time of physical reporting.
- (10) The candidates are required to visit the Institute website regularly for the latest updates.




