There is full tuition fee waiver for SC/ST/PWD categories as per the directions of Ministry of Education (erstwhile known as MHRD), Govt. of India. The other categories are also provided tuition fee relaxation on the basis of income of the family (up to 05 lac) from all sources.

The candidates seeking fee relaxation are required to produce income certificate, which must be issued by the Revenue Officer not below the rank of Tehsildar from his or her area of residence (preferably online certificate). The income certificate must include *Income from all sources of family for the Financial Year 2019-20* and must have been issued on or after April 01, 2020. The Affidavit/IT return submitted by the parents will not be considered towards tuition fee relaxation.

The candidate seeking fee relaxation must be ready with income certificate as mentioned above **on or before Nov, 09, 2020**. The institute will charge full tuition fee from the candidates who do not produce income certificate during Nov 09, 2020 to Nov, 13, 2020.

The institute will not entertain any request for extension in submission of income certificate for fee relaxation.
