The candidates who will be allotted seats in B.Tech. programmes of the institute in Academic Year 2021-22 through counselling process of JOSAA/CSAB-2021 are hereby informed that, the document verification will be held in the Institute in accordance with the schedule of JoSAA/CSAB-2021 in online/offline mode.

The schedule and guidelines for document verification and balance institute fee will be notified on the institute website in accordance with the schedule of JoSAA/CSAB-2021. They are advised to visit the institute/CSAB website in this regard.

There is full tuition fee waiver for SC/ST/PWD categories as per the directions of Ministry of Education (erstwhile known as MHRD), Govt. of India. The other categories are also provided tuition fee relaxation on the basis of income of the family (up to 05 lac) from all sources.

The candidates seeking fee relaxation are required to produce valid income certificate, which must be issued by the Revenue Officer not below the rank of Tehsildar from his or her area of residence (preferably online certificate). The income certificate must include **Income from all sources of family for the Financial Year 2020-21** and must have been issued **on or after April 01, 2021**. The Affidavit/declaration of income duly signed by Tehsildar will be considered towards tuition fee relaxation (**only for Rajasthan Domicile Students**).

The candidate seeking fee relaxation must be ready with income certificate as mentioned above on or before online/offline Institute reporting dates which will be notified on institute website after completion of JoSAA/CSAB-2021 admission process. The institute will charge full tuition fee from the candidates who do not produce income certificate at the time of institute reporting.

The institute will not entertain any request for extension in submission of income certificate for fee relaxation.
