The Institute also offers Master’s program in Computer Application and Business Administration (MCA & MBA).

National Institute of Technology Kurukshetra (NIT Kurukshetra), formerly a Regional Engineering College was established in year 1963. It is the first Engineering Institute established in the state of Haryana. 1. Counselling for admissions will take place as per counselling schedule displayed on website. No separate interview letters will be issued.
2. 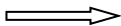

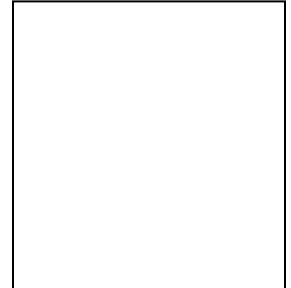
