1. In absence of eligible OBC (PWD) candidates, the vacant OBC (PWD) seat will be offered to the eligible candidates from Merit list of OBC Category.

2. In absence of eligible OBC candidates, the vacant OBC seat(s) will be offered to the eligible candidates from Merit list of Open Category.

3. In absence of eligible EWS candidates, the vacant EWS seat(s) will be offered to the eligible candidates from Merit list of Open Category.

4. In absence of eligible Open (PWD) candidates, the vacant Open (PWD) seat will be offered to the eligible candidates from Merit list of Open Category.

ESSENTIAL QUALIFICATIONS

The eligibility criterion is as under:

- Candidates must hold a Bachelor's Degree or equivalent qualification of any of the Universities incorporated by an act of the central or state legislatures in India or other educational institutions established by an act of Parliament or declared to be deemed as a University under section 3 of UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of HRD, Government of India / AIU. This degree must entail a minimum of three years of education after completing higher secondary schooling [Class 12 or equivalent] 10+2+3 system.
- The minimum percentage requirement in Bachelor's Degree or equivalent qualification is 50% (45% for SC/ST applicants).
- Basis for admission will be as follows: CAT/CMAT/GMAT/MAT or any other National level test Score card (Valid for 2021 Admission) 70 marks Performance in Personal Interview 30 marks

NOTE: No candidature will be considered for the Spot Round, If the candidate fails to produce the valid score card of any National level Test as mentioned above.
