- 4. The fees will be deposited with the assigned reference number only. No claim will be entertained for any mistakes on the part of the candidate. On the SBI Collect webpage, enter your name and reference number in the **remarks column**.
- 5. Due to the pandemic COVID-19, as of now, the fees of day-scholar (non-hostler) will be charged from all the students. All the dues related to the hostel, will be collected from the students opting for the hostel, at the time of physical reporting.
