NOTIFICATION

A meeting of all Deans, Chief Warden (Boys & Girls), SMO, Registrar I/C, Prof. I/C (Acad.), and Prof. A. Swarup, Sr. Most Professor as Special Invitee was held on 07.02.2022 under the Chairmanship of Hon'ble Director to review the prevailing situation and explore the possibility of allowing the students on campus. In light of Memo No. E 565431 DHE-010009/1/2022-Coordination-DHE dated 28.1.2022 received from Govt. of Haryana, Higher Education Department, Chandigarh (copy attached) and after detailed deliberations, following decisions were taken:

1. The students of M.Tech. 4th semester, MBA 4th semester, MCA 6th semester, B.Tech. 6th semester (for internship), and all Ph.D. scholars will be allowed on campus from 12.02.2022 onwards, however, the classes of these students, if any, will continue to be in online mode until 25.02.2022 and switched to **offline mode** from **07.03.2022** onwards.
2. *The mid semester break as scheduled from 11.03.2022 to 17.03.2022 is preponed and rescheduled from 28.02.2022 to 04.03.2022. This break, however, is not applicable to B.Tech. & MCA 1st year students.*
3. The students of B.Tech. 8th semester will be allowed on campus from 28.02.2022 onwards and their classes will be switched to **off-line mode** from **07.03.2022**.
4. For the students of B.Tech. 4th semester, M.Tech. 2nd semester, MBA 2nd semester, MCA 4th semester and rest of the students, a separate notification will be issued phase wise. Until then, the teaching and learning for these students will continue to be in **online mode** as per their respective academic calendar.
5. This arrangement will be periodically reviewed in view of the evolving COVID-19 situation and may change depending upon the prevailing conditions.
6. The above will be allowed on fulfillment of following conditions:

- The students must be fully vaccinated before their arrival on the Institute campus and they will be required to submit the proof thereof.
- The students will be required to follow COVID-19 appropriate behavior all the time during their stay in the campus including wearing masks, maintaining social distance etc.
- The Chief Wardens (Boys & Girls) will ensure that the above requirements are complied with by the students. In case of day scholars, the compliance of the requirements will be ensured by the office of Dean (SW).
- Normally, the students will not be allowed to go outside the Institute campus. However, in case of exigency, the students must take permission of the respective HoD/School Coordinator/Warden before leaving the campus.
- All HoDs/Coordinators of Schools will make arrangements for teaching and learning accordingly following the COVID-19 appropriate behavior.
- Dean (SW) will monitor the implementation of all measures regarding COVID-19 appropriate behavior and other arrangements.

7. The students will be required to pay the seat rent and other charges as per Institute norms.

Note: The students who are not vaccinated or who have not completed their second dose of vaccination, should inform the office of Dean (SW) immediately for further necessary action.

Instructions regarding COVID-19 Opening of Colleges and Universities.

Kindly refer to the subject cited above.

I have been directed to draw your kind attention to the order of Haryana Disaster Management Authority issued vide orders No. DMC-SPO-2020/1028 dated 28.01.2022 (Copy enclosed). In this regard you are requested to take necessary steps as follows:

All Universities and Colleges (whether State/Government or Private) are allowed to open w.e.f 01.02.2022 for physical classes while adopting requisite social distancing norms, regular sanitization and COVID 19 appropriate behavioural norms. All students of age group more than 15 years may also be advised to have at least first dose of vaccination, while attending physical classes. For fully residential universities, online classes are allowed till 28th February 2022, as the situation of covid will be ascertained by that time more clearly.

These orders are for strict compliance, please.


ORDER

It is in continuation of HSDMA order No. DMC-SPO-2020/863 dated 26.01.2022 vide which guidelines of 'Mahamari Alert-Surakhsit Haryana' were issued to be implemented in the State upto 10.02.2022(05:00AM).

Now, in exercise of the powers conferred under Section 22(2)(h) of the Disaster Management Act, 2005, the undersigned in my capacity as Chairperson, State Executive Committee order the amendments in the guidelines of 'Mahamari Alert-Surakhsit Haryana' as follows:-

- I. All cinema halls, theatres, multiplexes are allowed to open with 50% seating capacity while adopting requisite social distancing norms, regular sanitisation and COVID-19 appropriate behavioural norms.
- II. Universities, Colleges, Schools (for classes 10th to 12th only), Polytechnics, ITIs, Coaching Institutions, Libraries and Training Institutes (whether Government or private) are allowed to open w.e.f. 01.02.2022 for physical classes while adopting requisite social distancing norms, regular sanitisation and COVID-19 appropriate behavioural norms. Concerned institutions may advise all the students of age group more than 15 years to have at least first dose of vaccination, while attending physical classes. All the departments concerned will release guidelines for implementing the same.

All the Deputy Commissioners shall implement the guidelines strictly. Any person violating these measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005 and other legal provisions as applicable.
