The candidates who have been allotted a seat in B.Tech. programmes of National Institute Technology, Kurukshetra through counseling process of JoSAA/CSAB-2022 for Academic Year 2022-23 will be required to report offline in the Institute (Physical Reporting) for provisional admission only after completion of CSAB-2022 Special Rounds. As per schedule of Special Rounds of CSAB-2022, the Physical Reporting in the allotted Institute will be held from 04 Nov., 2022 to 09 Nov,2022. For more information in this regard , please visit www.josaa.nic.in & www.csab.nic.in regularly.

The following points may kindly be observed: -

1. The candidates who have been allotted a seat in B.Tech. programmes of the Institute through JoSAA-2022 will be required to pay Partial Admission Fee (PAF) during 19-21 October, 2022 on JoSAA/CSAB-2022 portal.
2. It is mandatory for candidates to pay PAF on JoSAA/CSAB-2022 portal in order to secure their final admission in the Institute, failing which their allotted seat will be reported as vacant seat to CSAB-2022 by the JoSAA-2022. The allotment on such seat will be automatically cancelled after 05:00 pm on 21 Oct, 2022 for which the candidate will be responsible.
3. The Institute will conduct offline reporting only after completion of CSAB-2022 Special Rounds from 04 Nov., 2022 to 09 Nov,2022 as per CSAB-2022 schedule. The detailed notification for the same will be uploaded on the Institute website by last week of October,2022 (www.nitkkr.ac.in under tabs :- Admission-2022 -> B.Tech.).
4. The classes for B.Tech. 1st semester are expected to commence from Nov. 09, 2022 in offline mode (Physical) only.
5. The candidates are required to produce photocopy of same medical fitness certificate uploaded on the JoSAA/CSAB-2022 portal.
6. The candidates are advised to get two doses of COVID-19 vaccination by end of this semester.
7. The Academic Calendar of B.Tech. 1st and 2nd semester will be notified on the Institute website by last week of October-2022. The candidates are advised to refer Academic Calendar of B.Tech. 1st semester for all teaching learning activities in this semester.
