**NOTIFICATION**

**Reporting Schedule for newly admitted M.Tech candidates through Regular / Special Rounds of CCMT-2022 counselling process for the Academic Year 2022-23**

The candidates who have been provisionally allotted a seat in the M.Tech programmes of National Institute of Technology, Kurukshetra through Regular / Special Rounds of **CCMT-2022** counselling process for current Academic Year 2022-23 are required to report **ONLINE from 11<sup>th</sup> Aug 2022 to 18<sup>th</sup> Aug 2022** by following the process as explained below :


- (1) The candidates must have deposited Partial Admission fee (PAF) or Special Round (SR) Participation Fee on CCMT 2022 Portal.
- (2) The documents of the candidates must have been verified on CCMT 2022 portal by the respective Verifying Officers and they must have Online Document Verification Certificate (ODVC) generated from CCMT 2022 portal.
- (3) All the candidates are required to deposit Balance Institute Fee (BIF) as per Annexure B through SBI Collect. The link for same will be made available and activated on the Institute website by 10:00 A.M on 10<sup>th</sup> Aug 2022.
- (4) Thereafter, the candidates are required to fill the **Google Form** for online reporting wherein the payment proof of BIF and the relevant documents as per **Annexure-A** are to be submitted. The link for Google Form will **be activated by 10:00 A.M. on 10<sup>th</sup> Aug 2022 and will remain activated till 5:00 P.M on 18<sup>th</sup> Aug 2022.**
- (5) The candidates are mandatorily required to include the duly filled in and signed undertaking as per **Annexure-C** regarding genuineness and validity of the documents as part of **Annexure-A**.
- (6) The provisional Roll No. will be issued to those candidates only who have completed all the above steps and the Roll Sheet for such candidates will be uploaded on the Institute website by 5:00 pm on 20.08.2022.
- (7) The admission will be provisional till the documents are physically verified at the Institute on the dates to be notified on Institute website in due course of time.
- (8) The candidates who do not report after payment of BIF as per CCMT guidelines during online reporting as per above schedule **will loose their allotted seats for which only they will be responsible.** It is responsibility of the candidate to complete all the admission formalities in the finally allotted institute.

- (9) The classes of M.Tech 1st semester will commence tentatively from 22<sup>nd</sup> August, 2022 in offline mode till further directions of Ministry of Education (MoE) and Government of Haryana due to COVID-19. The academic calendar will be uploaded on the Institute website.
- (10) The GATE Scholarship will be paid to the eligible admitted students of M.Tech Programmes only after physical verification of the documents at NIT Kurukshetra. The dates for physical verification will be notified in the month of September 2022. However, the scholarship will be paid to the eligible admitted students w.e.f commencement of classes subject to fulfilling attendance criterion.
- (11) The fee deposited by the candidate will be refunded as per Institute Refund Rules as mentioned in Annexure B, if a candidate wishes to withdraw admission after Online Reporting.
- (12) The hostel fee (Mess and Misc.), as per **Annexure-D**, will be required to be paid for hostel accommodation. Hostel authorities may be contacted in case of any query.
- (13) The candidates are required to visit the Institute website ([www.nitkkr.ac.in](http://www.nitkkr.ac.in)) regularly for latest updates.


