4. The fees shall be deposited **ONLY through SBI Collect**

5. The fees will be deposited with the assigned roll number (to be provided by the academic section from 30.06.2023 to 01.07.2023) and unique Id (mentioned in the First Merit List) only. No claim will be entertained for any mistakes on the part of the candidate.
6. After the deposit of fees, the candidate must submit the Fees receipt in the department till 05:00 PM for further process.
7. The candidates who do not deposit the FULL fees will lose his/her seat in the respective category and further no claim will be entertained in any manner.
