2. The fees will be deposited with the assigned roll number (to be provided by the academic section on 07.07.2023) and unique Id (mentioned in the Second Merit List) only. No claim will be entertained for any mistakes on the part of the candidate.

3. After the deposit of fees, the candidate must submit the Fees receipt in the department till 02:00 PM for further process.

4. The candidates who do not deposit the FULL fees will lose his/her seat in the respective category and further no claim will be entertained in any manner.

5. The vacant seats, if any, of the OPEN categories will be notified on **July 10, 2023**. The vacant seats will be offered to the waitlisted candidate in the order of the merit.

6. **No candidate will be considered for MBA Admission in any circumstance who have not appeared in the GD and PI process.**
