Spot Rounds of CCMT/CCMN-2023 counselling process for the Academic Year 2023-24

The candidates who have been provisionally allotted a seat in the M.Tech/M.Sc. programmes of National Institute of Technology, Kurukshetra through Regular / Special/national Spot Rounds of CCMT/CCMN-2023 counselling process for current Academic Year 2023-24 are required to report ONLINE from 17th Aug 2023 to 21st Aug 2023 by following the process as explained below:

- (1) The candidates must have deposited Partial Admission fee (PAF) or Special Round (SR) Participation Fee or National Spot Round (NSR) Participation Fee on CCMT/CCMN-2023 Portal.
- (2) The respective Verifying Officers must have verified the documents of the candidates on CCMT/CCMN 2023 portal and the candidates must have Online Document Verification Certificate (ODVC) generated from CCMT/CCMN 2023 portal.
- (3) The candidates will be allotted **Institute Roll No Provisionally** after announcement of Seat Allotment Result in National Spot Round (NSR) by the CCMT/CCMN-2023 (Tentatively by 05:00 pm on 17.08.2023). The candidates will be sent **Provisional Roll No. Allotment Letter (PRAL)** containing their **Provisional Roll No.** only on their registered email id received from CCMT/CCMN--2023. The candidates must use this Provisional Roll No whenever they communicate with the Institute regarding their admission in the Institute.
- (4) All the candidates are required to deposit **Balance Institute Fee (BIF)** as per **Annexure B** through SBI Collect. The link for same will be made available and activated on the Institute website by 10:00 A.M on 17th Aug 2023.
- (5) Thereafter, the candidates are required to fill the Google Form for online reporting wherein the payment proof of BIF and the relevant documents as per Annexure-A are to be submitted. The link for Google Form will be activated by 10:00 A.M. on 17 Aug 2023 and will remain activated until 5:00 P.M on 21st Aug 2023.
- (6) The candidates are mandatorily required to include the duly filled in and signed undertaking as per **Annexure-C** regarding genuineness and validity of the documents as part of **Annexure-A**.
- (7) The provisional Roll No. will be issued to those candidates only who have completed all the above steps and the Roll Sheet for such candidates will be uploaded on the Institute website by 5:00 pm on 22.08,2023.
- (8) The admission will be provisional until the documents are physically verified at the Institute on the dates to be notified on Institute website in due course of time.

- (9) The candidates who do not report after payment of BIF as per CCMT guidelines during online reporting as per above schedule will loose their allotted seats for which only they will be responsible. It is responsibility of the candidate to complete all the admission formalities in the finally allotted institute.
- (10) The classes of M.Tech and M.Sc. 1st semester will commence tentatively from 22nd August, 2023 in offline mode till further directions of Ministry of Education (MoE) and Government of Haryana due to COVID-19. The academic calendar will be uploaded on the Institute website.
- (11) The GATE Scholarship will be paid to the eligible admitted students of M.Tech Programmes only after physical verification of the documents at NIT Kurukshetra. The dates for physical verification will be notified in the month of September 2023. However, the scholarship will be paid to the eligible admitted students w.e.f commencement of classes subject to fulfilling attendance criterion.
- (12) The fee deposited by the candidate will be refunded as per Institute Refund Rules as mentioned in Annexure B, if a candidate wishes to withdraw admission after Online Reporting.
- (13) The hostel fee (Mess and Misc.), as per **Annexure-D**, will be required to be paid for hostel accommodation. Hostel authorities may be contacted in case of any query.
- (14) The candidates are required to visit the Institute website (www.nitkkr.ac.in) regularly for latest updates.




