The above research scholars are required to pay semester fee as applicable to the research scholars admitted in AY 2023-24 in addition to the mercy chance fee of Rs. 20,000/-, if not paid earlier.

They are required to report in the concerned Departments along with the payment proof of applicable fee to join the PhD programs from 04.09.2023 to 15.09.2023 failing which their provisional re-admission in PhD programs will be cancelled. They will not be allowed to submit thesis before two years from the date of fresh registration. The course work, comprehensive examination and publications, if any/completed, will be considered towards their PhD thesis submission.

The Chairperson, DRC/SRC is requested to appoint/re-allocate them supervisor/co-supervisor as per requirement under the provisions of PhD Regulations 2023-24.

NOTIFICATION


The Senate in its 49th meeting held on 27.04.2023 vide agenda item no. S 49.24 decided to give a mercy chance to the research scholars whose registration/re-registration period has expired or is expiring by 31st August, 2023 after maximum allowable period as per respective Ph.D. ordinance. They are hereby allowed to register afresh in Ph.D. program on request basis.

The below-mentioned terms and conditions will be followed in such cases:

1. The research scholars will be required to pay One-time additional amount of Rs. 20000/- besides the usual fee chargeable for fresh registration in the Ph.D. program.
2. The research scholars will not be allowed to submit thesis before two years from the date of fresh registration.
3. The course work, comprehensive examinations and publications, if any/completed, will be considered towards his/her Ph.D. thesis submission.

In view of above, the eligible research scholars registered in Ph.D. program in the years 2013 onwards and whose registration/re-registration period has expired or is expiring by 31st August, 2023 after maximum allowable period may request in writing to the Office of the Dean (Academic) for fresh registration in Ph.D. program in Odd semester of Academic Year 2023-24 latest by 31st August, 2023. The requests received after due date will not be considered.
