

S 50.05 To consider the requests of students for relaxation in the academic rules for promotion to higher semester of B.Tech. programme.

The Senate considered the proposal and approved relaxation in the academic rules for promotion to higher semester of B.Tech. programme with the following guidelines which will be effective from academic session 2023-24 for all batches.:

- (i) A student will be promoted to the higher semester irrespective of number of reappears in lower semesters. However, student will not be allowed to appear in the examinations for more than N+6 courses in any semester, where 'N' is the total no. of courses of the current semester the student is studying in and 6 is the maximum number of reappear courses (internal and/or external).
- (ii) The examination of odd semester courses (both internal and external) will be held in odd semester and the examination of even semester courses (both internal and external) will be held in even semester.

S 50.10 To consider the request of Defence Research & Development Organization (DRDO) for offering some vacancies for DRDO sponsored candidates under Research & Training (R&T) scheme in M.Tech. programmes of the Institute.

The enhanced intake under self-finance will be equal to the respective sanctioned intake in each M.Tech. programme. The self-financed candidates will not get any financial support from the Institute. GATE score will not be mandatory for admission to these seats under self-finance and the admission will be made through Spot Counselling by issuing notification on the Institute website. The fee structure of the candidates admitted under self-finance will have 50% higher tuition fee compared to the un-reserved candidates admitted to the M.Tech. programmes through CCMT counselling. will be no relaxation in the fee irrespective of the category of the candidate. The admissions will be made under this category from the academic year 2023-24 after getting the approval of the BoG of the Institute.
