Like last year, this year as well, the whole process will happen on a digital platform. Students shall write their tests online and appear for interview online from their respective locations.

Kindly find below a brief of whole process of OPJEMS 2024

1. The process shall start with concerned institute sharing nomination on the basis of the following **nomination criteria**.

*Engineering Institute:* First three toppers from 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> year of following streams:

- a. Civil Engineering
- b. Electrical Engineering
- c. Mechanical Engineering
- d. Metallurgical Engineering

2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> year – on the basis of their GPA of previous academic year and in the case of 1<sup>st</sup> year students – on the basis of their cumulative score of selection process.

*Management Institute:* First ten toppers from 1<sup>st</sup> & 2<sup>nd</sup> Year;

2<sup>nd</sup> year on the basis of their GPA of previous academic year and in the case of 1<sup>st</sup> year students – on the basis of their cumulative score of selection process.

2. OPJEMS 2024 assessment will be conducted in **Two Phases:**

Phase 1: Submission of business proposals by candidate & Online Test (PPA + Jindal Awareness)

Phase 2: Personal Interview

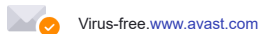
