

## Terms and Conditions

1. The provisional admission offer is valid only on award of the ICCR Scholarship to the candidate by the ICCR. In case, if you are awarded ICCR scholarship then please confirm your acceptance of this admission offer by Email: [dasa@nitkk.ac.in](mailto:dasa@nitkk.ac.in) on prescribed format as per Annexure-3 enclosed with this letter on or before **01-08-2024 (Plz visit ICCR and NIT Kurukshetra portal in this regard)**.
2. Please note that classes for the above programme will commence only after completion of the admission process on the regular seats through JoSAA/CSAB-2024. Please visit Institute website ([www.nitkk.ac.in](http://www.nitkk.ac.in)) regularly for latest update in this regard.
3. In case you accept the offer, the tuition fee, Institute Other Charges and Hostel expenses (as mentioned below) would have to be paid:

### **Tuition Fee, Institute Other Charges and Hostel Charges details (Per Semester):**

- a) **Tuition Fee** in INR as per Annexure-1 per semester. This is fixed for all the semesters during study.
  - b) **Institute Other Charges** is in INR as per Annexure-1 per semester. This fee is of variable nature and may be increased on the annual basis as per the approval of the competent authority.
  - c) **Hostel Mess Advance, Hostel Security (Non-Refundable, to be charged one time) and Electricity Advance** as per Annexure-1 per semester. The charges under this head are of variable nature and may have to be paid by every hosteller as per the rules of hostel administration. You are required to pay hostel advance as per Annexure-1 at the time of allotment of the hostel rooms during physical reporting in the Institute.
  - d) The candidates offered admission under ICCR scholarship scheme are only required to pay Institute Security (Refundable), Library Security (Refundable) from their own pocket. The candidates are also required to pay Hostel Seat Rent (Single Seater) from their pocket which is part of the Institute Other Charges at the time of acceptance of the admission offer. The ICCR will pay Hostel Seat Rent and other scholarship amount directly to the candidate as per new scholarship rules of the ICCR effective from AY 2023-24 onwards. The tuition fee & Institute Other Charges other than Hostel Seat Rent will be paid by the ICCR under relevant ICCR Scholarship scheme directly to the Institute.
  - e) The candidate is required to pay additional amount if ICCR Scholarship amount is short of his/her expenses towards Institute, tuition and hostel heads.
4. The Institute follows semester system the Academic Year and they are given as below for better understanding of the foreign students.

**Academic Year: July 01 to June 30**

**Odd Semester: July to December**

**Even Semester: January to June**

5. The Institute Security (Non-Refundable) and Hostel Seat Rent can be remitted online through Bank Transfer as per details given in Annexure-1.
6. The Institute/hostel fee paid will be refunded under the Institute/hostel refund rules in the bank account of the candidate, in case if you wish to withdraw your admission.
7. The Institute/hostel fee amount paid will not be refunded if it is found at any stage that you secured admission on the basis of fraudulent documents.
8. After remittance of Institute Security (Refundable) Library Security (Refundable) and Hostel Seat Rent, you have to submit Acceptance Letter on the prescribed format as per Annexure-3, educational and other documents as per Annexure-2 along with scanned copy of proof of Institute Security (Refundable) Library Security (Refundable) and Hostel Seat Rent payment as per Annexure-1 in the

office of the Deputy Registrar (Academic) through email at: [dasa@nitkkr.ac.in](mailto:dasa@nitkkr.ac.in) on or before **01-08-2024** (Plz visit ICCR and NIT Kurukshetra portal in this regard).

9. You are required to present yourself in person for completing registration/admission formalities (Physical Reporting) on any notified day. You will be intimated in this regard by email also. Extension request for Physical Reporting will NOT be permitted under any circumstances.

10. You are required to produce this admission offer letter along with other documents to the Indian embassy in your country to apply for VISA to enter India for studies at Institute probably before start of academic activity in the Institute in offline mode (In campus). The citizens of Nepal, Bhutan have VISA free entry if they travel directly from their country by Air/Land route to India.

11. The list of documents that you must bring along with you is mentioned in Annexure-2. You are strongly cautioned not to come to the Institute unless you have all originals of your qualifying degree certificates/mark sheets/transcripts, on the basis of which, you have been offered provisional admission to this programme.

12. Your admission is strictly on provisional basis and is liable to be cancelled in case, if you do not fulfil minimum requirement for admission in the programme.

13. You will be treated at par with the students admitted in the similar category i.e. Direct Admission Category (DASA, MEA, ICCR, SII etc).

14. The candidates securing admission on ICCR Scholarship are not eligible to apply for any other Government Scholarships.

15. You will be issued Roll No. of the Institute on provisional basis by the academic section on receipt of your Acceptance Letter on prescribed format as per Annexure-3, other required documents as per Annexure-2 along with scanned copy of proof of payment of Institute Security (Refundable), Library Security (Refundable) and Hostel Seat Rent as per Annexure-1 by email on [dasa@nitkkr.ac.in](mailto:dasa@nitkkr.ac.in) email id.

16. You shall abide by the rules and regulations of the country, state and the Institute and any violation of the same may attract appropriate disciplinary action of the respective rule framing authority.

17. You shall be provided hostel accommodation (separate for boys and girls) in the Institute hostels at the time of physical reporting. The Institute does not provide hostel accommodation for your spouse and family members.

18. Lodging/Mess facility is compulsory for all Hostellers. The Mess charges are likely to be around **US\$ 500/- (in INR 30,000/- to 40,000/- )** for each semester and will have to be paid as per the rules of the hostel administration.

19. The **territorial jurisdiction** for all type of disputes will be at **Kurukshetra/Haryana or New Delhi in India only** (whichever is applicable).

You are required to send Acceptance Letter on prescribed format as per Annexure-3, requisite documents in soft copy as per Annexure-2 along with scanned copy of proof of Institute Security (Refundable), Library Security (Refundable) and Hostel Seat Rent payment as per Annexure-1 at [dasa@nitkkr.ac.in](mailto:dasa@nitkkr.ac.in) on or before **01-08-2024** (Plz visit ICCR and NIT Kurukshetra portal in this regard) else this offer of admission will be automatically cancelled.
