The letter received from MOE, GOI and draft Guidelines are placed as <u>Annexure 65.10 (i) from page 64 to 66</u>.

The competent authority in the Institute constituted a committee vide office letter no. Dean(SW)/24/05 dated: 03.01.2024 for framing guidelines and modalities to be followed in establishment of NITK-AEB and NITK Alumni Endowment Fund (NITK-AEF).

Centrally Funded Technical Institutes (CFTI) Endowment Fund

Draft Guidelines

The following are the key features of the Endowment Fund that may be floated by each CFTI for the purpose of mobilizing donations and contributions from alumini, industry and Philanthropy:-

- i. Each CFTI should create a separate CFTI Endowment fund bank account where donations from alumni, industry and philanthropists will be kept. This account will have two types of donations.
 - a. Donations which come for a specific purpose, say Scholarships, Chairs, Infrastructure Development or even more specific purposes.
 - b. Donations for a general corpus or endowment (unencumbered corpus).
- ii. Separate and transparent accounting shall be maintained for each subhead within the CFTI endowment fund bank account.
- iii. The Endowment fund will be governed by a Board which will be chaired by the Director and would include some Professors from the CFTI and prominent donors from the alumni. The Board will take major decisions about the fund utilization.
- iv. Donations for the corpus will be invested and only earnings from them can be spent for purposes of developing the CFTI. The corpus amount will not be spent.
- v. The Governing Board of the Endowment Fund may decide on how the fund will be managed and if it needs to open a new section 8 company/trust. If the later option is taken, then the Director of the CFTI will be the Chairman (ex-officio) of the Board of this company/trust.

2. The above items constitute the core and fundamental principles of the Endowment hund and shall not be changed by the Board/Executive Body under any circumstances.

3. Inspirational value to the amount of corpus fund to be mobilized shall be fixed by each CFTI based on its alumni strength, average salary of each alumni and possibility of mobilizing donations from philanthropy from & other sources.

4. Further details of the Endowment Fund may be worked out by each CFTI based on its unique situation

5. In view of full tax benefits available to CFTIs, the Endowment Fund money shall be received in the bank account of CFTI and not of the Section 8 Company / Trust, till modification of the rules by Ministry of Finance.

6. The decision to have a Trust / Section 8 Company to manage the funds is left to the CFTI. In addition to fund mangement, the Section 8 Company / trust could also help in fund generation and organising reunions (at 5 year intervals) for batches of alumni.

7. FCRA account may be opened by the Institutes where substantial donations are expected from outside India. The FCRA account will receive foreign donations and transfer them to the Endowment Account.

8. Permission must be obtained from the competent Ministry / Authority in order to invest the endowment funds, outside of the Gol Guidelines.

REPORT

The University Grants commission, while formulating the guidelines of incentives for resource mobilization for X-Plan stressed the need of support from the public, in realizing the goals of higher education. Further the Ministry of Human Resource Development, Govt. of India via letter no. F.No.33-4/2020-TS-III (Pt.1), dated 5th May 2020 (copy enclosed), has directed the CFTIs to create the 'Endowment Fund' for the purpose of mobilizing donations and contributions from Alumni, Industry, Philanthropy etc.

To follow the directions of the Ministry, it is proposed that a **NIT Kurukshetra Alumni Endowment Fund** may be created in the institute to receive all funds/donations/endowment/contributions etc. from Alumni, Industry, Philanthropy etc. along with Alumni Fee collected yearly in an Institute bank account through various modes such as NEFT/IMPS/Wire Transfer/Cheque etc. Some of the NITs such as NIT Warangal, NIT Rourkela, SVNIT Surat, NIT Surathkal etc., have created such Endowment funds and are using their respective Endowment Fund.The institute seeks continued support from its alumni in making NIT Kurukshetra-Alumni relations stronger and making the institution take its rightful place among the top technological institutes of the world. In this regard the institute may open a separate account for this purpose.

Salient Features of the proposed NIT Kurukshetra Alumni Endowment Fund Structure

The proposed **NIT Kurukshetra Alumni Endowment Fund** will be established for the benefit of the institute and its alumni professional growth and reputation with a vision to further the mission of the institute. Recently, the national Quantum Mission was approved by the Union Cabinet to seed, nurture and adopt scientific and industrial R&D to create and demonstrate a vibrant and innovative ecosystem in Quantum Technologies in the country. With the advancement and growth strategy, the Institute also focussing upon Interdisciplinary Research including Quantum Technologies (quantum computing, quantum communication, Quantum sensing and metrology, and quantum materials & devices), Multifunctional materials, Data Science, Artificial Intelligence, Machine Learning, and Nonlinear Fiber Optics), Industrial Relations and Internationalization. The funds/donations/endowment/contributions etc. may be used to fund operating and capital expenses.

The endowment fund structure is envisioned on following fundamental principles.

- To further the mission of NIT Kurukshetra in line with its charter.
- To have the best-in-class governance structure.
- To ensure the sustainability of the institute in the long term and
- To provide maximum tax benefits to the donors and the institute.

Objectives of the Scheme

- To evolve a process for mobilizing resources by encouraging the participation of Alumni, Corporates and Society in the institute development.
- To extend financial support to the young talents/poor students to achieve their dreams without any financial constraints during their study period under special conditions..
- To create the corpus that works over a period of time, as a backbone for institutions specific purpose viz., Establishing Centres of Excellence in the specialized field of new technology and system management, provide financial assistance to Fundamental Research in Engineering, Science and Management, develop infrastructure for the growth of research activities.
- To ensure smooth sustenance of the institute in continuing the core activities of research, innovation and development during the financial crisis or any Unforeseen contingencies and
- To provide support to the organizations which involve society in their development activities.
- To offer scholarships to the performing students as per desire of donor.

With the aims and objects, on the terms and conditions and in the circumstances, set forth hereinafter:

Whereas, since the last many years, Alumni who are one of the principal stakeholders of the institute have been holding reunions of 10-year, 25-year, 40-year, golden jubilee and other periods and whenever such meetings of the Alumni of NIT Kurukshetra' were being held, the members who were attending those meetings were expressing their deep feelings of gratitude and being 'beholden to their Alma mater and are wishing to GIVE BACK TO THEIR ALMA MATER for what they are today.

In the recent past several such GIVE BACK initiatives were planned and Alumni batches have created corpus to the tune of several lakhs. Several Alumni have also expressed to donate bulk amounts with a focused objective like Innovation, Design thinking and Tinkering etc.

The underlying theme and notable feature of all such initiatives is that Alumni do have and feel great affinity akin to filial bonds of children towards their parents, and were conveying a deep Fund strong urge to do some significant, unique and substantial service in all possible ways and means, by working in tandem and association with NIT Kurukshetra and play a supplementary and even a complementary role in the promotion of studies, research and development in the fields of science, engineering and technology, including futuristic studies as also nascent and emerging technologies (like Quantum technologies; Cloud Computing, Data Centre, VLSI, Renewable Energy, Machine Learning and new branches of science like Nano-Science and Technology, Photonics, etc.,) and create necessary infrastructure and organizational setup.

In addition to these initiatives, several corporations are willing to support academic institutions by setting up Centers of Excellence with substantial funding from their CSR grants. Such initiatives also have a larger perspective of not limiting the benefits of such support to our institute, but in turn spread and share these facilities for the improvement of technical education in the region.

. Page **2** of The institute has some of the best talent pool of technocrats and researchers who are young and are willing to explore uncharted areas and challenges. In order to meet the aspirations and requirements of such researchers, funding from within the institute budget may not suffice. In such circumstances, departments or individual faculty can float a project proposal for funding with clear details of objectives, achievable deliverables and value addition to curriculum or to the institute. Such project proposals can be vetted by the NIT Kurukshetra Endowment Fund management committee (hereafter referred as "COMMITTEE") and floated to alumni and corporates seeking support and funding.

Utilization and purpose

The proposed areas of utilization of **NIT Kurukshetra Alumni Endowment Fund** shall be, but not limited to

1. Infrastructure development

Acquiring accommodation initially by way of lease or license; later, take up acquisition of land and construction of new building(s) like: Alumni and Students Career Centre (Training & Placement); Centre for Innovation & Product development; Renovation of Student Hostels; Seminar Halls, Classroom Modernization, Student Amenity Centres etc., Campus infrastructure - Roads, landscaping, gardens, play grounds, stadiums, swimming pools etc.; Facilities - Computing facility, network infrastructure, library, etc.

2. Research & Development

Faculty chairs (Endowment Professorship Chair) - to recognize and reward outstanding faculty members, Establishment of State-of-the-art Research centres including Centre of Quantum Technologies, Central Clean Room Facility, Central Characterization Facility, etc. Supporting research projects / interdisciplinary research projects, Development of Indigenous equipment/instruments for material characterization and evaluation, Establishment of Technology Incubation centres; Socially relevant projects, etc., Innovation, incubation and start-ups.

3. Faculty Development and Encouragement

International/National Travel support to Faculty and visiting faculty, Encouragement for patent filing, Encouragement for Book writing, Young Faculty Research Awards, Supporting training programs to faculty for knowledge enhancement either in India or abroad, Lecture series, by distinguished persons; Awards/prizes to encourage faculty members to conduct innovative research and development activities in the institute.

4. Student Development

All-round personality development / career building programs Inculcating, Entrepreneur development skills, International Travel support to students, Summer Undergraduate Research Grant for Excellence

5. Research Fellowship

6. Industrial Extension Services

Continuing Education programs / Refresher programs to field Engineers, Seminars / Conferences/ Workshops Collaborations with leading Research Centres / Institutions / Industries, both in India and abroad, Student exchange / faculty exchange programs & Creating opportunities for industry persons to work in the institute for short duration and to share their expertise with students/faculty.

7. Societal & Community Development Services

Skill development programs, rural development, Technology awareness campus Finishing schools for unemployed graduates etc.

8. Alumni Welfare

Organize social events, Get-Togethers, Guest lectures, Invited Talks, Workshops, Publish Newsletters or Magazines relating to Alumni etc.

Broad Category of Financial Contributions

- 1. Donation/Contribution by individual or others without any stated purpose of its utilization.
 - Such contributions shall be pooled into the Institute corpus and the interest accrued on the corpus shall be utilized by the institute based on the recommendation of the COMMITTEE.
- 2. Donation/Contribution by individual or others with a stated purpose of its utilization.
 - Such contributions shall be managed by the COMMITTEE with additional members co-opted from the DONORS to oversee and manage the contributed fund for the stated purpose and objectives of the DONORS.
- 3. Donation/Contribution by individual or others in response to a stated / defined project proposal.
 - Such contributions shall be managed by the COMMITTEE with additional members co-opted from the project initiators/user departments to oversee and manage the contributed fund for the stated purpose and objectives of the DONORS.
- Tax concessions/Rebate from Central Board of Direct Taxes (CBDT) and Section 35 of IT Act.

The receipts, expenses and utilization of the fund shall be audited every year as per statutory regulations and the copies of Audited accounts be shared with bulk donors as well batch representatives who have contributed as a batch.

NIT KURUKSHETRA ALUMNI ENDOWMENT BOARD (NITKKR-AEB)

The operations of NIT Kurukshetra Alumni Endowment Fund will be governed by 'NIT KURUKSHETRA ALUMNI ENDOWMENT BOARD (NITKKR-AEB)'. The NIT KURUKSHETRA ALUMNI ENDOWMENT BOARD (NITKKR-AEB) or its nominees will be the key signatory to the fund flows from the NIT Kurukshetra Alumni Endowment

- Dean (Planning & Development), NIT Kurukshetra

- Chairman
- Member
- Member

- Non-Alumni One or Two members with specific expertise and nominated by the Chairman
- Donor Alumni Maximum of Five/SIX representatives of DONOR groups

Any batch or individual who has donated a sum of Rs. 25 lakhs and above thereof shall be eligible to nominate one member. Corporates can nominate one representative. The DONOR representatives shall retire with a term of TWO years with induction of DONORS from latest years into the committee.

The NITKKR-AEB can also create an extended special body with a larger alumni representation to ensure an even greater involvement from the established alumni of NIT Kurukshetra for the benefit of the institution.

The NITKKR-AEB will set in place the detailed key donor clauses. Some of the proposed important points of the key donor clauses are as given below:

- Donated funds to be mandatorily governed by the NIT KURUKSHETRA ALUMNI ENDOWMENT BOARD in line with donor specific instructions or general purposes as decided by the NIT KURUKSHETRA ALUMNI ENDOWMENT BOARD.
- NITKKR-AEB to be the key signatory to the fund flows from the NIT Kurukshetra Alumni Endowment Fund account.
- Direct a certain portion of the donated funds (Not more than 5%) towards the funding of the expenses related to operations of the Endowment fund.
- Requirement of 2/3rd NITKKR-AEB approval for making any change to the structure of the NIT Kurukshetra Alumni Endowment Fund.

The Institute and its administration from time to time, based on its needs, goals, missions without prejudice to the objectives and management of the NIT Kurukshetra Alumni Endowment Fund can at their discretion affect any changes, alterations or modifications as to the organizational form, pattern and setup etc. The Director of the Institute is authorized to decide the operating modes for fund utilization and other issues.

The Character & Antecedents reports in respect of all above Assistant Professors Grade-I have been received from the concerned District Administration and nothing has been found adverse in the reports. Further, there is no vigilance case or disciplinary proceeding is either pending or contemplated against the concerned faculty members.

The special reports about work and conduct of all the above Assistant Professors Grade-I have been obtained from the respective Head of the Departments and the same have been assessed by the committee constituted for the purpose. The committee has recommended for confirmation of all the Assistant Professors Grade-I from the due dates of their confirmation.

In view of the above, it is proposed that the services of Assistant Professors Grade-I may be confirmed with effect from the due date of confirmation as mentioned against their names.

BoG 65.12 To consider the proposal for the nomination of Assistant Professors with at least 10 years of experience within the institute for the posts of Associate Deans.

An agenda item was placed vide item No. BoG 57.17 before the Board of Governors in its 57th meeting held on 30.03.2022 regarding to create the post of Associate Deans to assist the Deans in day to day administration of the Institute. The Board decided as under:

> "The Board considered the matter for the creation of the post of Associate Deans in the Institute and after detailed deliberations the Board agreed with the proposal to create the post of Associate Deans as detailed in the agenda."

The Board of Governors in its 58th meeting held on 25.08.2022 vide agenda item No. BoG 58.3 had decided as under:

"The Board confirmed the minutes of the 57th meeting of the Board of Governors of National Institute of Technology, Kurukshetra held on 30.03.2022 with the following minor amendment:

In respect of the item No. BoG 57.17: The Associate Deans be nominated from amongst the Associate Professors/Professors."

As per the agenda item twelve numbers of Associate Deans have been created in the Institute and they will assist the Deans in day to day administration of the Institute. It is relevant to mention that the existing Associate Professors in the Institute are very limited in number and many of them are already holding various administrative positions. As a result, some positions of Associate Dean remained vacant. In this context, it is stated that the institute has more than 60 Assistant Professors with at least 10 years of experience within the institute. Over years, they all have handled various administrative positions very effectively.

In view of the above, the Board may consider the proposal to allow for the nomination of Assistant Professors with at least 10 years of experience within the institute for the posts of Associate Deans. BoG 65.13 To consider the proposal for the cancellation of the lease agreement of the land of National Institute of Technology, Kurukshetra (excluding the area of 33/11 KV Sub-Station) provided to Haryana State Electricity Board (now Uttar Haryana Bijli Vitran Nigam Ltd.).

The Regional Engineering College, Kurukshetra was established in 1963. A significant landmark in the history of this institution is the up-gradation of REC Kurukshetra to NIT Kurukshetra with Deemed University status with effect from 26th of June, 2002. The year 2007 was memorable for NIT Kurukshetra as the Institute was conferred the status of an Institution of National Importance by the Government of India through an Act of Parliament.

It is relevant to mention here that a piece of land measuring 5.5 acres was given to Haryana State Electricity Board (UHBVN) by REC, Kurukshetra (from NIT, Kurukshetra) on 01.04.1971 for the construction of 33 KV Sub-Station Research Unit and other residential and non-residential building connected there to for maintenance and operation of power supply for thirty years paying there for during the said and renewed terms the yearly rent of Rupees One Hundred per acre by yearly payments on the 1st day of April each year. The agreement entered in to is for 30 years and NIT Kurukshetra has not renewed the agreement. Thus the agreement stands expired and no lease agreement exists now. Further, it is also relevant to mention here that a lease deed was executed on the 26th October, 1971 between Regional Engineering College, Kurukshetra (Now NIT Kurukshetra) and the Haryana State Electricity Board. A copy of the lease agreement dated 26.10.1971 is enclosed as *Annexure 65.13 (i) from 78 to 81*.

During the year 2019-20, the office of the Superintending Engineer (OP) and other offices of UHBVN, Kurukshetra established at NIT, Kurukshetra premises were shifted to their new building at Sector-8, Kurukshetra. Now the present land which was provided on lease to Haryana State Electricity Board (Now under possession of Uttar Haryana Bijli Vitran Nigam Ltd.) became abandoned and only the 33/11 KV Sub-Station exists on that land.

Now, the Institute is planning to construct students activities complex, technology park and peripheral road from Kirmich road to Kurukshetra University campus adjacent through 33/11 KV Sub-Station, UHBVN on the lease land provided by NIT, Kurukshetra to Uttar Haryana Bijli Vitran Nigam Ltd.(excluding the area of 33/11 KV Sub-Station) for the use of public purposes.

The Regional Engineering College Kurukshetra was established in 1963. A significant landmark in the history of this institution is the up-gradation of REC Kurukshetra to NIT Kurukshetra with Deemed University status with effect from 26th of June, 2002. The year 2007 was memorable for NIT Kurukshetra as the institute was conferred the status of an Institution of National Importance by the Government of India.

The Institute is celebrating its Diamond Jubilee year starting from 1st July, 2022 to 30th June, 2023. In this yearlong celebrations, various activities like new innovative Departments will be established and construction works like lecturer hall complexes, Hostels & Residential complexes will be made. Indeed, these have been proud moment for everybody associated with REC, Kurukshetra/NIT Kurukshetra to see the Diamond Jubilee Celebrations scheduled to be organized.

It is relevant to mention here that a piece of land measuring 5.5 acres was given to Haryana State Electricity Board (UHBVN) by REC, Kurukshetra (now NIT, Kurukshetra) on 26.10.1971 for the construction of 33 KV Sub-Station Research Unit and other residential and non-residential building connected there to for maintenance and operation of power supply. During the year 2019-20, the office of the Superintending Engineer (OP) and other offices of UHBVN, Kurukshetra established at NIT, Kurukshetra premises were shifted to their new building at Sector-8, Kurukshetra. Now the present land which was provided on lease to Haryana State Electricity Board (Now under possession of Uttar Haryana Bijli Vitran Nigam Ltd.) became abandoned and only the 33/11 KV Sub-Station exists on that land. - 83 -

BoG 65.14 To consider the proposal for the appointment of a Counsellor on contract basis under clause 28(2) of the Statutes against the vacant promotional post of Students Activity & Sports Assistant SG-II in the Institute.

An agenda item was placed vide item No.42.13 before the Board of Governors in its 42nd meeting held on 27.06.2017 regarding to consider for the appointment of a Counsellor on contract basis for the Students, Faculty and Staff of the Institute was placed before the Board in its 42nd meeting held on 27.06.2017. The Board had decided as under:

"The Board allowed the Institute to engage a Counsellor for the students, the Faculty and the Staff purely on contract basis, under clause 28(2) of the Statutes, for a period of three years (maximum) subject to satisfactory performance with one month notice period on either side. Further, the Board also approved that the qualification, experience, pay etc. shall be as per details given in the agenda item."

As per the above decision of the BoG, a Counsellor was engaged on contract basis under clause 28(2) of the Statutes in the Institute against the sanctioned post of Superintendent SG-I. Now the vacant promotional post of Superintendent SG-I has been filled. There is no post of Counsellor in the Recruitment Rules-2019 of NITs. The Institute needs to appoint a Counsellor on contract basis for the students, Faculty and Staff of the Institute. The Counsellor may be engaged on contract basis under clause 28(2) of the Statutes against the vacant promotional post of Students Activity & Sports Assistant SG-II on a consolidated salary determined as minimum Pay in the Pay Matrix of Level-8 (Rs. 47600-151100 with admissible DA). The required qualification and experience for the post of Counsellor has already been approved by the Board of Governors in its 42nd meeting held on 27.06.2017.

In view of the above, it is proposed that the Board may consider for the appointment of a Counsellor on contract basis under clause 28(2) of the Statutes against the vacant promotional post of Students Activity & Sports Assistant SG-II in the Institute.

BoG 65.15 To consider and approve the recommendations of the Selection Committee constituted for the appointment of Professors.

- 86 -

The Institute had invited applications for the recruitment of Professors for various departments vide advertisement No.29/2019 and the last date of submission of application form was 31.10.2019. Total 14 nos. of applications were received. The applications were sent to the HoDs of the respective Departments/Director's Nominee for the Department to check the eligibility of the candidates through the duly constituted Screening Committee as per the criteria laid down by the MHRD under Recruitment Rules notified in the Gazette of India dated 24th July, 2017.

The recommendations of Departmental Level Screening Committee were placed before the Advisory Committee on Faculty Recruitment (ACoFAR), constituted as per Recruitment Rules, 2017. A final list of shortlisted candidates to appear before the Selection Committee was prepared by the ACoFAR. The final lists of candidates to meet the Selection Committee was prepared in a combined meeting of the Director, the ACoFAR, the HoD and three senior faculty members of the HoD is Department. Further, in the Departments where Associate Professor/Candidate for the post of Professor or the Department have less nos. of Professors then the Department-wise Screening Committee as constituted by the Competent Authority were allowed to participate in the said combined meeting.

In the meantime, the Hon'ble High Court of Punjab & Haryana, Chandigarh in CWP No.30552 of 2019 (Vikas Mittal and Others Vs National Institute of Technology, Kurukshetra and Others) had passed the interim stay order on 13.11.2019. The operative part of the Hon'ble Court direction is reproduced hereunder:

> "In the premise, respondents are directed no to finalize the selection to the posts advertised vide impugned advertisement No. 29/2019 (Annexure P-9). It is however, made clear that the respondents are at liberty to proceed with the selection process"

Further, few faculty members of the institute have filed another CWP No. 19409 of 2020 (Shelly Vadhera & Others Vs National Institute of Technology, Kurukshetra and Another) seeking to cancel the advertisement no.29/2019 as the recruitment process was not completed with in 6 months. However, no stay was granted by the Honorable Court.

As per approval of the competent authority, the Selection Committee meetings for the recruitment of Professors were scheduled during the period from 20.11.2020 to 21.11.2020. The short-listed candidates were invited to appear before the Selection Committee for interview and also the list of the same was displayed in the Institute website. The Selection Committees were constituted under Clause 23(5)(a) of the Statute of NITs and interviews were conducted as per the schedule but due to the interim stay order dated 13.11.2019 of the Hon'ble High Court passed in CWP No. 30552 of 2019, the recommendations of the Selection Committee for the posts of Professors could not be placed before the Board of Governors of the Institute for approval.

The Hon'ble High Court vide its order dated 31.08.2023 has dismissed the CWP No.30552 of 2019. Therefore, the sealed covers containing the recommendations of the Selection Committees for appointment of Professors in various Departments of the Institute (Ref.:Advt.No. 29/2019) were placed before the Board of Governors in its 62nd meeting held on 06.09.2023 to consider and approve the recommendations of the Selection Committee constituted for the appointment of Professors. The Board decided as under:

"The Agenda item was deferred for being taken up in the next meeting of the Board of Governors."

Thereafter, in reference to the decision of BoG taken in its 62nd meeting held on 06.09.2023, another agenda item was placed before the Board of Governors in its 63rd meeting held on 21.09.2023 to consider and approve the recommendations of the Selection Committee constituted for the appointment of Professors. The Board decided as under:

"This item was deferred for being taken up in future alongwith BoG Agenda item No. 62.5."

In this context, it is stated that the agenda item no. BoG 62.5 is related to appointment of Associate Professor against Advt.No.03/2018 with reference to the applicability of Section (9) One-time relaxation or measures of amendment in the Statutes of NIT, Kurukshetra published in The Gazette of India on 30.06.2023 and BoG agenda item no. 63.3 is related to the appointment of Professors. It is relevant to mention here that the Board of Governors in its 53rd meeting held on 21.08.2020 had decided that appointment letters be issued to the selected candidates for the post of Associate Professors against the Advt.No.03/2018 in terms of the order dated 05.12.2019 of the Hon'ble High Court without applying the relaxation in qualification as contained in letter of the MHRD dated 06.10.2017. Accordingly, appointment orders were issued to the selected candidates without applying the relaxation as decided by the Board.

Further, the Board is apprised that the Hon'ble High court vide its interim order dated 10.01.2024 Stayed the operation of Section (9) in CWP No. 354/2024 (Dr. Hanuman Devidas Chalak and Ors. V/S Board of Governors, NIT and Ors.) and linked the matter with another case No. CWP-15972-2023 (Subrata Ghosh and Ors. V/S Union of India and Ors.), which has been pending since July, 2023.

Thus the Agenda item 62.5 pertaining to the recruitment of Associate Professors may not be taken up at this stage.

Further, the Board is hereby appraised that the Hon'ble High Court of Punjab & Haryana at Chandigarh while dismissing the CWP No.19409 of 2020 (Shelly Vadhera & Others Vs National Institute of Technology, Kurukshetra and Another), vide its final order dated 22.09.2023 has noted the following:

"16._____.

The petitioners are claiming that delay in the completion of recruitment process has caused prejudice to the petitioners, however, they have feigned ignorance of the fact that pendency of CWP No.30552 of 2019 and present petition has indubitably caused prejudice to those candidates who despite expiry of almost three years from the date of interview have not been declared successful. They must have become Professor in 2020 whereas till date they are wearily looking at the door of this Court."

Agenda of 65th Meeting of Board of Governors (06.03.2024)

Further, as per para 6 of the judgement in CWP No.19409 of 2020, the Hon'ble High Court recorded the submission of the respondents (institute) as:

- 89 -

"6.

The Interview conducted on 20/21-11-2020 and final result would be declared as soon as present petition is disposed of."

Thus the two court cases filed in the Hon'ble High Court regarding the appointment of Professors against Advt. No. 19/2019 have been dismissed and there is no pending issue in this regard.

The institute had submitted to the Hon'ble High Court that the final result would be declared as soon as CWP No.19409 of 2020 is dismissed and disposed off. It has been already more than 5 months since the case was dismissed and a few faculty of the institute have submitted representations to declare the results early. In view of the submission made to the Hon'ble High Court the sealed covers containing the recommendations of the Selection Committees for appointment of Professors in various Departments of the Institute (Ref.:Advt.No. 29/2019) will be placed on the table during the meeting of the Board.

The Board of Governors may consider and approve the recommendations of the Selection Committee.

BoG 65.16 To re-consider the cases of petitioners in the CWP No.35554 of 2019 & CWP No.5511 of 2020 for up-gradation of AGP of Professors to HAG Scale as per the directions of the Hon'ble Punjab & Haryana High Court, Chandigarh dated 07.12. 2023.

The existing 4 tier recruitment rule was issued by the MHRD vide letter F.No.33-9/2011-TS.III dated 15.01.2014 and adopted by the Board of Governors in its 33 meeting held on 04.06.2014. The revised Recruitment Rules (RRs) for faculty have been approved by the Council of National Institutes of Technology, Science Education and Research (NITSER) in its 10th meeting held on 26th May, 2017.

The MHRD vide letter F.No.35-5/2017-TS.III dated 31st July, 2017 has sent the amendments in the First Statutes of NITs alongwith a copy of notification bearing S.O. 947(E) dated 21st July, 2017 published in the Gazette of India Extraordinary Part II, Section 3, Sub-Section (i) on 24th July, 2017. As per the provision of notification, the amendments shall come into force on the date of their publication in the official Gazette. The schedule 'E' of this notification contains the qualification and other terms & conditions of appointment of Academic Staff. The following qualification and other terms & conditions are mentioned in the Schedule 'E':

Further, the NIT Council in its 11th meeting held on 18.07.2018 had approved the following guidelines for Higher Administrative Grade (HAG) scale to the Professors of NITs:

> "(i) A maximum of 40% of the sanctioned post of Professors who fulfill the eligibility criteria as prescribed in Schedule E of the Statutes notified on 24th July, 2017 can be awarded HAG scales on the basis of the recommendations of Selection Committee as prescribed in Statute 23 (5).

(a) of the Statutes of NITs and IIEST, Shibpur, respectively.

- (ii) Chairman Advisory Committee for Faculty Recruitment (ACoFAR) should invite, from all eligible and interested Professors, the Biodata incorporating their scholastic and administrative contributions since their appointment as regular Professor. It should prepare the list of candidates fulfilling all the minimum requisite conditions as prescribed by the Board.
- (iii) In case of upgradation of AGP of Professors to HAG scale, personal interview shall be dispensed with.
- (iv) The exercise will be carried out by the Institute once in an academic year with a cut off as 30th June."

As per the above guidelines, a maximum of 40% of the sanctioned post of Professors of the Institute who fulfill the above eligibility criteria as prescribed in schedule "E" of the Statutes can be awarded HAG scales. The detail calculation is as under:

Accordingly, the Institute had invited applications for the up-gradation of AGP of Professors to HAG Scale vide notification No.Estt.-I/4700 dated 11.09.2018. The last date for submission of application form was 05.10.2018. Total 24 Nos. of applications were received upto the last date of receipt of applications. Thereafter, with reference to the MHRD guidelines, the documents of eligible candidates for the up-gradation of AGP of Professors to HAG Scale were placed before the respective Selection Committee(s) consisting of all Professors of HAG Scale as per the provision in Statute 23 (5) (a) for assessment.

The recommendations of the Selection Committee meetings for Upgradation of AGP of Professors to HAG Scale, contained in the sealed envelopes were placed before the BoG in its 50th meeting (BoG 50.22) held on 20.06.2019. The Board had decided as under:

> "The Board was apprised that all due processes were adopted as per circulars/guidelines issued by MHRD on Up-gradation of AGP of Professors to HAG Scale. Therefore, the Board considered and approved the recommendations of the Selection Committee for Upgradation of AGP of Professor to HAG Scale."

As per the practice followed in the Institute, the result of the same was to be notified after confirmation of the minutes from the competent authority. In the meantime Dr. R. S. Bhatia, Professor, Electrical Engineering Department of this Institute had filed a CWP No.18333 of 2019 – titled Ravinder Singh Bhatia Vs National Institute of Technology, Kurukshetra and other in the Hon'ble High Court of Punjab & Haryana, Chandigarh by challenging the benefit of Higher Administrative Grade (HAG) in respect of Professors of this Institute and Hon'ble High Court had stayed the result of the same by passing the interim orders on 09.07.2019 in the said CWP.

Further, Dr. (Mrs.) Minati Baral, Professor, Chemistry Department of this Institute had filed a CWP No.35554 of 2019 – titled Dr. Minati Baral Vs National Institute of Technology, Kurukshetra & Another in Hon'ble High Court of Punjab & Haryana, Chandigarh regarding her non selection to Higher Administrative Grade (HAG) of the Professors. The Hon'ble High Court had decided on 07.12.2019 that the case is to be heard along with CWP No.18555 of 2019 (Ravinder Singh Bhatia).

In the same line, Dr. Puran Chand Tewari, Professor and Dr. Hari Singh, Professor both of Department of Mechanical Engineering of this Institute had filed a CWP No.5511 of 2020 – titled Puran Chand Tewari and Anr. Vs National Institute of Technology, Kurukshetra & Others in Hon'ble High Court of Punjab & Haryana, Chandigarh regarding their non selection to Higher Administrative Grade (HAG) of the Professors. The Hon'ble High Court had decided on 28.02.2020 that the case is to be heard along with CWP No.35554 of 2019 (Dr. Minati Baral).

The Hon'ble High Court vide its order dated 26.07.2023 has disposed of the CWP No.18333 of 2019 due to death of petitioner (Dr. Ravinder Singh Bhatia) and non-appearance of counsel for the petitioner.

In light of the orders passed by the Hon'ble High Court in CWP No.18333 of 2019, an agenda item was placed before the Board of Governors of the Institute in its 62nd meeting held on 06.09.2023 vide agenda item No. BoG 62.4 regarding the matter for the Upgradation of AGP of Professors to HAG Scale w.r.t. the BoG agenda item no.50.22. The Board decided as under:

"Dr. (Ms.) Minati Baral, Member of the Board left the meeting when this agenda item was considered as she was a candidate for the Upgradation of AGP of Professors to HAG Scale.

The Board noted that the earlier Board in its 50th meeting held on 20.06.2019 had approved the recommendations of the Selection Committee for the up-gradation of AGP of Professors to HAG Scale and confirmed the minutes in its 51st meeting held on 19.09.2019. Further, the Board noted that the Hon'ble High Court of Punjab & Haryana, Chandigarh has disposed of the court case (CWP No.18333 of 2019) on 26.07.2023 and also there is no stay order in other court cases (CWP No. 35554 of 2019 & CWP No.5511 of 2020). The Board resolved that the decision of the Board taken in its 50th meeting be implemented w.e.f. 20.06.2019.

Further, the Board confirmed the minutes of this agenda item."

As per the recommendations of the Selection Committees meetings held during 13-14.05.2019 for the upgradation of AGP of Professors to HAG Scale and with the above BoG decision, office orders were issued on 13.09.2023 in respect of the following candidates:

Further, the minutes of the 62nd BoG meeting (Item No.62.4) are confirmed in 63rd BoG meeting (item No. 63.2) held on 21.09.2023 as under:

"The Board considered the comments of Dr. (Ms.) Minati Baral, Professor, Department of Chemistry, NIT Kurukshetra on the recorded minutes of 62 nd BoG meeting. Dr. (Ms.) Minati Baral left the meeting when these comments were considered. The Board observed that it is prerogative of the Selection Committee either to recommend or not to recommend the names of applicants for the Selection of Professor (HAG). Further, the Board observed that the Selection Committee has not given reasons for recommending / not recommending the names of applicants for the selection.

Thereafter, the Board did not accept the comments of Dr. (Ms.) Minati Baral and confirmed the minutes of 62nd (Emergent) meeting of the Board of Governors held on 06.09.2023. "

Thereafter, the Hon'ble High Court of Punjab & Haryana, Chandigarh has disposed of the CWP No.35554 of 2019 (Minati Baral Vs NIT Kurukshetra & Another and CWP No.5511 of 2020 (Puran Chand Tewari and Anr. Vs NIT Kurukshetra and Others) on 07.12.2023 with the following orders :

"15. In the wake of above discussion and findings, this Court is of the considered opinion that Selection Committee has turned down candidature of the petitioners without applying laid down parameters and has further not disclosed basis of its opinion. Therefore, the respondents are directed to re-consider case of the petitioners for HAG scale, it is made clear that re-consideration of case of the petitioners would not effect case of those candidates who have already been granted benefit of HAG scales because sufficient posts are available. The needful shall be done within 3 months from today."

A copy of the order dated 07.12.2023 is enclosed as <u>Annexure 65.16(i)</u> from pages 96 to 97.

1. By this common order CWP-5511-2020 and CWP-35554-2019 are disposed of since issue involved in both the petitions and prayer sought are common. With the consent of parties and for the sake of brevity, facts are borrowed from CWP-35554-2019.

2. The petitioners through instant petition under Articles 226/227 of the Constitution of India are seeking direction to respondents to grant Higher Administrative Grade (for short 'HAG').

3. The petitioners are working with respondent institute as Professors. The petitioners were appointed on the post of Lecturer in

of eligibility of HAG scale. The petitioners admittedly fulfilled the eligibility criteria. The eligibility of the petitioners was determined by the Advisory Committee which recommended the names of the petitioners to Selection Committee.

14. With respect to objection of respondent regarding maintainability of writ petition, this Court finds that Supreme Court has not held that there is absolute bar *qua* interference of High Court in Selection matters. Considering the laid down parameters by respondents, eligibility criteria, opinion of Advisory Committee and record of meeting of Selection Committee, this Court is of the considered opinion that this is a fit case for interference.

15. In the wake of above discussion and findings, this Court is of the considered opinion that Selection Committee has turned down candidature of the petitioners without applying laid down parameters and has further not disclosed basis of its opinion. Therefore, the respondents are directed to re-consider case of the petitioners for HAG scale. It is made clear that re-consideration of case of the petitioners would not effect case of those candidates who have already been granted benefit of HAG scales because sufficient posts are available. The needful shall be done within 3 months from today.
