



At the outset, the Hon'ble Chairperson (Acting) welcomed the esteemed members of the BoG present in the 65th meeting of the Board of Governors with the following introductory remarks:

It was observed that, the Institute was facing large number of court cases and the number crossed even 125. Attention has been laid to reduce the litigations as the court cases are not only draining the resources in terms of Efforts, Time and Finances. Litigations are also leading to the demotivation amongst the Faculty and Non-Teaching Staff. Off late, the efforts made in this direction proved to be effective and the number of the court cases have been scaled down to less than 100. It is expected that this number will further be reduced drastically in near future.

It has also been noticed that dereliction of duties from the staff is also one of the contributing factors for increased litigations. To check this, efforts are being made to motivate the staff and also to curb the unwarranted practices and to improve the efficiency and productivity. Efforts are being made to revamp the administrative systems, and to rejuvenate the vigour and to speed up the administrative processes. Revamping and reorganize the sections, units, activities by merging and demerging, clubbing of various activities of the Institute and to entrust the Section/Unit/Activity to the right official at the right time and at right place, as and when need/requirement arises. These proposed measures will put an end to the lethargy creeping in the administrative processes. There is also a proposal to change the nomenclatures of various sections like Establishment, General Administration. Stores, Accounts as Admin-I, Admin-II, Admin-III and Admin-IV etc. These sections will be supervised through a Faculty-In-charge and assisted by an official/officer from the Non-Teaching and overall control will be with monitored by the Registrar. These measures will tone up the administrative efficiency of the Institute in all spheres and bring more positive results and also to reduce litigations. Such changes, will bring the desired results in taking NIT Kurukshetra to new heights.

The Board appreciated the proposed good initiatives for implementation. Thereafter, the Chairperson (Acting) asked the Secretary to present the agenda items.

The Ministry of Education, Government of India, Department of Higher Education, New Delhi had send a letter vide F.No.35-7/2022-TS.III dated 26.05.2023 regarding amendment in the Statutes of 30 NITs, IIEST, Shibpur and NIT, Andhra Pradesh. Accordingly, the Institute had published its notification dated 14.06.2023 in The Gazette of India Extraordinary on 30.06.2023, amongst others amending Statutes (9) of the Notification states as under:

"...(9) The one time relaxation or measures for the then stagnated and eligible faculty of the National Institute of Technology, Kurukshetra shall be as per the relaxations issued with the approval of the Council vide communications dated 6th October, 2017 and 17th November, 2017.

Provided that one-time relaxation or measures contained in the communications dated the 6th October, 2017 and 17th November, 2017 shall have no validity and stand exhausted after the first round of recruitments initiated and shall not have any validity for subsequent rounds of recruitments of the faculty in the National Institute of Technology, Kurukshetra".

A copy of the relevant pages is enclosed as <u>Annexure - 67.4 (i) from</u> pages 20 to 24.

In this regard, an agenda item was placed before the Board of Governors of the Institute in its 61st meeting held on 10.08.2023 vide agenda item No.BoG 61.5 regarding to adopt the notification dated 14.06.2023 of National Institute of Technology, Kurukshetra published in The Gazette of India dated 30.06.2023. The Board decided as under:

"The Board adopted the notification dated 14.06.2023 of National Institute of Technology, Kurukshetra published in The Gazette of India dated 30.06.2023 for implementation of the provisions contained therein."

Thereafter, Dr. Hanuman Devidas Chalak, Assistant Professor Grade-I, Department of Civil Engineering of this Institute had filed a case vide CWP No.354 of

2024 titled "Dr. Hanuman Devidas Chalak and others Vs BoG, NIT, Kurukshetra and others in the High Court of Punjab & Haryana, Chandigarh.

The Hon'ble High Court has directed in its interim order dated 10.01.2024 that "Inter-alia relies on the issuance of notice and grant of interim relief in CWP-15972-2023 - Dr. Subrata Ghosh and others vs. Union of India and other" and stayed the implementation of Statute-9 of the amended Statutes of NIT, Kurukshetra in the same terms and to be heard alongwith CWP-15972-2023."

The Hon'ble High court of Punjab & Haryana, Chandigarh had disposed of the above CWP with the following orders on 31.05.2024. The operative parts of the decision of Hon'ble High Court are as under:

- "34. Applying the aforesaid law to the facts of the present case, it is a apparent that the selection which were conducted under advertisement No.03/2018 cannot be given approval by the new amendments made in the Statutes. Even the counsel for the respondent-institutes have stated that the amendments would be prospective, therefore, now they would be free to issue new advertisement in accordance with the amendments granting due relaxation in the Schedule for the purpose of selection for the post of Associate Professor and Professor.
- 35. In other words, the authorities would be free to conduct afresh exercise by inviting applications of all eligible candidates in terms of the new amendments made vide notification dated 30.06.2023 for the post of Associate Professor and Professor. All the persons who are eligible for applying, would be considered. The petitioners and the respondents would be, therefore, entitled to be considered accordingly as per their work experience and other educational qualifications.
- 36. All the stake holders will also be entitled to be considered afresh for which now the respondent-Institute shall take steps, proceed and conclude the exercise within a period of four months from today. The advertisements issued by the respondent-Institute would, accordingly, be modified/ corrected and applied. The stay order passed by the Court dated 31.07.2023 stands vacated.
- 37. This order shall be effective for both the respondent-institutes. The writ petitions are accordingly disposed of in the aforesaid terms.
- 38. All pending applications shell stand disposed of."

A copy of the order dated 31.05.2024 is enclosed as <u>Annexure – 67.4 (ii)</u> from pages 25 to 27.

As per the above orders of the Hon'ble High Court, the new process for the recruitment of Associate Professors in the Institute is to be completed on or before 30.09.2024 by inviting applications from all eligible candidates in terms of new amendments of the Statutes of NIT, Kurukshetra published in The Gazette of India on 30.06.2023.

Further, it is relevant to mention here that the MHRD has issued a letter F.No.33-9/2011-TS.III dated 06.10.2017 regarding promotion of existing Assistant Professor to Associate Professor in accordance with the provisions under Section 32(2) (b) of the National Institutes of Technology, Science Education and Research (NITSER) Act, 2017 for adoption by the BoG for implementation. The contents of the letter dated 06.10.2017 are as under:

"Schedule E (Sl.No.4 – pertaining to Associate Professor):

(i) Six years after Ph.D. of which at least three years at the level of Assistant Professor with Academic Grade Pay of Rs. 8000/-

may be read as

Six years after Ph.D. at the level of Assistant Professor.

(ii) An existing faculty member with 09 years total working experience, of which three years should be after Ph.D., with at least three years at the level of Assistant Professor with Academic Grade Pay of Rs. 8000/-

may be read as

Nine years of total working experience with Ph.D. at the level of Assistant Professor. "

It has also been clarified in the above said OM that the NITs are advised to place the recommendations of the Anomaly Committee before the Board of Governors for adoption and ensure strict adherence of the instructions.

In view of the order of Hon'ble High Court dated 31.05.2024, the process of appointment for the post of Associate Professors will have to be completed within the period of four months i.e. 30.09.2024 in terms of the new amendments made vide notification dated 30.06.2023.



The main point arised and to be settled is the cut of date for the eligibility of the existing Assistant Professors of the Institute for the post of Associate Professor as per Statute (9) "one time relaxation or measures for the then stagnated and eligible faculty of the National Institute of Technology, Kurukshetra.

- These Statutes may be called the First Statutes of the National Institutes of Technology 1. (Amendment) Statutes, 2023.
 - They shall apply to the National Institute of Technology, Kurukshetra. (2)
 - They shall come into force on the date of their publication in the Official Gazette. (3)
- In the First Statutes of the National Institutes of Technology (hereinafter referred to as the principal Statutes), in statute 1, in sub-statute (1), for the words "The First Statutes of the National Institutes of Technology", the words and figures "the National Institute of Technology, Kurukshetra Statutes, 2017" shall be substituted.
- Throughout the principal Statutes, for the words "Ministry of Human Resource Development", wherever they occur, the words "Ministry of Education" shall be substituted.
- In the principal Statutes, in statute 23,-4.
 - (a) in sub-statute (5), in the opening portion, the words "or by promotion" shall be omitted;
 - (b) for sub-statute (12), the following sub-statute shall be substituted, namely:—
- "(12) Some of the posts may be exempted from the purview of the personal interview for selection, which may be decided by the Board and in case where the interview is compulsory, the Selection Committee shall examine credentials of all the candidates who have been called for interview, interview the eligible candidates and recommend the names of suitable candidates to the competent authority for approval and appointment thereafter.".
- In the principal Statutes, in Schedule 'E',-
 - (a) against serial number 1, for entries in column (2), the following entries shall be substituted, namely: —

"Assistant Professor, Grade – II (to be appointed on contract basis) in Level-10 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be.";

(b) against serial number 2, for entries in column (2), the following entries shall be substituted, namely:—

"Assistant Professor, Grade-II (to be appointed on contract basis) in Level-11 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be.";

- (c) against serial number 3,-
 - (i) for entries in column (2), the following entries shall be substituted, namely:—

"Assistant Professor, Grade-I in Level-12 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be.";

- (ii) in column (4), for the words "reputed academic Institute", the words "Institution of repute" shall be substituted;
- (d) against serial number 4,-
 - (i) for entries in column (2), the following entries shall be substituted, namely:—

"Associate Professor in Level-13A2 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be.";

(ii) for entries in column (4), the following entries shall be substituted, namely:—

"Six years after Ph.D. of which at least three years experience at the level of Assistant Professor Grade—I in Level-12 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be, or equivalent in an Institution of repute or Research & Development lab or relevant industry; or nine years total working experience, of which three years shall be after Ph.D. and with three years experience at the level of Assistant Professor Grade—I in Level-12 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be, or equivalent in an Institution of repute or Research & Development lab or relevant industry.";

"Professor in Level-14A of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be.";

(ii) for entries in column (4), the following entries shall be substituted, namely:---

"Ten years after Ph.D. or thirteen years total working experience, out of which seven years shall be after Ph.D. and with three years experience at the level of Associate Professor in Level-13A2 of the Pay Matrix of the 7th Central Pay Commission or four years at the level of Associate Professor in Level-13A1 or combination of Level-13A1 and Level-13A2 or equivalent in an Institution of repute or Research and Development lab or relevant industry.";

- (f) against serial number 6,-
 - (i) for entries in column (2), the following entries shall be substituted, namely:-

"Professor (Higher Administrative Grade) in Level-15 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or pay level approved by the Central Government or the Council, as the case may be.";

(ii) for entries in column (4), the following entries shall be substituted, namely:—

"Six years as Professor in Level 14 or equivalent or Level 14A or equivalent or a combination of service in Level 14 and Level 14A in an Institute of National Importance:

Provided that upto a maximum of 40% of the total number of Professors in position, after rendering regular service of six years as Professor may be granted Higher Administrative Grade scale after fulfilling the eligibility conditions and on the recommendations of duly constituted Selection Committee.";

(g) in Note 1,-

- (I) for paragraph (1), the following shall be substituted, namely:—
 - "(1) Any change in the pay scale shall be through an open advertisement and on the recommendations of the duly constituted Selection Committee, except where specifically exempted in these Statutes:

Provided that the Assistant Professor Grade-II appointed on contract basis in the Institute shall be, on successful completion of one year of service in Level-10 of the Pay Matrix of the 7th Central Pay Commission, may be upgraded to Level-11 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or grade pay or pay level, if found suitable by a duly constituted Selection Committee, but not through open advertisement.";

- (II) in paragraph (6), for sub-paragraph (a), the following sub-paragraph shall be substituted, namely:—
 - "(a) Permanent faculty with fifty years of age or above-
 - (i) The Assistant Professors Grade-II in Level-11 of the Pay Matrix of the 7th Central Pay Commission shall be mapped at the level of Assistant Professor Grade-I in Level-12 of the Pay Matrix of the 7th Central Pay Commission or any other corresponding pay scale or grade pay or pay level approved by the Central Government or the Council, provided that they have at least 10 credit points in their service.
 - (ii) The Assistant Professors Grade—I in Level-12 of the Pay Matrix of the 7th Central Pay Commission shall be mapped at the level of Associate Professor in Level-13A2 of the Pay Matrix of the 7th Central Pay Commission, provided they have at least 25 credit points in their service.
 - (iii) The Associate Professors in Level-13A1 of the Pay Matrix of the 7th Central Pay Commission shall be mapped at the level of Associate Professor in Level-13A2 of the Pay Matrix of the 7th Central Pay Commission, provided that they have at least 25 credit points in their service:

Provided that they have been found suitable through a Selection Committee duly constituted under the Statutes.";

- (III) for paragraph (7), the following paragraphs shall be substituted, namely:—

decision of a court without removing the defect pointed out in the said decision is opposed to the rule of law and the scheme of separation of powers under the Constitution of India. v. Abrogation is not a device to circumvent an unfavourable judicial decision. If enacted solely with the intention to defy a judicial pronouncement, an Amendment and Validation Act of 1997 may be declared as ultra-vires."

- 33. Thus, we find that while the legislature or rule making authority does not have the power to frame a rule stating that a decision of a Court is null and void nor it has a power to declare interpretation of law to be bad, it has a power to remove the defect due to which the earlier law framed by it was quashed or set aside by the Court. If the defect is removed and new law is framed by following due procedure, the new law cannot be quashed merely because it repeals the earlier law but after removing the defect. At the same time, such a law would not in any manner correct the action taken under the earlier defective law.
- 34. Applying the aforesaid law to the facts of the present case, it is a apparent that the selection which were conducted under advertisement no. 3/2018 cannot be given approval by the new amendments made in the Statutes. Even the counsel for the respondent-institutes have stated that the amendments would be prospective, therefore, now they would be free to issue new advertisement in accordance with the amendments granting due relaxation in the Schedule for the purpose of selection for the post of Associate Professor and Professor.
- 35. In other words, the authorities would be free to conduct afresh exercise by inviting applications of all eligible candidates in terms of the

new amendments made vide notification dated 30.06.2023 for the post of Associate Professor and Professor. All the persons who are eligible for applying, would be considered. The petitioners and the respondents would be, therefore, entitled to be considered accordingly as per their work experience and other educational qualifications.

- 36. All the stake holders will also be entitled to be considered afresh for which now the respondent-Institute shall take steps, proceed and conclude the exercise within a period of four months from today. The advertisements issued by the respondent-institute would, accordingly, be modified / corrected and applied. The stay order passed by the Court dated 31.07.2023 stands vacated.
- 37. This order shall be effective for both the respondent-institutes. The writ petitions are accordingly disposed of in the aforesaid terms.
- 38 All pending applications shall stand disposed of.
- 39. No costs.



The panel of expert nominees of the Senate form outside the Institute is to be nominated by the Senate.

The advertisement for the recruitment of faculty have been issued. Accordingly, the Selection Committee meetings for the recruitment is scheduled shortly; whereas the next meeting of the Senate is not likely to be held shortly. In this circumstances, the Chairman of the Senate, in exercise of powers conferred by Section – 9 of the NIT Statutes, decided to include the names of the Professors of all IITs, IIMs, IIITs, NITs and SPAs in the Panel of (Experts Nominee of the Senate) for the recruitment of Academic Staff (excluding the names of Professors already exist in Panel of experts of Senate) in various subjects.

The Board may note the above nomination.



BoG 67.8 To note the Panel of Experts (Nominee of the Senate) for the recruitment of Academic Staff for the discipline of Architecture & Planning.

As per Statute 23(5)(a)(4), for filling up the post of Academic Staff (excluding the Director and the Deputy Director) in various subjects in the Institute by direct recruitment or by promotion from amongst the members of the staff of the Institute there will *interalia* be one expert nominee of the Senate from outside the Institute.

As per the approval of BoG in its 65th meeting held on 06.03.2024, the Institute has introduced the discipline of Architecture & Planning from the academic session 2024-25. The advertisement for the recruitment of faculty have been issued. Accordingly, the Selection Committee meetings for the recruitment is likely to be scheduled shortly. Therefore, a valid panel of experts (Nominee of the Senate) is required.

In this context, it is stated that the proposed Panel of experts for the recruitment of academic positions have been prepared considering expert from IITs / NITs / reputed Central Universities from all across the country. The consolidated panel of experts for the discipline of Architecture & Planning has been approved by the Chairman, Senate in anticipation of the approval of the Senate.

The Board may note the fresh panel of External experts (Nominee of the Senate) for the recruitment of Academic Staff for the discipline of Architecture & Planning for a period of two years.



BoG 67.9 To consider the Action taken w.r.t. the minutes of the agenda item No. BOG 65.16 regarding upgradation of AGP of Professors to HAG Scale.

The Ministry of Human Resource Development (now the Ministry of Education), Government of India vide letter No. F.35-2/2018-T.III dated 26.7.2018 forwarded the minutes of the 11th meeting of the Council of National Institutes of Technology, Science Education and Research (NITSER) held on 18.07.2018. The Council of NITSER in its 11th meeting held on 18.07.2018 approved the guidelines for HAG to the Professors of NITs. The matter was placed before the Board of Governors in its 46th meeting held 23rd October, 2018 and the Board noted the guidelines for Higher Administrative Grade (HAG) scale to the Professors of NITs as approved by the Council of NITSER in its 11th meeting held on 18.07.2018.

As per the guidelines, a maximum of 40% of the sanctioned post of Professors of the Institute who fulfill the eligibility criteria contained in the Schedule 'E' of the Gazette of India notification No. SO.947 (E) dated 21st July, 2017 forwarded by the Ministry vide letter No. F.35-5/2017-TS.III dated 31st July,2017. Keeping in view the total sanctioned strength of 43 posts of Professors, 17 Professors are to be considered for HAG scales. Accordingly, the Institute invited applications from the eligible Professors for the grant of HAG scales vide letter No. Estt-1/4700, dated 11.09.2018. 24 applications were received from the Professors by the last date of submission dated 5.10.2018. As per the Recruitment Rules, an Advisory Committee on Faculty Recruitment (ACoFAR) was constituted to consider the eligibility of the candidates. The ACoFAR prepared the list of eligible candidates which was further considered by the respective department wise Selection Committee(s). The recommendations of the Selection Committees were approved by the Board of Governors in its 50th meeting held on 20.06.2019. However, on account of decision of the Hon'ble Punjab & Haryana High Court at Chandigarh passed in CWP No. 18333/2019 filed by Dr. RS Bhatia, the final result could not be implemented in the Institute immediately.

Further, the Hon'ble Punjab and Haryana High Court vide its decision passed on 26.07.2023 had disposed of the aforesaid CWP No. 18333/2019.

However, Dr. Minati Baral as well as Dr. Puran Chand Tiwari and others filed CWP No.35554 of 2019 and CWP No. 5511 of 2020 respectively for the consideration of their candidature to grant HAG scale. However, no stay was granted by the Hon'ble High Court of Punjab & Haryana, Chandigarh.

In view of the above, the matter was again placed before the Board of Governors in its 62nd meeting held on 6.9.2023. The Board decided as under: -

"The Board noted that the earlier Board in its 50th meeting held on 20.06.2019 had approved the recommendations of the Selection Committee for the up-gradation of AGP of Professors to HAG Scale and confirmed the minutes in its 51st meeting held on 10.9.2019. Further, the Board noted that the Hon'ble High Court of Punjab and Haryana, Chandigarh has disposed of the court case (CWP No. 18333 of 2019) on 26.7.2023 and also there is no stay order in other court cases (CWP No. 35554 of 2019 and CWP No. 5511 of 2020). The Board resolved that the decision of the Board taken in it 50th meeting be implemented w.e.f. 20:06.2019. Further the Board confirmed the minutes of this agenda item."

In view of the above decision of the Board, 10 Professors were granted the Higher Administrative Grade Scales w.e.f. 20.06.2019 i.e. the date of approval by the Board.

Further, the Hon'ble High Court of Punjab and Haryana, Chandigarh vide its decision dated 07.12.2023 passed the following orders in CPW No. 35554 of 2019 (Dr. Minati Baral Vs NIT, Kurukshetra & Another) and CWP No. 5511 of 2020 (Dr. Puran Chand Tiwari and Anr. Vs NIT, Kurukshetra and Others): -

"In the wake of above discussion and findings, this Court is of the considered opinion that Selection Committee has turned down candidature of the petitioners without applying laid down parameters and has further not disclosed basis of its opinion. Therefore, the respondents are directed to re-consider case of the petitioners for HAG Scale, it is made clear that re-consideration of case of the petitioners would not affect case of those candidates who have already been granted benefit of HAG scales because sufficient posts are available. The needful shall be done within 3 months from today."

A copy of the order dated 07.12.2023 is enclosed as <u>Annexure – 67.9 (i)</u> from pages 35 to 36.

In view of the above decision, the above candidates were considered for HAG Scales by the Selection Committees. The recommendations of the selection committees were placed before the Board of Governors in it 65th meeting held on 6.3.2024. The Board approved the recommendations of the Selection Committee dated 4.3.2024 as presented to the Board for the Up-gradation of AGP of Professors to HAG Scale. The Board resolved that the above decision of the Board be implemented w.e.f. the date of meeting of the Board i.e. 06.03.2024. These Professors are also requesting for granting HAG Scale notionally w.e.f. 20.06.2019.

Further, the Board in its 60th meeting held on 06.03.2024 had clarified that the up-gradation of AGP of Professors to HAG Scale w.r.t. agenda item No.BoG 50.22 will be notionally effective from the date of 50th meeting i.e. 20.06.2019 and the financial benefit will be from the date of 62nd BoG meeting i.e. 06.09.2023. Accordingly, 10 nos. of Professor were given HAG Scale on notional basis and financial benefits be extended w.e.f. 06.09.2023 instead of 20.06.2019. In order to maintain the parity, the Board opined that the cases of remaining eligible applicants (5 nos.) w.r.t. notification No. Estt-1/4700 dated 11.9.2018 be reconsidered within one month.

As per the above decision of the Board taken in its 65th meeting held on 06.03.2024 vide agenda item No.BoG 65.16; further process of re-consideration to grant HAG Scale was not initiated for the remaining eligible applicants. It was observed that 05 candidates are to be considered against the available 04 vacancies at that time for the grant of HAG scales. It may invite legal complications as posts have not been earmarked Department-wise.

In view of the above, it is proposed that "afresh applications may be invited from the all eligible candidates to grant HAG scales and complete the process as more no. of vacancies are available now."

The matter is placed before the Board for consideration and decision.

- 1. By this common order CWP-5511-2020 and CWP-35554-2019 are disposed of since issue involved in both the petitions and prayer sought are common. With the consent of parties and for the sake of brevity, facts are borrowed from CWP-35554-2019.
- 2. The petitioners through instant petition under Articles 226/227 of the Constitution of India are seeking direction to respondents to grant Higher Administrative Grade (for short 'HAG').
- 3. The petitioners are working with respondent institute as Professors. The petitioners were appointed on the post of Lecturer in

of eligibility of HAG scale. The petitioners admittedly fulfilled the eligibility criteria. The eligibility of the petitioners was determined by the Advisory Committee which recommended the names of the petitioners to Selection Committee.

- 14. With respect to objection of respondent regarding maintainability of writ petition, this Court finds that Supreme Court has not held that there is absolute bar *qua* interference of High Court in Selection matters. Considering the laid down parameters by respondents, eligibility criteria, opinion of Advisory Committee and record of meeting of Selection Committee, this Court is of the considered opinion that this is a fit case for interference.
- 15. In the wake of above discussion and findings, this Court is of the considered opinion that Selection Committee has turned down candidature of the petitioners without applying laid down parameters and has further not disclosed basis of its opinion. Therefore, the respondents are directed to re-consider case of the petitioners for HAG scale. It is made clear that re-consideration of case of the petitioners would not effect case of those candidates who have already been granted benefit of HAG scales because sufficient posts are available. The needful shall be done within 3 months from today.
- 16. Pending misc. application, if any, shall stand disposed of.

As per the Recruitment Rules and further appointment letter, their services were to be regularized only on acquiring the Ph. D. Degree within the specified period of three years or extended period for up to additional two years, as the case may be and their pay was to be fixed in Pay Bank 3 with atleast 2 non-compounding increments for M. Tech. Degree as per clause 24(vi) of Annexure-1 of Recruitment Rules 2011 notified by the Ministry of Human Resource Development, Government of India. However, such Assistant Professor is entitled to the usual increments and allowances, and to all other benefits such as PF, Pension, future gratuity etc. at par with the facilities extended to regular faculty during the contract period.

On completion of Ph. D Degree, the services of 07 nos. of Assistant Professors (on contract) were regularized and lack of clarity their pay was inadvertently fixed in PB-3 of Rs.15600-39100+AGP of Rs.7000/- +02 compounded increments. Therefore, the matter was placed before the Board of Governors in its 39th meeting held on 5.4.2016. The Board decided as under: -

"The Board considered the matter of regularization and AGP upgradation to Rs.7000/- for Assistant Professors recruited in 2013. After the detailed discussion, the Board decided that this issue be referred to the MHRD for obtaining the views of the Ministry."

Subsequently, the Government of India, Ministry of Human Resource Development, Department of Higher Education, New Delhi vide letter F.No.2-5/2017-TS.III dated 17.7.2017 issued the clarification that the regularization of Assistant



Professors (on contract) may be carried out as per the terms and conditions of the appointment letter and Recruitment Rules prevailing at that point of time.

Keeping in view the above clarification issued by the MHRD, the matter was again placed before the Board of Governors in its 43rd meeting held on 23.01.2018. The Board had decided as under:-

"After detailed deliberations, the Board decided that the AGP of 03 Assistant Professors at Sr.No. 1-3, namely Dr. Sudhansu Choudhary, Dr. Bhanu Partap and Dr. Mantosh Biswas be re-fixed to AGP Rs.6000/-plus 02 non-compounding increments in place of AGP Rs.7000/- plus 02 increments in consonance with the terms and conditions of their appointment letters and Recruitment Rules prevailing at that point of time (MRR-2012) i.e. in the same Pay Band and the same AGP of Rs.6000/- plus 02 non-compounding increments as per the clarification issued by the Ministry vide MHRD letter F.No.2-5/2017-TS.III dated 17.7.2017, and their date of regularization and confirmation be modified accordingly.

Further, the Board decided that the AGP of 04 Assistant Professors at Sr.No.4-7, namely Dr. Giribabu Dyanamina, Dr Jayram Nakka, Dr. Joy Prakash Misra and Dr. Rajneesh be re-fixed to AGP Rs.6000/- plus 02 non-compounding increments in place of Rs.7000/- plus 02 increments in consonance with the terms and conditions of their appointment letters and Recruitment Rules prevailing at that point of time (MRR-2012) i.e. in the same pay band and the same AGP of Rs.6000/- plus 02 non-compounding increments as per the clarifications issued by the Ministry vide MHRD letter F.No.2-5/2017-TS.III dated 17.7.2017, and their date of regularization be modified and their services be confirmed accordingly.

Further, the regularization of confirmation of services of such Assistant Professor shall be carried out as per the terms and conditions of their appointment letters and Recruitment Rules prevailing at that point of time (MRR-2012), i.e. in the same Pay Band and the same AGP of Rs.6000/- plus 02 increments as per the clarification issued by the Ministry vide MHRD letter F.No.2-5/2017-TS.III dated 17.7.2017."

A copy of the minutes of the 43rd meeting held on 23.01.2018 is enclosed as *Annexure* – 67.12 (i) on pages 46.

In view of the above decision of the Board, their pay was fixed accordingly vide Office Order(s) dated 09.02.2018. However, the said Assistant Professors challenged the said Office order(s) dated 09.02.2018 before the Hon'ble High Court of Punjab and Haryana, Chandigarh in CWP No. 5092 of 2018. The High

Court vide orders dated 02.04.2018 stayed the execution of order dated 09.02.2018 till the next date of hearing. Accordingly, the office order was withdrawn.

The action taken report was placed before the Board of Governors in its 45th meeting held on 4.6.2018 and the Board decided as under:-

"The Board noted the action taken by the Institute as per the decision of the BOG taken in its 43rd meeting held on 23.01.2018 and subsequent compliance of the orders of Hon'ble High Court.

After detailed deliberations, the Board decided that the AGP in said cases may be re-fixed after following the due procedure by issuing notice and providing them an opportunity of hearing. The Board authorized the Director to consider the replies and personal hearing. The report thereon be put up to the Board in its next meeting."

A copy of the minutes of the 45th meeting held on 4.6.2018 is enclosed as *Annexure* – 67.12 (ii) on pages 47.

In compliance of the above decision of the Board, a Committee was constituted to consider the issue accordingly. The recommendations of the Committee were placed before the Board of Governors in its 46th meeting held on 23.10.2018. The Board decided as under:-

"The Board noted the action taken on the minutes with reference to the agenda item no. 45.18 to fix the pay of Assistant Professors recruited against the advt. no. 14/2012 and 05/2013 regarding. Further, the Board considered and decided that the recommendations of the Committee be sent to MHRD for advice."

Accordingly, the matter was referred to the Ministry of Human Resource Development, Department of Higher Education, New Delhi vide letter No. Estt-1/5909, dated 6.12.2018. In response, the Ministry vide letter No. F.10-3/3/2019-TS.III dated 28th March, 2019 informed that the matter regarding pay fixation of faculty is purely administrative nature and Institute specific for which Board of Governors of the Institute is the apex decision making body. Therefore, the matter may be considered as per rules and regulations issued by the Ministry and extent relevant instructions of Government of India and place the same before the Board for taking a decision. A copy of the MHRD letter dated 28.03.2019 is enclosed as *Annexure* – 67.12 (iii) on page 48.



It is pertinent to mention here that Hon'ble High Court of Punjab and Haryana, Chandigarh vide its decision dated 22.5.2024 passed the following orders against the CWP No. 10181 of 2016 filed by Sh. Lalit Thakur and others Versus Union of India and others:-

"In view of statement of both sides, the present petition stands disposed of with a direction to respondent No. 2 to extend benefit to AGP of Rs.7000/- along with consequential benefits to the petitioners, however, respondent would be free to withdraw said benefit, if it is withdrawn in the case of similarly situated teachers.

A copy of the order dated 22.5.2024 is enclosed as <u>Annexure – 67.12 (iv)</u> from pages 49 to 50.

Keeping in view of the above decision of the Hon'ble High Court as well as clarification dated 28.03.2019 provided by the MHRD (Now Ministry of Education), to resolve the issue "it is proposed that the Pay of all the 07 Assistant Professors may be fixed on regularization of their services on acquiring the Ph.D. degree in the Pay Band-3 of Rs.15600-39100 + AGP of Rs.6000/- +02 non-compounded increments from the initial date of joining in terms of their appointment letters and Recruitment Rule prevailing at that point of time as well as MHRD, Govt. of India letter F.No.2-5/2017-TS.III dated 17.07.2017, MHRD letter F.No.10-3/2019-TS.III dated 28.03.2019 and DoPT OM No.1/1/2010-Estt.(Pay-I) dated 06.12.2012, FR-9(21)(a)(i) and Rule FR 27, GIO(9)."

The matter is placed before the Board for consideration and decision.

He like petitioners at the time of appointment was not possessing degree of Ph.D. He completed Ph.D. after his appointment as Assistant Professor with AGP of Rs.6,000/-. He has been extended benefit of AGP of Rs.7,000/-.

BOG 67.13 To consider the re-fixation of minimum pay in the Pay Band-3 of Rs. 15600-39100 plus AGP of Rs.7000/- in respect of Assistant Professors recruited in the year 2012 and 2013.

The Institute had recruited 29 Assistant Professors during the year 2012 and 2013 against the Advertisement No.14/2012 and No.05/2013 for various disciplines (under the standard 3-tier rigid faculty structure) following the Model Recruitment Rules (MRRs) received from the MHRD, Government of India vide OM No.F.33-7/2001-TS.III dated 14.03.2012 which were approved by the Board of Governors of the NIT, Kurukshetra. All the above said 29 Assistant Professors were appointed on the basis of Ph.D. qualification and placed in the Pay Band-3 of Rs.15600-39100 plus AGP of Rs.7000/- without any advance increment.

The admissibility of advance increments at the time of recruitment for the post of Assistant Professor (on probation against the regular position) in PB-3 with AGP of Rs.7000/- was not mentioned in the Model Recruitment Rules. Therefore, the initial pay fixation for the post of Assistant Professor on a regular post was made at the minimum of the Pay Band-3 of Rs.15600-39100 with AGP of Rs.7000/- without any advance increment.

Aggrieved with the above fixation, many faculty members of the Institute working as Assistant Professors with AGP of Rs.7000/- have filed a Writ Petition vide CWP No.4701 of 2016 titled Dr. Awnish Kumar Tripathi and Others Vs Union of India and Others seeking directions to fix the pay of the petitioners in the Pay Band-3 with the initial pay of Rs.18600/18750+7000 as AGP and 07 non-compounded increments at the entry level with all other consequential benefits with effect from the due date itself.

During the pendency of the above said CWP, in order to remove the anomaly in the pay fixation of Assistant Professors appointed in the AGP of Rs.7000/- with Ph.D. qualification through the aforementioned advertisements, the matter was placed before the BOG of its 51st meeting (Item No.51.11) held on 19.09.2019. The Board considered and discussed the matter in detail and constituted a committee.

The Committee had recommended to the faculty members appointed as Assistant Professors in PB-3 with AGP of Rs. 7000/- with Ph.D. degree, initial basic pay may be fixed at Rs. 25600/- inclusive of AGP Rs. 7000/- i.e. at the first stage of the Fitment Table-2 for AGP of Rs. 7000/- (under 6th CPC) as notified by the MHRD, vide letter no. F.No.3-1/2009-U.1 dated 04.06.2009 to the UGC. However, table is applicable only to the incumbent (existing) Assistant Professors and issue of fixation of pay in question is related to the fresh recruitees. A copy of the MHRD letter dated 04.06.2009 is enclosed as <u>Annexure – 67.13 (i) from pages 55 to 56</u>.

The committee after due deliberation vide its recommendations dated 09.11.2019 recommended as under:

"For the faculty members appointed as Assistant Professor in Pay Band-3 with AGP of Rs.7000/- with Ph.D degree, the initial Basic Pay may be fixed at Rs.25600/- inclusive of AGP Rs.7000/- i.e. at the first stage of the Fitment Table-2 for AGP Rs.7000/- (under 6th CPC) as notified by the MHRD, Govt. of India vide letter F.No.3-1/2009-U.I dated 04.06.2009, in place of Rs.22600/- as fixed by the NIT, Kurukshetra."

The recommendations of the committee were placed before the BOG in its 52nd meeting (items no. 52.12) held on 06.12.2019. The Board after considering the report of the committee resolved as under:

"The Board considered and deliberated the report of the Committee along with the agenda item BoG 51.11 of 51st BoG meeting held on 19.09.2019 including the MHRD letters and CCS (RP) Rules, 2008 annexed with the said agenda in detail. In this regard, the MHRD letter No.F.23-2/2009-TS.II dated 9th March, 2010 was taken into reference, in which the AGP Rs.7000/- is shown as equivalent Grade Pay of Rs.6600/- for various entitlements. Further, Rule 8 of CCS (RP) Rules, 2008 regarding fixation of Pay in the revised pay structure of employees appointed as fresh recruits on or after 1.1.2006 and further notified in the Gazette of India vide notification no. G.S.R.622(e) dated 29th August, 2008, the Entry Pay for GP Rs.6600/- in the revised pay structure for direct recruits appointed on or after 01.01.2006 in PB-3 (Rs.15600-39100) will be Rs.18750/- + GP Rs.6600/- = Rs.25350/-. Also, as per Clause-4 of the MHRD letter F.No.15-4/2017-TC dated 27th October, 2017 for revision of pay of faculty of CFTIs with reference to 7th CPC, the entry pay for the AGP Rs.7000/- will be Rs.25790/-.

In view of the above references and recommendations of the Committee, the Board decided that it will be appropriate to fix the initial Basic Pay (Entry Pay) be fixed at Rs.25600/- inclusive of AGP



Rs.7000/- for the faculty members appointed as Assistant Professors in Pay Band-3 with AGP of Rs.7000/- with Ph.D. qualification for direct recruits appointed on or after 1.1.2006."

A copy of the minutes of 52nd meeting held on 06.12.2019 is enclosed as <u>Annexure – 67.13 (ii) on page 57.</u>

The Institute, with the approval of the BoG, fixed the pay of Assistant Professors at is Rs. 25600/- inclusive of Rs. 7000/- AGP.

The Hon'ble High Court of Punjab & Haryana, Chandigarh vide its decision dated 19.09.2023 passed the following orders in respect of CWP No.4701 of 2016:

"In view of aforesaid facts and findings, this Court is of the considered opinion that petitioners are entitled to benefit of 7 non-compounded advance increments. The petition deserves to be allowed and accordingly allowed."

A copy of the order dated 19.09.2023 is enclosed as Annexure – 67.13 (iii) from pages 58 to 60.

The Institute has filed a LPA No.1-2024 (O&M) before the Double Bench of the Hon'ble High Court of Punjab & Haryana, Chandigarh against the above said order of the Single Bench. The Double Bench vide its decision dated 23.04.2024 has passed the following orders:

"It has been brought to our notice that the issue of granting non-compounded advance increments at the entry level of the Assistant Professors was also subject matter of consideration in LPA-130-2024, which is pending for 28.08.2024. Accordingly, let notice of motion be issued to the respondents for 28.08.2024.

To be heard along with LPA-130-2024.

Any payment made during the pendency of this appeal will be subject to the final decision of the appeal."

A copy of the order dated 23.04.2024 is enclosed as Annexure – 67.13 (iv) on page 61.

In view of the above, it is evident that no stay has been granted in the above said LPA. Therefore, the orders passed by the Hon'ble Single Bench are to be implemented and the pay is to be re-fixed accordingly.

It is pertinent to mention here that the Government of India, Ministry of Human Resource Development (Now Ministry of Education), Department of Higher Education, New Delhi vide letter F.No.33-3/2014-TS.III dated 17.06.2015 had conveyed the recommendations of the Oversight Committee w.r.t. Four-Tier Flexible Faculty Cadre Structure against the aforesaid anomaly of the pay fixation and clarified that the minimum pay in Pay Band (PB)-3 for Assistant Professors on contract with AGP of Rs.7000/- shall be Rs.15600/- plus 07 non-compounded increments. A copy of the MHRD letter dated 17.06.2015 is enclosed as *Annexure* – 67.13 (v) from pages 62 to 64.

Any advance increments are to be given only from the beginning of the pay scale attached to the post. In this case pay scale attached to the post of Assistant Professor is Rs. 15600-39100 + Rs.7000/- AGP whereas in Civil Services of GoI, the entry pay for GP Rs. 6600/- in the revised pay structure for Direct Recruitees appointed on or after 01.01.2006 in PB-3 (Rs. 15600 - 39100) will be Rs. 18750/- + GP Rs. 6600/- = Rs. 25350/- (pertaining to G P for non-teaching staff). These Assistant Professors are seeking basic minimum pay or Rs. 18750/- + AGP of Rs. 7000/- + 07 non-compounding increments; as per GoI norms applicable for the direct recruits (non-teaching) officers; whereas they are being paid Rs. 18600/- + AGP Rs. 7000/- = Rs. 25600/-. A copy of the Gazette of India Notification dated 29.08.2008 regarding pay in the revised pay structure for direct recruits appointed on or after 01.01.2006 is enclosed as <u>Annexure – 67.13 (vi) from pages 65 to 66</u>.

In view of the above, it is proposed that "the earlier decision of the Board taken in its 52nd meeting (Item No.52.12) held on 06.12.2019 may kindly be reviewed in reference to the MHRD letter dated 17.06.2015 and the pay of the 29 Assistant Professors may be re-fixed on the minimum pay in Pay Band (PB)-3 for Assistant Professors on contract with AGP of Rs.7000/- shall be Rs.15600/- plus 07 non-compounded increments."

The matter is placed before the Board for consideration and decision.

The Board of Governors of the Institute at its 52nd meeting held on 06.12.2019 has decided under:

BoG 52.12 To consider the fixation of minimum pay in the Pay Band-3 of Rs.15600-39100 + AGP of Rs.7000/- in respect of Assistant Professors recruited in the year 2012 and 2013 as per the instructions issued by MHRD, Govt. of India from time to time.

"The Board considered and deliberated the report of the Committee along with the agenda item BoG 51.11 of 51st BoG meeting held on 19.09.2019 including the MHRD letters and CCS (RP) Rules, 2008 annexed with the said agenda in detail. In this regard, the MHRD letter No. F.23-2/2009-TS.II dated 9th March, 2010 was taken into reference, in which the AGP Rs.7000/- is shown as equivalent Grade Pay of Rs.6600/- for various entitlements. Further, Rule 8 of CCS (RP) Rules, 2008 regarding fixation of Pay in the revised pay structure of employees appointed as fresh recruits on or after 1.1.2006 and further notified in the Gazette of India vide notification no. G.S.R. 622(E) dated 29th August, 2008, the Entry Pay for GP Rs. 6600/- in the revised pay structure for direct recruits appointed on or after 01.01.2006 in PB-3 (Rs. 15600-39100) will be Rs.18750/- + GP Rs.6600/- = Rs.25350/-. Also, as per Clause-4 of the MHRD letter F.No. 15-4/2017-TC dated 27th October, 2017 for revision of pay of faculty of CFTIs with reference to 7th CPC, the entry pay for the AGP Rs.7000/- will be Rs.25790/-.

In view of the above references and recommendations of the Committee, the Board decided that it will be appropriate to fix the initial Basic Pay (Entry Pay) be fixed at Rs.25600/- inclusive of AGP in Rs.7000/- for the faculty members appointed as Assistant Professors in Pay Band-3 with AGP o Rs. 7000/- with Ph.D. qualification for direct recruits appointed on or after 1.1. 2006".

- 1. The petitioners, through instant petition under Articles 226/227 of the Constitution of India, are seeking direction to respondents to re-fix their initial pay as well as extend benefit of 7 non-compounded advance increments.
- During the pendency of the petition, the respondent Nos.2 and 3 filed affidavit dated 30.08.2023 wherein it was submitted that a committee was constituted by respondent Nos.2 and 3 and on the basis of recommendation of the committee, the initial pay of ₹25,600/- inclusive of AGP ₹7,000 instead of ₹22,600/- as earlier, has been fixed.
- 3. On the basis of aforesaid affidavit, the petitioners submitted that petitioners would make representation to the appropriate authority with



consonance with communication dated 27.10.2017 of Ministry of Human Resource Development.

- 21. All the above-noted letters collectively indicate that there was always intention of the Government to extend 7 non-compounded annual increments to Assistant Professor appointed in PB-3 with AGP ₹7000.
- 22. The respondent has contended that after implementation of 6th Pay Commission and 7th Pay Commission, the pay of the petitioners has been re-fixed. As per fitment table which is based upon 6th Central Pay Commission, in the pay of the petitioners, a sum of ₹3000/- has been included in the basic pay.

Learned counsel for the petitioner while controverting the aforesaid contention of the respondents submits that contention of respondent that a sum of ₹3000/- has been included in basic pay in fitment table is factually incorrect because fitment table was prepared considering basic pay 1.86 times of pre-revised pay. The minimum revised pay was notified ₹15600/- thus, wheresoever, applying multiplier of 1.86 times to pre-revised pay, pay comes to less than ₹15600/-, the pay is fixed ₹ 15,600/-. Every entry of fitment table is based upon this formula, thus, there is no question of inclusion of ₹3,000/- in the basic pay as per fitment table. Court finds substance in the contention of the petitioners, however, it loses significance in the wake of above findings, on the issue involved.

23. In view of aforesaid facts and findings, this Court is of the considered opinion that petitioners are entitled to benefit of 7 non-

compounded advance increments. The petition deserves to be allowed and accordingly allowed.



As you are aware, the Ministry of HRD vide its Order F.No.27-11/2011-TS.I dated 10th October, 2014 re-constituted the Oversight Committee under the Chairmanship of Prof. Goverdham Mehta, Jubilant-Bhartia Chair Professor, School of Chemistry, University of Hyderabad for monitoring the implementation of the Four-Tier Flexible Cadre (Faculty) structure in the Centrally Funded IIITs, NITs and ISM — Dhanbad.

2. Following recommendations of the Oversight Committee have been approved w.r.t. Four-Tier Flexible Faculty Cadre Structure conveyed vide this Ministry's letters F.No.33-9/2011-TS.III dated 23rd August, 2013 and 15th January, 2014, respectively:

New Delhi, the 29th August, 2008

G.S.R. 622 (E).— In exercise of the powers conferred by the proviso to article 309, and clause (5) of article 148 of the Constitution and after consultation with the Comptroller and Auditor General in relation to persons serving in the Indian Audit and Accounts Départment, the President hereby makes the following rules, namely:

1. Short title and commencement -

- (1) These rules may be called the Central Civil Services (Revised Pay) Rules, 2008.
- (2) They shall be deemed to have come into force on the 1st day of January, 2006.

2. Categories of Government servants to whom the rules apply: -

- (1) Save as otherwise provided by or under these rules, these rules shall apply to persons appointed to civil services and posts in connection with the affairs of the Union whose pay is debitable to the Civil Estimates as also to persons serving in the Indian Audit and Accounts Department.
- (2) These rules shall not apply to:-
 - (i) persons appointed to the Central Civil Services and posts in Groups 'A', 'B', 'C' and 'D' under the administrative control of the Administrator of the Union Territory of Chandigarh;
 - (ii) persons locally recruited for service in Diplomatic, Consular or other Indian establishments in foreign countries;
 - (iii) persons not in whole-time employment;
 - (iv) persons paid out of contingencies;
 - (v) persons paid otherwise than on a monthly basis including those paid only on a piece-rate basis;
 - (vi) persons employed on contract except where the contract provides otherwise;
 - (vii) persons re-employed in Government service after retirement;



BoG 67.14 To consider the proposal for the cancellation of lease agreement of the land of National Institute of Technology, Kurukshetra (erstwhile Regional Engineering College, Kurukshetra) as provided on lease to Provincial Division No.-2, Public Works (B&R) Branch, Kurukshetra.

The Regional Engineering College, Kurukshetra was established in 1963. A significant landmark in the history of this institution is the up-gradation of REC Kurukshetra to NIT Kurukshetra with Deemed University status with effect from 26th of June, 2002. The year 2007 was memorable for NIT Kurukshetra as the Institute was conferred the status of an Institution of National Importance by the Government of India through an Act of Parliament.

A piece of land (Back side of Institute Health Centre), measuring about 4.06 acres was given on lease for a period of thirty years on 01.09.1975 with effect from 25.11.1970 to the Executive Engineer, P.W.D.(B&R), Provincial Division No.2, Kurukshetra, Govt. of Haryana for construction of Division Office and other residential buildings connected there-to for office accommodation and residential accommodation. The matter was placed before the Board of Governors of REC Kurukshetra in its 70th meeting held on 12.10.1987, vide Item No.70.9, and the Board had resolved as under:

"The Board noted the advice of the Government of Haryana, concerning Lease of College land to P.W.D.(B&R) Haryana, conveyed vide their letter No.44/57/85, Tech. Arch.(4)/264 dated 23.02.1987. The Deputy Educational Adviser(T), desired that the College should be very careful in leasing out any piece of land in future."

A copy of the lease agreement dated 01.09.1975 is enclosed as Annexure - 67.14 (i) from pages 70 to 73.

In this context, it is stated that at REC, Kurukshetra in the year 1975-76 there were 8 Courses (4 B.Tech. and 4 M.Tech) with an intake of 1330 students in total. At NIT, Kurukshetra in the year 2024-25, the admission intake is increased to 6996 students in 50 courses including 15 Under Graduate courses (14 B.Tech. & 01 B.Arch.), 22 Post Graduate courses (17 M.Tech., 3 M.Sc., MBA & MCA) and 13



Ph.D. programs which is about 5 times more than the intake of 1975-76. Accordingly the teaching and non-teaching staff strength has also increased 5 times.

Therefore, in order to meet the various requirements of the Institute due to increased intake strength of students and staff, the institute has decided to carry out various developmental works like construction of Lecturer Hall Complexes, Hostels, Auditorium, Community Centre & Residential Complexes etc.

Also, as per the instruction of Ministry of Education, Government of India, the Institute has prepared the Roadmap for Capital Expenditure for next five years i.e. from 2024-2029. During the Year 2024-25, the Institute is planning to construct an Academic Building, Boys Hostels and Residential Complexes etc. for the use of academic and Institute purposes in public interest. For all these purposes, the Institute needs land and 25% of the available land only can be used for construction as per local FAR regulations.

Further, it is also stated that some parts of the land which was provided on lease, is not being used by the Provincial Division No.-2, P.W.D. B&R Branch, Kurukshetra. Also, this lease is subject to payment of annual lease value of Rs. 100/-per acre per year but no such payment has been received so far. Hence it amounts that the lease terms are ab initio not adhered to.

The clause 3(i) of the said lease agreement states "That the lessee paying the rent hereby reserved and performing all the covenants by the lessee herein contained may hold and enjoy the demised premises the said and renewed terms without any unlawful interruption by the Lessor or any other person whatsoever provided the same in no way causes any interference with the instructional, Research, Administration and other works and functions of the college."


Further, the clause 3(ii) of the said lease agreement states "That the lease shall stand renewed by Lessor, at the end of initial term of thirty years hereby

granted, for a further terms of thirty years, and so on, from time to time thereafter at the end of each successive term of thirty years, unless a notice for termination is served by the lessee."

Keeping in view, our pressing demand for more space and expansion, it is requested to take back the land as provided on lease to Provincial Division No.-2, Public Works (B&R) Branch, Kurukshetra for the construction of Institutional development projects of NIT Kurukshetra at the earliest so that the above construction works shall be initiated.



The Regional Engineering College, Kurukshetra was established in 1963. A significant landmark in the history of this institution is the up-gradation of REC Kurukshetra to NIT Kurukshetra with Deemed University status with effect from 26th of June, 2002. The year 2007 was memorable for NIT Kurukshetra as the Institute was conferred the status of an Institution of National Importance by the Government of India through an Act of Parliament.

A piece of land, measuring about 5 acres was given on lease for a period of 99 years to the Executive Engineer, P.W.D.(B&R), Provincial Division No.1, Kurukshetra, Govt. of Haryana for construction of residential buildings and stores. The possession of 5 acres of College land (Back side of temple) was transferred to PWP(B&R) with effect from 01.06.1980. The matter was placed before the Board of Governors of REC Kurukshetra in its 50th meeting held on 19.05.1979, vide Item No.50.31, and the Board had resolved as under:

"RESOLVED the request of the Executive Engineer Kurukshetra Provincial Division No.1, PWD B&R, Kurukshetra, for leas of a plot of land measuring about 5 acres for a period of 99 years on the same terms and conditions as are applicable to the existing lease be accepted."

A copy of the lease agreement dated 12.01.1988 is enclosed as Annexure – 67.15 (i) from pages 77 to 80.

In this context, it is stated that at REC, Kurukshetra, in the year 1988-89 there were 11 Courses (5 B.Tech. and 6 M.Tech) with an intake of 1434 students in total. At NIT, Kurukshetra, in the year 2024-25, the admission intake is increased to 6996 students in 50 courses including 15 Under Graduate courses (14 B.Tech. & 01 B.Arch.), 22 Post Graduate courses (17 M.Tech., 3 M.Sc., MBA & MCA) and 13 Ph.D. programs which is about 4.7 times more than the intake of 1988-89.



Accordingly the teaching and non-teaching staff strength has also increased 4.7 times.

Therefore, in order to meet the various requirements of the Institute due to increased intake strength of students and staff, the institute has decided to carry out various construction works like Lecturer Hall Complexes, Hostels, Auditorium, Community Centre & Residential Complexes etc.

For all these purposes, the Institute needs land and out of the available land only 25% can be used for constructions as per local FAR regulations.

Further, it is also stated that some parts of the land which was provided on lease, is not being used by the Provincial Division No.- 1, P.W.D. B&R Branch, Kurukshetra, Govt. of Haryana. Also, this lease is subject to payment of annual lease value of Rs. 100/- per acre per year but no such payment has been received so far. Hence it amounts that the lease is ab initio not adhered to.

The clause 3(i) of the lease agreement states "That the lessee paying the rent hereby reserved and performing all the covenants by the lessee herein contained may hold and enjoy the demised premises during the said term without any unlawful interruption by the lessor or any other person whatsoever, provided the same in no way causes any interference with the Instructional, Resource, Administration and other works, and functions of the College."

Keeping in view, our pressing demand for more space and expansion, it is requested to take back the land as provided on lease to Provincial Division No.
1, Public Works (B&R) Branch, Kurukshetra for the construction of Institutional



development projects of NIT, Kurukshetra at the earliest so that the above construction works shall be initiated.

S 53.15 To consider the Establishment of Department of Architecture and Planning in the Institute.

The progress of a country depends to a great extent upon its infrastructure. For the rapid growth of a country, it is vital to have an efficient and excellent infrastructure in terms of buildings, bridges, roads, transport system, communication, etc. Being third largest growing economy of the World, the country has already started development of 'Smart Cities', and to meet the demand of increasing urbanization, Architects and Civil Engineers will play a vital role in the overall development of the level of standard of the society.

The field of architecture is part of the construction industry that historically rises and falls with the general economy. Architecture is concerned with the design and construction of infrastructural systems in their sociological, technical and environmental contexts. In order to meet the requirement of making the technically and professionally advanced manpower available in the country, it has been planned to start a Bachelor of Architecture and Planning (B. Arch. & Plan.) Degree course at this Institute in view of the fact that at present, only a few the institutions of national importance in the region are offering B. Arch. & Plan. degree course.

In view of the above, the matter was placed before the Senate in its 52nd meeting held on 12.2.2024. The Senate recommended to the Board as under: -

"After detailed deliberations, the Senate approved the proposal of redistribution of seats and starting of new B. Tech. and B. Arch. & Planning Course within the existing intake from the AY 2024-25."

On the recommendations of Senate made in it 52nd meeting held on 12.02.2024, the Board of Governors of the Institute in its 65th meeting held on 06.03.2024 has approved the proposal for the starting of new Programme Bachelor of Architecture with an intake of 40 from the Academic Year 2024-25. Accordingly, the Institute has applied to the Council of Architecture (CoA) Portal for the grant of approval to start Bachelor of Architecture Degree Course at this Institute. Therefore, we have to set up the Department of Architecture & Planning at this Institute.

As per clause 8 (xii) of the First Statute of NITs, the Senate may make recommendations to the Board with regard to the creation or restructuring of Departments or Programs or Centres and the abolition of existing Departments or Centres thereof.

In view of the above, it is proposed that Department of Architecture and Planning may be established in the Institute.

The Senate may consider and decide.

BoG 67.18 Action taken w.r.t. the minutes of the agenda item No. BoG 65.8 (Ref.:S52.12) regarding introduction of Minor Degree programmes from the Academic Session 2024-25.

As a part of NEP 2020, Institute has planned to introduce minor degree programme in all the disciplines from the Academic session 2024-25.

UGC guidelines are providing that students can join Masters programmes in the areas/subjects of Minor degrees obtained by them, hence enable the students to choose Masters programmes based the minor degree specializations. To enhance the avenues to the students the Institute is proposing to offer Minor degree programmes from the academic session 2024-25 onwards. This will widen the students' choices to choose the appropriate PG Programme in spectrum of Courses at Masters Level.

Acquiring additional skills through Minor degrees will widen the placement prospects of the students and Institute placement status will also upgrade. The students can avail the facility of learning the additional skills and upgrade their knowledge during the course of their regular enrolment for bachelor courses and thereby their employability will be enhanced substantially. They need not specially spend time after the regular degree programme to acquire these additional skills through minor degree courses as they will be facilitated to acquire the same while they are in their regular studies. Thus this time saving is a paramount in their career. This will also enable the students who obtains the minor Degree in addition to major Degree course and serves as additional qualification.

The Institute will offer these minor degree certificates courses in accordance with the choice of students. These minor degree courses will enhance the students' capacity and skills and at their choices for higher academic degree programmes. This will increase their skills and also serve as additional qualification thereby Employability and placement prospects will be improved considerably.

The minor degrees will be offered to the students pursuing Bachelors' Degree Courses starting from 4th/5th Semester and will be extended to the students studying PG programmes and Ph.D. programmes. The institute will organize these minor degree programmes on Saturday and Sundays so that the normal Academic degree programmes will remain unaltered. The teaching facility for minor degree courses will be provided through Guest Faculties or existing faculties on payment basis at the BOG approved rates for guest faculty. Teachers also will get trained and this approach will lead to the Multidisciplinary teaching and learning for teachers and learners.

These minor courses will be additional avenue to the students and these will be operated through Guest Faculties or Institute faculties by the respective departments or in collaboration with Industry and others. The teaching will be assigned to a faculty who is in the practice of teaching as per the UGC norms. The payment to the teachers will be as per the guest faculty norms prevailing as approved by the BOG.

The Senate in its 53rd meeting held on 10.07.2024 has decided that Rs. 4000/- cost per credit shall be charged from the students. The cost for meeting the additional efforts of offering Minor degrees will be met by collecting Rs.4000/- per credit of the course from the interested students joining for Minor degree programme. The Institute has planned this additional service for the benefit of the students. The institute shall ensure that the teaching of regular Academic programme is not affected with the teaching of minor degree courses. This will augment the Internal Revenue generation also thereby institute will be benefited.

In view of the above, it is proposed that "Minor Degree Programmes may be introduced from the Academic Session 2024-25 w.r.t. the recommendations of the Senate (Ref. Agenda Item No.S52.12)".
