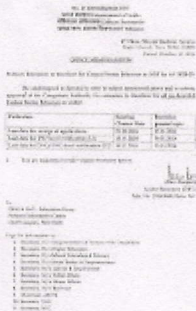
At the same time it is informed that the last dated to apply for all Scholarship schemes for disabled person is extended from 31-10-2024 to 15-11-2024.

In view of the above you are requested to do wide publicity in this regard and at the same time inform about the extension of date to all institution under you.

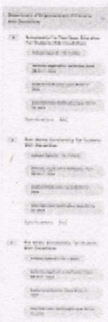




