At the outset, the Hon'ble Director and the Chairman of the Senate welcomed all members of the Senate and accorded permission to present the agenda of the meeting.

The agenda was presented and after detailed deliberations, the following decisions were taken in the meeting:

S 55.01 To confirm the minutes of 54th Senate meeting held on 7.10.2024.

S 55.02 To note the minutes of 68th SCSA meeting held on 19.12.2024.

S 55.03 To note action taken report on the minutes of 54th Senate meeting held on 7.10.2024.

S 55.04 To ratify the approval of the Chairman, Senate for the following:

- (i) Relaxation of period of experience for regular employees from two years to one year for part-time Ph.D. programme.
- (ii) To increase the seats of MCA Self-Finance from 32 seats to 42 seats
- (iii) Relaxation for part-time Ph.D. candidates for opting course work in online mode or on MOOCs platform.
- (iv) Extension for one year to part-time Ph.D. research scholar and extension of 3 months for comprehensive exam. to Ph.D. research scholar as special cases.
- (v) Proposal of Memorandum of Agreement (MOA) between Seattle University, USA and National Institute of Technology Kurukshetra.

S 55.05 To consider some minor modifications in Ph.D. regulations.

After discussions, the Senate decided the modifications in Ph.D. regulations as under:

S 55.06 To consider the proposal of introducing M.Sc. Economics in Humanities & Social Sciences Deptt. from AY 2025-26.

After deliberations, the Senate approved the proposal of introducing M.Sc. Economics in Humanities & Social Sciences Deptt. from AY 2025-26 in principle. It was found that there are some observations which can be ratified before the commencement of the programme. The seat matrix of all M.Sc. programmes will be same. The M.Sc. Economics in Humanities & Social Sciences Deptt. should have same template like other M.Sc. programmes i.e. in Mathematics, Chemistry, and Physics. The admission will be through CCMN with qualified JAM.

S 55.07 To consider and approve the new scheme and seat matrix of M.Tech. programmes.

After detailed deliberations, the Senate approved the new M.Tech. scheme and seat matrix of M.Tech. programmes. However, it was decided that the HoDs of Mechanical Engg. and Civil Engg. will again prepare the seat matrix duly approved by their DACs and send to the Academic Section to be decided in SCSA meeting.

S 55.08 To consider the proposal for initiation of Institute Postdoctoral Fellowships.

After deliberations, the Senate approved the proposal for initiation of Institute Postdoctoral Fellowships in principle. However, a Committee will



be constituted by the Chairman, Senate to frame eligibility and criteria of Institute Postdoctoral Fellowships for implementation.

S 55.09 To consider and approve the 3rd & 4th year scheme of following three B.Tech. programmes started in AY 2023-24.

The Senate considered and approved the 2nd year scheme of the following UG programmes started in AY 2024-25.

S 55.11 To consider and approve the Academic Calendars for Odd and Even Semesters of Academic Year 2025-26.

The Senate considered and approved the Academic Calendars for Odd and Even Semesters of Academic Year 2025-26. It was suggested that the technical and cultural activities will be planned in the morning and

evening within the duration of 4-5 days. After modifications, the academic calendars will be approved by the Chairman, Senate.

S 55.12 To consider and approve the assessment and evaluation process of B.Arch. degree course.

The Senate considered and approved the assessment and evaluation process of B.Arch. degree course.

S 55.13 To consider and approve the proposal for creation of new departments of UG and PG programmes.

The Senate considered and recommended the proposal for creation of new departments of UG and PG programmes.

S 55.14 To consider and decide the proposal related to fee for M.Tech. students in case of delayed submission of dissertation.

After deliberations, the Senate approved that if the part-time/full time student fails to submit his/her thesis in the given timeline, he/she will pay continuation fee of Rs. 10,000/- per semester. He/she will not require to pay full semester fee. The time line for thesis submission will be 31st July of applicable academic year instead of 30th June. The same will be modified under clause PG.8 and PG 9.1 of PG regulations.

S 55.15 To consider the proposal for minor modification in attendance rules.

After discussions, the Senate approved the modification in attendance rules that in special cases, if any student is detained in the current semester in only one or two courses may be allowed to repeat the theory/lab course(s) through self-study and appear in the end semester exam of 100 marks in the upcoming (Odd/Even) semester. For this, the Senate authorized the Chairman, Senate to take decision in this regard.

Further, the Senate approved the 'D' grade option in case of attendance less than 50% for students of 2022 batch for one time only.



S 55.16 To consider and approve the minor modification in scheme of M.Sc. Physics.

The Senate approved the minor modification in scheme of M.Sc. Physics. Simultaneously, the Senate also approved the modification in scheme of M.Sc. Mathematics.

S 55.17 To consider and approve the evaluation criteria of M.Sc. programmes.

The Senate considered and approved the evaluation criteria of all M.Sc. programmes. Further, on the pattern of M.Tech. viva-voce examination, the external examiner will be paid remuneration and TA/DA.

S 55.18 To consider the provision of multiple entry and exit with transfer of credits in line with NEP-2020

The Senate agreed upon the proposal for provision of multiple entry and exit with transfer of credits in line with NEP-2020. For this, a Committee will be constituted to frame the rules and regulations for this provision.

S 55.19 To consider the amendment of evaluation criteria for the 'Best All-Round Student' for the batch of 2021-25 and onwards.

After long deliberations, it was decided that the proposal to be revised by the Dean (SW) in consultation with Prof. I/C (Tech.) and Prof. I/C (Clubs) and submit the report for discussion in the next Senate.

ST 55.05 To consider the proposal for summer internship for UG & PG students.

The Senate is agreed upon the proposal for summer internship for UG & PG students. For this purpose, the Chairman, Senate is authorized to constitute a Committee to frame the modalities for implementation.

Any other item

Under any other items, the following points were discussed and decided as under:


- (i) The Senate considered and approved the minor modifications in the scheme of B.Tech. Computer Science & Engg. and Information Technology.

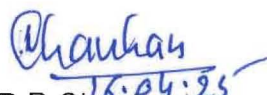

- (ii) While considering the request of Mr. Abhishek Sharma, Research Scholar, Computer Applications department for allowing him to submit synopsis, the Senate decided the case to be referred back to DRC of concerned department for reconsideration.
- (iii) The Senate agreed upon the option 'D' grade for Mr. Ayush Pratap Singh, B.Tech. final year Elect. Engg. student whose attendance was less due to off-campus internship.
- (iv) The Senate did not agree upon the proposal for relaxation in eligibility conditions of admission in part-time Ph.D. programmes for regular employees of the Institute.
- (v) One of the Senators proposed some modifications in Ph.D. regulations:
 - i. All GATE qualified candidates (any passing year) may be exempted from the written test for admission.
 - ii. Applications received for admission will be scrutinized by the Committee constituted by the concerned HoD.
