1. Eligibility Criteria

- Academic Qualification: Open to undergraduate (UG) students with a Minimum CGPA of 7.0 (or equivalent).
- Financial Eligibility: Annual family income must not exceed ₹5,00,000.
- Disciplinary Record: No history of disciplinary actions, penalties, or examination malpractice. Compliance with institutional /hostel/ departmental codes of conduct is mandatory.

2. Scholarship Details

- Number of Beneficiaries: Approx. 30–50 students will be selected initially.
- Scholarship Amount: Approx. ₹20,000 to ₹30,000 per semester (disbursed upon meeting renewal criteria).
- Renewal: Continuation would require maintaining a CGPA of 7.0+ and adherence to eligibility terms.

3. Important Conditions

- There is no bar on applicants holding other scholarships to submit application. However, they are required to make full disclosures in this application, such as amount and periodicity of previous/other scholarship(s) (ie, one-time, per semester, etc)
- Disbursement Compliance: Funds will be released only after verification of eligibility.

Step 1: Institutional Coordination

- Role of Institutions:
 - Circulate the scholarship opportunity to eligible UG students.
 - Verify applications for: Income documentation, Academic performance (CGPA) and Clean disciplinary record.

Step 2: Selection by CSR Committees

- Selection Authority: Final decisions rest with the CSR Committees of M/s. Metro Waste Handling Pvt. Ltd., City Life Foundation & City Infra Group.
