National Institute of Technology invites online admission applications through Google Form (available on the Institute website) for the following seats in various specializations / disciplines of PG Programmes in Academic Year 2025-26:

<u>Left over seats of CCMT and CCMN-2025 (Regular and Self-Financed) after National</u> Spot Round (NSR) of CCMT/CCMN-2025

- a) The eligibility criteria and qualification will be same as per CCMT and CCMN 2025.
- b) The seat matrix of left over seats from CCMT/CCMN-2025 of M.Tech./M.Sc. Programmes will be prepared after completion of National Spot Round of CCMT/CCMN-2025.
- c) The candidates who have valid GATE (2023,2024,2025)/JAM (2025) score card will be considered on left over seats of CCMT / CCMN -2025.

Self-Financed seats for M.Tech. and still Left over self-financed seats of CCMN-2025

- a) The eligibility qualification will be 6.5000 CGPA (on 10-point scale) or 60 % marks aggregate based on all semesters or equivalent in qualifying degree examination. For SC/ST/PwD candidates, 6.000 CGPA (on 10-point scale) or 55 % marks aggregate based on all semesters or equivalent in qualifying degree examination.
- b) GATE/JAM score is not mandatory.
- c) The self-financed candidates will not get any financial support from the Institute.
- d) The admission to these seats will be made strictly on merit prepared on the basis of Marks/CGPA/GPA of qualifying examinations.
 - (i) The candidates who have completed qualifying examination will be considered first and seats will be allotted as per merit prepared on the basis of percentage calculated up to final semester. In case of CGPA/GPA, normalized equivalent percentage will be calculated using the formula given below:

Percentage= [(CGPA/GPA)/ (Point Scale)] *100

- In case of tie in the normalized percentage, the candidate older in age will be given preference in the merit list.
- (ii) The candidates whose final result of qualifying examination is not declared until the last date of the application will be considered for remaining seats as per merit prepared on the basis of percentage calculated up to pre-final year (up to 6th semester for B.Tech./B.E. or equivalent and up to 4th semester for B.Sc./B.A. or equivalent). The normalized percentage will be calculated as per formula mentioned at point (i) above. However, such candidates will be required to submit final year passing results up to 30th September, 2025 failing which their admission will be liable to be cancelled.

Sponsored seats in M.Tech.

a) 6.5 CGPA (on 10-point scale) or 60 % marks aggregate based on all semesters in qualifying degree examination as per CCMT / CCMN 2024. For SC/ST/PwD candidates, 6.0 CGPA (on 10-point scale) or 55 % marks aggregate based on all semesters in qualifying degree examination. On last date of applying, two years experience after graduation in the organization(s) of the types specified, out of which at least one year continuous experience should be as regular employee in the sponsoring organization. However, for employees of DRDO/R&D organizations/Govt. organizations etc., the experience requirement is relaxed.

Note: The specified organization(s) means: Government Organization/Public Sector Undertaking/Companies Regd. under Indian Companies Act 1956 Govt./Govt. aided/Private Engineering Colleges/ Polytechnics.
