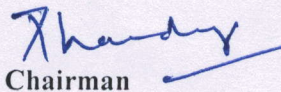
Guidelines for SPOT Round- MBA Admission (2026-28)

- The candidates are required to remain **present physically** in the Department of Business Administration, NIT Kurukshetra on 31st August and 1st September 2026 for Spot Round MBA Admission Counselling.
- Reporting time for NitMAT is 12:00 Noon and Test Commencement Time 01:00 PM to 02:30 PM
30th August 2026,
GD & PI, 09:00 AM to 10:00 AM, 31st August 2026.

** Candidates need to strictly follow the reporting time for NitMAT and GD&PI.*

LATE COMERS WILL NOT BE ENTERTAINED FOR ANY REASON WHATSOEVER.

- The Department will not consider any such request for delay in arrival due to train/bus/any other mode of transportation in any circumstances whatsoever. Any candidate who fails to report physically and sign the Attendance sheet between above mentioned timing, their candidature will get cancelled and will not be considered for further admission process.
- It is mandatory for candidates to sign the Attendance sheet to further participate in the spot round admission process at Department of Business Administration.
- The MBA seats (subject to available seats in the respective category) will be offered to the shortlisted candidates (in order of merit) only out of those who report physically for admission process in the Department of Business Administration.
