**MOST IMPORTANT LETTER TO PARENTS OF 2ND YEAR STUDENTS
(AS PART OF MEASURE TO PREVENT RAGGING IN THE INSTITUTE)**

Dear Parents (2nd Year Students of B.Tech, M.Tech, MBA & MCA Programmes)

Greetings from the Institute !

This is to inform you that your ward has been promoted to 2nd year in the respective academic programme offered by the Institute. It is brought to your kind notice that ragging is a criminal offense and the UGC has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the scourge of ragging.

The Institute has constituted an Anti-Ragging Committee (ARC) and Anti-Ragging Squad (ARS) for Academic Year 2026-27 as per the instruction issued by the UGC. The details of ARC and ARS are also uploaded on the Institute website under Student's Welfare-> Anti-Ragging.

The ARC and ARS of the Institute has been empowered to take punitive action against the ragging culprits under the provisions of UGC regulations on curbing the menace of ragging in higher educational institutions, 2009.

The following actions but not limited to can be taken against the culprits under the provisions of UGC Regulations-2009.

- i) *Suspension from attending classes and privileges*
- ii) *Withholding/withdrawing scholarship/fellowship and other benefits*
- iii) *Debarring from appearing in any test/examination or other evaluation process*
- iv) *Withholding results*
- v) *Debarring from representing the Institution in any regional, national or international meet, tournament, youth festival etc*
- vi) *Suspension/expulsion from the hostel.*
- vii) *Cancellation of admission.*
- viii) *Rustication from the Institution for a period ranging from one to four semesters.*
- ix) *Expulsion from the Institution and consequent debarring from admission to any other Institution for a specified period.*

In view of the above, you are advised to bring these consequences to your ward arising due to ragging activities and direct him/her not to be involved in the heinous crime of ragging.
